25 Senators having voted in the affirmative and 7 Senators having voted in the negative, with 3 Senators being absent, the motion by Senator **MARTIN** of Aroostook to remove from the **TABLE, PREVAILED**.

Senator **MARTIN** of Aroostook moved to **PASS**.

**THE PRESIDENT:** The Chair recognizes the Senator from Kennebec, Senator Gagnon.

Senator **GAGNON:** Thank you, Madame President, men and women of the Senate. What lofty things we debate here in the Senate. I would hope that we could have kept this item on the table a little bit longer. I know the issue about Legislative license plates is near and dear to all of us. Last year we had a review of a bigger issue facing the legislature having to do with the impression and the look of the legislature as a distinct branch of government, distinct from the Executive Branch. The Legislative Council did pass a motion that asked the Facilities Committee, of which I chair, to look at this whole issue of the look of the legislature as a distinct branch and to try to come up with some strategies on how the people of the State of Maine can understand that there is a distinction, a difference, between the Executive Branch and the Legislative Branch and the fact that we are a co-equal branch of government.

I'm reminded of the time I visited my parents shortly before my father's death and my Dad said, 'I saw your boss on television last night.' I'm thinking, 'My boss at Colby?' I didn't know who he was talking about. He said, 'No, the Governor.' I went, 'EEEEEE' The Governor is in a different branch of government but there is this impression out there, because we're all gathered in one big building and we're all sort of part of government, that that somehow all work for the Governor.

I'm reminded of the time when children are brought into the room. When I have kids from my district come in and I always bring them into this chamber and I ask them, 'Who owns this building that you are in? Who's in charge of this building?' Of course I'm looking for the answer that it belongs to the people of the State of Maine. Invariably the kids will say, 'The Governor.'

That's part of what the whole strategy was all about. We're trying to look at some impression. We're trying to look at how we approach the media. We're trying to look at how our impression is different and distinct from the Executive Branch. The Legislative Council agreed with that and we sent it to the Facilities Committee. From there, the Facilities Committee, because of timing issues, thought we wanted to look further at license plates because that is probably the biggest impression that people have. They thought it was time for a change. Changes had not been made since the 1970's and the look of the blue plates for the House and the red plates distinguishing the House from the Senate wasn't necessarily healthy in that we are trying to be unified in our look but also distinctive from the other branches of government. We looked at those issues and started looking at designs. The council did, in fact, approve this new design that people are now critical of. I understand that. Maybe we rushed into that issue. What I was hoping to be able to do is to keep this item on the table so that the Legislative Council can revisit this issue because the Legislative Council has this as a primary and overriding objective for the entire legislature. To now ask the Secretary to go off and sort of circumvent the council and to come up with plates that are different and distinct from the House, I'm not sure how this would work. If we get new plates, do we get rid



of the old ones? Do we have two different types of plates? It would sort of defeat the whole purpose of what we're trying to do. Of course, this whole debate sort of defeats the purpose of what we're trying to do, which is to try to make it look like we are a vital and important branch of government.

I would like to see the Legislative Council revisit this issue and I had planned to have it on the agenda for the next Legislative Council meeting.

**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, Senator Martin.

Senator **MARTIN:** Thank you, Madame President and members of the Senate. The order before us is a result of a number of members who came to me to basically say ask if there was a way to reverting back to the old plates and that is the purpose of the order. It is not an attempt to undermine anyone's authority. As a matter of fact, I probably should be the last one in the chamber to want it because the good Senator from York, Senator Andrews, would now be number one rather than me. I would be number thirty-five. Certainly it's not because of the numbering that I am presenting the order. It has become, I think, an issue that should never have been an issue, in my opinion. We don't need to change the purpose of the plate. We're just trying to go back, for those who want to go back, to the old style. It is really that simple. To me, it's a very simple question. It seems to me that we ought to deal with it.

Let me remind everyone that the council is the old council that clearly has no authority over this body and what we do in this body. That is why it is our prerogative and that is why the order is drafted the way it is. It does not interfere with what the other body may choose to do. That is entirely up to them, if they choose to anything at all about it. That is where we are. I will point out that earlier on this question the good Senator from Kennebec, Senator Gagnon, asked if I would be willing to table this until the Facilities Committee of the council would meet. I was not opposed to that, but subsequently, when I asked when that was going to occur, it was in some future date. Frankly, it's either we do it now or we don't do it. To me, it's that simple. Everyone can vote any way they want to. Let's get rid of it. To me, that's what we ought to be doing this morning.

**THE PRESIDENT:** The Chair recognizes the Senator from Piscataquis, Senator Davis.

Senator **DAVIS:** Thank you, Madame President. May I ask a question through the Chair?

**THE PRESIDENT:** The Senator may pose his question.

Senator **DAVIS:** Could the committee get together within ten days and come up with a solution to this problem?

**THE PRESIDENT:** The Senator from Piscataquis, Senator Davis poses a question through the Chair to anyone who may wish to answer. The Chair recognizes the Senator from Kennebec, Senator Gagnon.

Senator **GAGNON:** If the Senator is asking whether or not the Facilities Committee can get together, that certainly is the case. Of course that is a committee of the Legislative Council of the Senator is a member.

**THE PRESIDENT:** The Chair recognizes the Senator from Piscataquis, Senator Davis.

Senator **DAVIS:** First a comment. I have been a member and am the longest serving member. I do not recall ever voting to accept these plates. However, I did have some reason to miss a few meetings last fall. That might possibly be why I don't recall it. Madame President, I have another question.

**THE PRESIDENT:** The Senator may pose his question.

Senator **DAVIS:** If the council going to meet within the next week or two? Could they act upon this or could we, as a council, do it by ballot?

**THE PRESIDENT:** The Senator from Piscataquis, Senator Davis poses a question through the Chair to anyone who may wish to answer. The Chair recognizes the Senator from York, Senator Sullivan.

Senator **SULLIVAN:** Thank you, Madame President and colleagues. I'm going to vote to support the motion to accept this. My reason is very simple. A lot of people sort of laughed when I said it. Safety. They said, 'Oh no.' If you have been on the interstate or the tumpike, driving home as I do, at night during bad weather, blue and red plates are much more reflective. As a woman traveling alone, even with a cell phone, I believe that if somebody saw my plate, from either side of the aisle, they would stop because they recognize the plate and we are a family. The plates that we have now are too light. They blend in. When those 18-wheelers go by you at speeds much more than 45 miles-per-hour, as the weather that I'm talking about would ask them to, it's dangerous. I also would not pull over for anybody stopped on the side of the road unless they had a plate that was part of my family. Part of my family is either side of the aisle and either chamber. For me, it's simple. I wasn't part of this. I don't want to make it partisan. I want it for safety. I've discussed this with my husband. We have AAA on me. We have a cell phone on me. There are certain understandings. He feels a lot more comfortable with those plates that show up. Personally, I like the blue plate, however, I think we need to do what we need to do. I want, and will vote for, safety and to be able to recognize people quickly to decide whether or not I should stop or if somebody would stop for me. Thank you very much.

**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, Senator Martin.

Senator **MARTIN:** Thank you, Madame President. First, I cannot respond to the question posed by the good Senator from Piscataquis, Senator Davis, since I am obviously not a member of the council. I would just say that this matter is no longer before the council. It is before the Senate. This body has precedent over the authority of the Legislative Council under the constitution.

**THE PRESIDENT:** The Chair recognizes the Senator from Kennebec, Senator Gagnon.

Senator **GAGNON:** Thank you, Madame President and men and women of the Senate. Here we go, one of the longer debates of

the session so far. I agree with some of the concerns that the good Senator talked about in terms of safety and that is something that the committee can take a look at without changing the objective. This order actually talks about procurement of plates. As many of you don't know, the exclusive authority over these plates rests with the Secretary of State. This session has established plates based on the recommendation of the Legislative Council and those are the plates that we have today. The Secretary of State is not going to be faced with a situation where one body of the legislature is asking for another set of plates, even though we are obligated to pay for the cost of those plates. Clearly, I don't think there are people sitting in the basement over at the Secretary of State's office with nothing to do. Instead they are going to be asked to design or come up with another legislative plate for the legislature and presumably pushing off other responsibilities that they have. Once again, I think that the appropriate place for this is within the Legislative Council. I can assure the body that I have heard what people have to say about these plates and that the committee will meet about whether we bring it back before the Legislative Council, which is the appropriate place for it to be. That is where it began. Remember that while the Senate Rules apply to what goes on inside this body, we're talking about license plates that are obviously outside this body. Also remember the objective of trying to be a united legislature and trying to improve our image within the legislature. In fact, I'm not so sure we haven't already failed at that.

**THE PRESIDENT:** The Senator from Aroostook, Senator Martin, requests unanimous consent of the Senate to address the Senate a third time on this matter. Hearing no objection, the Senator may proceed.

**Senator MARTIN:** Thank you, Madame President and members of the Senate. I just need to advise you that I have discussed this with the Secretary of State. There is no cost through the Secretary of State's Office. Whatever costs there would be would be borne by those of us who choose to purchase the plate, as required by state law.

Senator **BRENNAN** of Cumberland moved to **TABLE** until Later in Today's Session, pending the motion by Senator **MARTIN** of Aroostook to **PASS**.

Senator **MARTIN** of Aroostook requested a Division.

On motion by Senator **DAVIS** of Piscataquis, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

The Doorkeepers secured the Chamber.

The Secretary opened the vote.
