**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Plowman.

Senator **PLOWMAN:** Thank you, Madame President. We were in the middle of debating this the other day so I'd like to bring people back up to speed. This is a bill that has come to us because the Department of Transportation has said that there is not enough traffic through this intersection to warrant a light. Unfortunately, the danger posed here is enough to warrant a light. The approach to this intersection is blind. You can't see who is coming. You can't see that there is even going to be an intersection for quite a bit. It is one of the main thoroughfares. It is the route that our school buses take to take children to school every day, 180 days a year. For 180 days a year those children are at risk because we have not taken into account anything more than population. There is danger. There are circumstances. I just think that this is the time where we are supposed to act because the rule disallows everything else. It's brought to us because the situation is greater than the rule. I would ask that you remember this when you are deciding because, personally, the next person that is killed there, when I read their name in the newspaper, I will remember that we had the chance to save their life and we didn't. I would urge that you reject the Ought Not to Pass motion and that we put a little safety where it belongs. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Schneider.

Senator **SCHNEIDER:** Thank you, Madame President. I rise again, also, urging you to reject the motion. This is a dangerous intersection. I actually had discussed this with the membership at the town offices, gotten reports from them about whether or not the communities believed that there was a real danger. They believe, the people who travel these intersections, that this is very much needed. I would like to remind this body that we had one of our colleagues who was nearly killed at this intersection, Representative Richard Blanchard. I would strongly recommend that we allow a traffic light to be put at this intersection. Thank you, Madame President.

**THE PRESIDENT:** The Chair recognizes the Senator from Piscataquis, Senator Davis.

Senator **DAVIS:** Thank you, Madame President. I would very briefly like to reaffirm what my colleagues from Penobscot have told the Senate this morning. I go back 35 years in law enforcement. It's no secret to anyone in law enforcement in that part of the state that this is a terrible intersection. It has claimed the lives of people before. I know that it can be said that every community in Maine has one of these intersections. I would only counter that by saying that the department has known about this

for 35 years, that I know about, and nothing has happened. I think it's time something does happen. Thank you very much.

**THE PRESIDENT:** The Chair recognizes the Senator from Kennebec, Senator Gagnon.

Senator **GAGNON:** Thank you, Madame President. I hope that folks will vote for the pending motion. This is a situation where we're faced here in the Senate with dealing with specific traffic lights at specific intersections in the State of Maine. It sounds as though there may be an issue with the policy of how DOT determines where traffic lights ought to go and what the standards are. That is inappropriate, I think, for the Legislature to decide. If we are going to start deciding which corners in the State of Maine are going to have traffic lights, which individuals in the State of Maine are going to have liquor licenses, what individuals in the State of Maine are going to have fishing licenses, and those types of issues as opposed to the broader policy issues, which is what it sounds like this is really about. I know nothing about this intersection. I know nothing about the emotions surrounding this. I am concerned about the precedent that we set here. When somebody needs a traffic light and they get denied at a local level or denied by DOT or some other organization, whether it be a traffic light or stop sign or crosswalk or whatever it might be, that they can then come to the Legislature and the Legislature will then override all of the systems that we have in place to say that this is better in this particular situation. I think we have procedures for this and a process for this. If there is something flawed with the process, which it sounds like there might be, appropriately there should be action for that. I would support any type of order that would require that the Department of Transportation look at that process. To start going through each intersection in the State of Maine, I think, we would be, what is the expression we've used before, on a slippery slope, camel's nose under the tent, or whatever it may be. I hope that you will support the pending motion. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Plowman.

Senator **PLOWMAN:** Thank you, Madame President. I would like to make a tabling motion that we table all accidents, injuries, and death that may occur at this intersection until the committee of jurisdiction has time to act on this matter. If we could do that then I would be very comfortable in waiting for an agency to step up and save lives. As you know, I can't make that motion, but that is basically what we're asking here. That's wrong. We can't control that. All we can control is safety factors. I'd be willing to work on the issue too, but tell that to the next person who gets a knock at the door from a police officer and they have to hear, 'Your son, daughter, wife, husband just died because there is not enough people in this area using that road.' I don't think we can do that. I don't want to be the face behind the next death.

**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, Senator Martin.

Senator **MARTIN:** Thank you, Madame President and members of the Senate. Let me just give you a little history of a community in my area that felt the need for some sort of a traffic light. In this instance they were referring to a blinking light. Working with them

now, they will be paying for it because the Department of Transportation felt it was not warranted. The municipality is coming up to the plate and they intend to pay for the cost. The law does not prevent the community, in this case, from paying for it if they believe so strongly that there is a need for it and they don't meet the standard presently established by the Department of Transportation. If that is the case, and I don't know it to be, either one of those communities or collectively could actually pay for it, as is what is going to happen in my district.

**THE PRESIDENT:** The pending question before the Senate is the motion by the Senator from Hancock, Senator Damon to Accept the Majority Ought Not to Pass Report. A Roll Call has been ordered. Is the Senate ready for the question?
