H.P. 1136

ORDERED, the Senate concurring, that the Commission to Study Long-term Funding for the Department of Inland Fisheries and Wildlife is established as follows.

1. Commission to Study Long-term Funding for the Department of Inland Fisheries and Wildlife established. The Commission to Study Long-term Funding for the Department of Inland Fisheries and Wildlife, referred to in this order as "the commission," is established.

2. Membership. The commission consists of the following members:

A. Two members of the Senate, appointed by the President of the Senate, each of whom serves on the Joint Standing Committee on Inland Fisheries and Wildlife, one of whom belongs to the party with the largest number of seats and one of whom belongs to the party with 2nd-largest number of seats; and

B. Two members of the House of Representatives, appointed by the Speaker of the House, each of whom serves on the Joint Standing Committee on Inland Fisheries and Wildlife, one of whom belongs to the party with the largest number of seats and one of whom belongs to the party with 2nd-largest number of seats.

The Commissioner of Inland Fisheries and Wildlife or the commissioner's designee and the Commissioner of Conservation or the commissioner's designee are invited to serve on the commission as voting members.

3. Participation of stakeholders. The commission shall invite the participation of and input from interested state agencies and stakeholders, including, but not limited to:

- A. Sportsmen in the State;
- B. Small woodlot owners;
- C. The Maine Farm Bureau;
- D. Large landowners;
- E. Environmental organizations;
- F. Registered Maine guides;
- G. The State Economist;
- H. Retailers of outdoor equipment; and

I. Outdoor recreational businesses.

4. Commission chairs. The first-named Senator is the Senate chair of the commission and the first-named member of the House is the House chair of the commission.

5. Appointments; convening of commission. All appointments must be made no later than 30 days following passage of this order. The appointing authorities shall notify the Executive Director of the Legislative Council once all appointments have been made. When the appointment of all members has been completed, the chairs of the commission shall call and convene the first meeting of the commission, which must be no later than August 1, 2005.

6. Duties. The commission shall review sources for long-term funding of the Department of Inland Fisheries and Wildlife. The commission shall also review other issues, including, but not limited to, issues associated with nonconsumptive recreational use and landowner relations.

7. Staff assistance. The Legislative Council shall provide necessary staffing services to the commission.

8. Compensation. Legislative members of the commission are entitled to receive the legislative per diem and reimbursement for travel and other necessary expenses related to their attendance at authorized meetings of the commission. Public members not otherwise compensated by their employers or other entities that they represent are entitled to receive reimbursement of necessary expenses and, upon a demonstration of financial hardship, a per diem equal to the legislative per diem for their attendance at authorized meetings of the commission.

9. Report. No later than December 7, 2006, the commission shall submit a report that includes its findings and recommendations, including suggested legislation, for presentation to the Joint Standing Committee on Agriculture, Conservation and Forestry, the Joint Standing Committee on Inland Fisheries and Wildlife and the Legislative Council. The commission is authorized to introduce legislation related to its report to the Second Regular Session of the 122nd Legislature at the time of submission of its report.

10. Extension. If the commission requires a limited extension of time to complete its study and make its report, it may apply to the Legislative Council, which may grant an extension. Upon submission of its required report, the commission terminates.

11. Budget. The commission shall seek outside funds to fully fund all costs of the commission. If sufficient outside funding has not been received by the commission by July 15, 2005 to fully fund all costs of the commission, no meetings are authorized and no expenses of any kind may be incurred or reimbursed. Contributions to support the work of the commission may not be accepted from any party having a pecuniary or other vested interest in the outcome of the matters being studied. Any person, other than a state agency, desiring to make a financial or in-kind contribution must certify to the Legislative Council that it has no pecuniary or other vested interest in the outcome of the study.

The certification must be made in the manner prescribed by the Legislative Council. All contributions are subject to approval by the Legislative Council. All funds accepted must be forwarded to the Executive Director of the Legislative Council along with an accounting record that includes the amount of the funds, the date the funds were received, from whom the funds were received and the purpose of and any limitation on the use of the funds. The Executive Director of the Legislative Council shall administer any funds received by the commission. The executive director shall notify the chairs of the commission when sufficient funding has been received. Within 10 days after its first meeting, the commission shall present a work plan and proposed budget to the Legislative Council for its approval. The commission may not incur expenses that would result in the commission's exceeding its approved budget.

Senator **DAMON:** Thank you, Madame President, men and women of the Senate. My amendment simply changes the southern boundary of Taunton Bay. Presently, the area of Taunton Bay that has been in question is defined by the bridge that crosses Taunton Bay. The more natural definition of Taunton Bay is where the reversing falls come in and out. That area is about 100 yards south of the bridge. My amendment proposes to define Taunton Bay as all of that area north and west of the reversing falls. It's a rather minor amendment but I wish to have it included in the bill. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Somerset, Senator Mills.

Senator **MILLS:** Thank you, Madame President and members of the Senate. This is a bill that has only two sentences in it. It's a proposed amendment to the Constitution. It derives from my experience in going to many town meetings over the decades that I've lived in Maine and witnessing how responsible people are at town meetings for setting up reserve funds to buy equipment, make improvements to the town office, or make road improvements. These reserve funds that are established in the town meetings are carried over from year to year. People seem to honor and respect the creation of these funds and withdraw from those reserve funds in the subsequent years. They take money out only in a fashion that's consistent with the way in which the fund was created. I remember in 1997 and 1998 we had surplus in state government. We may have surplus again, someday. When we do, it seems to be appropriate that the legislature that has the benefit of that surplus, if they have the right to spend that money, as they most surely do, then they ought to have the right to set it aside to build a reserve fund

towards a future purpose. I have in mind such things as the Fund for a Healthy Maine and the laptop fund, for example, that the former Governor King was so fond of. How about funds in these professional service accounts? The plumbers, the doctors, and osteopaths all have funds set up that we have a habit of dipping into now and then. It seems to me that if those are created in a reserve way than we should be honoring that, as this Constitutional amendment would provide, absent a 2/3 vote of both chambers of a future legislature. A 2/3 vote would allow the next legislature, or some subsequent legislature, to withdraw from those reserve funds in a fashion that might be inconsistent with the purposes established for the reserve. It's a fairly simple measure. It has no fiscal note that I know of. It would provide an interesting tool, I think, for the legislature to have at its disposal. I think we would put it to use for such things as the Fund for a Healthy Maine and other such reserves that most of us think very highly of. Another fund we might want to fund someday might be the Land for Maine's Future. Perhaps we should be able to take surplus funds and dedicate it to the Land for Maine's Future and know that this money, as set aside, would be protected against the intrusions of a future legislature except by a 2/3 vote. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Rotundo.

Senator **ROTUNDO:** Thank you, Madame President, men and women of the Senate. I urge you to support the majority Ought Not to Pass report. I would argue that this restriction of funds proposed in L.D. 843 ties the hands of the legislature too tightly. While I appreciate this tightening of spending, which is precisely why the good Senator from Somerset, Senator Mills, is proposing this legislation, I feel it goes too far in taking away the flexibility of the legislature to make certain fiscal decisions. I would further argue that maintaining the existing practice of majority rule is an important one. Maine people can and will make their evaluation of policy choices made by legislators. If the majority of the legislature votes either for or against a particular policy, Maine voters will decide whether their representatives are acting in their interests and will express their opinions in the voting booth. I would urge you, please, to support the majority Ought Not to Pass report.
