In Senate Chamber Wednesday January 4, 2006

Pursuant to the provisions of Article 5, Part 1, Section 1 of the Constitution and the laws of the State of Maine, the Senate convened in the Senate Chamber at ten o'clock in the morning and was called to order by President **BETH EDMONDS** of Cumberland County.

REVEREND CLARK: Shall we join in prayer? 31 Senators having answered the Roll, the Chair declared a quorum present.

THE PRESIDENT: As the Second Session of the 122<sup>nd</sup> Legislature begins today, I want to briefly look back at our accomplishments in 2005. Over 450 laws were enacted as a result of our work. We approved education funding, a balanced budget, and bonds to improve Maine's future plus a host of other bills to benefit Mainers from Kittery to Fort Kent.

Now we must look forward to our challenges as responsible representatives of Maine people in this Second Session. Our unfinished business from this past spring includes 161 bills carried over in committee and 72 bills on the Appropriations Table. In addition the Legislative Council approved 210 emergency bills. The latter are truly emerging issues that demand our immediate attention. We also know of 64 agency bills. We have a total of 507 to consider between now and early April. This workload is slightly higher than in recent Second Sessions. The 120<sup>th</sup> Legislature had 362 bills before it at the start of the Second Session. The 121<sup>st</sup> had a total of 363. If we are to complete our work in a timely fashion we must begin making hard decisions from the start. I am confident we can and will do so.

It's another cold winter in Maine and our first order of business is to take good care of our own. Today we will take up the Governor's proposal to appropriate \$5 million to supplement the low income heating assistance program, LIHEAP. There has been no increase in Federal support in LIHEAP so we must make emergency action in the Legislature to support this need.

Next, we must move quickly in a bi-partisan fashion, addressing the needs of all Maine people. As we start this session, the state Revenue Forecasting Committee estimates a budget surplus of \$164 million. We must make hard choices and be fiscally responsible with these funds, staying within the spending caps we enacted in the last year.

First, we must set aside funds for a rainy day in the state Budget Stabilization Fund. Some of the surplus should be invested in economic development. We have an opportunity to assist in the creation of more well-paying jobs. This presents an excellent opening to enhance research and development and education, promising a bright future for Maine people.

Finally, we can pay some of our bills with this surplus. The state government has obligations from education to hospitals that need to be met. Once we take a hard look at the demands before us, this surplus will rapidly be spoken for. There is no spending spree on the horizon. I am sure you will agree we must continue to be frugal caretakers of taxpayer dollars.

There is much more to be done, so I'll spare the details so we can get to work. The session before us is about to move forward effectively and efficiently. I truly look forward to working productively with all members of this Senate. I very much appreciate your commitment to the people of Maine by all your hard work and I'm just glad to see you all. It's good to be back with you and I look forward to our working together.

In accordance with Title 5, M.R.S.A., §13070-J, we are pleased to submit the "agency report" for the Governor's Training Initiative (GTI). GTI has been instrumental in the creation and retention of high skill, quality employment for Maine residents since its inception in 1996.

In calendar year 2004, thirty nine companies received GTI reimbursement payments totaling \$10,000 or more. The attached report lists the amounts paid and the anticipated job growth and retention associated with those funds. Because the GTI funding cycle is spread over a two-year period, funds related to the Economic Development Incentive Report (EDIR) reporting requirements for calendar year 2004 may be associated with GTI contract allocations spanning three funding cycles (program years 2002, 2003 and 2004).

Statistics included in this report indicate the public benefit derived from GTI assistance, including actual private dollars leveraged via company match for direct training related activity. A short selection of company comments has been provided representative of responses received regarding company and public benefit.

GTI ensures that the needs of small firms are addressed via the scoring process, and requires applicants to identify the public benefit resulting from proposed training projects. GTI continues to be a primary vehicle for achieving sustainable long-term economic growth for Maine. Pursuant to 5 MRSA Section 13070-J, the State Tax Assessor is required to submit a report to the legislature identifying the amount of revenues foregone as the result of the Jobs and Investment Tax Credit (JITC), the Research Expense Tax Credit (R&D), the Seed Capital Investment Tax Credit, the shipbuilding Facility Credit, and public funds spent on the Business Property Tax Reimbursement Program (BETR). Attached are four reports providing you with this information.

The first table lists corporations that reduced their Maine income tax liability with the JITC, the R&D credit, and/or the Seed Capital credit in tax year 2003, as well as the value of the credits. Table Il lists the number of individual filers that reduced their Maine income tax liability with the JITC, the R&D credit, and/or the Seed Capital credit in tax year 2003. Tax year 2003 is the last year for which we have full information on both corporate and individual filers. Statutes governing the release of confidential taxpayer information prevent us from reporting the names of the corporations or individuals that benefited from these tax credits.

The third attachment explains the Shipbuilding Facility credit. As required by statute the report provides information on the level of employment, yearly investment and the cumulative amount of investment. Since the inception of the credit, the level of employment has been such that the annual cost to the state treasury has exceeded the base credit amount of \$3 million per vear.

The fourth attachment is a computer printout of BETR recipients. For purposes of this report, businesses that filed for reimbursement during calendar year 2004 are listed. BETR

recipients filed between August 1, 2004 and December 31, 2004 for eligible property taxes paid during calendar year 2003. For that period the state reimbursed \$74.1 million to 1,764 companies.

Of the 1,764 businesses that received a BETR reimbursement, 444 received a reimbursement of \$10,000 or more, requiring them to file an Economic Development Incentive Report with DECD. Firms receiving a BETR reimbursement greater than or equal to \$10,000 represent 25% of recipients and 96% of the total BETR expenditure in calendar year 2003.

On motion by Senator COURTNEY of York, Senate Amendment

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Courtney.

Senator COURTNEY: Thank you, Madame President, men and women of the Senate. This amendment is fairly simple and straightforward. What has happened, and many people I have talked to in the halls don't realize it, is there is a sales tax imposed for business heating fuel. The sales tax is based on the total purchase price. What has happened is that the \$1.25 a gallon oil price for heating a small business has gone up and now the tax is based on the \$2.50 price. Essentially, the tax for heating businesses has doubled. All this amendment would do is roll it back. The state has gained a lot of money out of this. I think if you look at the fiscal note, it's been a pretty good little windfall for the state. I think that with the commitment going forward in the original LIHEAP bill, here is an opportunity where we can start out this session and return that excessive money taken from businesses and perhaps help them make it through the winter as well. It will also help create jobs.

On further motion by same Senator, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

Senator BARTLETT of Cumberland moved to INDEFINITELY POSTPONE Senate Amendment "A" (S-430).

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Bartlett.

Senator BARTLETT: Thank you, Madame President. While this amendment has a lot logictives, and I certainly think we all need to think about the impact of energy prices on our small businesses, but I believe this is not the proper method of doing it. We came here today, as I understood it, because an agreement had been reached and that we would vote, up or down, on a particular proposal so we could put \$5 million into the LIHEAP funds in order to keep people warm this winter. A special session wasn't called prior to now because the agreement had been reached that this would be the first item that we would take up. This bill hasn't gone through the committee process because of its very limited scope. It was limited purely to adding some emergency funds to try to get us through the winter. Unfortunately this amendment adds new ideas, new concepts that should properly be vetted before the relative committee of jurisdiction before it be taken up. Personally, I've only seen this amendment this afternoon. I have not had an opportunity to fully vet it to determine whether it fits in with a larger strategy that we're developing to deal with energy prices, not only in the immediate future but also over the next decade. For those reasons. I urge you to support the motion for indefinite postponement. It's not that I think these ideas are bad or not worthy of consideration; it would appear that this is not the proper venue for them to be addressed.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Courtney.

Senator COURTNEY: Thank you, Madame President, men and women of the Senate. I appreciate the comments. I agree there might be a better way to do it. We tried to do that through the Legislative Counsel and submit this last month as a bill. It would have been better to do that. However, the need is there. The need for small businesse, the need for jobs. We go around and we tell people and businesses, we have the big rallies and we stand up behind the podium and tell people what we're going to do for businesses. We have an opportunity to do it, at no additional cost to the state because it won't cost the state any more than it did two years ago before the fuel prices went up. That's why I feel we should keep this issue alive. We need to keep talking about it. I would urge you all to look deep and go for it. This is an excellent way to stand up and show that you support small businesses in Maine. Thank you, Madame President.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Bartlett.

Senator **BARTLETT**: Thank you, Madame President. My fundamental goal in coming here today is to make sure that we get \$5 million into the LiHEAP funds so that nobody freezes this winter. I think it is a shame to endanger those funds and the people who rely on them, the most vulnerable people in our society, including a number of seniors who simply do not have the resources to full up their tanks with oil. Although, again, I think the goal of helping small businesses is a laudable one, and I hope that we can address it later on in the session, I simply do not think it's appropriate to endanger these funds at the time when they are needed most.

**THE PRESIDENT:** The Senator from York, Senator Courtney, requests unanimous consent of the Senate to address the Senate a third time on this matter. Hearing no objection, the Senator may proceed.

Senator COURTNEY: Thank you, Madame President. Nobody wants to slow this thing up. Nobody wants to not get the funds for the LIHEAP program. I think we all agree to that. I think that this is just an opportunity where we can stand up and be counted and maybe not just provide funds for LIHEAP but to provide funds so maybe somebody can keep their job so they won't need LIHEAP. I will continue to fight for this and I hope that we'll be able to make the argument. Maybe I don't make a good enough argument on this issue. I think it's very very clear, the state is collecting double on heating oil for small businesses than what it collected two years ago. If we don't pass this, this Legislature is saying we can pass along raising that tax. If that's the case, that's fine. I can't sit here without speaking out. Thank you, Madame President.

**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, Senator Martin.

Senator MARTIN: Thank you, Madame President and members of the Senate. I am usually the last one to be talking about the fact that leadership didn't let a bill of mine in, but I would just remind the good Senator and all of the members of this body that there is a way around leadership, provided for in the rules, that allows the good Senator and any Senator to put in an order to call a bill from the committee. We should not be spending time on an amendment that is proper for a bill, as is this item before us. We were going to come in for a special session. It was postponed in the hopes that the very first action we would take would be this item. It ought to be clean and clear. If the good Senator and others want to deal with the other issue, there are ways to do it.

On motion by Senator **DAVIS** of Piscataquis, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.
