In Senate Chamber Wednesday January 25, 2006

Senate called to order by President Beth Edmonds of Cumberland County.

Prayer by Reverend Peter Panagore of First Radio Parish Church of America.

REVEREND PANAGORE: Good morning and let's pray. Here we are in a chamber, dressed and ready to rule. On motion by Senator **WESTON** of Waldo, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Strimling.

Senator **STRIMLING**: Thank you, Madame President. Just quickly, all this bill does is to have the state take a look at whether or not we should be funding firefighters' retirement benefits. These are folks who are on the frontline. These are the folks who are the first responders. All it is doing is taking a look at the issue to find out whether we can afford it or not afford it. I'd strongly encourage my colleagues to support it.

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Clukey.

Senator **CLUKEY**: Thank you, Madame President, ladies and gentlemen of the Senate. First of all I'd like to say that I have much admiration for firefighters. They put their lives on the line every day saving property and lives. My opposition to this is not derived from the fact that I don't think the study should be done or that I don't think that they should have this insurance. It's simply the fact of who should pay for it.

When we first took this up in committee, we ended up carrying it over to ask the people that were in favor of this to go out and see if they could find some way to do it on their own. They did and came back to us this session. I got the feeling, listening to their testimony when they came back, that all they really did was just let the time pass and came back to ask for us to do it again. My opposition arises from the fact that I don't think the state should have to pay for this study. I think the municipalities that collectively feel this should be done should come up with the money to do it. Also the fact that I didn't feel that they made an honest effort to do this themselves, they just passed the time away and came back and asked us to do it again. That's where my opposition arises.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Diamond.

Senator DIAMOND: Thank you, Madame President, men and women of the Senate. The good Senator from Aroostook, Senator Clukey, makes a good point regarding this. However his point in that most firefighters want this, we certainly thank them for all the work they do. Maybe we don't want to fund it, but maybe we do. Maybe we want to fund it at a little less money. My sense is, because of the seriousness of the volunteer system in this state and for all the work that these people do, all of your firefighters and mine, that I think they deserve at least a chance on the table and have the Appropriations Committee take a look at this, ask further questions, and then see if they do want to fund it. It certainly came out of our committee with a majority Ought to Pass report. I might add that there was no opposition at the public hearing. I think it deserves enough effort on our part to say that maybe it should be funded, maybe we should at least look at it and recognize the need and the work that all of our firefighters do back in our districts. Thank you, Madame President.

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Nass.

Senator NASS: Thank you, Madame President, men and women of the Senate. As one of the Senate's representatives on the Fire Protection Services Commission, thanks to Madame President, I've been in favor of this. I have been at meetings now for two years, listening to the discussions about this. In my opinion, this is exactly what the state should do. There has been no decision about whether the state or the localities should fund health insurance benefits for firefighters, both permanent and volunteers. That decision hasn't been made. Gathering the information necessary to make that decision is a function I believe best accomplished by the state. That doesn't mean I like study committees. This is not a study committee in the normal sense that we are used to. This is not a summer job for legislators. This is about hiring the technical help necessary to figure out what the details of this insurance product might be or what the tax ramifications of this effort might be. Even though it is potentially \$75,000, this is exactly what we should be doing.

This is all about retention and recruitment for, at least in my district, volunteer firefighters. This is an item that will go to the table. Is it still going to be difficult to get it off the table to fund this in the environment that we are in? This is not an accomplished fact if you vote for this. I urge that you support this. If you are not aware that your local fire departments are having problems with recruitment and retention, please talk to your fire chiefs. In my town I've been a volunteer for over 30 years. We have a pretty good department now, mostly young people, but it's not forever. We don't even know if it's for six months from now. People move around. The young people, especially, move around quite a bit. This is about recruiting and retention and about a function the state, I believe, should perform to help the process, to look forward to deal with what is a very valuable commodity, Madame President. That's volunteer help, especially in the fire service. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Sullivan.

Senator **SULLIVAN**: Thank you, Madame President, men and women of the Senate. I am somewhat confused, which will not surprise any of you. First of all, I have some questions if I may pose them. They are sort of rhetorical, unless somebody wants to answer them.

THE PRESIDENT: The question before us is acceptance of the Majority report.

Senator **SULLIVAN**: My question is, I heard it said that it dealt with part-time or volunteer firefighters. At one point that had been talk last session on it being full-time firefighters, career firefighters, and volunteers. That would be my question.

How much money are we speaking for the study that we are talking about? Could that study be expanded to health insurance for teachers, under that same report since we're been working piecemeal trying to bring parody up for teachers, which there is also a problem with recruitment? Thank you.

THE PRESIDENT: The Senator from York, Senator Sullivan, poses several questions through the Chair to anyone who may wish to answer. The Chair recognizes the Senator from York, Senator Nass.

Senator NASS: Thank you, Madame President. The breadth of those questions, Madame President, takes my breath away. \$75,000 is the proposed amount. Don't confuse this proposal with another bill which has gotten some press in the *Maine Sunday Telegram*, for instance, this Sunday about health insurance for permanent firefighters and policemen. I think that is L.D. 1020 or L.D. 1021. That is a separate issue. Even beyond that, hopefully, a separate issue in everybody's mind here, is health insurance for teachers. I suppose we could really look forward and see these things coming together someplace. I would hope that you won't go there, for this small step forward.

THE PRESIDENT: The pending question before the Senate is the motion by the Senator from Cumberland, Senator Brennan to Accept the Majority Ought to Pass as Amended Report. A Roll Call has been ordered. Is the Senate ready for the question?

The Doorkeepers secured the Chamber.
