Senator **ROTUNDO:** Thank you, Madame President, men and women of the Senate. Sergeant First Class Shawn Dostie died on December 30<sup>th</sup> in Iraq. He was 32 years old. He was born in Rumford and graduated from Lewiston High School in the class of 1991 and received his Associate Degree from Troy University. He served in the U.S. Army at Garistadt, Germany; Vicenza, Italy; Fort Benning, Georgia; and served three assignments at Fort Campbell, Kentucky. Sergeant First Class Dostie's awards include the Bronze Star Medal, the Purple Heart Medal, the Army Commendation Medal with two Oak Leaf Clusters, the Army Achievement Medal with one Oak Leaf Cluster, Humanitarian Service Medal, National Defense Service Medal, Army Good Conduct Medal, Multinational Forces Observer Medal, and Global War on Terror Service Medal. In addition, Sergeant Dostie earned the Combat Infantry Man's Badge, Expert Infantry Man's Badge, Drill Sergeant's Badge, Parachutist Badge, U.S. Belguim and British Air Assault Badge, and the Pathfinder Badge.

Sergeant First Class Dostie loved his family, his friends, and his country. He enjoyed spending time with his beloved family; particularly his children, Bayleigh and Cameron. He will be remembered for his energy, his love of family, and his willingness to risk his own life to make ours safe.

The people of Maine, I know, share the pain and grief of his family and it is my hope that when we adjourn today we will do so in honor and lasting tribute of Sergeant First Class Shawn Dostie.

Because of the circumstances and the money that we needed to borrow in order to build a house, we went to Mr. Mitchell, and on a handshake, he built this house for us. It was exactly the house we wanted. He hired the contractors who he worked with and then he built the house for us. It was exactly what we wanted; carpeted, paint, everything. When we went to the closing, the closing was actually in an attorney's office near his office, and we were able to get the check from the bank because it was an investment of, obviously, a house that was already built. I was able to get my insurance from him. He provided the proof of insurance and it was all done. I've never been at such a fast closing. It took about three minutes. Now I know why attorneys get so much money because of what they do.

Mr. Mitchell has just been a real pleasure for all of us in Waterville. On a personal basis, he's just been a tremendous help to my family. All because he just really wanted young people, and good young people, to stay in Waterville and to help the City of Waterville as he has done so much. This is a surprise for him today. We have him behind us and I hope that you will all join me in welcoming him to the Senate chamber today. Thank you, Madame President.
