### JOINT RESOLUTION RECOGNIZING SUNSHINE WEEK, MARCH 12 - 18

WHEREAS, the basic principles of freedom of speech and freedom of the press guaranteed in the United States Constitution are fundamental to our national heritage; and

WHEREAS, the American Society of Newspaper Editors has initiated Sunshine Week: Your Right to Know as a way of illustrating the importance of open government; and

WHEREAS, Sunshine Week 2006 participation by nonjournalism groups is growing, with national and local forums already planned by civic groups, libraries and open government and freedom of information groups, as well as by student media; and

WHEREAS, Sunshine Week was established to spark a discussion about the importance of open government and public access to government documents and meetings; and

WHEREAS, these issues are important in the State of Maine, where public access issues emerge all the time; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-second Legislature now assembled in Second Regular Session, on behalf of the people we represent, take this opportunity to recognize Sunshine Week: Your Right to Know during the week of March 12-18, 2006 and that we confirm the basic principles of an open and accessible government in a free society, and we urge all citizens to join in this observance.

**THE PRESIDENT PRO TEM:** The Chair recognizes the Senator from York, Senator Hobbins.

Senator **HOBBS**: Thank you, Mr. President, men and women of the Senate. Last year about this very time I was pleased to stand before you to present a Joint Resolution honoring the first National Sunshine Week. This year I am pleased to once again present to you a Joint Resolution honoring Sunshine Week. The public must have unfettered access to government and the activities of those in charge. Valuing the importance of access to public records and proceedings to a strong democracy, the Maine Legislature was the first in the nation to enact a freedom of access law more than four decades ago. As other countries around the world continue to model a democratic form of government after our government we must continue to serve as a role model to show the world that government and the democratic process can be open and accessible to both the public and the press. It gives me great pleasure to present this Joint Resolution recognizing Sunshine Week. Thank you.

**THE PRESIDENT PRO TEM:** The Chair recognizes the Senator from Androscoggin, Senator Rotundo.

Senator **ROTUNDO**: Thank you, Mr. President, men and women of the Senate. As the Senate Chair of the Freedom of Access Advisory Committee I, too, want to recognize that this is Sunshine Week and call attention to the fact that Maine was one of the first states in the country to pass a public access law, which is designed to guarantee open meetings and access to public records. At a time when other states have been retreating from their commitment to more open government, Maine passed a far-reaching law in recent years that will significantly strengthen our FOA law. Transparency in government is critical to a strong democracy. This resolution gives us the opportunity to reflect on that fact as well as our role as legislators in making the government's work open and accessible to the people that we serve. Thank you.

**THE PRESIDENT PRO TEM:** The Chair recognizes the Senator from Cumberland, Senator Strimling.

Senator **STRIMLING:** Thank you, Mr. President. I quote, 'During the Holocaust Allied leaders turned down repeated pleas to bomb the Nazi extermination camps. The same paralysis occurred as Rwandans were being slaughtered in 1994 and much the same has been true of the western response to the Armenian genocide of 1915, the Cambodian genocide of the 1970's, and the Bosnian

massacre of the 1990's. In each case we have wrung our hands afterwards and offered the lame excuse that it all happened too fast or that we didn't fully comprehend the carnage when it was still underway. Now the same tragedy is unfolding in Darfur.' That was written by Nicholas Kristof in the January 21<sup>st</sup> edition of the New York Times Review of Books.

Distinguished members of the Senate, I stand before you today and ask for your support of L.D. 1758, An Act to Require the Maine State Retirement System to Divest Itself of Certain Holdings. In a nutshell, L.D. 1758 requires the Maine State Retirement System to divest all its holdings, approximately \$50 million, of its \$9 billion portfolio from companies doing business in Sudan. Some may ask, 'Why are asking us, the State of Maine, to deal with an issue that effects people over 10,000 miles away when we have so many problems here at home?' Well, beyond the fact that genocide must be confronted from every corner possible, I introduced this bill because it is our Maine residents who are losing their loved ones every day. This is not some far away war that doesn't touch our state. In fact, in Portland we have the largest percentage of Darfures for the size of our population in the country. In the Labor Committee we heard from many of them in our hearing on this legislation last month and some of them are here today in the chamber.

Here is another quote from the same article mentioned above. 'On one of the first visits to Darfur I came across an oasis along the Chad border where several tens of thousands of people were sheltering under trees after being driven from their home villages. Under the first tree I found a man who had been shot in the neck and the jaw. His brother, shot only in the foot, had carried him for 49 days to get to this oasis. Under the next tree was a widow whose parents had been killed and stuffed in the village well to poison the local water supply and then the Janjaweed militia, which is the government backed militia, had tracked down the rest of her family and killed her husband. Under the third tree was a four-year-old orphan girl carrying her one-year-old baby sister on her back; their parents had been killed. Under the fourth tree was a woman whose husband and children had been killed in front of her, and then she was gang-raped and left naked and mutilated in the desert.' Here is a quote from a young man who hid under a dead mule and was the only survivor in his family. 'The attackers took a knife and cut my mother's throat and threw her into the well. Then they took my older sister and began to rape her one by one. My father was kneeling, crying and begging them for mercy. After that they killed my brother and finally my father. They then threw all the bodies in the well.'

While the United States has been pushing for a strong UN response to Darfur, the Security Council has only passed weak resolutions with no real threat of sanctions or military response although they did declare Darfur the worst humanitarian crisis in the world today. The US Congress also passed a unanimous resolution labeling the situation in Darfur genocide. Both President Bush and Secretary of State Colin Powell have also declared it genocide. If there is a threshold for divestment genocide certainly crosses that line. You ask, 'What will divestment do?' Divestment will affect the revenue that the government receives. The government has used the funds it receives to purchase Russian migs which have been used in the attacks in Darfur and to arm the Janjaweed. The Darfures receive no benefits from the central government, but more significantly their destruction is partially enabled by the wealth of the government. I ask my colleagues to please join the Majority

Ought to Pass report and join the states of Illinois, New Jersey, Oregon, Louisiana, and Arizona by supporting this vital piece of legislation. Twelve additional states have or will be introducing similar legislation this year. As Maine did in the 1980's, when we passed legislation to divest from South Africa and Ireland, our attention must turn to the region that now needs our assistance, but most importantly Maine people need our help so their families can be protected. Thank you, Mr. President.
