**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Diamond.

Senator **DIAMOND:** Thank you, Madame President, men and women of the Senate. This bill is passing through and about to be engrossed. It's something I think this Body needs to know about, what's going on with this bill, and I asked to have it set aside so I could just spend a minute or two sharing that with you. The Criminal Justice and Public Safety Committee, in our review

of the Department of Public Safety, learned or discovered, whatever you may want to call it, information about the Computer Crime Taskforce that was created in 1999. In the Computer Crime Taskforce, the purpose was to deal with computer crime. Only after the short time this taskforce soon became overwhelmed with child pornography and child pornographers. It became so overwhelmed that it became a major problem for the two staff persons that operate that taskforce and download the computers. What happens is this; when a computer hard drive is confiscated by the police, local police agency or the Sheriff's Office or the State Police, it is taken to the taskforce. Theoretically, the taskforce members will download them, get the evidence, take it to the prosecutors, and prosecute to get these people off the streets, get them arrested and put in jail. That is how it is supposed to work, but because child pornography has become the fastest growing business on the internet that's not happening. In January of this year they had 80 hard drives sitting in the closet at the taskforce's headquarters in Vassalboro that they couldn't get to. Every one of those hard drives contained evidence that would, hopefully, get the child pornographer convicted and put in jail. Now, as of two weeks ago, the number of hard drives has reached 120. As you can see, it is just getting more and more. The most frustrating part is that without staff people we cannot get to computers and they cannot download them, and therefore, the evidence sits there. The evidence literally sets 20 feet from an empty desk. It's something that you need to know about, we all need to know about it, and we need to address this. This bill will address that by adding two staff members to help the taskforce do its work.

Some would say that these are just child pornographers on the internet and what is the harm? The U.S. Postal Service, through a study that they have done, has told us that 80% of the people who view child pornography actually become sexual molesters. That's a high number, a high percentage. There is an organization in Wyoming called the 'Internet Crimes Against Children'. They deal with every state and provide information to law enforcement agencies in every state. What you had passed to you this morning was a list of 150 towns that shows how Maine did in 2005. You might want to check your town, it may be on the list. This is tracking they have done out of Wyoming to show what each state has had for activity, peer to peer. That's not someone who sets at a computer and once in a while an image will come up or they might seek an image. These are people who see hundreds and thousands of images. They go to kiddie pics or several hundred of other terms you can type in. The taskforce has the IP number of all these computers when this happens. What you have is a list of what has happened in the state of Maine in 2005. You can see on that list whether it is a large town or a small town, rich or poor, and what is happening in the peer-to-peer problem with child pornography. Portland, for example, as you probably noticed, is the highest because they have the highest population. You can then go to Monmouth where there were 64 peer-to-peers. Windham had 50. It's something that we need to address, something we cannot let go any longer. The other thing is that these are not child pornographers that dwell on teenagers. What they have at the taskforce in Vassalboro are all children who are, for the most part, 7 years old or younger, down to just a few months old. There is no confusion as to whether these are actually 17 or 18 year olds. These are all kids who are very very young. I bring this to your attention, knowing full well it has a fiscal note on it; knowing that the Governor supports it; Commissioner Cantara supports it; the Chief of the State Police

supports it; and I think everybody else that we've talked to certainly supports it. I bring it to your attention so you will know what's happening, that you will know the condition, and know that, according to the experts, that if we had two people over there, they would be able to make headway on those stored, at this point unusable, evidence to take these people off the streets. The longer they set there, the longer these people run free. I would just thank you for your time. I wanted to bring this to your attention. Thank you, Madame President, for allowing me to share this information.

**THE PRESIDENT:** The Chair recognizes the Senator from Lincoln, Senator Dow.

Senator **DOW:** Thank you, Madame President, ladies and gentlemen of the Chamber. I heartily support the same bill. With what little experience I have with this, I realize this is a major problem and needs to be eradicated from society. I will support this bill. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Nutting.

Senator **NUTTING:** Thank you, Madame President, ladies and gentlemen of the Senate. I beg your indulgence. In my years of serving as a legislator, I have sat through so many department reviews where we have to review the department. Ladies and gentlemen of the Senate, this issue would not have come forward today and be properly addressed if it hadn't been for the committees' diligently reviewing the department. I couldn't resist pointing that out. At least sometimes there is some very good that comes out of that. Thank you.
