Senator **BARTLETT:** Thank you, Madame President. When this bill came before the Utilities and Energy Committee we learned of some very unfortunate transactions taking place on the internet. Unfortunately, cell phone records were being widely distributed over the internet. Anyone could log on and simply acquire records of anyone else. This never occurred to us to be a problem because we already have legal protections for our land-lines. Those records can't be sold. It's one of those cases where technology got a couple of steps ahead of us and we were very happy to move this legislation along. While we did that, though, we learned of some additional concerns, which is why the other Body has placed an amendment on this bill. Of particular concern is that it is now possible, with a lot of these modern cell phones, for someone to hack into your cell phone and place some software in there that would then allow them to track your cell phone information. It's not just about records any more, it's about, like with a computer, the ability of people to hack in and steal your information. The amendment simply adds that provision to the bill and by passing this all of our constituents will be much safer as we go forward. Thank you, Madame President.

She was a tireless worker to bring a nursing program to York Community College. I am so pleased that she did have occasion to know before she passed on that this program had been approved. She was a tireless advocate for both nursing and the citizens of York and she'll be sorely missed. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Sullivan.

Senator **SULLIVAN:** Thank you, Madame President, men and women of the Senate. While I am not a nurse, it was, for me, Pat Ryan's warmth. When you think of college president, community college president, you think of some office where there is no interaction. The president just signs bills and has a wonderful job, much like our president here. She had real warmth. Whenever there was a reception or anything she would call us by name. She just made education something to aspire to for young people. The York County Community College has had a strange development. It is mortgaged, unlike any other of our community colleges. She was an outstanding person and the warmth that she brought to education, to aspire that indeed no child would be left behind, and no adult would be left behind. She did everything in her power to be sure that everybody got a chance to further themselves as a life-long learner. She will be sorely missed. Thank you.

Senator **NASS:** Thank you, Madame President, men and women of the Senate. Thank goodness we don't have to do this very often. Eulogies are difficult, especially if you haven't done many of them. We were frequently invited and I think that was part of Pat Ryan's doing. She stayed in touch. She was very accessible. She would listen to what was going on up here, both rumors and truth, and would allow us a lot of latitude. She was the perfect president. I can't tell you the number of times and the number of issues we took to her. She was gracious. She was engaged. I think more importantly, you never had the sense that she was pushing at all for anything. Even though she had a lot of issues, I always left with the sense that she was calm about it and that things would happen in their own good time, but she would be constantly reminding you of the need to get something done. We will miss her. It will be difficult to replace her. I think I'll stop there. Thank you, Madame President.

**THE PRESIDENT:** The Chair recognizes the Senator from Somerset, Senator Mills.

Senator **MILLS:** Thank you, Madame President and men and women of the Senate. I'm on the majority Ought to Pass report but I have gotten further information since voting in committee and have had a better chance to examine the consequences of this bill. I am advising the Chamber, if I may, that I would suggest

that we follow the good work of the other Body and vote against the pending motion.

The bill before us would create four new positions within the Department of Insurance and a new position within the Office of the Attorney General, which is already the State's largest law firm, by quite a bit. These would all be for purposes of examining, investigating, and prosecuting a very thin sliver of our criminal laws; the criminal laws that have to do with insurance fraud. At present, these investigations and these prosecutions are done by our District Attorneys in much the same fashion that embezzlement, theft, and other crimes are investigated routinely and prosecuted and brought to justice. I don't understand why we, at this point, need to create five new positions to prosecute a special and narrow area of crime at a cost of \$450,000 a year. The Bureau says that they can either absorb this cost or they will go ahead and blithely charge, as they are entitled to do, the insurance industry, which will be passed through to customers, for these new positions. My own view is that we ought to let the criminal justice system, as it is presently structured, take care of these crimes in the usual way and not create a special prosecutorial system for a select class of citizens. In this case that select class of citizens is a bunch of insurance companies who would like to have their own criminal justice system. I just think that they ought to line up with the rest of the victims in our society and get their justice at the County Commissioner's Offices and at the DA's Offices, where citizens are accustomed to getting it as well. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Sullivan.

Senator **SULLIVAN:** Thank you, Madame President, men and women of the Senate. Indeed, at one point, this was a 12 - 1 report and I'm hearing it is now an 11 - 2 report. I would like to correct a couple of statements and explain a little of the history on this.

First of all, it is two positions that the Bureau would add. It is a request from Will Lund's department, which is consumer protection. This bill is about consumer protection and I would suggest to each of you that when you go home for your weekend, hopefully soon, check on your PNC and your property premiums and take a look at your car insurance. You will see that a certain amount of that premium goes to fighting fraud. Maine has now been hit. We have sat for so long and said we were well protected because we live in such a nice little community. Well, we're really close to a lot of places. The drugs and all have come up. We have rings of people who actually will step in front of a car, say they are hit, collect the insurance, and move on to another one and collect the insurance. It's a ring. These are scam rings.

This was a carry-over bill while the Department of Consumer Regulations took a look at it and came up with it. The reason why the Bureau says they can absorb it, and indeed they never mentioned raising more premium rates, because this bureau is self-funded. It does not go to the General Fund at all. The insurance agents asked for this. They fund this. They are not the greedy insurance companies today. Tomorrow I might say something different. On this bill they are here asking and willing to pay for this with the very money they are paying out. They are paying those fees.

It's two positions. It is a growing problem. I know if I go to my District Attorney, Mark Lawrence, he will tell us that there is a

huge back-log and many cases are either plea bargained or whatever. Insurance companies are asking for help and that help effects your premiums and it effects the premiums of your constituents. That is what this bill is about. That is why this bill originally was a 12 - 1. Only one Representative was in the opposition. This is about protecting your constituents by a group of people who pay to self-fund their own regulations. That is what this bill is about. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Kennebec, Senator Cowger.

Senator **COWGER:** Thank you, Madame President and colleagues in the Senate. During my time on the Appropriations Committee during the last session I was observing that the other special revenue funds of the Bureau of Insurance typically had substantial balances in them. I was wondering if anybody could tell me, if I may ask the question, what the balances are in those funds currently?

**THE PRESIDENT:** The Senator from Kennebec, Senator Cowger poses a question through the Chair to anyone who may wish to answer. The Chair recognizes the Senator from Sagadahoc, Senator Mayo.

Senator **MAYO:** Thank you, Madame President, ladies and gentlemen of the Senate. Very briefly, since I have been in the legislature I have been involved with one of these issues and as a result I presented a bill before the legislature dealing pretty much with what we have in front of us. At that point, the insurance industry was not particularly sympathetic to it and the bill did not go very far. I was traveling back to my hometown on a four-lane highway and the car in front of me stopped, with no taillights, and I rear-ended that particular car. Interestingly enough, the sheriff of the county happened to be behind me because we had both been at the same meeting up the road. It ended up costing my insurance company a little in excess of \$80,000 by the time that case was settled. Subsequently, we found that this was the seventh time that this particular individual had been rear-ended in less than ten years. Unfortunately, the county attorney had so many other matters ahead of him that he chose not to move forward with it. As far as I know this same situation may be going on with the same individual.

I think this is a good piece of legislation. I was happy to sign on the majority report and I hope it goes forward today as consumer protection. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Somerset, Senator Mills.

Senator **MILLS:** Thank you, Madame President and men and women of the Senate. There are good arguments on both sides of this bill and I don't want to suggest that there isn't an alternative position. After all, I adopted it about two weeks ago. I do want to correct the record. The bill does authorize and call for a Public Service Manager II position, an Auditor III position, one Field Investigator position, and one Clerk Typist III in addition to a full-time Assistant Attorney General; five positions to be added to service this very particular kind of crime. I don't understand why it's being called a consumer protection bill. It is a bill that is designed to prosecute wayward consumers or fraudulent consumers. I'm all in favor of getting that done, but to suggest

that the DAs don't have the resources to prosecute these crimes is absurd. If they are having problems then they must be having such problems across the board with property crimes, crimes of violence, crime of embezzlement, and all sorts of things. Why aren't all of the victims of crime here today asking for better funding and more positions in the DA's offices? Why is it that we have an industry that comes in and says, 'We want to get out of your system. We don't want to be in the same system as all of the other scruffy victims. We've got our own victim's court, our own victim's prosecution system. We want insurance companies treated specially when there is fraud against them, but if you've got a homeowner break-in or an embezzlement of a small business, well they can go wait in line along with the rest of the public and take justice as it comes up.' There is something that bothers me about the special privilege that seems to be created for a special class of corporate citizens in this bill. That is what's bothered me about it and why I've changed my mind about it. For that reason I will vote against the pending motion. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Sullivan.

Senator **SULLIVAN:** Thank you, Madame President, men and women of the Senate. I just wanted to say a couple of quick things. I would, again, remind you that there are consumers who pay the premiums, day in and day out, while there are people going around taking advantage of that and suing insurance companies, going to court, and letting the lawyers make lots of money. They must be calling Joe Bornstein. The insurance agents want to be able to find the people that are stealing from them. Quite frankly, just like with shoplifting in retail business or any things else, the good people, the honest people, pay for it. That's what we are doing. It's a consumer bill because it came from the Department of Consumer Protection. It's not a criminal protection bill, unless it fails. It's a consumer protection bill. You and I, because we drove here today, are paying part of that to let people who are on the road have insurance frauds because our District Attorneys are overworked. You've listened to the Chief Justice tell you that. You've heard about the backlogs. Quite frankly, they are prioritized just like you probably do your budget. The worse crimes are prosecuted first and they go down the system. There is nothing new about this. This is smoke and mirrors. I'm asking you to support what has come forth as a consumer protection bill. Just like we would prosecute shoplifters for retail stores, this is people taking advantage of the insurance companies that you and I support with our premiums and we pay dearly. Look at your premiums. Take a look. Read the back side and you'll find out that it talks about the money they pay towards fraud.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Plowman.

Senator **PLOWMAN:** Thank you, Madame President. May I pose a question through the Chair?

**THE PRESIDENT:** The Senator may pose her question.

Senator **PLOWMAN:** Thank you, Madame President. For anyone who could answer, does this cover only liability, property insurance, and automobile or will this include Workers' Comp and medical insurance as well?

**THE PRESIDENT:** The Senator from Penobscot, Senator Plowman poses a question through the Chair to anyone who may wish to answer. The Chair recognizes the Senator from York, Senator Sullivan.

Senator **SULLIVAN:** Thank you, Madame President. I want to take a stab at this one. I believe Workers' Comp goes through their own system. I may be wrong on that. Also it would cover property. It would cover anywhere there is fraud going on. That's why they have the special units.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Plowman.

Senator **PLOWMAN:** Thank you, Madame President. In reading the fiscal note, I'm trying to figure out how much of the cost would actually be covered by the Bureau of Insurance. I see that the Attorney General's position is. Are the support staff positions also covered in this fiscal note or would that be coming from the General Fund?

**THE PRESIDENT:** The Senator from Penobscot, Senator Plowman poses a question through the Chair to anyone who may wish to answer. The Chair recognizes the Senator from York, Senator Sullivan.

Senator **SULLIVAN:** Thank you, Madame President, men and women of the Senate. When I first arrived in the other Body and people started talking about appropriations I had no idea what they were talking about. What do you mean, appropriations? What is this all-night stuff that you're talking about? Then in my second term I was on the Banking and Insurance Committee. We got these big things called budget bills and budget books that you went through. We don't even report to the Appropriations Committee unless they want the money or the interest that is given to them. They charge enough and the bureau keeps enough money on hand to cover one year in case insurance companies were to go belly-up or whatever. It's the way they do it. I believe it might have been the good Senator from York, Senator Nass, who was a Representative at that time, who asked if perhaps they could take over the budget. Then they wouldn't have to worry about that. This was when we were giving you \$6 million or whatever it was.

On the other question, the Attorney General and office staff, that part will also be paid by the Bureau. Many of the positions are part-time positions or job sharing or whatever. The Bureau will pay for everything. It does cover all insurance types, going back to the good Senator from Penobscot, Senator Plowman's question. It is all insurance, not just one small thing like motor vehicles. It covers all. It allows for investigating company fraud also, which we are not able to do now.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Plowman.

Senator **PLOWMAN:** Thank you, Madame President. Having heard the information, I appreciate the answers. There is a provision in this bill that does concern me and it's the request for immunity in order to share information from company to company and bureau to bureau. When a company asks for immunity I think we ought to be very careful about how we provide that kind of

immunity. You are going to be sharing information about me, my constituents, and as we call them in this bill, consumers. You remove all liability for what is shared and take away all responsibility for the impact that this information has. As we know right now insurance companies are using a lot of information to determine what we pay, including credit scores and other personal information. What worries me is that when you are given blanket immunity in order to share this kind of information no one is held responsible for the outcome. While we are talking about protecting consumers from fraud, I think it's almost insidious that we will not allow them any kind of protection to know what is being exchanged regarding their personal information and there is no ability for them to be notified of what will be exchanged and there is no ability for them to be able to refute the information that is exchanged. The consumer protection will be extended to prosecute but there will be no protection expended or extended to defend yourself against allegations made about you from one insurance company to another, and perhaps presented to the Attorney General's Office and forwarded on to a Grand Jury. These are all very unintended consequences, I'm sure, but the protections are not there. If you worry about what goes on your credit report, at least you can check it. I'm inclined not to vote for this bill because of the immunities offered. This is not what my consumers want to have floating around. I do understand that we can already prosecute these crimes and there maybe a lack of resources at that area. We have to get at that problem before I'm willing to put my vote on the board and tell my consumers that they have lost all their protections and everything will pass under the radar back and forth. I'm sorry that I will not be able to support this report. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Bartlett.

Senator **BARTLETT:** Thank you, Madame President, men and women of the Senate. I just wanted to clarify that if information is collected and forwarded to a prosecutor for prosecution anyone charged with that crime is going to have an opportunity to get discovery. That means that they are going to be able to get the evidence against them so they will know that information has been shared, and in all likelihood, know where it has come from. There is a process in place through the legal system once it's forwarded onto a prosecutor. There will be an opportunity to challenge any transfer of that information at that time.

**THE PRESIDENT:** The Senator from Penobscot, Senator Plowman, requests unanimous consent of the Senate to address the Senate a third time on this matter. Hearing no objection, the Senator may proceed.

Senator **PLOWMAN:** Thank you, Madame President. May I ask a question through the Chair?

**THE PRESIDENT:** The Senator may pose her question.

Senator **PLOWMAN:** Thank you, Madame President. I understand that a consumer will be notified if their information is forwarded for prosecution. If the information is only exchanged between insurance company and insurance company and effects a person's right to be insured or effects their rates, what kind of protections are offered to the consumer, not knowing that this

information is being exchanged? That is certainly as high a penalty as being sent forward for prosecution, but it certainly could have an impact on whether you are able to insure your home, your automobile, or your business. If someone could answer, what protections are there for an agency-to-agency sharing of information I would appreciate it. Thank you.

**THE PRESIDENT:** The Senator from Penobscot, Senator Plowman poses a question through the Chair to anyone who may wish to answer. The Chair recognizes the Senator from York, Senator Sullivan.

Senator **SULLIVAN:** Thank you, Madame President, men and women of the Senate. For the record, as a good teacher I always say this will be the last question that I will answer on this because we have spent time and we need to get on. Kids love to take you on tangents. This will be my last question answered, but I will try to do it.

First of all, the biggest reason why we have company-to-company is that, and I use the case of car insurance, is because they go to different companies. It might be Company ABC. If ABC kept getting the same ring of people in these accidents they would catch on real quickly. ABC doesn't know what is happening with XYZ, so they would share that information so they would know. There has to be reason to believe that there is fraud going on. Companies are not just going to take all their policies and begin. There are also laws that tell them what kinds of information you can share. This is simply to allow better company-to-company sharing of information on what they suspect is fraud or a scam ring. We have very definite laws, privacy laws, as to what kind of personal information you can share. We're talking about fraud information. We're talking about suspect that something illegal is going on. I want a disclaimer that whatever question is asked, I may or may not know the answer, but I'm not standing up to answer it anyways. Thank you.
