Dr. Theodore N. Mitchell, of Penobscot Nation, Indian Island, a beloved and respected leader and educator. Dr. Mitchell spent his entire life on Indian Island but the effects of his legacy are farreaching and profound. He and his wife of 64 years. Eleanor. worked whatever odd jobs they could to support their family of 13 children and never asked for or received assistance from state welfare. As the children left home, Dr. Mitchell returned to college and earned his degrees in higher education while working full time in construction. He then dedicated his energies full time to the field of higher education and spent the last 40 years of his life fighting for and supporting Native American students. As a result of his drive, more than 360 students from 4 Wabanaki Tribes in Maine have received a postsecondary education. Dr. Mitchell's legacy lives on in the Wabanaki Native American Center that was established in 1991 at the University of Maine at Orono. Because of his persistent efforts, this center exists along with a Native American Studies program to serve not only the needs of Native American students but also to educate the nonnative public of the innumerable contributions Native Americans have made in Maine and the country. Dr. Mitchell received many honors and awards but the most important to him was the Native American Student Alumni Distinguished Service Award which he received in 2004. He will be deeply missed and

long remembered by his family, his many friends and colleagues, and an extended community which will continue to reap the benefits of his hard work;

The SPEAKER: The Chair recognizes the Representative from Old Town, Representative Blanchard.

Representative **BLANCHARD**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. It seems like it was only about two years ago that I rose to speak about another fellow Penobscot friend, Representative Sockalexis. It seems that I always get this kind of duty to speak about the friends that I've had over there in the Penobscot Indian Tribe.

Dr. Mitchell, or Ted Mitchell as most everybody in Old Town and the area knew him, was a man that titles meant very little. He was a proud, working member of the tribe, but he was also a great husband and a great father to 13 children. As it was stated, Ted Mitchell worked two jobs. He would work construction during the daytime, and at night, he would hand sew shoes and moccasins in order to supply whatever his family needed. He never received any donations from anybody, because he was such a proud human being. He had a dream and a goal, but first before I speak to you about his dream and goal, let me tell you how I first met Ted Mitchell.

My dad, when I was in high school, was operating in fuel, oil, propane and service station, and of course, being the young fellow that I was, my dad says you are going to work when you get 18 years of age and you are driving an oil truck. Well, sure no double, I got a license and I drove an oil truck, and it was always on Saturday mornings. The Saturday mornings consisted of going to two islands: one was called French Island which is now Treat-Webster Island; the other was to go to Indian Island and make the deliveries. My dad told me that Ted Mitchell was a good friend of his and a good customer, but he says he wants to pay you to do it. I want you to make sure that you knock on the door so that he can pay you.

Well, this went along fine for two or three weeks, four weeks, five weeks, and then one morning I got there fairly early. I went to Indian Island first instead of Treat-Webster Island, knocked on the door and nobody answered. I knocked again and nobody answered, so I left the slip between the doors, I got in the truck and was driving around the island, and who do you suppose is following me to pay the bill but old Ted Mitchell. That afternoon, he ended up down at the shop with my father having a coffee, and he says, I don't know what we are going to do with that boy.

Later on, during my lifespan, I decided to run for public office. I decided to run to be a county commissioner. Of course, one of the first people that I went to speak to was a good old friend, Ted Mitchell. He looked at me and he says you finally made it. He says, I will tell you what, I will support you and I am going to get you as many votes on this island as there is available. He did that. Again, when I ran for the Legislature, the first man that I spoke to on the island was Ted Mitchell, and Ted Mitchell did the same thing for me then. Though he was in his house, he was a little bit of an invalid, he made sure that his family went out and promoted me.

As I said earlier, Ted Mitchell had a dream. His dream was finishing his education. Midlife, he decides he is going to go on to college and he was going to get a degree. He worked days, went to school nights. Finally, he got his degree, a very, very proud man. But you probably wonder why he did this. I think probably, knowing Ted the way I do, it was to set an example, an example for his family and his grandchildren, for the members of the Tribe on the island, and for all of the American Indians across the United States to better themselves through education. He had a great promoting type feeling about him. If he saw the student, especially a Tribal student that was kind of laying back or even a Passamaquoddy, who the Passamaquoddy Representative has told me that he did for him, he says he would probe and he would push and he would even help to make sure that they finished their education.

Ted Mitchell, I believe, the goal was to promote a better life for all Native Americans and this was through education. Ted Mitchell, the humble, humble Penobscot Indian did achieve his dream. Thank you.

The SPEAKER: The Chair recognizes the Representative from Greenville, Representative Johnson.

Representative **JOHNSON**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. It was in 2008 at a 911 meeting to rename the roads and the Plantation of Kingsbury, where it was voted unanimously to rename a part of Route 16 as the Alton Worcester Highway, pending the pleasure of the state's Legislature.

Alton served 20 years in the United States Air Force and retired in 1974, moving back to Kingsbury Plantation, where he and his family purchased a blueberry farm. He resided there until illness required him to move closer to a hospital. He was diagnosed with ALS, Lou Gehrig's disease, in 2001. In 1975, he was elected as the first assessor of the plantation, and remained in that position until his death. He also served as road commissioner and constable. During the first years in Kingsbury, he and his family were the only people that lived there year round. On many occasions, he assisted travelers on that remote highway. Alton not only served his community and many areas as the first assessor, constable and road commissioner, but he served the local area in the American Legion, in that capacity, 16 years as Commander of the Scott Flanders Post in Sangerville. He served his fellow veterans, the youth of the community, and organized the host of patriotic events.

For a long time, the travelers on that desolate stretch of road from Abbot to Bingham, when going through the woods of Piscataquis County, the only place to get assistance was the big white house on the corner by the dam where Alton and his family lived. During the course of the years, from 1974 until he could no longer do it in 2001, he devoted much time and many hours to the workings of the plantation. Alton was known throughout the region as a leader and a compassionate citizen who, for nearly three decades, was willing to help anyone in need. We are doing a great thing today by passing this Resolution.

The SPEAKER: The Chair recognizes the Representative from Ripley, Representative Thomas.

Representative **THOMAS**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I have spent a number of hours making lots of trips back and forth from Abbot to Bingham. The first winter I ever drove a log truck was hauling logs to Quimby Veneer in Bingham, and it has got to be one of the scariest stretches of road there is, and at the risk of sounding older than I really am, in those days you had a hard time sometimes to get those trucks over a hill when the pavement was bare. When it was snow covered, it was a different story altogether. You always had to look forward to that last end of the trip, that three of four mile slide down into Bingham that had killed a number of people. It was when you turned the corner at Titcomb's Store in Abbot you had a ride to look forward to, and just knowing that the Worcesters were half way across if you had trouble, always gave you a little bit of comfort. I would like to thank Lois and give her my condolences. Thank you.

The SPEAKER: The Chair recognizes the Representative from Sangerville, Representative Davis.

Representative **DAVIS**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I certainly don't want to be outdone by my two colleagues, that is for sure. Alton Worcester certainly served us very well. He served 20 years, as Representative Johnson said, in the United States Air Force. He, after retiring to Kingsbury, became, again as Representative Johnson stated, he became commander of the Legion in Sangerville.

I was a member of the Legion, very strangely come to be a member. Former Representative Carr, who sat in this body for a number of years, his father was a chaplain of the Legion, and he came to see me one time and said if I joined the Legion, they would never ask me to do anything, they would never ask me to come to a meeting, and they would never ask me to serve in an office or anything like that. I said well I guess I can accomplish that alright, so I joined, but little did I realize that Lois and Alton would be in the mix. They had a fair booth in Dover-Foxcroft where they cooked French fries, and I had the opportunity to keep most of the farms of Aroostook County busy by cooking French fries at the Legion in Sangerville. Their fair booth existed for 50 years, the American Legion, the little post in Sangerville had that booth for 50 years, and it only went to the fire department in Dover after Alton was gone.

Kingsbury is an interesting place, as Representative Thomas said, it is a bend in the road, but you don't go there without having some sort of an experience of wildlife. As a state trooper, I usually had to follow you over there, at one time or another, when you hit a moose or a deer or whatever. Therefore, I spent a lot of time in Lois' kitchen, and it was interesting to be polite, it was very interesting. They are wonderful people, they had a wonderful home. I remember one year going to a town meeting in their kitchen. Everybody in town was there, all 10 voters, every one of them. During my brief career in the state Senate, I had the opportunity to meet and greet and get to know and have contact with thousands and thousands of people, and I can tell you the day I went to the town meeting in Kingsbury, I got grilled more, was asked more questions and got more scolding than I ever did from anywhere else. That is the truth. Every election year was interesting. I would get a call from Lois, and she would say, Well Davis, you did it again. I would say, what's that? Eight to two, you still got two people over here that don't like you, what are you going to do about it?

In closing, Madam Speaker, they were great people. Alton was a great man, Lois is a wonderful woman, and while I gave up Kingsbury when I left the Senate and Representative Johnson now, Lois moved to Dover-Foxcroft there so I could have her. Thank you very much, Madam Speaker.

Subsequently, the Resolve was **FINALLY PASSED**, signed by the Speaker and sent to the Senate.
