## JOINT RESOLUTION TO HONOR THE DAYS OF REMEMBRANCE

WHEREAS, the Holocaust was the state-sponsored, systematic persecution and annihilation of European Jewry by Nazi Germany and its collaborators between 1933 and 1945, by means of concentration camps, extermination camps, ghettos, firing squads and starvation and using every arm of the Nazi bureaucracy; and

WHEREAS, although Jews were the primary victims, with 6,000,000 murdered, millions more people, including Romani people and Poles, as well as people with handicaps who did not measure up to Aryan perfection, were also targeted for destruction or decimation for racial, ethnic or national reasons; and

WHEREAS, many specific groups, including homosexuals, Jehovah's Witnesses, Soviet prisoners of war and political dissidents, also suffered grievous oppression and death under Nazi tyranny; and

WHEREAS, the history of the Holocaust offers an opportunity to reflect on the moral responsibilities of individuals, societies and governments whether at peace or at war; and

WHEREAS, the people of the State should always remember the terrible events of the Holocaust and remain vigilant against hatred, persecution and tyranny so that such horrors are never repeated; and

WHEREAS, the people of the State should actively rededicate ourselves to the principles of individual freedom in a just society; and

WHEREAS, the Days of Remembrance have been set aside for the people of the State to remember the victims of the Holocaust as well as to reflect on the need for respect of all peoples; and

WHEREAS, pursuant to an Act of Congress, the United States Holocaust Memorial Council is responsible to designate

the Days of Remembrance of the victims of the Holocaust, and this year's commemoration is April 19, 2009 to April 26, 2009, including the Day of Remembrance, known as Yom Hashoah, on April 21, 2009; and

WHEREAS, it is appropriate for the people of the State to join in this international commemoration; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-fourth Legislature now assembled in the First Regular Session, on behalf of the people we represent, pause in solemn memory of the victims of the Holocaust and express our common desire to continually strive to overcome prejudice and inhumanity through education, vigilance and resistance; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Holocaust and Human Rights Center of Maine and the United States Holocaust Memorial Council in Washington, D.C., on behalf of the people of the State.

READ.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Cohen.

Representative **COHEN**: Thank you, Madam Speaker. Madam Speaker, Men and Women of the House. I am honored and humbled to have my name attached to this important resolve. We face the reality that the generation of those who survived the Holocaust is quickly disappearing, as is the generation of those brave American soldiers who liberated them from the horrors of the Nazi concentration camp system.

I have no doubt that when survivor and liberator met on that cold, gray day in April or May 1945, they both believed that one had experienced, and one had witnessed the worst one human could inflict upon another and still be called a human being. I believe that both survivor and liberator thought that such an event as the Holocaust could never be duplicated, that with the evil of the Nazi wars against the Jews and against humanity now defeated, a new era of human understanding and dignity might begin in the ashes of a discredited civilization.

How wrong they were to believe in such an optimism. What we have seen since 1945, since we pledged never again, since we outlawed genocide, the destruction of a racial, political or religious group, is more of the same. In Rwanda, Cambodia, Bosnia, Darfur, and a dozen other places of indescribable killing. the willing executioners have stepped forward and killed and Don't the survivors and the liberators deserve killed again. better? Our nation and our State believe they do. That is why we have placed a national museum on the Holocaust in the heart of America's sacred space in our nation's capitol. That is why we have placed a center on the Holocaust and genocide on the campus of the University of Maine here in Augusta, in the sacred space of our State's capitol. And that is why the University of Maine at Augusta has just approved a new minor in Holocaust, Genocide and human rights studies that will begin in the fall.

In these museums, and in many more across our nation, Americans will learn what both victim and liberator understood on the fateful day of their meeting: that we must defeat the evil of genocide before it devours us. That only by being vigilant in our defense of liberty and human rights for all can we indeed dream of a world free from future Holocausts and genocides.

On Yom Hashoah, the Holocaust day of remembrance, we will stop and remember those who died, those who survived and those who freed them from the indescribable horrors. But on the very next day, we will have to do more. Our survivors and our liberators deserve no less. Thank you.

The SPEAKER: The Chair recognizes the Representative from Freeport, Representative Webster.

Representative **WEBSTER**: Thank you, Madam Speaker. Madam Speaker, Men and Women of the House. I rise to briefly comment on the importance of this day.

Why do we remember? We remember so that this should never happen again, and yet it does. Why do we try to not let this happen again? Because we are humans and we must be human. The conditioning that we create for each other, as human beings in our relationships, has a lasting impact, generation after generation.

As one survivor of the Holocaust wrote, "We were slowly conditioned into the role of victim. We were the ones that were hunted. We looked it and we acted it. We didn't even need that yellow star on our left chest; the fear in our eyes gave us away." We were slowly conditioned, and we as an oppressor become slowly conditioned to accept, or we who stand aside when wrong is done are slowly conditioned to accept, but we must turn away from that. So in honor of the concept of diversity, prejudice, and issues of human right, I ask us together to pledge to never again forget the importance of being human. Thank you.

- **2. Membership.** The commission consists of 11 members, appointed as follows:
  - A. Five members appointed by the President of the Senate as follows:\_
    - (1) Two Senators;
    - (2) One member who has expertise in financial matters;
    - (3) One member who is a teacher from a rural school district; and
    - (4) One member who is an administrator from a large school district; and
  - B. Six members appointed by the Speaker of the House as follows:
    - (1) Four members of the House of Representatives, one of whom was a teacher from a large school district within the past 4 years;
    - (2) One member from the Department of Education; and
  - (3) One member who is an administrator from a rural school district.
- **3. Commission chairs.** The first-named Senator is the Senate chair of the commission and the first-named member of the House is the House chair of the commission.
- 4. Appointments; convening of commission. All appointments must be made no later than 30 days following passage of this order. The appointing authorities shall notify the Executive Director of the Legislative Council once all appointments have been made. When the appointment of all members has been completed, the chairs of the commission shall call and convene the first meeting of the commission.
- **5. Duties.** The commission shall study how the new system of school administrative consolidation is creating extra

administrative burdens that can be alleviated with careful review in both rural and large school districts. The study must focus on reducing extraneous, unnecessary and duplicative regulations and paperwork and ascertain ways to alleviate any extra burdens in school administration.

- **6. Staff assistance.** The Legislative Council shall provide necessary staffing services to the commission.
- 7. Report. No later than December 2, 2009, the commission shall submit a report that includes its findings and recommendations, including suggested legislation, to the Second Regular Session of the 124th Legislature. Pursuant to Joint Rule 353, the commission is not authorized to introduce legislation. Upon receipt of the report required by this section, the Joint Standing Committee on Education and Cultural Affairs may, pursuant to Joint Rule 353, introduce a bill during the session to which the report is submitted to implement its recommendations on matters relating to the study.

The SPEAKER: The Chair recognizes the Representative from Newcastle, Representative McKane.

Representative McKANE: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. The first thing I would like to say about this bill is that it has nothing to do with our current auditing department or anyone who works for that department. We are very lucky to have such a competent department and state auditor, and they are all doing a fine job. We have been fortunate in the past to have had so many competent state auditors and their department. That might not always be, because the system that we have does not require any accounting education and it is a biased system, and it allows our majority party, which ever one that may be-and we have been doing it this way for a long time—to simply pick whom we want for an auditor. Again, we have been lucky so far, we have been very fortunate to have so many competent state auditors, but one could envision in the future where this might not always be the case.

The perception of bias, whether it is justified or not, will continue to erode the public trust, resulting in a further skeptical and cynical electorate, and this would be especially so if and when the auditor happened to have been opinionated in any way in his or her former political life. One can only imagine 50 years from now, when our grandchildren sit in these seats, the possible scenarios of an unscrupulous controlling party appointing puppet constitutional officers. I would like to add what the Comptroller General of the United States said several years ago, to finding the independence needed for an auditor: "In all matters relating to the audit work, the audit organization and the individual auditor, whether government or public, should be free both in fact and appearance from personal, external, and organizational impairments to independence."

The second reason that I submitted this bill was money. Hiring out, contracting out a single state audit would save this state money. It is there on the fiscal note; it would save about \$ 1 million every budget. So I hope you will oppose the pending motion and give this some thought. Thank you.

The SPEAKER: The Chair recognizes the Representative from Belfast, Representative Giles.

Representative **GILES**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I rise to speak in support of Representative McKane and his objection to the Majority Report, and let me just talk about this a little bit. Again, I am going to echo his very careful words of, this is not about criticism of an existing audit function within state government.

What this is about is independent verification, inspection, accountability, and the best possible way to get the right financial reporting for money that is not our money, this is taxpayer money, and we want to make sure we are reporting this as best as we can. This economy, in the last four or five months, has been literally turned on its ear. There are many traditional, historical financial practices that have just amazed everyone in terms of how inaccurate some things were done. I am not speaking of the State of Maine; I am speaking nationally and globally as well. But I think, as legislators, it puts more burden on to us to make sure our financial practices of the state are the best they can be. I am going to use as an example for you, and, again, we have fine people that work in our audit department under our state auditor, but think of this: Many of us work for businesses or we own a business, or we may be a member of a nonprofit board organization, and you have access, usually, to some level of financial information. But ask yourself this: Sitting on that board of directors for your nonprofit—your hospital, your girl scouts, whatever organization it is, or owning a business would you ask the employees of that organization to provide your financial report, the only one you get annually, on your financial status and reporting? I don't think so. I think you would feel much more comfortable, there may be some level of internal work, but you would look to an external, independent, certified public accounting firm that has its own rules, regulations, reporting capabilities to make independent assessment of this.

So in bringing this bill forward—Representative McKane has had it here before for those of you new to the Legislature—I think given the times we are in, in 2009, it is particularly important that we give serious consideration to looking at an external auditing firm for doing our single state audit annually. In closing, I do speak against the Majority Ought Not to Pass Report, and I would ask others to follow my light.

The SPEAKER: The Chair recognizes the Representative from Biddeford, Representative Beaudette.

Representative **BEAUDETTE**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. Government auditing is a very unique aspect of the auditing process. We have heard some discussion about nonprofits and other types of businesses that would be audited and the wisdom of having an independent auditor, but a government audit is a very unique item. We are very fortunate here in the State of Maine that our Department of Audit has received a certificate of achievement for excellence in financial reporting from the Government and Financial Officers Association.

In contrast, when other states have hired outside independent auditors, the results have not always been quite so glowing. In Kansas and in Maryland, where independent auditors were hired, they were found to have made numerous costly errors, and in the case of Kansas, errors that cost the state tens of millions of dollars. So the aspect of looking at possibly being able to save some money by contracting out the outside audit is actually put at risk because of the uniqueness of doing a government audit. Nebraska and California, for example, have already brought the single audit back in house after having it done out of house for a period of time. So in accordance with the wise, old axiom: if it

ain't broke, don't fix it.

The SPEAKER: The Chair recognizes the Representative from Sanford, Representative Boland.

Representative **BOLAND**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I would like to echo Representative Beaudette's remarks, and also add that the auditor serves the Legislative Branch. If there were an auditor hired from outside, that has been brought up as an issue where they would probably be wanting to please so that they continue to have the job. The auditor, as we have now, needs to please the Legislature and be accountable directly to the Legislature. They have found millions of dollars in savings for us. I think we all know how complicated it is when we start looking at the budget and the different departments. These people are working on it constantly. If we had an independent auditor, they would have to go to them repeatedly for input as well, so they would still be working on it so, ultimately, it really is not a cost savings. Thank you.

The SPEAKER: The Chair recognizes the Representative from Belfast, Representative Giles.

Representative **GILES**: Thank you, Madam Chair, for allowing me to rise one more time on this. Just to address the comments that were made, I just want to make a brief comment that there are public accounting firms that do have expertise in state government as well as municipal auditing, and I am sure through an RFP process, you would be able to find that appropriate external expertise. Thank you.

The SPEAKER: A roll call has been ordered. The pending question before the House is Acceptance of the Majority Ought Not to Pass Report. All those in favor will vote yes, those opposed will vote no.

Representative **SCHATZ**: Thank you, Madam Speaker. Madam Speaker, Men and Women of the House. I rise in opposition to the pending motion. I was in the committee the day

that the other good Representative from Biddeford came forward and presented this bill with some very compelling testimony, and apropos this day of remembrance, I feel that that testimony should reach us in the House, and I am hoping that the good Representative will share that with us. I would hope others will oppose this motion and follow my light, and I would like the yeas and nays when the vote is taken, please.

Representative SCHATZ of Blue Hill **REQUESTED** a roll call on the motion to **ACCEPT** the Majority **Ought Not to Pass** Report.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Biddeford, Representative Casavant.

Representative CASAVANT: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. This is probably not the most important bill that we are going to be facing in this particular session, but I think it is a bill that makes people think. The genesis of the bill came from one of my classes, my American Studies class. I teach the class thematically, and the first unit that I teach deals with American character, the idea of what is it that makes Americans unique? We look at things like character traits, individuality; we look at the work ethic, we look at the American dream, a bunch of things of that nature and, as part of that, we looked at exploration. In doing so, they came across a number of readings about Columbus, and they were shocked by what they read because it was not the history that they read about or learned about, or perhaps that you learned about, in grammar school. They saw him linked to slave trading: they saw him linked to the murders of Native Americans; they saw his greed. That could be interpreted as historical revisionism, so we talked about that, and we talked about the myth of American history, the idea that George Washington never cut down a cherry tree; the idea that Plymouth Rock really wasn't the first place that the pilgrims landed; and we talked about Columbus. They still didn't like the idea about celebrating Columbus, especially when they realized that he never even came to America. I said, well we can change that, we could pass a bill but you have to participate in it, and you have to submit testimony, and they agreed. That was the genesis of the bill.

But then it started to change the more I thought about it and the more that they thought about it, and I realized that, you know, if we are looking at American character, what makes all of us special as compared to a European nation or Asian nations, there is not a holiday that really addresses that. We have the Fourth of July to celebrate the birth of the nation, and we have the Memorial Day that honors the dead, but what about the living, what about the people who are making America great today? Now if you look at Columbus Day, that has been embraced by Italian Americans, and that is a good thing, and to some degree it has been embraced by traditionalists, even though that is fairly recent, Franklin Roosevelt is the one who first came up with the idea. But still, there are so many people who think about America as something bigger than that, it is dynamic. It is not locked in 1492; it is ongoing.

So as I began to think about it a little bit more, I began to think about the immigrants who came here. Yesterday, we had Franco-American Day. Clearly, they shared something with this country and made it something and made America something. Today, we are looking at the Holocaust survivors. They brought something with them, too, when they came to America; and the Greeks and the Cambodians. Everybody came here and brought something, so when you start to look at American character, what I am saying is it is a dynamic process not locked in time. So the genesis of the bill changed, it became a chance for us to

embrace who we are and where we are going. Yes, Columbus has a place in that too. I don't want to just discard him because, as some members of this group said to me, well, you know you can't judge him by those standards. I don't want to do that. I want to have an opportunity to at least say, let's make the holiday more relevant to today, where we can look at ourselves and say we are a good people, especially in bad economic times, we are a good people because of where we came from and why we came here, and that is what the whole idea of Heritage Day is all about. I would ask you to think about that and the meaning of America and Americans. Thank you, Madam Speaker.
