This is just a point of clarification: This bill deals with, it says, regarding seatbelts only applies to those people who are delivering newspapers. In other words, people who are constantly in and out of their car in the mornings, 150 times. This is what it applies to, so I want to make that point clear. Thank you.

#### READ.

Representative MAZUREK of Rockland moved that the House **ACCEPT** the Majority **Ought Not to Pass** Report.

The SPEAKER: The Chair recognizes the Representative from Old Orchard Beach, Representative Hogan.

Representative **HOGAN**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I rise to speak in opposition to the motion. Obviously, this is a 9-1 vote and the odds of me prevailing here is not great, but I have to do this. I have to do it for me, and I have to do this for all of those people that came to our hearing.

The day of the hearing, the room was completely filled with citizens, unsolicited. They were there on their own. Also, there were two smaller rooms that were also filled, and then we would bring them in, in groups. Every single one of them, without exception, said support this bill. That is the general public, that is the public that we serve.

The lobbyists, the lobbyists normally come out big-time against any prohibiting of cell phones. This time, every lobbyist did support the prohibiting of handheld cell phones. The State Police; State Police at least recognize that yes, we have a problem. They clearly stated that. Then they passed out this information that they got from a study from NHTSA, which states a whole bunch of facts, and just let me give you a few of them: Certainly, one of them is drivers using cell phones are four times likely to get in a crash. Then again, texting is another issue that I will be talking about in just a little bit here. But they also said that drivers using a cell phone are 400 percent times distracted as others.

Ladies and Gentlemen, we are turning our cars into something other than safe vehicles. We are turning our cars, in some sense, into our offices. We think that we have the right or the ability. We do have the right; we have the ability to get into our car, take our hands off the wheel, text, cell phone, do any number of things that create a distracted driver. Every study, every single study states that cell phone use is the number one distraction.

The enhancement of the technology of cell phones is creating a huge problem in all of our vehicles. We are supposed to be promoting good, safe, healthy driving habits. Well, we're not, and for our own personal use, I think that some are actually supporting this motion. You shouldn't do that. The number of people who came to this committee to voice their opinions is the ones we should listen to.

Let me just briefly tell you a little bit about the bill: The bill says that hands free cell phones are acceptable; handheld cell phones are not acceptable. Texting, any mechanical device would be prohibited, and that surely would include texting in any other device that you might or anybody might want to have in their possession while driving. Then came the exemptions, and this is primarily why I think the 9-1 came, because we got hung up on exemptions, everybody and their brother wanted an exemption. Well, the exemptions are the police and rescue; the commercial licensed trucks, while they are on duty; municipal public workers, MTA people and the public utility people, and I believe that might have been it. But that's where we got hung up, that's where this 9-1 vote came from.

Ladies and Gentlemen, I stand here before you today because I want to be on the right side of the issue. There is a reason why, for example, ExxonMobil, Shell, big companies like that have issued a directive prohibiting their people from using a cell phone while on company business. Then again, there is the City of Saco, a great little town in southern Maine, who has issued, also, a directive to their people. Nobody will use a cell phone while on city business, so we are starting to get into the municipalities. To think this is going to go away lightly, it's not; it is going to come back every single year. But do want to say that I want to be on the right side of an issue, just in case there is a catastrophic accident, like occurred in Los Angeles, California. A train went through a crossing and crashed into a school bus, killing many students. I don't want that to happen here and see the race down to the Revisor's Office to see who is going to put in the bill first. I just say use your common sense. The Lewiston Sun Journal stated it very clearly: Legislature, are you listening? They supported the prohibition of handheld cell phones. Madam Speaker, I would ask for a roll call. Thank you.

Representative HOGAN of Old Orchard Beach **REQUESTED** a roll call on the motion to **ACCEPT** the Majority **Ought Not to Pass** Report.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Saco, Representative Valentino.

Representative VALENTINO: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I rise today to speak in opposition to the motion pending on the floor. My good friend from Old Orchard Beach, I think, has made an excellent point on this. I have prepared no written testimony today, because I don't think we need a written testimony today. I think every single person sitting here knows cell phones are dangerous. I don't need to pull statistics, I don't need to pull any information on accidents or anything else. We have all driven down the highway, we have all had that car go in front of us, 65-I want to say 85 mph, but we can't go 85 on the Turnpike-85 mph, then they slow down to 65, because then you pass them and they are on their cell phone, you know they got a call. Then they speed up and they pass you again. Then, all of the sudden, they get another call and they slow down, going back and forth. We know how dangerous they are. We know how dangerous they are because we know lots of times we've looked up, and

we've hit the rumble strip when we are on our cell phones. So I don't have to give you statistics. We all know in our hearts that they are dangerous, that's all.

Actually, a very famous gentleman, the other day, hit a guardrail on 295. F. Lee Bailey was in town. I didn't even know he was still alive, but it was great that he got his name in the paper, because he went for his cell phone and he hit a guardrail and he made the papers. I thought that was great he was actually in the State of Maine. I also have one of those little ear buds. I thought it was cool to get one. That was three years ago. It came with the phone; I had the hands free on the phone. I'm not the best on technology. I have never learned how to use it, it's still in the box, I have all of that stuff. If this bill passes, I am going to have to learn how to use that to be a safe driver. Maybe I need a bill to force me to open up a box that I paid \$100 for, three years ago, so I can put it in my ear and be a safe driver.

The Representative from Old Orchard Beach is correct: Our cars are not our offices. We treat them as an office, and I think a lot of people who may vote against it, it is because we do so much business in our car. As I see, my good friend, the Representative from Wilton, has his little ear bud here and some days you have it on here. But I want to tell you that this bill is not about us. It is not about our convenience to drive and to answer all of our phone calls and to do it. As the Representative from Old Orchard Beach said, people know the dangers of this. But when you vote, don't vote for yourself. This bill, to me, it's about my daughter and my two grandchildren. It's about them, because when you answer your phone and you are not paying attention, they may be driving down the road totally innocent, and if you hit them because you feel you have a right to go on your cell phone, and you hurt or injure or kill them, then that is not fair. You should have two hands on the wheel, 10 and 2, and your eyes ahead and your mind on the road. Not on what you are going to be doing when you get to Augusta or when you get home or anyplace else. I think we all know in our hearts this is dangerous, and I urge you to vote against the pending motion. Thank you.

The SPEAKER: The Chair recognizes the Representative from Rockland, Representative Mazurek.

Representative **MAZUREK**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I would just like to make a comment or two regarding this bill. First of all, with the exemptions, if all of those exemptions were added to the bill, the bill would be watered down tremendously. I agree that the people who are on, whether it is handheld cell phones or the other type, they are distracted. We are, right now in the Transportation Committee room, working on a distracted driving bill that would probably and more than likely cover this situation. So I urge you to go along with the Ought Not to Pass Report. Vote in favor of the Ought Not to Pass, because this type of situation of distracted driving is an issue, it is recognized, and it is being worked on. Thank you.

The SPEAKER: The Chair recognizes the Representative from South Portland, Representative Morrison.

Representative **MORRISON**: Thank you, Madam Speaker. Good morning, Men and Women of the House. I just wanted to bring a point of order to everyone, and I want to follow along with Representative Hogan. Tuesday morning, when I was coming to Augusta, there were two people that I saw texting on the road while driving up here, and I was tempted to call and report them when I got here. Today, I found one person texting while driving. Not only were they just texting while driving, but they were also weaving in the road, so this bill is important. I do compliment Representative Hogan and I am glad there is another bill pending, but I just wanted to say that it is out there and I see it on a daily basis when I am coming to Augusta. Thank you.

The SPEAKER: The Chair recognizes the Representative from Biddeford, Representative Beaudoin.

Representative **BEAUDOIN**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. Talking on the phone, text messaging, e-mailing, and even dialing a phone while driving, draws your attention away from the road, and drivers have no business putting others in danger.

Studies have shown that the use of a cell phone, regardless of the use of a hands-free device, increases the risk of an accident.

A 2006 University of Utah study showed that people, who are talking on cell phones, either holding the phones or using a hands free device, are impaired at the same level as drivers with a blood- alcohol limit of .08 percent.

We can't legislate common sense, but it has been our practice to try to stop practices that put other people at the greatest risk.

Cell phone use while driving reduces the speed at which a driver can process information; it reduces the speed at which a driver responds; it reduces the driver's cognitive functions as "driver."

I urge you to vote to ban the use of cell phones while a person is driving.

The SPEAKER: The Chair recognizes the Representative from Old Town, Representative Blanchard.

Representative **BLANCHARD**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. You have heard all of the negative issues about handheld cell phones. I have one; I'll bet you 95 percent of everybody here has one. We have all seen the dilemmas on the road.

I'm going to tell you a little story about my own home life, this is a true example: My daughter in-law has a very bad tendency of texting or using her cell phone while she's driving. Well, it irritates my wife so much that, if she should call the house, the first question my wife asks her is "Are you on a cell phone?" She says, "Yes." "Well, hang up and call me when you get home."

The other day when I left here, Thursday night, it was about six thirty or seven o'clock, I called my wife, I am in the yard, I hadn't even driven out of the yard, and I called my wife, and I said, "I think I'm coming home tonight." She said, "Are you on a cell phone?" I said, "Yes." She said, "Hang up, you can tell me when you get home." My wife is not a person against cell phones. She is just afraid of anything that might happen on the road when you are distracted. So I am going to support my fellow Representative from Old Orchard Beach and oppose this bill. Thank you.

The SPEAKER: The Chair recognizes the Representative from Ripley, Representative Thomas.

Representative **THOMAS**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. The Representative from Saco might want to check with studies before she takes her ear piece out of the box, because study after study shows there is no difference. Even though we all believe the hands free devices are safer, they're not. In the second, this bill had so many exemptions that, those of you who have a Class I license, could drive a 100,000 lb log truck south from Greenville in an ice storm and use your cell phone. It would have been perfectly legal. But if you were driving on the Interstate on a dry day, that would be against the law.

Finally, Madam Speaker, let me assure you, my grandchildren are a much bigger distraction than any cell phone. Shall we ban grandchildren from cars too?

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Russell.

Representative **RUSSELL**: Madam Speaker, may I pose a question through the Chair?

The SPEAKER: The Representative may pose her question.

Representative **RUSSELL**: Thank you, Madam Speaker. I would like to know if this prohibits dialing the phone under the text messaging clause. Thank you.

The SPEAKER: The Representative from Portland, Representative Russell has posed a question through the Chair to anyone who may care to respond. The Chair recognizes the Representative from Old Orchard Beach, Representative Hogan.

Representative **HOGAN**: Thank you, Madam Speaker. Yes, it does. You are not to, it was hands free. It is set up so that you can use it, but not hands held.

While I have the floor here, in response to my good friend from Rockland, I didn't think we were supposed to speak to other bills, but briefly, the distracted driver bill he is referring to is an after the fact bill. In other words, when you get in the accident, that is when they will enforce it.

The SPEAKER: The Chair recognizes the Representative from Saco, Representative Pilon.

Representative **PILON**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. A couple of weeks ago, as I was coming up to the State House, I was following a gentleman that was weaving up the highway We were both doing a little bit more than the speed limit, and I was noticing that he couldn't keep his car on the road. When I had the opportunity to pass him, I noticed that he was balancing a cell phone on his ear, drinking coffee, and kind of shuffling papers on the passenger's seat. I was wondering how he was driving the car. Well, he really wasn't driving the car at all. He was driving the car with his knees at 75 mph. Once I got on the other side, I noticed there was his cell phone cradled underneath his arm and his head. This is the kind of behavior the cell phone, the lack of legislation, is exhibiting. So I support the good Representative from Old Orchard Beach's bill, and I hope that everyone will follow his light. Thank you.

The SPEAKER: The Chair recognizes the Representative from Westbrook, Representative Peoples.

Representative **PEOPLES**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. It is not any accident that this is a vast Majority Report. I don't think anybody on the Transportation Committee is in any doubt that cell phones and texting are a terrible, terrible distraction. I think the point has been made that there really is no statistical difference between handheld and hands free. But added to that, Representative Pilon just brought up the fact that the guy was drinking coffee.

We have all gone down the road and seen women putting their makeup on. I think some of us may have been guilty of that on occasion. There is the old brushing the hair distraction. There is the book on the steering wheel distraction. The newspaper on the steering wheel distraction. The notepad and pen on the steering wheel distraction. The notepad and pen on the steering wheel distraction. There is the distraction of, Oh gee; I just dropped something down in the well of the passenger's side. So when we talk about things that cause accidents, we are looking at something much, much greater than one simple device. It is a whole host of things that have become more important since we have way much more traffic on the road now. It requires us to be way more focused on our driving than perhaps some of us were when we were younger. We have to look at this thing in a more global way than just simply one device. The difficulty with banning this one device, used in this one way, is it doesn't address any of the rest of these things, and going to the exceptions, the road to heck is paved with good exceptions. Once you give one person an exception, we are going to be here every year, year after year, four or five special cases, Oh we have to have an exception. So I would say let's try to view this thing more globally. It is going to take a change in peoples cultural behaviors, and I think that is where we need to be going with this. So I would ask you very much to support the majority, and let's keep working on this. Thank you very much.

The SPEAKER: The Chair recognizes the Representative from Sanford, Representative Boland.

Representative **BOLAND**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. | just have to add that this message was brought home rather clearly to me this morning, because I consider myself a pretty cautious driver, but I was on my cell phone and I got stopped by the police in Hallowell. I don't think I was weaving or anything, he was very kind, very nice and luckily got a warning, and wouldn't have happened in Wells, for instance. Those police there have taught me very well to be very cautious. As much as the almost two hour drive from here to Sanford makes it very appealing to make calls on my cell phone that I hadn't been able to get to perhaps during the week, I think we all sort of need a little extra nudge to help us do some of the things we think would be appropriate. While there could be more global pieces of legislation or maybe better ideas come along, sometimes it seems that what we find in the House is that we can take maybe a small bite of the apple; maybe the bigger one will get swallowed. So it seems to me that it would be worth while to at least take a step in this direction. Thank you.

Representative THERIAULT of Madawaska **REQUESTED** that the Clerk **READ** the Committee Report.

The Clerk **READ** the Committee Report in its entirety.

The SPEAKER: The Chair recognizes the Representative from Augusta, Representative Crockett.

Representative **CROCKETT**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. For many years, the Legislature has tried to pass bills to ban handheld cell phones. I remember the Representative from Lewiston, Representative Bouffard, had a bill in many years ago. I think we probably don't have a perfect bill before us, but we certainly know that many pieces of legislation that we enact, we come back the next year and we make exemptions and we make corrections. But I think today we have a bill before us that could save a life, and I think we all should be voting against the pending motion and vote Ought to Pass. Thank you.

The SPEAKER: The Chair recognizes the Representative from Lewiston, Representative Carey.

Representative **CAREY**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I want to speak briefly to a couple of the points that have been brought up and share with folks what was brought up in committee.

First of all, and I don't want to speak for the other 11 members of the Majority Report, but I think we all feel that there is a problem and it will be dealt with in this session.

Second, speaking to what the State Police shared with us. We asked them last year when a similar bill came up, or two years ago, we asked them to come back to us with a review of the data. Some of the data has been shared today. What they shared with us was two summaries.

First, the data is all over the map. There is one study that shows that cell phone use is the eighth highest distraction behind things like the grandkids, as was mentioned before, drinking coffee, eating food, reaching into the wheel well. Cell phone usage in that report distracted about 1 percent of drivers. So there is a broader issue and the data is not clear as to exactly whether this is the worst problem.

The second thing that they shared, and this really hit home with me and I think with some of my peers, it goes to what the Representative from Saco was talking about, Representative Pilon, talked about the example of watching somebody who had three or four distractions going on in the car this morning as they were weaving around the road. Well, the weaving around the road, that is an observable offense. The State Police can do that. They are very concerned with enforcing who is talking on a cell phone. There are some significant enforcement concerns. They would urge us, if we do something like this, to make it an observable offense, and I think you will see a bill coming before the chamber in the later months that has exactly that provision.

Finally, I want to focus on the exceptions, and this to me was the piece that really tipped the balance. To me, it comes down to, if it is good for the goose, it is good for the gander. So let me read the exceptions: Drivers of authorized emergency vehicles; physicians; holders of commercial driver's licenses while operating a commercial vehicle; municipal public works personnel; Maine Turnpike Authority personnel; state transportation personnel, all employees and contractors; personnel of a public utility and all contractors and employees of that public utility. Folks, if it is good for everybody, it is good for everybody. If we are going to exempt people for whom this is not in the training for those jobs. We are exempting fighter pilots, that's great. Those folks are trained to multitask. Commercial driver's licenses have a very thick rulebook that they have to go through. It doesn't deal with multiple sources of input coming in from a cell phone, the dashboard, on the road. So why are we exempting them and not the rest? The exemptions stink and that is why I am voting against the bill, and I call for a roll call if it hasn't yet been called for.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Harlow.

Representative **HARLOW**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I would like to thank the good Representative Hogan to give me a chance to vote correctly. I am changing my vote, and I just wonder if Representative Thomas had put a bill forward to outlaw his grandchildren from going in the back seat. I'll second that for you. Anyway, I think if there is anything that adds to danger and driving, we should always think about it and stop it. Thank you very much.

The SPEAKER: The Chair recognizes the Representative from Cape Elizabeth, Representative Dill.

Representative **DILL**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I will be voting against the pending motion, and I just wanted to clarify a few points as well. The exceptions that my good friend and seatmate just outlined are not in fact the exceptions that appear in the bill. Those exceptions are not before you with the pending motion.

I would also note that the bill that has been referred to maybe inappropriately, maybe not, as the later bill, specifically excepts cell phones, so it doesn't deal with cell phones. So if what you are concerned about is cell phones, the late bill, as it is currently drafted, doesn't cut it.

Thirdly, there has been a lot of talk about the State Police and their good work, and I appreciate and value the work that the State Police do. But in my community, we don't have a lot of State Police. The State Police don't patrol my neighborhoods and my towns, and I know for a fact that cell phones are a problem in my community and that is why I am supporting Representative Hogan's bill. Thank you. The SPEAKER: The Chair recognizes the Representative from Rockland, Representative Mazurek.

Representative **MAZUREK**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I just want to make a point that when we talk about cell phone distraction and other types of distractions, I have seen people play the drums, read, eat sandwiches, do everything while driving the car. Cell phones are only one small part of driver distraction.

As I mentioned, we do have a distracted driver bill that is coming before us. All of these things will be taken into account. We wonder why we say, well, we'll take one small bite of the apple. We clutter up our law books, and we don't ever get to the problem with distracted driving. So let's not rush into this and feel good and say, well, we've done something wonderful today. Well, let's give this a chance to do a good bill and that is the distracted driving bill, and I will tell you that this will more than likely be part of it and other areas of distracted driving. All you have to do is stand on any street corner and you can see what happens to people. They are doing everything but paying attention to driving, and we have to put an end to it. This bill will not serve that purpose. Thank you.

The SPEAKER: The Chair recognizes the Representative from Freeport, Representative Webster.

Representative **WEBSTER**: Madam, Speaker. May I pose a question through the Chair?

The SPEAKER: The Representative may pose his question.

Representative **WEBSTER**: Thank you, Madam Speaker. Madam Speaker, I would like to know that since I operate hands free Blackberry with a headset whenever I am driving, it requires for me to press a button that says say a command, so that I can then verbally dial a phone number. Would actually dialing, hitting that button, be a violation under the terms of this piece of legislation? Thank you.

The SPEAKER: The Representative from Freeport, Representative Webster has posed a question through the Chair to anyone who may care to respond. The Chair recognizes the Representative from Old Orchard Beach, Representative Hogan.

Representative **HOGAN**: Thank you, Madam Speaker. No, I think we should apply a little common sense, but you shouldn't be using the Blackberry anyways.

The SPEAKER: A roll call has been ordered. The pending question before the House is Acceptance of the Majority Ought Not to Pass Report. All those in favor will vote yes, those opposed will vote no.
