Representative CHASE: Thank you, Madam Speaker.

Madam Speaker, Ladies and Gentlemen of the House. I am extremely proud today to tell you about the Wells/Ogunquit Center at Moody, our Senior Center in Wells and the incredible volunteers who are members there.

I've known many of them since 1997, when we first began the goal to build a much needed Senior Center for the Wells and Ogunquit area. Thousands of volunteer hours later spent in fundraising, knocking on doors, presentations to local businesses and organizations and grant writing, we opened our beautiful facility in 2004 with more than 800 people attending the grand opening ceremonies.

The volunteer efforts and the commitment of the members of WOCAM (the acronym we go by) have grown with the expanded membership-now more than 600 strong-of which I am one. Over the nearly 5 years since the center's opening, this active group has continued to raise the money needed to operate and maintain the center as well as provide programs. functions, entertainment and fun to those who go there. With an annual budget of more than \$175,000 that is no small feat. It is truly a facility owned, operated and funded by seniors-no tax money supports this center. Exercise classes, art classes, health seminars, cribbage, bridge, pinochle, Bingo, pancake breakfasts, trips, counseling, computer classes, karaoke, bowling, yoga, sing-a-longs, dinner theater, lunches and raffles are some of the things going on weekly. There is even a gift shop full of wonderful homemade crafts created by and sold by center volunteers.

When the energy costs rose so dramatically last fall, members of the Board of Directors for the Center applied for and received a grant from Bank America to help fund a concept for "Days of Warming". The idea was to open the Center for the nine coldest Saturdays—January thru February—encourage people to turn down their home thermostats and come to the center for a day of camaraderie, entertainment and a free lunch, while saving on their home heating costs. Local restaurants and organizations donated the food and the Centers members, again, stepped up to the volunteer plate to provide the people power to do it.

On those nine "Days of Warming" more than thirty eight volunteers worked more than 600 hours to serve over 500 hot lunches and provide games, crafts, movies, karaoke and fun bingo to area residents. It was a huge success.

Representative **PETERSON**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. It is my great pleasure to speak today to honor a Maine native that has been a hero of mine for many years. Mike Thomas Brown won a state championship in wrestling for Bonny Eagle High School before going on to wrestle at and graduate from Norwich University.

I met Mike 10 years ago. At the time, he was my brother's wrestling coach at the University of Southern Maine and had just begun competing in the sport of mixed martial arts, or MMA, a hybrid of martial arts disciplines. The super bowl of the sport of MMA was then and still is the ultimate fighting championship, or UFC, as it is more commonly known. When my brother introduced me to Mike, he said to me, some day we will be watching Mike on Pay-Per-View in the UFC. Sure enough, a few years later we sat at home and watched Mike, along with millions of other fans, compete in the UFC on Pay-Per-View.

Since then, Mike has gone on to fight around the world against the toughest athletes in this sport. He has fought in Japan and Russia and has attained multiple titles. But the real highlight of his career came back on November 5, 2008, a day after the election. Mike faced the then champion of the world, at 145 lbs, and went into the fight as a severe underdog. Mike, to everyone's surprise, except those that knew him, flipped the MMA universe upside down by defeating the champ in less than two and a half minutes and claiming the title as his own. He most recently defended his world championship by stopping his challenger, this time in less than two minutes.

I could go on for hours about this man's athletic accomplishments, but the real gift of Mike Brown is his humility, his kindness, and his commitment to chasing his dreams. Despite countless challenges, setbacks, injuries and uprooting, Mike never stopped dedicating himself to going for more, not just in sport but in life in general. Mike Brown has inspired me to stay focused, stay disciplined, and to stay inspired. He is set to defend his title from the man he took it from on June 7th. We wish you good luck and Godspeed, and I love you brother.

The SPEAKER: The Chair recognizes the Representative from Waterville, Representative Trinward.

Representative **TRINWARD**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. This is a resolution proposing an amendment to the Constitution of Maine regarding early voting. Early voting is the time period before an election, during which voters have an opportunity to cast a ballot at a designated voting place within their municipality in the same manner as Election Day. By the same manner, I mean that voters walk in; they check off their name on the list; they receive a ballot; they go into a voting booth; they leave the voting booth and they cast their ballot, which means in some municipalities they put their ballot into an optical scanner, in other municipalities they drop their ballot into the ballot box. This is different than absentee balloting, where you put your ballot into an envelope to be processed later.

The 123rd Legislature authorized a pilot program on early voting. It was provided for three communities in the State of Maine. It was a huge success and tremendously popular. It provided convenience in ease of access to voting. Maine consistently ranks among the states with the highest voter turnout. I am very proud that the citizens of Maine continue to remain so active in our political process and, as long as I am in

the Legislature, I will work as hard as I can to continue that policy.

Early voting is just another tool that has helped to increase voter participation in our elections. Thirty-one states now already allow early voting, it streamlines the ballot process, it helps by reducing errors, by reducing the number of times that absentee ballots are handled and dealt with. I urge all of you to support this amendment today for early voting, and I wish to call for a roll call.

Representative TRINWARD of Waterville **REQUESTED** a roll call on the motion to **ACCEPT** the Majority **Ought to Pass as Amended** Report.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Standish, Representative Shaw.

Representative **SHAW**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I urge that you support this measure. Three years ago, I was involved in an election where I originally won by 13 votes. A lot of the ballots that were cast that night were absentee ballots. People, generally, would go into the town hall, ask for their ballot, go off to another room and mark the ballot, then fold it up and put it in an envelope and give it back to the town clerk. Essentially, they were doing exactly what we are talking about here, except the ballot wasn't run that night. All the envelopes were taken to the voting place at the local school, the envelopes opened, the ballots run.

The problem that night, they were having problems with the optical scanning machines, where the creases in the ballots were getting gummed up in the machine. If the people had just been able to take the ballot and stick it into the machine the day they went to the town hall to vote, where they were going to the town hall to do their absentee vote, if they hadn't had to fold it all up and stick in the envelope, a lot of the problems of that night would have been resolved.

I ended up losing the election by six votes after a recount. There was a swing of 19 votes. A lot of that could have been taken care of if they had the early voting option at that date. Problems with the voting machine were only because of the creases in the absentee ballots, so I would urge the members of the House to adopt this early voting. Thank you.

The SPEAKER: The Chair recognizes the Representative from Pittsfield, Representative Fitts.

Representative **FITTS**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. We are talking about changing Election Day to Election Ten Days. There will be no opportunity to practically watch the polling place to ensure that things are being done properly. We have today opportunities for poll watchers and those opportunities keep election fraud from occurring. This would eliminate, for a great part, any opportunity to prevent anything negative from happening and the contamination of a ballot box. One bad ballot spoils an election, remember that.

This issue of absentee voting and folding of ballots, there are many opportunities to correct those problems. The Secretary of State's office has those opportunities by getting bigger envelopes. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Scarborough, Representative Flaherty.

Representative **FLAHERTY**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I rise to support this piece of legislation. As some of you may know, the Town of Scarborough has been doing early voting for a number of election cycles. This year, we had over 90 percent turnout in the Town of Scarborough. Over half of those people voted early. Early voting enables people to prevent themselves from waiting in line. This will help people who work through the day, senior citizens who can't stand up in line, they will be able to come, vote early, cast their vote, engage in the civic process. This bill will only do more to encourage more people to vote and that is always a good thing. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Russell.

Representative **RUSSELL**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I would like to urge my members to support this initiative. For one thing, we are already doing this in many ways. We are already allowing people to vote early, we are just calling it absentee voting. The only difference that we are advocating for is that, currently, you put your name and you sign your name to the absentee ballot. What this would do is to allow you to put that ballot into a machine or into the ballot box.

One of the reasons this is important is that people need to know that their vote counts. There is a myth out there that absentee votes don't matter, that they are not counted unless it is absolutely necessary, and in a state like Maine where we do take pride in our voting turnout, we do want to make sure that everybody understands and knows that their vote counts. More importantly than that, they need to understand that there is a sanctity to that vote. What this does is to create a separation between someone's name and their vote.

Currently, when you absentee vote, you write your name and you sign your name on that ballot. That causes me concern because I really feel strongly that we should have the right to a secret ballot, and when the vote is no longer secret, and I put full confidence in my registrars and in my city clerks that they are not tracking how I am voting and what I am voting for; however, there is an appearance that there is not a secret ballot. Frankly, someone could come up and open my ballot and know who I am and say, oh gee, I wonder who they voted for? We all have small towns that we grew up in or we live in, we know how small towns work. Think about it here in the Legislature: Well, so and so didn't vote Democrat, or so and so didn't vote Republican. Come on, we know this happens. So what this does is to make sure that you have a secret ballot and that everyone in this state has a secret ballot, which they don't really have right now. So all we are asking with this constitutional amendment is that people be able to separate their name from their vote and to be able to make sure that vote counts.

This is a process issue; it does not change the entire paradigm by how we vote on any level. It is a simple process issue. We are already doing this; we are already allowing people to vote early through absentee voting. All this does is to protect the integrity and the sanctity of that secret ballot, and to make sure that people understand and recognize and know that their vote counts. They are not just handing someone an envelope, they are actually putting the ballot into a machine or into a box, of which is entirely secure. So Ladies and Gentlemen of the House, I ask and urge that you vote in support of this constitutional amendment. It protects the integrity of the voting process and opens the doors for folks who want to be able to vote by secret ballot. Thank you very much, I appreciate it.

The SPEAKER: The Chair recognizes the Representative from Mexico, Representative Briggs.

Representative **BRIGGS**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I am an employee at the Town of Mexico, and I have done this process through absentee balloting. Because of the last couple of elections, of course, I can't even go near the ballots, and I see my coworkers doing this process on a daily basis, and it is a lot of work for them. It is a lot of added work for them.

I think it would be really great; it would be convenient for them to allow the people, when they come into the town office, to be able to just slide their ballots in the machine, we check them off that they have voted, and they don't have to go through the long process of filling out the absentee envelopes. The town clerk, she has a registrar that she has to keep every day when somebody comes into vote, she has to write their name down, she has to acknowledge all of the documentation. This would be much more convenient for the clerks and the employees doing this on a daily basis. It would be really helpful in order to do it in this manner. As Representative Russell has just stated, they are doing it anyway as far as voting. It is going right into the machine and it is a done deal. I am in strong support of this, and I would appreciate everybody else following my light. Thank you.

The SPEAKER: The Chair recognizes the Representative from Alna, Representative Fossel.

Representative **FOSSEL**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. This is my first time speaking, but it is something I feel strongly about. I think that more than anybody else in this chamber, I have been involved in close and controversial elections. I strongly feel that we need to reform the way we vote, we count votes and we recount votes, and I would strongly support us looking at the whole procedure. However, to do this piecemeal simply allows the problems we have to fester for one more election cycle, so I strongly urge you to turn this down. Thank you.

The SPEAKER: The Chair recognizes the Representative from Whiting, Representative Burns.

Representative **BURNS**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I rise in opposition to this bill. I don't propose to know what it is like in the larger communities where voting is congested, but I can speak to what it is like in small communities, and I think there is one thing that we do overlook from time to time and that is the importance and significance of that voting day. I see it time after time when people come to the polls, it is a significant day, it is a day that you bring your kids to the polls to learn about history, it is a day of importance, and I am concerned that if we lengthen the amount of time that you can come in and cast your vote, we take away from the significance and the importance of that heritage that we have in this country.

I know that we have made ample provisions for those who aren't able to get in there to the polls by the 45 day absentee voting, and I think that is very good, I think all clerks go out of their way to accommodate those folks that can't get in or, for other reasons, aren't able to come in. But that voting day is a very, very important day, and I think to protect the integrity of the voting process, it needs to be done on that day. When you come in, you have to stand in line a little while, but you exercise your constitutional rights to cast your ballot. I think that when we diminish that, we are taking away from our heritage. Thank you.
