The SPEAKER: The Chair recognizes the Representative from Old Town, Representative Blanchard.

Representative BLANCHARD: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. It gives me great pleasure today to speak about this very special lady who, in a few weeks, will become 100 years of age. She came here at the age of three from Quebec. She and her family settled in what was known back then as French Settlement, which is now known as West Old Town. A lot of people here are going to wonder why it was French Settlement. Well, the reason it was French Settlement is because my mom was raised there. Also, I think she met her future husband there. Later in life, they were married. She and her husband moved from French Settlement to what is now known as Treat and Webster Island, which was called, back then, French Island because 90 percent of the people that lived on that island were French speaking people. They raised four nice children. Her husband worked in most of the wood mills in town, the brush handle, the canoe shop, and she, for awhile, stayed home, raised her family, they always planted a big garden behind the house.

After the children had grown a little bit, I guess she decided she wanted to try to help cut the costs in the operation to the house, so she went to work. I think she went to work at the woolen mill, as what they called a sewer, which was basically a person that replaces what the weave did not do, as they would run the threads through. They only had a half an hour for lunch, these ladies, so on Friday, on pay day, most of these ladies would leave their jobs, head downtown, they'd eat their hot lunch on the half hour span before they left while they were on the job, they went down cashed their checks, paid the family bills, got back to work within the half hour. There was a nickname for these ladies and it was because they all walked very fast to get downtown. It was a nickname that came out and it was "the woolen mill gate."

After the mills closed, she continued to work, finally retiring at the age of 90. She was working at the Orono Nursing Home as a housekeeper with the housekeeping staff. However, after retirement, she did not slow down. She and her daughter walk about a quarter of a mile everyday from their home to downtown. Now it's not a very long walk, but coming back it's a tough walk, because there's a real steep hill to get back to the island home. Her daughter says "I can't keep up with her." Now on a bad day or a stormy day, they get into the car, they drive to the Old Town-Orono YMCA, and they walk the new track which is a quarter mile long, not just one time around but guite a few times. However, Mrs. Cloutier is still walking when her daughter is sacked. The other retirees and the other walkers are amazed because none of them can stay with her; she just walks right on by them. My comment would be that I think maybe the Olympics ought to have a special treat of people over 75 in a walking contest. If that would happen, I know Lucienne Cloutier would probably come home with the gold. She loves the Red Sox, and she says "I only vote Democrat."

It's been my good fortune to be able to know this lady for 48 years, the reason being, I happened to marry her niece. So to you, Aunt Lucienne, which I can call Aunt now, I wish you a very, very happy birthday on your 100th and hope that you have very many more.

Dr. Hoenig serves on the United States Department of Agriculture Secretary's Advisory Committee on Foreign Animal and Poultry Diseases and is a member of the American Veterinary Medical Association Council on Public Health and Regulatory Veterinary Medicine. He also serves as the Director of the Division of Animal Health and Industry in this State and as the State Veterinarian. Representative GILES: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I am pleased and proud to rise and speak in support of Dr. Donald E. Hoenig, of Belfast-although, locally, we know him as "Dr. Don"although I know him not just for his veterinarian achievements, but I know him more as a devoted husband, father and a community member. Don is a leading member on the Board of Directors for the Waldo County YMCA, and he was an instrumental member in helping build our first YMCA and create us a "Y with Walls", during the past five years. And he currently co-chairs a capital campaign for the Y to have a new pool. Don is a past high school soccer coach and led the Belfast Area High School Girls Soccer team to many championship victories. occasion, he finished the playoff game and then drove all night to be with his daughter to participate in the NY marathon the next day.

Professionally, I have heard Don speak about his experiences and with that, he is quite modest. So, I borrowed the following excerpt from the Bowdoin College Alumni magazine—Don is a 1973 Bowdoin graduate—and the following excerpt was written following one of his trips abroad to help with animal health issues in England, and I'll read from that:

"Don Hoenig was among the first U.S. veterinarians to arrive in England to assist with the Foot-and-Mouth Disease (FMD) epidemic March 2001. The United States sent over 400 state and federal vets to help with that crisis, and to learn from it. Preventing a similar outbreak in Maine is one of Don's responsibilities as state veterinarian. He is responsible for overseeing all livestock and poultry health and to prevent the introduction and spread of contagious disease, especially those diseases directly or indirectly transmitted to humans....

Don spends about half of his time on the road, visiting mostly with dairy farmers, helping them with quality issues. "Farmers are the hardest working people around," he says. "I have a real admiration for their work ethic."

Don has worked in his capacity with the State of Maine since the mid-1980's when he and his wife, Lynn, decided they wanted to live on a small farm in Belfast and raise their three children. Today, I am very pleased to honor Don with this Legislative Sentiment. I am even more pleased that he and his wife could be here with us today, and I congratulate him on his achievement and thank both he and Lynn for being a part our Maine community.

The SPEAKER: The Chair recognizes the Representative from Bremen, Representative Pieh.

Representative **PIEH**: Thank you, Madam Speaker. Madam Speaker, Men and Women of the House. I rise on behalf of the Agriculture, Conservation and Forestry Committee to thank Dr. Hoenig. He's been tireless as a state vet helping us win issues we need. He also helped at a national level to get funding, so that folks that come back here, take veterinary medicine and come back and get some help with their loans and grants for financing their school expenses, and he really has been willing to go anywhere. He'll come to our committee at any time to talk to us and answer our questions about what's going on in the world of agriculture in Maine or the country or the world, and I have almost forgiven him for being a Yankees fan.

The SPEAKER: The Chair recognizes the Representative from Caribou, Representative Edgecomb.

Representative **EDGECOMB**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. Dr. Hoenig has provided quality information and testimony to the Ag Committee on numerous occasions, whether he's telling us about animal diseases or his visit to the poultry farm in Turner, it's always been extremely helpful. As a matter of fact, when he gets done, you say, wow, that was really interesting and informative. Representative Pieh kind of got a step ahead of me, but I want to tell you the respect that he has for this body. When you have an opportunity to see him in the gallery, you'll notice he will not be wearing his Yankees hat.

Jacob R. Paul, a citizen of the Penobscot Indian Nation, born and raised on Indian Island, for his contributions to his community and State. The son of Michael and Terri Paul, Jacob has been a leader throughout his life. In 1999, he received the National Native American Indian Student Eagle Awards: the Jim Thorpe Award, the Outstanding Leadership Award and the Community Service and Spiritual Leadership Award. Jacob has excelled in school as an honor student and was the runner-up in the Bangor Daily News Spelling Bee in 2003-2004. In 2005, he won first place in the Wabanaki Art show. During his school years, he excelled in sports as well as academics, playing Youth Basketball, Little League and football and participating in crosscountry track. In his senior year, Jacob was an All-Star 1st Team Offensive Tackle and 2nd Team Defensive Lineman and was chosen as an All-Star Senior Player in the Annual Maine Shrine Lobster Bowl Classic, which raises money for the Shriners Hospitals for Children burn care centers. Also in his senior year. he was a spring track senior-year player in the shot put, javelin and 4 x 100 relay. He was chosen to play at "Close Up" in Washington, D.C. Jacob has an extensive and exemplary involvement with his community as a member of the Penobscot Nation Tribal Youth Group and as a volunteer at the Penobscot Nation Boys and Girls Club, helping to build the "Medicine Path Boardwalk" so that community youth and other nonnative people could learn Tribal medicine plants. He also helped plan and participated in the first Penobscot Nation Boys and Girls Club "National Night Out," an evening during which youths are encouraged to volunteer and become involved in the community and to find paths other than those of crime and drug use. The SPEAKER: The Chair recognizes the Representative from Orono, Representative Cain.

Representative CAIN: Thank you, Madam Speaker. It's amazing how fast something that you've worked on for so many hours arrives on your desk in one fell swoop. I think I calculated. and I believe the Appropriations Committee has logged nearly 1,000 hours on this one document, and now it arrives not even filling a single sheet of paper on our desks. But it's important to not let this moment go by without acknowledging the work and the reality of what LD 353, as amended, really represents. Shortly after the strong vote on engrossment last evening, a colleague in the chamber said to me, well you must feel happy now. I guickly answered, no, not happy. This budget is not a budget that anyone feels happy about; however, I am proud of the work and extremely proud of the process that got us here. and that's exactly how I feel. This budget is not a document that either party will or should point to as defining their principles. priorities or agendas. I hope that we can all point to this budget and say that this is a moment where we put partisanship aside, rolled up our sleeves and got the job done, because it was the right thing to do for the great State of Maine. This is a very responsible budget. It is a reflection of the current economic

times, and, considering the recession, I am proud that this Legislature is meeting the challenge in a bipartisan, thoughtful way, by working to minimize layoffs, protect services to those who need them most, and taking every opportunity to use this crisis to look for efficiencies and opportunities for savings that will improve the quality of state government long into the future. But there is still work to be done, so we cannot pretend that this vote is a cadence to the final chord, but rather the close of one movement and the start of another round of very difficult work that begins right away.

While I may be of only a few who speak often and in great detail about this budget. I do not do it alone and many thanks are in order, Madam Speaker. First, the amazing Appropriations and Financial Affairs Committee, I can only say thank you. We have 13 members who bring their own unique perspective, experience and passions to the horseshoe every single day in our committee room. Every single member contributed significantly, worked for nearly 1,000 hours on this budget, and I can personally say that all of the members of the committee taught me something along the way, since January. Special appreciation goes to the Representative from Waterford, Representative Millett, who's vears in state government number more than my age, but who has only treated me with the utmost respect and as an equal throughout this entire process, and that has made all of the difference. I also must thank my Co-Chair from the other body. the good Senator from Cumberland, Senator Diamond, whose thoughtful approach to this budget and to working as a team also made the difference. He is a cowboy, a gentleman, and a person of outstanding integrity, and it was our different but very complimentary dispositions that helped move this process along. But our team extended beyond the 13 members of the Appropriations Committee. Great thanks is due to the Commissioner of the Department of Administrative and Financial Services, Commissioner Ryan Low, and State Budget Officer, Ellen Schneiter. Ryan and Ellen put in as many hours as we did and then some. I'm quite certain their families will be very excited to get them back, although, don't get you used to it, because we're going to need you just as much as we continue the work ahead. The Office of Fiscal and Program Review, particularly Maureen Dawson and Grant Pennoyer, the entire team of that office supports all of your committees, but our committee especially relies on their expertise and their experience to help navigate us through what is a very complex web of finances, policy, and blood sweat and tears that go into a budget document, and I owe them great thanks.

I'd also like to thank leadership on all sides for their willingness to let the Appropriations Committee do our work. They put a lot of trust in us and I believe we rose to that challenge and I hope exceeded expectations along the way, but we were only allowed to do that, we were only able to do that because the leadership on all sides said we trust you, and I know that I took that trust very seriously and I believe all the members of the Appropriations Committee did as well. I will thank, again, the policy committees, who I thanked yesterday but it's worth mentioning again. As one member of the press said to me this morning about last night's vote, well that was quick, and I said that's only because so many hours have already gone into this Every policy committee had their hands on a significant portion of it along the way, and I believe that is the reason we were able to take the final step forward with a unanimous vote from the Appropriations Committee last week, when many said it could not be done.

Finally, Madam Speaker, I think it's important again to recognize that this is only the beginning of our work. It's my hope that we have set the tone and we have raised the bar on how

budgets can be done in this body and in the great institution of the State of Maine's Legislature. Bipartisanship is kev. communication is key, transparency is utmost, and we tried to honor all of those things at every step of the way, every single day in the Appropriations Committee since January. It is my pledge to all of you to continue that work with that spirit, with that transparency, with that communication, with that bipartisanship as we go forward. In my opinion, it is the only way we navigate through the tough waters that we are in right now. You only need to look at the headlines of other states to see that Maine is really doing it the right way, Maine is really getting the job done and setting a standard for other states. So I'm not happy, but I am proud. I'm not excited, but I am optimistic for what lies ahead for Maine, and I believe that LD 353, as it sits before us now, after the thousands of hours of work, is the right step at the right time to help keep Maine on track and make sure that, when things do get better, we will be ready to take advantage of the growth and of stronger economic times ahead. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Waterford, Representative Millett.

Representative **MILLETT**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I think our House Chair has covered everything that needs to be said, relative to both the process, the results of our work and the challenges that lie ahead. I appreciate her kind comments. I only wish she could have chosen something other than a reference to my chronological maturity, but be that as it may, I want to say back at you. Representative Cain, it's been a pleasure to work with you and your Co-Chair, the Senator from Windham, Senator Diamond, in an extremely comfortable and cooperative working relationship. I'd also like to thank the four members of my caucus on our side of the aisle: Representative Nutting, Representative Flood, Representative Robinson, and the good Senator from Bucksport, Senator Rosen.

I agree with the comments that Representative Cain has made about the challenges that lies ahead. All we need to do is look at the revenue report that was on our desk vesterday to become a little concerned at the immediate future as well as the long-term recovery that we are so uncertain about. nearing the end of this year with little over a month to go, and we're closing in on the revenue re-projection downward and closing in at a point that I'm seriously concerned about. Be that as it may and given all the work that has gone into this budget and the recognition of the difficult times that lie ahead. I think we are well positioned to continue our work and, should the challenges arise immediately, I believe we're qualified and capable of accepting them. So I want to thank all members of the committee, including the other five members of the Democratic membership, including the longest serving member of the House, the Senator from Eagle Lake, who has mellowed considerably over the years and was truly a joy to work with this year. Thank vou all.

The SPEAKER: The Chair recognizes the Representative from Newport, Representative Tardy.

Representative **TARDY**: Thank you, Madam Speaker. Madam Speaker, Members of the House. Good morning. Madam Speaker, my decision to support this budget, as you know, was not made in haste. When you and I met several months ago, we agreed that the Chief Executive's proposal, as laid out in LD 353, would need thorough deliberation, that in order to best serve the people of Maine, an efficient but deliberate process would need to be undertaken, not the fast track that some people suggested. We needed to do this to create a better budget and one that could possibly get some Republican endorsement.

Madam Speaker, I'd like to thank you and the Representatives from Unity and Bowdoinham, Representatives Piotti and Berry, for your professionalism, for your good faith. I would suggest to this body that you are each skilled negotiators, who advocated passionately and vigorously for your core principles and your priorities, and you did so while, at the same time, listening to what we have to say in our core principles and our priorities. I, too, would like to thank the members of Appropriations, all members, for your service, and I'd also like to, in particular, thank the members from my caucus and my assistant, the good Representative from Madison. Service on Appropriations and leadership is a huge sacrifice. It's long hours, high stress, contention and controversy, both on a partisan basis and in an internal basis. I would just like to publicly state that my trust and confidence in the Republican members on Approps and my assistant is unequivocal. And I'd especially like to thank my good friend from Waterford, Representative Millett. I don't know what we could do in this state without your willingness to put yourself through this budget process.

Madam Speaker, budget making, in the worst recession of our time, is extraordinarily difficult, and I would respectfully suggest that this negotiated document has many flaws, makes revenue assumptions that will undoubtedly need to be revisited; it passes on many problems to the next Chief Executive, the next Legislature; puts obligations on municipalities to step up and share in the process of downsizing, rightsizing and streamlining, or additionally burden the property taxpayer; but I would suggest that this budget does begin the process. The trend towards rightsizing, that reflects the reality of our national and state economy. At over \$500 billion less, this budget is smaller than its predecessor, and I think that's one of the first times that's happened in decades. This budget has a streamlining commission that we on this side of the aisle intend to take seriously, and I would suggest, again respectfully, that that is a bipartisan confession that further cuts need to be made, that we need to make structural changes and downsize and more appropriately right size state government. The streamlining commission's goals are lofty but necessary. We've made structural changes in state employee health insurance and those were very difficult decisions to make. We've made significant structural changes in MaineCare. Did we go where we needed to go? I'd say no, but we did make positive steps toward getting our welfare system closer to the national average and moving the size of government in the right direction, and I think, importantly, this negotiated budget reduces the tax burden compared to the Chief Executive's original proposal. To the income taxpayer, the negotiated product is an improvement; to the property taxpayer the negotiated compromise is an improvement. From any partisan standpoint, there's a lot in this budget not to like, and I respect every individual member of this body right to vote yea or nay, and I think my caucus notes that, but we have heard this saying that perfect should not be the enemy of good. I think it's more appropriate, in this context, to say that good should not be the enemy of reality and necessity.

Madam Speaker, I don't understand this recession. I don't know when it's going to change. The common indicators aren't encouraging—bankruptcy filings, foreclosures, food stamp applications, those are all bad indicators—those are up and this recession has had a profound personal impact on me. Businesses are closing, and I believe times are going to get worse and we will be back dealing with this. I believe that we should hope for better times, and I appreciate the hope and optimism expressed yesterday and today by the good Representative from Orono, but I urge the members of this body to prepare for heavier lifting and far more difficult times. You

know, as leader, Madam Speaker, I need to look at myself and members of my caucus and answer the question is this my best effort and is this our best effort? To my constituents and the people of Maine, I have to ask that same question: is this my best effort and is this our best effort? To the employees of Moosehead Furniture, who in recent months have endured pay cuts, reduced hours, elimination of health insurance benefits, whose neighbors and relatives in nearby Guilford have lost their jobs, I have to ask is this my best effort, is this our best effort? Madam Speaker and members of the House, after thorough deliberation and much, much heartache, my answer is yes. In the absence of the ability to unilaterally make policy, but in recognition of our obligation to shape it, LD 353 has my support and I will be voting yes. Thank you.

The SPEAKER: The Chair recognizes the Representative from Unity, Representative Piotti.

Representative PIOTTI: Thank you, Madam Speaker. Madam Speaker, Men and Women of the House. Our State Constitution is fairly clear: We're required to enact a balanced budget and, in a few moments, we'll take that action, but that simple step doesn't reflect the incredible amount of work, toil that has gone into this process. So I too would like to chime in and thank the many people who have made what we're about to do possible, starting with the Chief Executive and his staff, most notably, Commissioner Low, phenomenal efforts; extending that to the members of leadership, who have put in a lot of time in good faith, not always agreeing, but certainly be willing to work together; and I extend a hand to our colleagues, the Representative from Newport, Representative Tardy; the Representative from Madison, Representative Curtis. I, too, applaud and appreciate all of your efforts and good graces through this process. I also want to thank all of you because, as the Representative from Orono, Representative Cain, mentioned, this has been truly a work of everyone in this body. The policy committees laid the foundation upon which the Appropriations Committee could do its good work. Last, but certainly not least, I need to applaud, congratulate and commend the work of the Appropriations Committee. It's become almost a cliché that we're talking about this budget as something that's not great, this budget is something that has shared pain, and those statements are all true, but I view it as us having produced about as good a product as we could in these times. That has not been easy, and, again, I applaud everyone, but particularly the Committee on Appropriations and Financial Affairs and it's leadership, the the Representative from Waterford, Republican lead, Representative Millett, and our House Chair, the Representative from Orono, Representative Cain. Extraordinary work from all.

As I look around what's happening nationally and I see what's occurring in other states, we all know that the problems we're facing in these fiscal times are not our own, it is a national problem, but the mechanisms and the approach that we take to solve those problems vary, and I'm very proud of the bipartisan way we've worked together in this state, and I'm very proud of the manner in which we've tried to solve our problems. When you compare it to what's happened in other states, when you look at the number of layoffs that are occurring, when you look at the new taxes that are being proposed, I think we can be very proud in Maine that we have come to consensus. Sometimes the word compromise is a false word, it doesn't really show that good efforts have been taken but rather that people have caved in. I don't think that's the case here. I think here that compromise is consensus. I think here compromise has produced a better product. But as the Representative from Orono said, the work just begins here. As difficult as this was, this was something that we had no choice on. Our Constitution requires that we come to

resolution and, as I said, I'm proud of the resolution we have come to, but a lot of difficult work lies ahead on other matters before this body. I hope the same spirit of bipartisanship and cooperation will endure. I'm confident that it will, given what I know about the people in this chamber. I'm very proud of the work that's been done, I'm very proud with the way that Maine has dealt with this issue. Thank you all for your commitment to this state. Finally, Madam Speaker, I request a roll call.

Representative PIOTTI of Unity REQUESTED a roll call on PASSAGE TO BE ENACTED.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Ripley, Representative Thomas.

Representative THOMAS: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. A few weeks ago, I went to a town meeting in Ripley, and we went over our budget line by line. We had people who live on some of our gravel roads, who can't get to their houses in the spring. We didn't have the money we needed to fix that road so that they could get in and out. We've got paving projects that we had to do, we couldn't do them. Still, we're probably looking at a 20 or 25 percent property tax increase when the bills come out later this year, in large part due to school consolidation. consolidation, Madam Speaker, has cost Somerset County thousands and thousands of dollars in extra property taxes. We squeezed that budget for everything there was. There's not extra spending in our town budget. I talked to a business owner this morning and they have taken one paycheck since the first of the year, and they're wondering how are we going to pay our property taxes, and I wonder too, and this budget is going to push \$140 million more onto the property taxpayers of the State of Maine. I'm sorry, Madam Speaker. I can't push that much onto the property taxes. I'm going to push my red light. Thank you.

The SPEAKER: A roll call has been ordered. The pending question before the House is Passage to be Enacted. All those in favor will vote yes, those opposed will vote no.

In accordance with the provisions of Section 21 of Article IX of the Constitution, a two-thirds vote of all the members elected to the House being necessary, a total was taken.

The SPEAKER: The Chair recognizes the Representative from Wells, Representative Chase.

Representative **CHASE**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I live in a coastal town, we have three beautiful beaches, and there are a lot of living creatures that live along this beach that we protect on a regular basis, the Piping Plover is one of them, and some of the others that live there. Well, one of the species that we're not doing a very good job of protecting that live along the beaches are the human species right now, and the people that live along there love the ocean, love the beach, just like the animals that live there love the ocean and love the beach, and they want to protect their nests.

This is a bill that was a simple request for someone that lived along Drakes Island to be able to protect their home from some of the severe storms that hit along that area. Now there are seawalls that are there that are perfectly legitimate and they protect along the front, the frontal dunes, and they do the job that they're supposed to do. What this gentleman really wanted was to be able to put up a fence or replace a fence that he already had there, that so when the ocean came above that seawall and the rocks and the ice or whatever else happens to be thrown up and over that seawall and comes across his lawn and into the front of his house wouldn't destroy his home. His fence got destroyed in a storm, but it did protect his home. He requested to have that fence replaced and he was denied, and it was simply because this particular barrier, because you never know when a storm is going to come, it doesn't necessarily come in only the six or seven months in the wintertime, sometimes it can come in the fall equinox or before, and in the spring equinox when the moon is full and the tides are high, or sometimes I've seen it happen on just a regular storm that you wouldn't think was going to do anything, the sea just turns up and things are thrown above that wall and homes are damaged. This person just wanted the ability to be able to build a barrier fence, and this is just a simple little slatted fence that goes along the front of their home, but between them and the seawall on the already developed portion of their lot, they wanted to build and replace this fence and they were denied.

Now some of the reasons were because a barrier fence kept getting interchanged with the word dune to protect the seawall along the ocean, but this is not a seawall, this is a fence behind the seawall and in the developed yard of the person who lives there, and I'm asking you to really take rethinking this process and think about protecting some of the people that live there. We wonderfully protect all the other little creatures that live there, but you know what, humans live there too and their nests are just as important to them as a Piping Plover nest is to them, so I'm

asking you to rethink this Majority Ought Not to Pass and to vote it down. Thank you.

The SPEAKER: The Chair recognizes the Representative from Hudson, Representative Duchesne.

Representative DUCHESNE: Thank you, Madam Speaker. Madam Speaker, Men and Women of the House. This is the kind of bill that I really hate to rise on, because I feel the pain of these individuals who brought this bill forward. It's a very difficult situation when you live in that circumstance and the committee really wrestled with this for a long time looking for options.

The bill was brought forward to us to help two neighbors in Wells, whose houses are in a coastal flood zone and, in the past, this has been a very, very contentious issue, so contentious, in fact, that a few Legislatures ago, this was sent out to a stakeholder group which involved half of the free world, I think. There were an awful lot of people serving the stakeholder's group and they fought and wrestled for a very long time trying to come up with rules that would be protective of property rights, but also not so injurious to the coastal dune system that we were having impacts that we would be paying for later on. To give you some idea of what happens if you erect barriers in the wrong places, it can cause coastal erosion which impacts your neighbors, and it can impact tourism if you erode enough of the beach because, in that area of Maine, beaches are a significant part of the tourism industry. So these rules were crafted by a stakeholder group, they were passed. I believe in the 122nd Legislature, and they've been in place ever since. They did grandfather a lot of the previous fences and a lot of what was currently on the coast. This bill would remove that part of the grandfathering exemption so that anybody who is in the situation that these two residents were would now be able to build fences. The problem is this may in fact work in that location and have very few impacts. But, once again, this is a law for the entire State of Maine, and we don't know how many other people, under this bill, would now be able to build fences and cause significant impacts to the tourism industry and to other neighbors, and, without that kind of knowledge, it was really difficult for the majority of the committee to go along with this bill.

The other problem, I think, that the majority have to deal with is that there are other options that were presented to these owners. They could create a dune in front of the house instead of a perpendicular barrier fence, but they, for their own reasons, declined to do so. Since they did not decide to go with the other options, or at least pursue them, the majority of the committee decided this was a bill that Ought Not to Pass. Thank you, Madam Speaker.

I noticed that whenever you can illicit a soliloguy from Representative Duchesne, you've probably accomplished your goal that was worthy of the Merchant of Venice to listen to him speak. However, I hope that you listen very carefully to the Representative from Wells, Representative Chase. She outlined it very eloquently, the problem that is facing these two elderly couples. They have a home on Wells Beach. Because of, I believe, the Patriot's Day storm a few years ago, the water from the ocean did come in and erode their front lawn badly. They were simply asking—they were denied the permit initially—they were simply asking that we allow them to build a barrier so that their front lawn would not be washed away. There are barriers on both sides of their home. They showed us pictures. It was very plain to see that a simple barrier would have solved their problem. It was beyond understanding as to why they were not allowed to simply build this structure so that their vard would not be washed away. It would not have hurt the Piping Plovers in any way, the Piping Plover's nest and sand dunes, and not in the littoral zone or the zone between high tide and low tide. I ask you to please allow these people, these elderly people who don't want to see their home washed away, the ability to simply put this wall up. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Oxford, Representative Hamper.

Representative **HAMPER**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. The Representative from Wells did a very good job of defining the issue here. I would love to be able to talk about the narrowly crafted Minority Report, but I can't do that at this time, so I just rise to ask you to defeat the Majority Ought Not to Pass and let's give the Minority Report a chance to be heard. Thank you very much.

The SPEAKER: The Chair recognizes the Representative from Newcastle, Representative McKane.

Representative McKANE: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. resolution proposes to amend the Constitution of the State of Maine to limit increases in property taxes to the rate of inflation, quite simple. I'm not going to hold my breath that we will get a two-thirds vote here today, but I think it's an important issue. We have all heard about property taxes from our constituents, I think I can say that with confidence, and it's not secret to anyone in the room the anguish that property taxes cause among Maine citizens. Our property taxes in this state are among the highest in the country and continue to rise dramatically, especially along the coast. State and local governments and school systems that continue to spend beyond the rate of inflation are the culprit, not so much the state this year, perhaps, but then again, we are shifting a lot on to property taxes this year and we're going to be feeling next year and the year after. As one municipal official put it, our expenses go up faster than inflation, so I don't quite understand that, but that was one of the reasons that they should be able to have no limits on property taxes. Another one said this could tie the hands of municipal government. Maybe that's not such a bad idea. The Maine Municipal Association, who are paid for by our property taxes, were the only ones with opposing testimony. Maine homeowners are helpless to this system and must simply pay these ever increasing property taxes or sell their homes. When someone purchases real estate, usually their biggest lifetime investment, I believe they should be able to predict far into the future what the expenses of that property will be. We know what the mortgage payments will be, we have a good idea what maintenance and insurance will be, but we really can't say what our property taxes will be, even next year. Property taxes need to be stable, predictable and fair. With income taxes, if you earn more you pay more. With sales taxes, if you spend more you pay more. But with Maine's property taxes you pay more if your evaluation increases, or if the state decides to allocate less money and GPA, or when the government and education spending continues to rise, but not because of something you are directly responsible for.

Property tax caps have been very successful in other states, Massachusetts is a model. Massachusetts implemented a cap in 1980. At the time, their property tax burden was second only to New York. Now they rank in the middle of the pack nationally. They shed the "Taxachusetts" label. Capping property taxes doesn't seem to affect education results. In 2007, Massachusetts school children outscored every other state in the country on three of the four National Assessment Educational Progress exams and tied for first on the fourth. The average SAT score for Massachusetts' high school students was 29 points above the national average, 61 points above New York's average, with essentially the same percentage of students taking the tests. California's famous Prop 13, passed Prop 13 back in 1976. It has been extremely successful, Madam Speaker, and considered the third rail of California politics because of its popularity. Proposition 13 has provided predictability for property owners and it has increased community stability. Supporters argue that while the progressive income tax may take higher incomes, property taxes take a higher percentage of lower incomes, especially for those people who own highly valued property but have lower incomes, and that is often the case here in Maine where, along the coast, we have ancestral homes, they are valued very high but the incomes do not match the evaluations.

In 2004, the Polesky Tax Cap Initiative was defeated at the polls in Maine for primarily two reasons: One was that the initiative was simply too extreme. It contained a retroactive clause that would have taken evaluations back ten years. The other reason that the Polesky Tax Cap Initiative failed was that the people of the state had been promised real property tax relief with the MMA referendum, which passed in June 2004. The referendum directed state government to pay for 55 percent of the costs of education and 100 percent of the cost of special education. The result, in January 2005, was LD 1, along with the promise of bold and historic tax relief. This has not been the case. The Department of Education continues to shift expenses that were formally 100 percent funded by the state onto the backs of property taxpayers by including these programs in the EPS formula. Also, as we well know, minimum receiver districts got their promised 100 percent allotment cut in half last year. The promise of bold and historic property tax relief simply has not happened, especially on the coast. Programs such as the Circuit Breaker Program, Homestead Exemption, Working Waterfront, Tree Growth, etcetera do help, but participation in the Circuit Breaker Program, however, is only around 50 percent around those eligible, and the Homestead Exemption is really only a small amount. Working Waterfront helps only a select few. More needs to be done, yet our most recent budget has cut back on these programs also. LD 840 is real property tax reform, will provide real relief that this Legislature keeps promising but never really accomplishes. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Bath, Representative Watson.

Representative **WATSON**: Thank you, Madam Speaker. Madam Speaker, Men and Women of the House. This measure would simply strangle municipalities. It's as simple as that. If you don't feel that municipalities can treat their own budgets with responsibility, that municipalities have no care for how taxpayers face and pay their property taxes and increase their taxes year to year, then you can vote for this measure. It's really kind of like trying to pass a constitutional amendment to stop the rain today. If the good Representative from Newcastle, Representative McKane, really feels that Proposition 13 accomplished such great things in California, then I wonder why California is currently laying off 5 percent of its government employees, is facing a multibillion dollar deficit and is likely to go bankrupt unless things can change out there quickly. We don't need this kind of measure. It's a nice thing to talk about, but it's not workable and I

encourage you to support the Majority Ought Not to Pass Report. Thank you, Madam Speaker.
