# JOINT RESOLUTION MEMORIALIZING THE PRESIDENT OF THE UNITED STATES AND THE UNITED STATES CONGRESS TO ENACT THE LYME AND TICK-BORNE DISEASE PREVENTION, EDUCATION, AND RESEARCH ACT OF 2009

WE, your Memorialists, the Members of the One Hundred and Twenty-fourth Legislature of the State of Maine now assembled in the Second Regular Session, most respectfully present and petition the President of the United States and the United States Congress as follows:

WHEREAS, Lyme disease is a common but frequently misunderstood illness that, if not caught early and treated properly, can cause serious health problems; and

WHEREAS, Lyme disease is a bacterial infection that is usually transmitted by a tick bite, and early signs of infection may include a rash and flu-like symptoms such as fever, muscle aches, headaches and fatigue; and

WHEREAS, although Lyme disease can be treated with antibiotics if caught early, the disease often goes undetected because it mimics other illnesses or may be misdiagnosed and, if untreated, can lead to severe heart, neurological, eye and joint problems because the bacteria can affect many different organs and organ systems; and

WHEREAS, although Lyme disease accounts for 90% of all vector-borne infections in the United States, the ticks that spread the disease also spread other diseases such as ehrlichiosis, babesiosis and anaplasmosis; and

WHEREAS, the federal Centers for Disease Control and Prevention indicates that the reported cases of Lyme disease are only 10% of actual cases that meet its surveillance criteria and has reported 27,444 new cases of Lyme disease in 2007, a 38% increase from the year before; and

WHEREAS, the persistence of symptomatology in many patients without reliable testing makes treatment of patients more difficult; and

WHEREAS, the Lyme and Tick-Borne Disease Prevention, Education, and Research Act of 2009 has been introduced in the 111th United States Congress as H.R. 741/S. 1352; and

WHEREAS, the Lyme and Tick-Borne Disease Prevention, Education, and Research Act of 2009 would advance the treatment of, and cure for, Lyme disease and other tick-borne diseases by expanding federal efforts concerning prevention, education, treatment and research activities related to Lyme disease and other tick-borne diseases by providing authorization for the appropriation of \$20,000,000 for each of the federal fiscal years from 2010 to 2012 for these activities; and

WHEREAS, this legislation would also require the United States Secretary of Health and Human Services to annually report to the United States Congress on these activities and make recommendations for further research and education and would establish the Tick-Borne Diseases Advisory Committee within the Office of the Secretary, United States Department of Health and Human Services; now, therefore, be it

RESOLVED: That We, your Memorialists, on behalf of the people we represent, respectfully urge and request that the President of the United States and the United States Congress enact the Lyme and Tick-Borne Disease Prevention, Education, and Research Act of 2009, which is currently pending in the United States Congress; and be it further RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable Barack H. Obama, President of the United States, to the President of the United States Senate, to the Speaker of the United States House of Representatives and to each Member of the Maine Congressional Delegation.

The SPEAKER: The Chair recognizes the Representative from Kennebunk, Representative Legg.

Representative **LEGG**: Thank you, Madam Speaker. Madam Speaker, Men and Women of the House. This is a culmination of an effort to promote education, to dispense information and, particularly in this Joint Resolution, to do research on Lyme disease, which has been neglected far too long and is growing at a terribly rapid rate throughout the country, but particularly here in Maine. I want to thank the members of the York County Advocacy Group and Cumberland County Delegation, both bipartisan, for helping with this effort. It is very important. It now exists in every county in the State of Maine and is growing.

This is a Joint Resolution to request federal funding for the bill that is being presented and supported by the entire Maine Delegation to do research. And for the first time, we have a chance to really begin to diagnose this disease and treat it properly, particularly the long-term version. So I thank you for your support and those who signed on as co-sponsors and urge you to support this Joint Resolution. Thank you.

## JOINT RESOLUTION MEMORIALIZING THE UNITED STATES CONGRESS TO ENACT A STRONG FEDERAL CLEAN ENERGY AND CLIMATE BILL

WE, your Memorialists, the Members of the One Hundred and Twenty-fourth Legislature of the State of Maine now assembled in the Second Regular Session, most respectfully present and petition the United States Congress as follows:

WHEREAS, not only the State of Maine, but the United States as a whole, is now facing historic energy and climate challenges, particularly economic and environmental challenges, that are a result of our overdependence on fossil fuels; and

WHEREAS, citizens of the State of Maine are finding it increasingly difficult to heat their homes affordably, and federal action on our energy and climate is long overdue; and

WHEREAS, the Federal Government must act quickly to develop and implement a clear climate and energy policy; and

WHEREAS, Maine has the oldest housing stock in the nation, and 80% of Maine homes are heated with oil, and Maine people suffer major financial hardship during periods of price volatility; and

WHEREAS, the Central Intelligence Agency has created a center on climate change, the United States Marine Corps plans to reduce its carbon emissions by 30% by 2020 and the United States Navy is reducing its carbon pollution on homeland bases by 50% by 2020 and launching a clean energy battle group by 2016; and

WHEREAS, Maine's industrial sector is struggling with its energy costs, putting hundreds of good jobs at risk throughout the State; and

WHEREAS, having access to efficient energy, using the cheapest and cleanest form of energy and properly weatherizing buildings would create jobs and reduce energy consumption and energy costs for the vast majority of the people of Maine; and

WHEREAS, Maine has created the Efficiency Maine Trust to coordinate energy efficiency efforts across the State; and

WHEREAS, Maine is a leader in renewable power research and development, is successfully migrating from fossil fuels to nonfossil fuels and indigenous and renewable resources and has a plan in place to develop significant inland and off-shore wind farms as a means to create jobs, reduce our carbon impact and produce clean, renewable power; and

WHEREAS, Maine must become a leader in the energy sector with a workforce prepared with the skills and information necessary to attract strong, vibrant businesses; and

WHEREAS, the American Clean Energy and Security Act of 2009, which passed in the United States House of

Representatives, lays the foundation for solving America's energy and climate challenges; and

WHEREAS, this Act would increase the use of renewable energy, spur the development of a smart power grid, promote electric vehicles and require the implementation of energy efficiency measures; and

WHEREAS, the American Clean Energy and Security Act of 2009 will put Americans back to work building, delivering and installing the systems and technologies that will help us meet our energy and climate challenges; and

WHEREAS, in addition, 2 other major bills have been introduced in the United States Senate on this important subject, including the Clean Energy Jobs and American Power Act and the Carbon Limits and Energy for America's Renewal (CLEAR) Act; now, therefore, be it

RESOLVED: That We, your Memorialists, on behalf of the people we represent, respectfully urge and request that the United States Congress enact a strong clean energy and climate bill that:

1. Puts in place a carbon reduction standard that reduces carbon emissions by 17% below 2005 levels by 2020;

2. Dedicates revenues for energy efficiency and weatherization, giving priority to those states with the greatest need;

3. Ensures that states retain their authority to set higher standards than the Federal Government; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the President of the United States Senate, to the Speaker of the United States House of Representatives and to each Member of the Maine Congressional Delegation.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Russell.

Representative RUSSELL: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I want to thank those of you who got on board and supported the clean energy and climate resolution. One of the reasons that I ran for office originally was that I wanted to make sure that everyone could heat their home. I believe that heat should not be a luxury item and we have the oldest housing stock in the country here in Maine and we use 80 percent of our heating source through oil. So for me to get from heating my home to clean energy and climate was a long progression and I believe strongly that if we were to pass a strong federal clean energy and climate bill, we'd be able to fund the Efficiency Maine Trust far better than we are currently today. And if we can fund the Efficiency Maine Trust, it will put us in a position to be able to make certain that every Mainer has the right and the ability to afford to heat their home. So I want to thank those of you who have been kind enough to sign on board and I want to thank, of course, Representative Fitts for his work to help make this bipartisan, and we've gotten quite a bit of, don't laugh over there my friend, and we've gotten quite a bit of support for this and I just want to thank you.

The SPEAKER: The Chair recognizes the Representative from Dennysville, Representative McFadden.

Representative **McFADDEN**: Thank you, Madam Speaker. It is my pleasure to speak about the State Class C champions from Washington Academy. The Washington Academy Raiders have a very respectable basketball team, year after year, but have always fallen a little short of the State Championship. They have won a few Eastern Maine Championships, but never the State until this year. They have a new coach, but basically the same team as a year ago. Each and every player on the team will tell you the coach makes a tremendous difference. We are not saying that previous coaches were not good coaches but, this year, Coach Pineo appeared to use a little different strategy than happened in the past. The Class C Raiders played several Class B schools and defeated all but one, and that one defeat was decided in the final seconds of the ballgame.

What made the difference this year? Most will agree it's teamwork and exceptional speed. The team that they defeated, Dirigo of Dixfield, is an excellent and exceptionally quick team but the Raiders were just a dite quicker. Let's not take anything away from Dirigo as they were the best in the west. It seems like Calais and Dirigo were battling each other year after year for the state championship. Now how did WA get there? They defeated Calais for the Eastern Maine and they defeated Dirigo for the Gold Ball. They won the championship with a dazzling display of defiance and quickness and, of course, they scored more points. That was guite important. I just want to mention also, this same group of boys from Washington Academy were the State Class C Soccer champions a year ago. So I'd like to congratulate Coach Pineo and the Washington Academy Raiders for a super year and bringing the Gold Ball back to Washington Academy and Washington County. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Whiting, Representative Burns.

Representative **BURNS**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. It is my distinct pleasure today also to help to honor the Washington Academy Raiders who are here with us in the chamber today. After a very exciting game on February 27<sup>th</sup> with their very capable opponents, the Dirigo Cougars of Dixfield, the Raiders won the State Championship in Class C Basketball. This is the first time in the school's long and distinguished history that this goal has been achieved. Although their team, as Representative McFadden mentioned, did bring home the gold in boys soccer last year.

Washington Academy is a very old school, some 218 years, it is steeped in impressive history, and was a school that started some 200 years ago as a prepatory school for Harvard University. Since that beginning there have been a lot of accomplishments, however today, I suspect, that one of the most important accomplishments to the group of men up in our gallery is bringing home the gold ball and the championship.

I am also very pleased to say that all five of my children and I graduated from Washington Academy and I also had the distinct pleasure of serving on their board of trustees for 19 years. So you can understand why I am so proud to help to honor them today.

This is not about me; it is about a group of young athletes, their managers and their coaches that came together as a team and as a "family". They put their personal and self interests aside for the good of the team and its goals. Other Raider teams have come very close in the past, as has been mentioned, having won the Eastern Maine Championship three other times, and even to the point of losing one of the championship games in an overtime situation in 1992. But that's another story for another time.

Washington Academy has had some of the greatest ball teams that we've seen in this state over the years, earning the well renowned title of the "Running Raiders" and this year was no exception. Coach Steve Pineo told me that when the season started, they knew that they had a big challenge ahead of them. His 15 players come from many different towns. Washington Academy has students from 25 different sending units, two other states and 16 foreign countries. Some of the team has played basketball against each other since pee wee and junior high school. Sometimes that can be a problem, but not this year. This year, it all came together. The team had 10 major goals, one of which was to beat their rivals, the Calais Blue Devils, and as Representative Perry knows full well, another great school and ball team in Washington County. They were the four time defenders of the Eastern Maine Championships. Another of those 10 goals was to "become a family" and work selflessly as a team. I believe that happened this year. When Senator Raye, Representative McFadden and myself had the privilege to attend the victory celebration back home, we listened to player after player give credit to each other and praise for their fellow team members and their coaches for their accomplishments, including coaches from other sports teams that they had participated in. One player even felt that his entire attitude had changed for the best through this past season. Remarkable I say, and that's why I believe this is much more than winning a basketball game. It's about learning priceless life skills, values and attitudes that will stay with them throughout their lives.

I would be remiss if I did not mention all the hard work, encouragement, long nights, bus rides, support and worrying that the team's managers, their coaches, the administrators and parents, especially the parents, have endured to get them here today. Their families and fans were also very supportive and faithful, following them all around the state, throughout the season. And I think most all of Washington County was down here for that tournament game and we were very happy to contribute to the economy here in Augusta. And though their coaches want no credit or recognition for their accomplishments, they have been mentors, the role models, the friends, as well as being their trainers. Yet Norm still took the time, despite all of his obligations, to talk issues, policies and campaigns with a kid. Not many people of this stature do the same.

His kindness continued even after he left office. Norm could be counted on for counsel and advice on crucial issues. Yet for all of his impact on our county and state, his achievements as a public servant are surpassed by that of a family man. He was married for 50 years to his lovely wife, Barbara, and was a father of four sons who went on to great achievement in their own right. Norm was indeed a special man who led a life worthy of emulation.

As a boy, I often heard him say a politician must stand up to be recognized, speak up to be heard and sit down to be appreciated. So with this in mind, I'll sit down in remembrance of Norm's legacy.

The SPEAKER: The Chair recognizes the Representative from Sangerville, Representative Davis.

Representative **DAVIS**: Thank you, Madam Speaker. I would simply echo the remarks of my seatmate here. When I came to the other body in 1998, Norm Ferguson was one of the first people that I met. The sentiment speaks to his honesty and his trustworthiness and I can't say more than that. He did have courage.

In regards to the St. Andrew's Society, he and the good Senator from Bangor, Senator Sawyer, wore kilts to session one day and that made things very interesting.

I visited with him last, last summer, and in his typical courage he looked in my face and he said, "Paul, I'm dying of cancer." And he knew it, but he faced it bravely and I would just extend, again, my sympathies to his family and ask that we close our session today in honor of him. Thank you.

So he was a wonderful person and he was a great colleague to work with and I just wanted to extend my comments on that as well.
