# ONE HUNDRED AND TWENTY-FOURTH LEGISLATURE SECOND REGULAR SESSION 29th Legislative Day Monday, March 29, 2010

Representative MAGNAN: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. There are people we remember who informed and shaped the adults we are today. All of us have that special teacher in mind. This is one of those teachers we would remember as smart, stern but fair, funny and the one with the eyes on the back of their head. the one who never misses a thing in her classroom. Charlene is one of those memorable teachers and hundreds of Searsport students will remember her for those things. The great thing is she's still at it today, Grade 5. But more than that, Charlene is one of those people with a great pride of place for her town and heritage, Searsport. Charlene has always had an interest in the history of Searsport and its people, and has taken the time and interest to the level of authorship. Charlene wrote a biographical profile of Searsport's Sam Houston, not the Texan of the Alamo. Searsport's Sam Houston was a Revolutionary War soldier who served in General George Washington's personal guard, a group of young men who were, by George Washington's own standards/orders, handsome, sober and orderly in their persons. So we get an instant image of a fine looking young man from Searsport who was called to serve his country. This profile of Captain Sam Houston, along with the memoir of Joseph Plumb Martin, Private Yankee Doodle, placed my District 41 in the spotlight of the average citizen solider of the Revolutionary War. Charlene has used the family diary and resources from the Penobscot Marine Museum Library and Archive for her research. We, historians, are grateful to Charlene Knox Farris for this insightful and well researched biographical sketch, and for her continued interest in activity with the Searsport Historical Society. I'm glad that we can take the time today to celebrate the achievements of Charlene Knox Farris, who is here today with members of the Historical Society, Dr. Karen Kelley, Valerie Murphy, Mary Brann and her husband, Rodney Farris. I am glad that we can do that and also celebrate her achievements as a teacher and author and historian, and as the first official town historian of Searsport. Finally, with Charlene's highly developed sense of humor and joy of a historian, actually being recognized while still alive, the irony can't be lost on her today. Thank you.

Shipwrecks and treasure tend to go hand-in-hand with adventure, but for Sub Sea Research the real adventure began when they realized the best treasure in the world could be found right here at home.

Following the devastating earth quake in Haiti, Gregory Brooks decided his ship, the Sea Hunter, had a higher calling. After collecting more than twenty tons of humanitarian supplies, the crew set off from Maine to bring those supplies to the victims of the earthquake.

Accustomed to navigating shipwrecks, rocks and stormy weather, the crew of the Sea Hunter spent weeks navigating

governmental red tape. While they went through trials and tribulations in Miami and off the coast of Haiti, Maine residents back home were right there every morning with each new column written by Bill Nemitz. Each new stalemate met by the crew was felt back home by readers riveted by the unraveling story. When the crew was frustrated in Miami, Mainers were frustrated back home. When the crew leaped for joy at the small hard-won victories along the way, Mainers back home were letting out cheers and tears in coffee shops, offices and homes around the state.

For Maine people, this was one of the greatest stories of determination and heroism in recent memory. The crew brought the values of Maine people with them to the frontlines of Haiti in a story that captivated our hearts and souls. Kudos to Greg Brooks and his crew for their heroism, and to Bill Nemitz for without whom this story, the greatest story, would never have been told. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Orono, Representative Cain.

Representative **CAIN**: Thank you, Madam Speaker. Madam Speaker, Men and Women of the House. This is a bill that I proudly brought forward to the Legal and Veterans Affairs Committee. I do recognize that it is a constitutional amendment. I do recognize that that requires a two-thirds vote of the House and the other body before going to the people for affirmation, but I think it's a point that is not to be missed during this legislative session and that's why I rise today.

Maine has been privileged with the citizen initiative process for nearly 100 years, and I would say, by enlarge, it has served us very well. It enables people to bring ideas forward no matter what they are, to put them before the people, to have a public debate, have them voted on and brought to the Legislature. It's a process that I believe in, but it's a process that I think is ripe for an opportunity to be improved and that's what this bill seeks to do.

This bill would ask the people of Maine to amend the Constitution so that it would say that when you bring forward an initiative, you not only must determine through the Office of Fiscal and Program Review what that bill would cost or what it would save, but if it was going to cost the state money, as part of your legislation you'd need to identify a funding source. Now this does not change the role of the Legislature. If you put forward a bill that sought to raise a certain revenue to pay for it, when it comes before the Legislature after it's been passed by the people, the opportunity for the Legislature to amend that bill in any way remains. This is not a new concept. Several states already require in their constitution that initiative proposals be fully funded. States like Arizona, Mississippi, Missouri and Nevada.

I was even more bolstered in my support for this concept last year after an article entitled "Exercise the Power, Play by the Rules: Why Popular Exercise of Legislative Power in Maine Should be Constrained by Legislative Rules" was published last year in the Maine Law Review by a former member of this body, the Honorable Jeremy Fischer. That article really brought home for me that this not only should be what we do but that it really is a better way for the citizen initiative process in Maine to be run. Just like when any of us bring forward any piece of legislation, we must identify a funding method that pays for our proposal to make sure our budget stays in balance.

Perhaps the greatest example of this in my short time, my six years in the Legislature, was during my first term when I, like many of you, we were elected for our first term on the heels of the 2004 June election related to 55 percent of the cost of education. We came in and in a very intense beginning of a very tough session, we had a select committee that quickly worked to identify how we were going to meet the challenge of 55 percent, and the word challenge may not be strong enough at this time that we knew then what was before us. If that referendum had included a funding source, it would have been a more honest choice for the people of Maine, as they would have considered not only what we wanted the state to pay for for education, how it would go back into property taxes, but that they would be assured that the Legislature would have no excuse when that would come before them the next session because a funding source could have been identified. It would have been a more fair and honest choice for the people of Maine to vote for that amendment knowing full well how it would be paid for. And instead, here we are nearly six years later not having met that obligation, going door-to-door, being in our districts, having that hung over our head left and right. I contend that it was not a fair question to begin with and I contend that this Legislature, that Legislature, any Legislature would have more opportunities to address the concerns of citizen initiatives if they were presented in a way that was more consistent with the legislative process by recognizing the fiscal impact and trying to address it.

I believe this change would strengthen the citizen initiative, not bring it down. I believe that it would in fact lead to greater transparency and accountability, not only for the Legislature who would deal with those referendums that were successful, but also for those initiators, regardless of what they want to put forward. I think if you have a good idea, you should be willing to say I have a good idea and I'm willing to accept and pay for what that idea would cost. It is that that inspired my bill, it is that reason that I stand before you today on what is a Divided Report, on what is a very high threshold for votes, and I would ask your consideration. I would ask your consideration for transparency, for fiscal responsibility and for the sake of the good ideas out there that deserve to not only be passed into law by the people but actually come to fruition in the Legislature, and I believe this would approve that in the end. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Saco, Representative Valentino.

Representative **VALENTINO**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I rise today to oppose the current motion on the floor. The Majority Report was Ought Not to Pass on this. I want to thank the good Representative from Orono for bringing this forward. Last year, she brought forth a similar bill, LD 235, which meant that a citizen initiative had to put on the top of the ballot how much it would cost if this went through. Although it was felt by the committee that this is the second part to say not only how much does it cost, where are we going to get the money for it, I feel that the unintended consequences on this bill are huge.

First of all, when we submit our bills, we do not have to put where we're going to get the money to pay for it. We submit a bill, we submit an idea, and if the committee passes it then a fiscal note is drawn and attached to it. That fiscal note then has to go to the Appropriations. We ourselves, as sponsors, do not say I want this to pass into law and this is how I'm going to pay for it. If we don't ask that of ourselves, how are we going to ask that to the citizens of Maine, who are not up here and are not familiar with the budget process, to have them do that? The unintended consequences of this, I can see very clearly. People might put in do you want to reduce the income tax to 4.5 percent and in order to do that, we're going to cut 2,000 state employees who have an average salary of \$37,000. The argument is saying, well, we don't have to be bound to that. Once we get it up here, we can do what we want. Well, why are we asking the citizens to put in something if we're not going to be bound for it? What if they put in we're going to eliminate the salaries of all the State Representatives? We're a citizen legislature. Why not be for free and have nothing being paid for us? Why not finally consolidate that natural resource agency that everybody's been heard out, let's lower the income tax and do that. I could go on and on and on, on examples that the citizens might come up that is not in the best interest of all of the people of the State of Maine.

I also raise the question when we put out an issue on a referendum, it only has to contain one issue not two. What if somebody wants to lower the income tax to 4.5 percent but they don't want to lay off 2,000 state workers. Are we asking them one question or are we really asking them two questions? Does that meet our constitutionality of referendums on having two questions or is it one question on that? I don't know.

I also know that the citizens do not have available the tools to do this that we do here. We do not ask ourselves to do this on our bills, how can we ask them? I also know that this is a constitutional amendment, one that should not be taken lightly. A constitutional amendment, just last year, to allow city clerks additional time on elections to process ballots failed, failed just to give them a few more days. Do you want this constitutional amendment to go out there against the citizens of Maine saying if you want to do this then you have to come up with the numbers? I would urge you to vote this down. I hope that the caucus will see that it may have had a good intent but the unintended consequences are huge on this and do we really want all these citizen initiatives to come back with an amount that we know we are not going to do as far as the reductions in funding, or the increases in the sales tax, or however else they decide to duns it. So I urge you to vote against the Minority Ought to Pass and please vote for the Majority Ought Not to Pass. Thank you.

The SPEAKER: The Chair recognizes the Representative from Newfield, Representative Campbell.

Representative **CAMPBELL**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. Representative Valentino said she could go on and go on and go on, but I'll continue on for her. She evidently forgot about the good citizens of Maine when we passed the beer and wine tax, and then set up a soda pop. The soda pop people spent hundreds of thousands of dollars to pay for signatures, not go grassroots, to pay for them, and then the beer and wine distributors spent around \$4 million to kill a bill. So she should stop and think about we're trying to probably stop that, that you don't need legislators to pass laws when the people with the money out there can turn around and spend enough money to kill whatever we do up here. I hope she remembers that. And any of the freshman that didn't know about it, they know about it now. Thank you.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Russell.

Representative RUSSELL: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I rise today in opposition to the pending motion, primarily for a couple of reasons. One, we passed a really good bill today, under the hammer as I recall, that addresses many of the reforms that I believe are important for the citizen's initiative process, and I think we've taken a major step forward this year. And I think we need to be very cautious about what we do going forward and we need to protect the right of the citizens to petition their government. I'd like to point out that the good Representative from Orono, I share her concerns. I really do. I share the concern that people can put forth initiatives that are asking us to fund things that we don't necessarily have a context of how we're going to fund. But this is a statutory process. We're not like California. We don't have a constitutional referendum. We have a citizen's initiative and it's a statutory referendum and so our Constitution allows this Legislature, this body, to make decisions about what the citizens put before us. It's perfectly within our right. We don't like doing it and I certainly don't encourage us to do it, but it's well within our rights that if a citizen's initiative passes at the ballot box, we can change it, we can gut it, we can do just about anything we want to it. The citizen's initiative does

not have the right to bind a future Legislature any more than we do. We cannot bind a future Legislature. So I would be very cautious about passing a constitutional amendment that gives us a right that we already have.

The other thing I'd like to point out is that when we talk about the funding mechanism, we're talking about the direct initiative. not the citizen's veto, and the funding is related to how to fund that program, that idea, that cut. It's not related to how to fund the referendum process. So to the good Representative from Orono, I really share her concerns and I'd love to find a solution and work with her, but I just don't feel that this is the solution that we should be looking at today. And I have to say, again, we passed good legislation this morning, the other body has passed it, it's probably going to be signed into law that addresses fraud and addresses many of the reforms that some of us are very deeply concerned about. We have a responsibility to legislate, we also have a responsibility to protect the people's right to petition their government and if I were a citizen in the State of Maine, I would not be voting on a constitutional resolution that would limit my right to petition my government. Thank you very much, Ladies and Gentlemen. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Orono, Representative Cain.

Representative **CAIN**: Thank you, Madam Speaker. Just three quick things. Number one, this bill does not amend the law of unintended consequences. That law will stay in effect for as long as all of us will live and well beyond us. I wish we could amend that law, but it's not true. The second, there was a question about the fiscal side and where it would be determined. It would be using the same staff we use here in the Legislature, in OFPR. And to clarify that, certainly the laws we pass are certainly statutory. The process, however, originates from the Constitution, which is why it's here. Finally, Madam Speaker, I request a roll call.

Representative CAIN of Orono **REQUESTED** a roll call on the motion to **ACCEPT** the Minority **Ought to Pass as Amended** Report.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: A roll call has been ordered. The pending question before the House is Acceptance of the Minority Ought to Pass as Amended Report. All those in favor will vote yes, those opposed will vote no.

The SPEAKER: The Chair recognizes the Representative from Biddeford, Representative Casavant.

Representative CASAVANT: Thank you, Madam Speaker. I would like a chance to just talk to everyone about the Minority Report if I can. I spoke to you last year about this same particular issue and things have changed dramatically since then. The Race to the Top funds, which we're all aware, is looking for certain types of innovation. I believe the charter schools can deliver that type of thing, something that the traditional public school cannot. I want to be clear. Charter schools are not private schools, they are not religious schools. They are public schools that have openings for anyone who wants to go there. But the idea is to attempt to eliminate those kids that fall through the cracks and many of you who are teachers or have been teachers clearly know who I'm talking about. The kids that you can't reach no matter how hard you try and you know they're gifted, you know they're smart, but for whatever reason, the dynamic of the classroom doesn't work for them. I believe in my heart that charter schools are an option for them.

Now for some reason there's much opposition. Seventy years ago, Franklin Roosevelt said, we have nothing to fear but fear itself. Pat Paulsen, in 1968, said, we have nothing to fear but fear itself, and the boogeyman. In the State of Maine, seemingly, the boogeyman is charter schools and I have no idea why. When Roosevelt was dealing with the Great Depression, he had no master plan. His goal was try anything. Charter schools are not the silver bullet. I'm not going to tell you that scores are going to go up and I'm not going to make any of those promises, but they give people a chance for alternative free choice. I've received countless emails and countless phone calls the last week or so with people whose kids were jeopardized by the system. They told me stories how their kids were successful in the private schools with which they paid tuition. You probably

know people yourselves who took their kids out of schools and put them somewhere and paid for it. Well, why can't those who can't afford it also be allowed free choice to put their children at a public charter school where innovation and alternative styles of teaching can take place? In all the arguments that I heard last week and the week before against charter schools, there's something that struck me. Not a single argument talked about what was best for the children, talked about loss to various districts because ideally the money follows a child. So if a student is at a public school and suddenly wants to go to a private school, the money follows that child and people are scared of that because it might affect their district. But here's the catch: Those schools, those charter schools are designed to try to attract the kids that drop out, the ones who never really materialize in terms of money for the district.

What I ask you is to reject the Majority Report and go on record with the Minority Report saying that we, as a state, believe that innovation is our goal for all students in the State of Maine, no matter what their economic standing, and we can do that through the use of charter schools. Thank you.

The SPEAKER: The Chair recognizes the Representative from Stockton Springs, Representative Magnan.

Representative MAGNAN: Thank you, Madam Speaker. Madam Speaker, Representatives of the House. I stood last year to speak against charter schools and I will do it again and I will speak in favor of the innovative schools. I think that is the way for us here in Maine to go. At a recent NCSL education leadership workshop, I found out that charter schools are kind of declining because they're not living up to the potential that they were touted to be. As usual, something that's overly relied upon for wonderful results only gets the wonderful results through cherry picking and through location. So if you are a suburban, well-to-do area school and you want to put a charter together, you're going to get pretty good results on your tests. If you're an inner city charter school and you clearly reflect the neighborhood and vour clientele, including special needs students, you don't do any better on the whole than the regular schools. And so this problem of the charter schools is real.

It also extends into the issue of who controls the schools. We've now passed data collection on students from birth to practically death and that was a shame but it's happened. We now have adopted common core standards. Many states have gone to state run school boards, some with a little bit of disastrous results such as Texas, but the problem is that charter schools feed into that consolidation towards state control in a grants way because they don't report to their local school boards the way the innovative schools would. They report to the state Department of Education, pulling together the charter schools under the state. And so I would be careful in sanctioning charter schools and I will talk about the kids because we treat our kids very well. In most studies you'll find on the national level people talk about schools, generally they say, oh, the schools need this, the schools need that, they're underfunded, they're overworked, and the kids aren't doing well. But when asked specifically about their own schools, even some of the toughest schools in the country will clearly report that they're very proud of their school. It's not their school. Their school is doing the best they can with the most they have with whatever they have, and so I don't believe for a minute that the charter schools are going to be a cure all or even a real alternative to our young children and our young adults in the State of Maine. It does draw public money away from the public schools in a way that the innovative schools will not. Let's give those innovative schools a chance and not have unfair competition.

I'm going to say one last thing here. No, I think that's about it.

I think I will stand firmly against charter schools and proudly ask you to follow Representative Sutherland's light. Thank you.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Lovejoy.

Representative LOVEJOY: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I rise to support the motion at this time. I appreciate Representative Casavant's passion about charter schools and, guite honestly, in many ways I agree with him. But let me ask you, how many of you are comfortable with the amount of funding your school system is getting right now? This would draw away from that and in a time where we are cutting back our funding to schools, that's going to be an issue for all of us. Innovative schools are out there. This will move us forward. Many of you have heard about Casco Bay High School in Portland, which has done an incredible job as an innovative school without charter school status. This will be helping move us forward on that. I believe that it is the right step. Yes, its part of the Race to the Top, which many people wonder where we stand with, but the fact of the matter is we do need to look for more innovation. I agree with Representative Casavant. I've sat with him in all of the discussions in committee. But at this time, I'm afraid I can't support charter schools. We need to take and keep funding and keep our schools working as officially as we can, and I think trying to move for charter schools right now would be the wrong decision for us in this budget. Thank you.

The SPEAKER: The Chair recognizes the Representative from Mount Vernon, Representative Jones.

Representative **JONES**: Thank you, Madam Speaker. Point of Order. I have a question for the Chair.

The SPEAKER: The Representative may proceed.

Representative **JONES**: If we vote against this, does this jeopardize our state's chances of getting federal funding for Race to the Top?

The SPEAKER: The Chair would answer that that would not be a Point of Order but that may be properly a question posed through the Chair to another member of this body who may care to answer. The Chair recognizes the Representative from Chapman, Representative Sutherland.

Representative **SUTHERLAND**: Thank you, Madam Speaker. One of the major components of the application for Race to the Top is how this state addresses innovative programs in the public schools, and, yes, we do need to provide that piece to the department in order to have the most competitive proposal.

The SPEAKER: The Chair recognizes the Representative from Greenville, Representative Johnson.

Representative JOHNSON: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I'm going to reserve me comments on charter schools as the Speaker requested. However, let's look at 1801 that is before us now. I sat through all of the deliberations on this bill when it came before us, and the committee was under whelmed, under whelmed with the specificity that goes with the definition of innovative schools. There is nothing within this bill that makes schools any more innovative than they currently can be. Existing state law allows for alternative schools to be created within public schools. Even with this bill innovative schools are bound by current law in the areas of instructional design, staff selection and school calendar. How can schools be innovative if they are bound by existing statutory and regulatory requirements? The answer is they can not. At least this bill offers no more opportunity to do this than the existing law. I would ask that people vote the pending motion down so that we can get on to something that the Federal Government agrees and many people agree will allow for a

degree of innovation that this motion does not currently entail. Thank you.

The SPEAKER: The Chair recognizes the Representative from Dennysville, Representative McFadden.

Representative **McFADDEN**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I rise to support innovative schools. LD 1801 will permit any school administrative unit across the state to establish an innovative school that meets all criteria requirements to make Maine eligible to compete for Race to the Top funds. One of the requirements for an innovative school, they must have open enrollment and permit any resident student in that LEA to enroll in the school. Also, they must have the course district school calendar, the staff selection and professional development assessment. It may differ from other schools in the district but it must not be in conflict with any state regulations and rules. In other words, the requirement for an innovative school should exceed the requirements of other schools in the district.

Now our committee heard positive testimony from the DOE commissioner, the Maine Teachers Association, the Maine Principals' Association, the chair of the state board, and the president of Small School Coalitions. The only person or only entity that testified against the innovative schools, it was the Maine Heritage Policy Center, and the only reason they testified against it is because they said it didn't go far enough. Going far enough meant they wanted charter schools. But we've got to realize that LD 1801 is one of the three bills that make up the points for Race to the Top funds.

I know charter schools is not what we're talking about, I realize its innovative schools, but two or three things about charter schools. One thing, I heard another Representative mention it sucks GPA right from the other schools and, at this time, no school can afford to lose any GPA from the budget and, on top of that, paying penalties. Another thing that hasn't been mentioned is charter schools, only two-thirds of the teachers must be certified. Now you have teachers in the regular school that must take six credits every five hours to be recertified and two-thirds of these teachers don't need to do that. So I suggest that we vote yes on the Majority Report. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Alna, Representative Fossel.

Representative **FOSSEL**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I come from the little town of Alna that has K-12 choice right now. There's no boogeyman. They're no boogeyman under the bed. It actually makes the situation much better because those parents who have a problem finding an appropriate education for their children within the public school, or within the public school that they're assigned to, have other choices and they don't go to constant parent-teacher conferences or say their kid should have special ed. I think it actually improves the situation and it's overwhelmingly supported in my community. Therefore, I see absolutely no reason to support this bill, and I think we ought to look at other alternatives. Thank you.

The SPEAKER: The Chair recognizes the Representative from Saco, Representative Valentino.

Representative **VALENTINO**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I do not serve on the committee and I do not pretend to know a lot about the innovative versus charter school difference of it. I do know that we passed another bill here, LD 800, which was the first component, and in that testimony it was given that we needed to pass this because we did not want to stand in the way of being competitive to get the funds for Race to the Top. I guess my concern then is following up on the good Representative from Mount Vernon's concern is that if we're going to put in an application, why not put in our best possible application? The application is due in June. We will know before next session whether or not we have been approved on this. I'm greatly concerned about the cliff that we're facing and if this is the way to get good competitive schools and to put charter schools in, which is not taking somebody half the way, I guess I question the motives of going half the way and not going the whole way of charter schools. I know a very much admired person I know is coming to Portland on Thursday and he likes charter schools and I guess I think I can support going all the way, because I want to make sure that whatever we put in, we're in the best possible position to get these funds for Race to the Top. So therefore, I will be voting against the current motion.

The SPĚAKER: The Chair recognizes the Representative from Sanford, Representative Boland.

Representative **BOLAND**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I would also urge a vote against this bill. I think it puts an extra burden on public schools that are already stressed right now and it's really not as credible as an alternative might be. It seems that we are losing kids and schools have been trying really hard, they've been doing their best for a long time. I think maybe there's something a little bit more innovative that we can choose to do. Thank you.

The SPEAKER: The Chair recognizes the Representative from Lewiston, Representative Wagner.

Representative **WAGNER**: Thank you, Madam Speaker. I, too, rise to support this motion. I will remind people that there is \$3 billion out there in the Race to the Top, only two states have been approved of the 41 who applied the past several months. Two states, \$3 billion left. We should, as the good Representative from Saco suggested, we should put our best foot forward and passing a bill that supports innovative schools is an excellent way to do it, has the additional advantage of getting people within various school districts, regional units and so on to start working on their own schools to make them better for all the students in the district rather than just for the mainstream folks. So I urge you to support this bill. Thank you.

The SPEAKER: The Chair recognizes the Representative from Biddeford, Representative Casavant.

Representative **CASAVANT**: Thank you, Madam Speaker. Just a couple of other points. I'm asking you in this case to really consider the kids of Maine, because that's what the issue is here. Clearly the status quo of education is in favor of innovative schools, but I think we can do better than that. I say why not experiment, why not take the chance over the next 10 years to see what develops. What harm can come? Absolutely none.

I also want to dispute that whole idea, once again, about the loss of money. We are already losing kids from our public school systems. We have home schooling at a record-breaking pace. We have people enrolling their kids in private schools. The kids are vacating now. Do we think that there's going to be a flood? If there is a flood that means our school, our public school is failing. That's what it tells us. So do we want failing public schools?

And the last thing. We started improving our schools, what, 10, 15 years ago? Look how long it's taken to get to this point. It's a slow process through public education. I sincerely believe that going through the public charter system will not only deliver the innovation but deliver it more quickly than we've ever seen in public education today. Thank you.

The SPEAKER: The Chair recognizes the Representative from Saco, Representative Pilon.

Thank you, Madam Speaker. Representative **PILON**: Madam Speaker, Ladies and Gentlemen of the House. I agree with Representative Casavant. What about the children? If we lose those children from the school system, where do they go? If all of the sudden they become uneducated, they're not going to be part of the productive members of society. Where do they go? How are they going to be able to compete in the global world that we're trying to create in the State of Maine? We can't take square pegs and try to fit them in round holes, and that's what we're doing in the current public school system. So in the traditional classroom setting, where we probably have 25 to 30 kids in a classroom, these children that historically would be well suited in a charter classroom where we can work with them to get their strengths, find their strengths, find their capabilities, work with them to make them productive members of society rather than lose them, because they're going to be dropouts, what's the matter with this? What's the matter with this proposal, Madam Speaker? So I support the Minority Report. Thank you.

The SPEAKER: The Chair recognizes the Representative from Falmouth, Representative Nelson.

Representative NELSON: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House. I was not going to rise on this issue, but I feel that I must, and as much as I did speak in the prior session in support of charter schools and yet I support the Majority Report in this case. We have lots of challenges in education in the State of Maine, not the least of which is resources. I think that the department came forth with the proposal that we put in law, some opportunities for innovative schools and innovative programs, such as programs that are existing in the state right now. We have an innovate school, the Maine School of Mathematics and Science, in Limestone, that is an extraordinary example, named nationally as one of the finest schools in the country. We do have the opportunity to put together very innovative schools and programs and this legislation puts that into statute so that it's available. I think the discussion on charter schools, as we've heard today, is a long one, it's a complicated one, and, for me, this is not the right vehicle in which to do that. I think that we need a fair and honest and open debate to put in place, in the State of Maine, the best legislation we can. This is a long piece of legislation if one were to go with charter schools, and I think that we owe it to ourselves and to the students and the teachers and the schools in this state to consider carefully how we put that kind of legislation in place. So I urge you to support the Majority Report. Thank you.
