In Senate Chamber Tuesday January 19, 2010

Senate called to order by President Elizabeth H. Mitchell of Kennebec County.

Men and women of the Senate, I want to thank the good Senator from Penobscot, Senator Perry, for acknowledging my constituent, Danny Lafayette, who actually lives in Hampden but does run a huge endeavor out of his office in Hermon. He's the kind of guy you would all like to claim as your constituent. He employs over 1,000 people in the state of Maine. I'll tell you how many of you could claim him. He owns a hotel in Auburn. He owns one in Augusta. He owns several in Bangor and a couple in Bar Harbor, Belfast, Boothbay Harbor, Ogunquit, Old Orchard Beach, Orono, Portland, South Portland, Waterville, and Wells. This is a man who knows Maine. He's an incredible citizen and an incredible employer. In the spirit of giving back to the state of Maine, Lafayette Hotels, with Danny at the head of it, has pledged \$2 million to the cancer care center in Brewer. That's not \$2 million from Danny's pocket, that's \$2 million that his corporation decided that they would all raise. A lot of it is from Danny's pocket. One of the women that works for him raised \$1,000 in a yard sale. They sell teddy bears and bottles of water at other events and they are raising \$2 million the hard way, but that is the kind of people that Danny and Carla Lafayette are. They received the Governor's Tourism award, which recognizes their efforts in bringing Maine to the forefront of where people think to go. If you have ever stayed at a Lafayette property you know that it speaks so well of the state of Maine. When they come they know that they are being hosted, they are being cared for, and Danny's values show all the way through, all the way through from top to bottom, in his organization. I want to thank the Senator for bringing this forward. I kind of wish I had been on it with him, but I do want to thank him for bringing it forward because it's not often that a man as humble as Danny Lafayette is recognized in this Body. He has been recognized nationally for many other things, but I think it makes him very proud to have been recognized by the Governor of the State of Maine. I'm pleased to speak on behalf today in the Maine State Senate. Thank you.
