#### JOINT RESOLUTION MEMORIALIZING THE PRESIDENT OF THE UNITED STATES AND THE UNITED STATES CONGRESS TO ISSUE THE \$250 ONE-TIME PAYMENT TO SOCIAL **SECURITY RECIPIENTS**

WE, your Memorialists, the Members of the One Hundred and Twenty-fourth Legislature of the State of Maine now assembled in the Second Regular Session, most respectfully present and petition the President of the United States and the United States Congress as follows:

WHEREAS, the Social Security Administration announced there will be no cost-of-living increase for 57,000,000 Social Security beneficiaries in 2010 because consumer prices have fallen; and

WHEREAS, this year marks the first time that Social Security benefits have not increased annually since the cost-of-living adjustment requirement was put into effect in 1975; and

WHEREAS, to help people who are not getting a cost-ofliving increase, President Obama has called on Congress to send a \$250 relief payment to every Social Security recipient, disabled veteran, railroad retirement recipient and citizen who receives a federal or state pension instead of Social Security to ease the economic strain; and

WHEREAS, the government issued a \$250 relief payment last year; and

WHEREAS, this proposed \$250 payment is roughly equal to only a 2% increase in benefits for the average Social Security beneficiary and last year Social Security beneficiaries got a 5.8% cost-of-living adjustment, the largest since 1982, largely because of the jump in energy prices; and

WHEREAS, Congress approved a similar payment as part of the American Recovery and Reinvestment Act of 2009 and, as with that payment, this 2nd payment would be exempt from income tax and provide immediate relief to those most in need; now, therefore, be it

RESOLVED: That We, your Memorialists, on behalf of the people we represent, take this opportunity to respectfully urge and request that the United States Congress pass legislation in order to send \$250 to every Social Security recipient, disabled veteran, railroad retirement recipient and citizen who receives a federal or state pension instead of Social Security to offset the lack of a cost-of-living raise in benefits from Social Security in 2010; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable Barack H. Obama, President of the United States, to the President of the United States Senate, to the Speaker of the United States House of Representatives and to each Member of the Maine Congressional Delegation.

JOINT RESOLUTION IN SUPPORT OF THE ANNUAL WASHINGTON JUNETEENTH NATIONAL HOLIDAY OBSERVANCE

WHEREAS, for more than 143 years, Juneteenth National Freedom Day, also known as Emancipation Day, Emancipation Celebration, Freedom Day, Juneteenth Independence Day and Juneteenth, has been one of the most recognized African-American holiday observances in the United States; and

WHEREAS, Juneteenth commemorates the day freedom was proclaimed to all slaves in the South by Union General Gordon Granger, on June 19, 1865 in Galveston, Texas, more than 2 1/2 years after the signing of the Emancipation Proclamation by President Abraham Lincoln; and

WHEREAS, Juneteenth commemorates the determination of the first people from Africa, approximately 11,500,000 of whom survived the awful voyages across the Atlantic and who were brought to this country to serve as slaves and whose descendants served as slaves for 200 years before the horrific system was abolished; and

WHEREAS, over 130 years after the Emancipation Proclamation and after years of informal annual celebration, Juneteenth was finally officially recognized in 1997 as Juneteenth Independence Day in America by the President of the United States and the United States Congress in the first session of the 105th Congress with bipartisan cooperation in Senate Joint Resolution 11 and House Joint Resolution 56; and

WHEREAS, "Until All are Free, None are Free" is an oftrepeated maxim that can be used to highlight the significance of the end of the era of slavery in the United States; and

WHEREAS, the National Juneteenth Observance Foundation is sponsoring the premier celebration, concert, worship services and campaign to commemorate what many people consider to be America's 2nd Independence Day Observance, the "19th of June," and to recognize this country's movement towards a "One America": and

WHEREAS, it is important to continue a dialogue of the realization of what Juneteenth historically means to all Americans, to promote racial healing, reconciliation, restoration and justice; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-fourth Legislature now assembled in the Second Regular Session, on behalf of the people we represent, support the National Juneteenth Holiday campaign and encourage people in our State to participate in the Annual Washington Juneteenth National Holiday Observance during the week of June 19th in Washington, D.C.

Senator **SMITH** of Piscataquis was granted unanimous consent to address the Senate on the Record.

Senator **SMITH**: Thank you, Madame President. The desk before you, just to make it perfectly clear what it is, is the original Senate President's desk. Many of you have asked how could a humble country lawyer from Maine's smallest county end up in the ownership of such a desk. This is the story of how it happened. I will tell you that the preservation of that desk is greatly intertwined with a distinguished family from Piscataquis County. It is not the Smith family that I talk about here. It is quite a story of service to country, to state, to community, and of philanthropy to this great state. I think we ought to get that story out as the desk is much intertwined with it.

Let me just pick it up quickly when Joseph B. Peaks was born in 1839 in my general area of the state of Maine. He grew up there, educated at Charleston Academy, which was one of those town academies, and East Corinth Academy, another one of the town academies long defunct. At the end of his high school career he pursued other educational opportunities and in April 1861 ended up in Lowell, Massachusetts visiting his brother. The morning of April 15, 1861 there appeared in the local Lowell newspaper Lincoln's call for the first 75,000 troops to volunteer to deal with the crisis that had arisen as result of the firing on Fort Sumter and the cession of several states. Early that morning Joseph B. Peaks read that headline and inquired of his brother whether there was a place that he could go to perhaps volunteer and was told that there was an armory. It was the home of the Lowell City Guards. It was a unit of the soon to be famous 6<sup>th</sup> Massachusetts Regiment. He appeared at the armory early that morning and by 10:30 was in uniform, in the afternoon was in drills, and under orders of Governor Andrews of Massachusetts, a

Maine-born governor of Massachusetts I might add, he was on his way the next morning to defend Washington D.C. He served his three months, that was a three month call of volunteers. The entire regiment volunteered for an additional month and at the end of that month it was mustered out of federal service and Joseph B. Peaks returned to Charleston, Maine. He was just in time to teach a term of school, a short term, which he did. He then re-enlisted in the United States Army in a very famous unit from Maine, the 1<sup>st</sup> Maine Cavalry headed by a famous cavalry officer by the name of Colonial Calvin S. Douty. Colonial Douty was later killed in action. Joseph Peaks saw action in many significant battles in the early part of the Civil War including Fredericksburg and Brandywine. He was severely wounded in the Battle of Aldie and was taken prisoner for a time and later escaped. He was discharged in late 1863.

He returned to the Dover-Foxcroft area to recuperate and to start a long and distinguished career in business and politics. In 1870 he passed the bar, such as it was in those days, and joined the Piscataguis bar, according to the records of the Maine Supreme Court. In 1871 he married a local girl by the name of Eliza Chadburn, who was from a fairly well-to-do family there. In 1872 he had his first child, Anne. In 1874 he had a second child. This family was very dedicated to our area, was a very loving family, and as it grew Joseph embarked upon this very distinguished career. In 1880 he was appointed by Governor Davis, no relation to my seatmate I presume, as one of Maine's early Insurance Commissioners. Later in the 1880's he led a group that brought the railroads into that area of the state of Maine. It was exhausting undertaking and I am told that so much so that at the end of the multi-year effort, where he worked day and night, his health had deteriorated and he had a hard job staying on top of it for the rest of his life. The railroads came into the area. In the late 1800's he served in the State Legislature in the House and then in the Senate. The Senate was not, of course, located here. In those days it was located in another part of the State House. He eventually was appointed to the Railroad Commission and ascended to its chairmanship because of his vast knowledge of railroads and oversaw the development of Maine's railroad system up until about 1910.

In 1902 this desk was sold by the State of Maine to Mr. Peaks. It was transported to Dover-Foxcroft and sat in the upper chamber of a carriage house for nearly three-quarters of a century. Mr. Peaks died in 1911. Mrs. Peaks died in 1934. Anne died in 1959. Francis, at the age of 90 by the way, decided that much of the family property, which is surrounding Sebec Lake, he could no longer use and decided to give it to the State of Maine. At the age of 90, this old lawyer, who had taken up his father's practice, gave a large piece of property, some 800 acres around Sebec Lake, and in 1964 Governor Reed came to town and it was dedicated as Peaks-Kenny State Park, one of the most popular and used state parks in inland Maine. Back to the desk, as it sat there for three-quarters of a century in the barn, Francis died three days short of a lifetime goal of reaching 100 years of age. He died on February 23, 1974. On February 26, 1974 he would have been 100 years old. That summer I was serving as an intern, really, in the local County Attorney's office under the old County Attorney system between my second and third year of law school. The County Attorney had gotten the estate to administer and he came over to me at the County Attorney's one day and the Peaks' estate was exactly next door to the court house. He said, 'After work would you mind going with me next door so that you can help me with a couple of things I need some help with?' I

said I'd be happy to. He took me to the carriage barn and we crawled around there, handling a lot of stuff over. He was obviously trying to put the inventory of the estate together. We came upon two large boxes. He said, 'It's time for us to take a board off the top of those boxes and see what's in there.' We did and, low and behold, there was a large desk in one box. We popped a board off the other one and there was another large desk. I said, 'That is a magnificent looking desk.' He said, 'It's all going to go for auction in a few weeks.' I said, 'I would like to have one of those desks for my law office that I'm going to shortly set up in Dover-Foxcroft.' He said, 'Well, I hope you get one.' No offer of payment of that desk for my services that day, I'll tell you.

The auction day arrived and my mother, God love her, who sits in this chamber today listening to this presentation, has a great interest in antiques and had a particular interest in running an errand for me that day and attended on my behalf. I was in the Legislature at the time and could not attend the auction. I was off on State business. I told her that I wanted one of those desks, having no idea what it was. I can tell you that I sent a good agent to the auction that day. My mother is not known for spending money unnecessarily. The first desk that was put on the auction block, we didn't know it at the time, was the original desk of the Speaker of the House. The bidding started rather high that day and went north of \$100, then north of \$200, then north of \$300, and settled out somewhere in the \$400 to \$500 range, as I recall. By that time my mother, knowing that another desk was to follow, had dropped out of the bidding. It went to, as it turned out, a neighbor of mine down the street on main street Dover-Foxcroft. Thinking they were going to get the second highest bid, they put the second desk right up. This is an accomplished auctioneer. I'll tell you, Robert Hall, who is a leading antiquarian of the state at the time. He was quite sure he was going to get that second highest bid. He put it on the block and the bidders were silent. He looked at my mother, knowing that I wanted that desk, and she said, 'I'll give you \$5 for that desk.' He said, 'Sold.' I became the owner of the desk for \$5. By the way, my mother also bought for me a much-treasured possession that came out of that distinguished estate. It was an ancient picture of Abraham Lincoln. It is some sort of original in its original frame. It hung in my law office for many years. She paid the large sum of \$25 for that picture of Abraham Lincoln. I got the desk and the picture for a total of \$30. It went first over to the hall establishment there to be sort of cleaned up and refurbished. It had been sitting around for about three-quarters of a century in the top of that barn.

It eventually made it back to my office where I used it for close to 20 years as my personal desk. I tell you it was a lovely desk and kicked off a lot of interesting conversations with many hundreds of people that came through in that period of time. Everybody was interested in it. I was beginning to worry about what I was going to do with it, to tell you the truth. In late 1993 or early 1994 it became known to me that the State was trying to reacquire some of the original desks and furniture from the original State House. The original State House was a very small part of what we see here today. It was established and occupied for the first time in 1832. We believe that this desk probably entered the Senate chamber about that time. It is pictured in an 1870 photo that is on the wall nearby here in the State House clearly as the Senate President's desk. I was pleased that the State wanted to acquire it. I contacted the State Museum. Talked to the fellow who couldn't believe what he was hearing. He immediately left for Dover-Foxcroft with a van to verify its authenticity, which I had proof of, and I was pleased to return it to the State of Maine. I am particularly pleased that my mother was here today to see the desk one more time because she had a key role in obtaining it and continuing its safety for the next 20 years before it was returned to the State. It's a priceless piece. By the way, I suppose you would all want to know what it was appraised at at the time I gave it back. After it was in State possession it was appraised by a well-known appraiser for \$7,500. If it had been a cash transaction it would have been a tidy profit but it was not a cash transaction. I was very pleased to be able to use it. It's a beautiful thing. It's laced with history. I've given only a part of it here today. I hope the State will be able to find some useful place to display it and I hope that the public will come to understand its importance historical value to us all. Thank you.

THE PRESIDENT: The Chair thanks the Senator from Piscataguis, Senator Smith, and the Chair would also like to recognize the person who really acquired the desk on his behalf. His mother, Miriam Smith, is here as well as his wife, Cartha. Would you both stand and accept the greetings of the Maine Senate. Because we are doing some historical celebrations and we have our own historic person here in the person of Earle Shettleworth, who is State Historic Preservation Officer, I thought he would like to hear these comments. I wanted to share something with you. I hope you will all come into my office to see it. I hold here a picture of the office. The only thing that looks remotely different is there is no moose. I am going to ask Senator Bryant from Oxford if he could remedy that situation. This was the Governor's office, now the current Senate President's office. The picture that you see was Governor Carl E. Milliken signing the Women's Suffrage Proclamation in 1917 in the Governor's office. I wanted Earl to be here because he presented this. It's a copy of the print that he has. Earl is always reminding us of our roots and I thought today's a perfect day. We have both the desk and we have the women's right to vote right here before us. Thank you very much. Earl, would you stand.
