Senator **PERRY** of Penobscot moved the Senate **ACCEPT** the Majority **OUGHT NOT TO PASS** Report.

**THE PRESIDENT**: The Chair recognizes the Senator from York, Senator Nass.

Senator NASS: Thank you, Madame President. Ladies and gentlemen of the Senate, this bill, for several good reasons, has been sitting on the table for a while. It's a little moldy around the edges, but we'll try to explain why. Obviously this is a split report on partisan lines. This is important to at least the Republicans, in my opinion, because this represents an item or a plan, I guess, that some folks here have suggested doesn't exist, that's the Republican plan for tax reform. This has been, in one variety or another, the Republican plan for as long as I've been here, 16 years. In the 117<sup>th</sup> Legislature, when this Body was controlled by the Republicans, a version of this was introduced. It passed as part of the budget negotiations. In the 118<sup>th</sup> it was repealed and some version of this has been in existence in every legislative session that it has been my pleasure to be here. Unfortunately we haven't been able to do anything with this. What it does, basically, and it's simplicity is just amazing, it basically says that in years when there is a growth in income tax revenue we should use that growth, recognize it, and use it for something. In our case it was to buy down future income tax rates or the rate for the future. Over time, but not always, almost every cycle we raise more money here in income and sales taxes than we did in the prior period. We're not in one of those periods now, obviously. If you look at what the result of that would have been if this had staved in effect, we would have had a tax burden almost \$800 million less than what it is now. On average, in most cycles, we collect \$60 million to \$70 million more than we did in the prior cycle. We never do anything with it. Well, that's not exactly right. We do do things with it. We fund new programs. We hire new employees. The down side of this is that if we had invoked and done something like this our citizens would be paying \$784 million less in taxes over the period that I've been here. What is the down side? The down side is we would not have been able to fund new programs. We would not have as many employees, State government would be that much smaller. That is pretty much what happens in the private sector in this period of time. The question I have and have never been able to ask is why doesn't it happen here? Why do we just let this place grow, this government grow, bigger with no challenge to it? No brake on it. To me, that indicates if we had gone down a different path we would be in a substantially different place. That money would have been available for economic growth in this economy. We would have looked substantially different than we do now in a relatively short time. That is the point and the reason, I think, for asking for a vote on this, the recognition that there is a different plan. It's been reported in the press lately that the Republicans don't have a plan for tax reform. It is my hope today to say that is wrong. It is here, It is the same plan that has been in existence for a long time. The question is, why don't we do something about it? That's what I'm hoping we can answer today, Madame President.

On motion by Senator **NASS** of York, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT**: The Chair recognizes the Senator from Penobscot, Senator Perry.

Senator **PERRY**: Thank you, Madame President. Ladies and gentlemen of the Senate, I'm going to resist my temptation to sit still on this bill and I guess add a few words. It is a plan; I'll give

you that. It might do something some number of years down the road. It's designed to take excess revenue and use it for further reductions. We've heard that had we done this in the 118<sup>th</sup> we would have \$800 million less burden reduction. Now that is speculation. Possibly true. Had that been in place I submit that a lot of things we have done over the years we couldn't have. Things such as reducing the sales tax from 6% to 5%, repealing the Snack Tax, or creating the Homestead Exemption. In fact part of that repeal was to create the Homestead Exemption because at the time those of us who passed the Homestead Exemption looked at that as a much fairer way to share excess revenue with all Mainers because property tax seemed to be a bigger burden than reducing just the very top rate. I believe that plan was so only half of taxpavers would enjoy the benefit at that time. I know this bill is somewhat different. It addresses a more fair way of reducing burden. I'm not sure we could have funded BETR up to the \$80 million price tag we once funded it to. Beyond that, I don't think we could have repealed the personal property tax on business equipment, which is one of the most important things we were told we could do for the business climate in Maine. I kind of doubt we could have done Pine Tree Zones. I'm not sure we could have put a billion dollars into school funding to reduce property taxes. I'm pretty sure we couldn't have doubled the Circuit Breaker Program, which we did in L.D. 1. That all aside, who knows where we would be on the funding side of things; what programs may or may not have been funded. I can't answer that. There seems to be a notion that if we take a hard problem and just kick it down the road with some sort of arbitrary trigger or mechanism, a TABOR-like mechanism or excess revenues will go to do this. Right now the excess revenues go to buying down our unfunded liabilities. It goes to building up the Rainy Day Fund. There are already places that money goes. I would say the best scenario is that sometime many years from now we may see some burden reduction through this bill, possibly, but not for a very long time. I guess I did not realize this is the Republican alternative to tax reform because they had the opportunity to report that out as a report when we did tax reform but the report was Ought Not to Pass. This wasn't there. In fact, the folks leading the effort to repeal tax reform. I don't recall seeing any of them in the Taxation Committee ever to offer suggestions or other plans. It wasn't until it was passed that folks took the lead on repealing this. Had this been the alternative I think that would have been the time to vote it out as an alternative rather than a simple "no". All that aside, this is a repeat of what we did on Tuesday. This is in direct conflict with tax reform. The tax reform package that lowers the income tax rate from 8.5% to 6.5% and pays for it so it goes into action today, the tax reform plan that was editorialized in the Wall Street Journal as a Maine miracle, this is in direct conflict with that package and we won't know until sometime in June if the voter accept that \$50 million in burden reduction or reject it. Because of that the Attorney General has advised us not to take action on this bill. It is in conflict. I would urge acceptance of the Ought Not to Pass report. Thank you, Madame President.

**THE PRESIDENT**: The Chair recognizes the Senator from Aroostook, Senator Sherman.

Senator **SHERMAN**: Thank you, Madame President. Ladies and gentlemen of the Senate, I have been here a number of years. I came in when we had the surplus budget. I think I'd like to tell a little story about then-President Michaud when we had a fairly

even divided Senate and House. That's how I thought things were always going to be. If I'd known what we would evolve into I would not have bothered running again after that first term. We had to negotiate things. I have a story I'd like to relate about President Michaud. We had a little surplus going and I used to go in and eat his donuts and drink his coffee in the mornings. Senator Stanley, President Michaud, who is now a Representative in the U.S. House, and I wanted to use some of that surplus money to pay down the unfunded liability in the retirement system. I still have somewhere in a box under box after box materials on if we paid down part of the unfunded liability. I don't remember exactly what it was, \$100 million maybe or \$200 million, within three or four years time, by paying down the unfunded liability, it would be like paying forward on your house. My daughter's doing that. She's paying an extra \$100 a month on the principle. Her house is going to be paid for in a fairly short period of time. In terms of calculations on the unfunded liability, it was rather simple. President Michaud had it out five years as to what would happen to the unfunded liability. His thought was that we know in the budget there is a piece that pays, every year it's getting larger and larger, towards that wonderful thing called the unfunded liability. We would have freed up money to a large degree that we could have done other things with. Budgets aren't one time things. We know that. People have 401Ks. They live a long time span. It bothers me that we are talking about things that probably should have been done a few years ago. To come forward, we had two Senators, as you well know, one rather conservative and one rather liberal, who put together a tax package that was vetted and vetted and vetted. Maine Revenue Services came up. When you were looking at tax reform, or what ever you want to call it, you had some sense of what was taking place. If you recall, we never had the chance to vote on that in this Body. Now we are hearing the same old tired refrain, we can't do anything because something else is going to happen. The sun is going to come up tomorrow. I'm sure it's going to go down tomorrow. The cobwebs may grow on some of the tax reforms we think we're going to do. This little piece, basically the Attorney General has a ruling on it, at least shows folks that we understand where we should be going. That is a little history lesson. Not a very good one. There was a bright and shining moment there that we could have done something and didn't do it. I know some of the funds that we did buy onetime stuff and we have a police barracks in Houlton to show for that and a higher ed center to show for that. Maybe there is something in Lewiston to show for that. There was still money left over that could have gone to the retirement system and we wouldn't be in the fix that we are in the retirement system. I would urge us to follow the good Senator from York, Senator Nass' light just for the fun of it to say that we actually voted for something that might do some good.

**THE PRESIDENT**: The Chair recognizes the Senator from York, Senator Courtney.

Senator **COURTNEY**: Thank you, Madame President. Men and women of the Senate, it's always nice to get up and counter some of the comments of my good friend from Penobscot, Senator Perry. Just for a little history lesson, because often sometimes on both sides we end up trying to see it through a different view, last session the Republicans did have this bill put forward. It was stuck on the table in the Taxation Committee. It wasn't released. We put it forward many other times and it's been rejected, usually

on party line basis. There was an alternative during the last debate for the tax reform, the sales tax expansion bill, for us to have an alternative and we chose not to expand the sales tax at that level. Expand the sales tax and then suspend the automatic indexing so it actually would be a tax increase going forward. That debate will be for another day. It will be out with the people. We did offer a true alternative. Actually the bill that the good Senator from Penobscot, Senator Perry, is talking about got recalled from the Governor's desk after it passed the Body and it was softened up a little bit. There was a little break, I think, for golf and ski lift tickets and things like that. All that stuff you've got to do to try in stay in shape. Unfortunately, the guy who has to get his car repaired still had to pay the bill. Having said all of that, this bill also reduces the income tax, eliminates it, for families earning \$30,000 a year or less. It directs excess revenue above and beyond the L.D. 1 cap that we passed a few years ago. It doesn't put a strain on the existing budget. If your goal is to grow State government at a very rapid rate then this probably wouldn't be the bill for you. If it isn't this is a way. This is a way to redirect revenue on an ongoing basis. It's a way to reach across the aisle and make a commitment to reducing the income tax until we get to 4.5%. I almost thought this was getting kind of mocked a little bit with some of the comments from my good friend from Penobscot but I'm sure he didn't mean it that way. Had we done this back in the late 1990's, when the Republicans and the Democrats were working together in the Senate because they had to, because the revenues the first few years were incredible, if we had done that, we may have been able to drop the rate at that point, reached our goal, and only God would know what we could have done for the economy of Maine. Thank you, Madame President, for the opportunity to have this discussion.

**THE PRESIDENT**: The Chair recognizes the Senator from Lincoln, Senator Trahan.

Senator **TRAHAN**: Thank you, Madame President. Ladies and gentlemen of the Senate, as enticing as it would be to have this debate around tax reform, I am rising to ask that we have this debate in the proper forum, which is going to be when we are out of session. We have so much work to do that I think we all know how this will fall. Bringing up things and getting into long and lengthy debate is taking time away from the other things we need to work on. I would encourage this chamber, I'm not telling you what to do, I'm just encouraging you to join me in moving on and not taking the bait.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Bartlett.

Senator **BARTLETT**: Thank you, Madame President. This has been a fascinating discussion about what would have been or could have been had this bill been passed years ago. While we are on the subject of what would have been or could have been, had there not been a Citizens Veto effort Maine tax payers would have had their income taxes reduced to 6.5%. Most of them less because of a refundable credit that was put in place for Maine families. Let's start there. I also agree that the proper forum for the debate around tax reform is out in the public. As I mentioned on Tuesday, the Republican Party led an effort to put this issue on the ballot. They gathered thousands of signatures. Those people have the right to have their say, to have a free and fair debate in the public square about the tax reform issue and that is where it ought to stay. That's why this bill is troubling to me. It is clearly intended to try to influence the outcome of that vote, having first put the issue in front of Maine votes and we're now going to try to influence how they vote through legislation we pass this year. Less there be any doubt about the intent of this bill, I would encourage you to take a look at the Committee Amendment on the Minority Report which specifically has a contingency provision that would only take effect if the tax reform Citizen Veto effort is successful. It is telling people to join the effort to repeal the tax reform package that was presented to them and that we've got something else waiting in the wings. That is cynical and it's unfair to Maine voters and we ought to have this debate out in the public square. Let's do it. Let's stop having the charade of alternatives that try to influence their votes here in this chamber. Let's take the debate to the people and let them have their say. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Washington, Senator Raye.

Senator **RAYE**: Thank you, Madame President. I have to stand in response to the comments of my good friend from Cumberland. I'm sorry. It's not a charade. This is a discussion of heartfelt differences. I think the suggestion that this is somehow a charade is very unfortunate. It's not just an issue of what would have happened if a bill like this had been passed. The fact is that a bill like this was passed. Unfortunately, when the Democratic Majority in the subsequent legislature took office, they repealed it. We had this law on the books and it would have brought us a lot further ahead, I believe, in strengthening the economy and the job picture in this state. This is an alternative to the measure that I know friends on the other side of the aisle like and put through with their automatic indexing to subject taxpayers to tax increases down the road, but it is not a charade. It is a discussion, I think, of a heartfelt difference in opinion. Thank you.

**THE PRESIDENT:** The pending question before the Senate is the motion by the Senator from Penobscot, Senator Perry to Accept the Majority Ought Not to Pass Report. A Roll Call has been ordered. Is the Senate ready for the question?

#### JOINT RESOLUTION MEMORIALIZING THE PRESIDENT OF THE UNITED STATES AND THE UNITED STATES CONGRESS TO ENACT THE LYME AND TICK-BORNE DISEASE PREVENTION, EDUCATION, AND RESEARCH ACT OF 2009

WE, your Memorialists, the Members of the One Hundred and Twenty-fourth Legislature of the State of Maine now assembled in the Second Regular Session, most respectfully present and petition the President of the United States and the United States Congress as follows:

WHEREAS, Lyme disease is a common but frequently misunderstood illness that, if not caught early and treated properly, can cause serious health problems; and

WHEREAS, Lyme disease is a bacterial infection that is usually transmitted by a tick bite, and early signs of infection may

include a rash and flu-like symptoms such as fever, muscle aches, headaches and fatigue; and

WHEREAS, although Lyme disease can be treated with antibiotics if caught early, the disease often goes undetected because it mimics other illnesses or may be misdiagnosed and, if untreated, can lead to severe heart, neurological, eye and joint problems because the bacteria can affect many different organs and organ systems; and

WHEREAS, although Lyme disease accounts for 90% of all vector-borne infections in the United States, the ticks that spread the disease also spread other diseases such as ehrlichiosis, babesiosis and anaplasmosis; and

WHEREAS, the federal Centers for Disease Control and Prevention indicates that the reported cases of Lyme disease are only 10% of actual cases that meet its surveillance criteria and has reported 27,444 new cases of Lyme disease in 2007, a 38% increase from the year before; and

WHEREAS, the persistence of symptomatology in many patients without reliable testing makes treatment of patients more difficult; and

WHEREAS, the Lyme and Tick-Borne Disease Prevention, Education, and Research Act of 2009 has been introduced in the 111th United States Congress as H.R. 741/S. 1352; and

WHEREAS, the Lyme and Tick-Borne Disease Prevention, Education, and Research Act of 2009 would advance the treatment of, and cure for, Lyme disease and other tick-borne diseases by expanding federal efforts concerning prevention, education, treatment and research activities related to Lyme disease and other tick-borne diseases by providing authorization for the appropriation of \$20,000,000 for each of the federal fiscal years from 2010 to 2012 for these activities; and

WHEREAS, this legislation would also require the United States Secretary of Health and Human Services to annually report to the United States Congress on these activities and make recommendations for further research and education and would establish the Tick-Borne Diseases Advisory Committee within the Office of the Secretary, United States Department of Health and Human Services; now, therefore, be it

RESOLVED: That We, your Memorialists, on behalf of the people we represent, respectfully urge and request that the President of the United States and the United States Congress enact the Lyme and Tick-Borne Disease Prevention, Education, and Research Act of 2009, which is currently pending in the United States Congress; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable Barack H. ## JOINT RESOLUTION MEMORIALIZING THE UNITED STATES CONGRESS TO ENACT A STRONG FEDERAL CLEAN ENERGY AND CLIMATE BILL

WE, your Memorialists, the Members of the One Hundred and Twenty-fourth Legislature of the State of Maine now assembled in the Second Regular Session, most respectfully present and petition the United States Congress as follows:

WHEREAS, not only the State of Maine, but the United States as a whole, is now facing historic energy and climate challenges, particularly economic and environmental challenges, that are a result of our overdependence on fossil fuels; and

WHEREAS, citizens of the State of Maine are finding it increasingly difficult to heat their homes affordably, and federal action on our energy and climate is long overdue; and

WHEREAS, the Federal Government must act quickly to develop and implement a clear climate and energy policy; and

WHEREAS, Maine has the oldest housing stock in the nation, and 80% of Maine homes are heated with oil, and Maine people suffer major financial hardship during periods of price volatility; and

WHEREAS, the Central Intelligence Agency has created a center on climate change, the United States Marine Corps plans to reduce its carbon emissions by 30% by 2020 and the United States Navy is reducing its carbon pollution on homeland bases by 50% by 2020 and launching a clean energy battle group by 2016; and

WHEREAS, Maine's industrial sector is struggling with its energy costs, putting hundreds of good jobs at risk throughout the State; and

WHEREAS, having access to efficient energy, using the cheapest and cleanest form of energy and properly weatherizing buildings would create jobs and reduce energy consumption and energy costs for the vast majority of the people of Maine; and

WHEREAS, Maine has created the Efficiency Maine Trust to coordinate energy efficiency efforts across the State; and

WHEREAS, Maine is a leader in renewable power research and development, is successfully migrating from fossil fuels to nonfossil fuels and indigenous and renewable resources and has a plan in place to develop significant inland and off-shore wind farms as a means to create jobs, reduce our carbon impact and produce clean, renewable power; and

WHEREAS, Maine must become a leader in the energy sector with a workforce prepared with the skills and information necessary to attract strong, vibrant businesses; and

WHEREAS, the American Clean Energy and Security Act of 2009, which passed in the United States House of Representatives, lays the foundation for solving America's energy and climate challenges; and

WHEREAS, this Act would increase the use of renewable energy, spur the development of a smart power grid, promote electric vehicles and require the implementation of energy efficiency measures; and

WHEREAS, the American Clean Energy and Security Act of 2009 will put Americans back to work building, delivering and installing the systems and technologies that will help us meet our energy and climate challenges; and

WHEREAS, in addition, 2 other major bills have been introduced in the United States Senate on this important subject, including the Clean Energy Jobs and American Power Act and the Carbon Limits and Energy for America's Renewal (CLEAR) Act; now, therefore, be it

RESOLVED: That We, your Memorialists, on behalf of the people we represent, respectfully urge and request that the United States Congress enact a strong clean energy and climate bill that:

1. Puts in place a carbon reduction standard that reduces carbon emissions by 17% below 2005 levels by 2020;

2. Dedicates revenues for energy efficiency and weatherization, giving priority to those states with the greatest need;

3. Ensures that states retain their authority to set higher standards than the Federal Government; and be it further
