THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Alfond.

Senator ALFOND: Thank you Mr. President. Mr. President and ladies and gentlemen of the Senate, I stand here today to oppose Mr. Congdon's nomination for the Commissioner of the Department of Economic and Community Development. Let the record show that I stand here today not against Mr. Congdon's very impressive qualifications as a businessman or all of his impressive personal successes. Instead I stand here as a business owner myself. I stand here as a business owner myself with deep concerns that Mr. Congdon is not qualified for this job. By his own admission, he doesn't have the experience necessary to lead such a sophisticated department. There are major gaps in his resume. I'll highlight one; tourism. Tourism in the state of Maine is a critical part of our economy. Yet, as I look through his resume and I listen to the guestions asked when Mr. Congdon was in front of the Labor, Commerce, Research and Economic Development Committee, I didn't see or hear anything that made me feel comfortable about his tourism experience.

I'm especially uncomfortable and dismayed by his lack of preparation during the hearing, especially around his admission that he hasn't even considered economic development in Aroostook County. A gentleman who has been nominated for this post has not considered economic development in Aroostook County. I'm trying to connect the dots. Governor LePage has stated over and over again that economic development is his top priority. Yet today, and through the committee, they have nominated someone who doesn't have the experience to lead that very department in charge of economic development and labor. We have unique economic development issues here in the state of Maine. I'll bring up one; Brunswick Naval Air Station, a very sophisticated transaction that this state has spent years working in preparation for. Yet we are, today, looking to nominate someone who doesn't have that sophisticated experience to lead this department.

This job is too important to give to someone who will be getting on the job training. I believe there are lots of talented people in the state of Maine that could have been tapped but they weren't. Thank you Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Knox, Senator Rector.

Senator RECTOR: Thank you Mr. President. Ladies and gentlemen of the Senate, I must say that I am a little stunned by my good colleague from Cumberland's objections. Under the circumstances, it seems to me we had a candid, forthright, and wide-ranging discussion with the candidate, Mr. Congdon, as our potential Commissioner for the Department of Economic and Community Development. He brings to us a range of management skills that I think are unquestionable and unexcelled in that role. I would suggest to you that his understanding of the direction that the state needs to take in terms of research and development and the development of new technologies is probably unsurpassed. That candor, I must say, was also particularly refreshing and I think is part of what my good colleague is referring to. When Mr. Congdon was freely speaking about some of the issues that he didn't care to stand and make long comments about but instead wanted to recognize the fact that he was going to be ready to learn the job in the specific areas in a way that reflected both the administration's values, I think, and the values of the people of the state of Maine. As far as tourism goes, being involved in that business myself and having a particular concern that we recognize the value of tourism up and down the coast and in the lakes and mountain regions of the state, I think we have demonstrated our expertise in that area and I know Mr. Congdon is going to bring his new vision to that department and be able to continue the work that we are doing. I will say that it is also the privilege of the Chief Executive, in my view and I have demonstrated this in my committee activity throughout my time here in the legislature, to choose the candidates that he feels most reflects his values and will be able to lead the department most ably in his opinion. I think Mr. Congdon has the full trust of both the committee and the Chief Executive and I know will capably lead the state of Maine forward in the economic development arena. Thank you Mr. President.

At the request of Senator **PLOWMAN** of Penobscot, Report **READ**.

THE PRESIDENT: The Chair recognizes the Senator from Sagadahoc, Senator Goodall.

Senator GOODALL: Thank you Mr. President. Men and women of the Senate. I rise today to speak in opposition of the Governor's nominee for the Department of Labor, Business, Commerce, Research and Economic Development. At the same time this exercise of debating the merits of nominees is worthwhile, is needed, especially in this deliberative Body. For me it's a great concern that this nominee is lacking experience with those small businesses that dot Main Street of all of our districts. His resume is impressive and we owe him a great debt of gratitude for his service to the state in the short time that he has been here and to the economy of this country. Now is not the time to have someone in this position that does not have a plan moving forward and experience in the number one industry, and that is tourism. In years past I may have felt differently about this but the voters of Maine, without a doubt, have concerns about the economy and, most importantly, job creation. For me, and I think many of us would agree, those micro-businesses, especially the small businesses, are what is going to help our economy

rebound. I bring that to this debate and I urge you to join me in opposition. Thank you Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Lincoln, Senator Trahan.

Senator TRAHAN: Thank you Mr. President. Ladies and gentlemen of the Senate. I would like to reiterate a lesson that I learned early in my political career. Having been a fighter and somebody who was willing to come up at any given time and face a challenge and put up a fight, I had some good advice given to me once that goes like this: Dave, don't fight for the sake of fighting, fight for principle. I'm going to speak to you today about a conversation I had with our new Chief Executive just vesterday. When we were discussing a future appointment to another cabinet level position he stressed to me that he wanted to change the direction of the state, he wanted people that were honest, that were tough, and were willing to challenge the status quo. I think the nominee before us is just that type of person. If you ask me if I want to follow the model of the past that has led us to be ranked by the Forbes folks as fiftieth worse place in the nation to do business I would say to you that it's time to change the model. I don't want to use the model of the past. I want to use a model of reformers, of people that want to come to Augusta and change the course of the state. We have that nominee and I ask folks that if you are going to put up a fight put up a fight for principle, not just simply to fight.

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Jackson.

Senator JACKSON: Thank you Mr. President. Members of the Senate, I don't know if I am putting up so much of a fight but I listened to the nominee for an hour and a half and was struck by how honest and candid he was on a number of questions. He certainly seemed like someone you would enjoy spending time with outside of this institution. As happens many times, you leave this building and go outside of this vacuum. I was sent many emails over the weekend from people that are in economic development, particularly in Aroostook County. They are quite concerned with the answers to some of the questions that the nominee was asked. So I'm a bit torn by my vote in committee at this point. I represent Aroostook County and have had a number of people in Aroostook County question the qualifications. Honestly, as I stand here I don't really know which way I'm going to go. I know that Mr. Congdon, I thought, was quite honest in the committee, which was refreshing, but at the same time I'm elected to represent Aroostook County. As I said, I'm torn. It would be nothing personal if I was to change my vote at this point. I don't know if I have actually done that in the past but it certainly would be my prerogative. My biggest reason for standing up is to explain what is going on right now with the people in my district.

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Courtney.

Senator COURTNEY: Thank you Mr. President. Men and women of the Senate, I rise today because I had the opportunity to look at the resume of Mr. Congdon when it was presented by the Governor a couple of weeks ago. I've got to tell you that I am a little surprised, after going through the unanimous report, that we are even having this discussion today but each Senator has

the right to do that and I respect the we exercise that right. I will say that if you look at his resume it probably is much better than most of us sitting in these seats. You know it's a new day in Augusta. It's a day where we're going to look at things differently than the way that we did before. We're not going to take somebody with a lot of political history or political influence and make them a Commissioner just because they've made a lot of friends around this building for a long time. It's time that we brought people with common sense solutions from the private sector to try to right the ship of state government. It hasn't been working the way it is. Any time you take on a new job there are certain areas that you just have to learn on the job. I believe that if you look at this background of this eminently qualified candidate I think that you will see that he will more than rise to the occasion to save the economy of our state. I would encourage you to vote with me, opposing rejection of the nomination by voting no in support of Phil Congdon. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Gerzofsky.

Senator GERZOFSKY: Thank you Mr. President. Ladies and gentlemen of the Senate, I've sat in this chamber and I have listened to many debates on confirmations. I remember the person who used to occupy this desk getting up and speaking eloquently opposing some of the nominees in the last year or two, the reappointments. I believe that there are consequences with elections. It's the darnedest thing. People go out, they run for office, they run on a program, they are very lofty in their goals, and when they win the election they win everything that comes with it, for good and for bad. I think that the Chief Executive ran statewide on a very explicit program and was clear in his intention to what he was going to do if he was successful. His nominees come in front of the Senate for confirmation after they go through the committee process and it is our obligation to look at that nominee, look at his qualifications, look at his background, look at his past, and see if there is anything that is glaringly in opposition with the fundamental beliefs of Maine. I haven't seen any of those. I've read the resume but probably less than others. I've been dealing with my own committee. I think it's the Governor's opportunity to name who he feels is going to do the best job. That person is a reflection on the Governor. He is a reflection on the Governor's choice and, for good or bad, the Governor is going to have to live with that decision. If the nominee does a really good job, and really does the things that the Governor talked about, the Governor will get credit or blame, however that is interpreted by the people. I think it's my responsibility, as I didn't run for statewide office and I didn't run to be Governor but I ran to be a Senator, is represent my district. That's the way that I think the Senate is built. We're going to look at these nominees and we're going to understand that the Governor is the one that appoints this person. We're only going to confirm it or not confirm it. We're not making those appointments. It's up to the Governor to pick the right people and when he thinks he has I think it's up to the Body to support that nominee. At the end of the day it's the Governor who is going to rise or fall on his nominations. Thank you very much.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Bartlett.

Senator BARTLETT: Thank you Mr. President. Each and every one of us that is elected to this chamber has a responsibility to evaluate the qualifications of each and every nominee that comes before us. That is our right and our responsibility to vote in accordance to our values, our principles, and what we think is best for our districts and the people of state of Maine. To oppose a nominee because, based on his own admission, his resume on economic development is thin to chair the Department of Economic Development, to me, is not fighting for the sake of fighting, it's not trying to get in the way, it's simply trying to acknowledge the weakness in the qualifications of a particular candidate and to vote according to our own conscience and our own principles. I hope that as we move forward each and every one of us can do that with pride and can respect the competing points of view even when our principles pull us in different directions. Thank you Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Schneider.

Senator SCHNEIDER: Thank you Mr. President. Men and women of the Senate, I am, quite frankly, surprised at all this debate given the report that was fully supportive of this nominee and taken a bit off guard by it. I was not privy to the entire debate at the committee hearing. However I did check in with some folks to see how that hearing went. I heard the nominee did rather well and answered as candidly and honestly as he could during the hearing. I think there are always occasions when people don't have all the answers and they don't have all the experience but are still able to proceed and do a very thorough and adequate job. My hope is that this nominee will do that and I'm going to support this nominee. Thank you.

In accordance with 3 M.R.S.A., Chapter 6, Section 151, and with Joint Rule 506 of the 125th Legislature, the vote was taken by the Yeas and Nays.
