The President laid before the Senate the following: "Shall the recommendation of the Committee on CRIMINAL JUSTICE AND PUBLIC SAFETY be overridden?"

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Gerzofsky.

Senator GERZOFSKY: Thank you Mr. President. Ladies and gentlemen of the Senate, I'm pleased to stand here today in full support of Joe Ponte for Commissioner of the Department of Corrections. As people in this chamber know, we've had some questions on this nominee around private prisons, his association working for a private prison system. Out of 41 years, the last 8 years of his career he spent in private prisons. That brought concerns to us, especially where during this past campaign we had talked about and we had heard mentioned privatizing our system or bringing private prisons to the state of Maine. That brought a lot of concern and questions from my committee, from this side of the aisle, and I heard some from the other side of the aisle. We spent many hours going over these questions with the nominee and going over it with the Governor's Office. We had assurances that this wasn't going to be the case, to bring private prisons to the state of Maine, because there was no real need of

it. We have the capacity to be able to incarcerate more people in the state of Maine. We talked about the nominee's stocks that he owns in the company and his willingness to sell those stocks so there wouldn't be a question going forward. We talked about his qualifications, especially in the area of juvenile incarceration, women, and people with mental illness. He answered all those questions and showed that he had a deep understanding of modern thinking on incarceration, especially with those populations. He brought, I believe, quite a bit of comfort to the committee through the process. Chief Executives get to appoint the Commissioners and the Senate gets to advise and consent. We certainly gave a little bit of advice, but we really gave a lot of consent. I stand today in full support, as I hope the Body will today, and will vote in a unanimous manner for this nominee.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Mason.

Senator **MASON:** Thank you Mr. President. Ladies and gentlemen of the Senate, I rise in support of Mr. Ponte today. We had our committee hearing yesterday, as the Senator from Cumberland, Senator Gerzofsky, pointed out. He was really quite impressive, to say the least. He endured well over an hour of questions from the committee. He answered them thoroughly and to the point and, in my opinion, satisfactorily. Anyone who can endure an hour of questioning in a committee is worth their weight in salt in my opinion. This gentleman has 40 years of experience in corrections. He has a proven history of reform. He's recommended by private and public prison officials as well as dignitaries from around the country. We had a litany of people who were clamoring to support Mr. Ponte for this position. I think we had ample testimony in his favor. One of the most telling recommendations came from a gentleman who didn't even intend to testify; a former inmate of the Maine State Prison who came to listen to the proceedings because he understands what it's like to be on the inside of a prison. He stood up to say that this man nailed it on the head; he knew the relationships that prisoners and guards and corrections officers were supposed to have with each other. Coming from an inmate, I think that this is admirable. In closing, Mr. President, we need someone who has been outside of the box and knows how to think out there. I think that it's admirable that this nominee is willing to come to our state and look at it, as he said, with no dog in the fight and be willing to look at our prison system, improve on it, and make it better than it already is. We have a well qualified candidate here that has graciously accepted the Chief Executive's offer to take this position. Mr. President, I would ask the Senate to unanimously confirm Mr. Ponte today. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Brannigan.

Senator **BRANNIGAN:** Thank you Mr. President. Lance Tapley approves of it.
