The President laid before the Senate the following: "Shall the recommendation of the Committee on INLAND FISHERIES AND WILDLIFE be overridden?"

THE PRESIDENT: The Chair recognizes the Senator from Lincoln, Senator Trahan.

Senator TRAHAN: Thank you Mr. President. Ladies and gentlemen of the Senate, it is my pleasure today to rise in support of the nominee, Chandler Woodcock, a good friend and a fellow colleague and member of the Inland Fisheries and Wildlife Committee. We had a lengthy public hearing on Chandler Woodcock's nomination. For well over two hours the candidate and his supporters were before our committee. I just want to repeat some of the really nice things that people said about Chandler Woodcock. Ex-Senator Karl Turner called Chandler Woodcock a gentleman, thoughtful and pragmatic as well as principled individual with an unbounded love for Maine's outdoors. I concur. The Maine Audubon Society supported Chandler Woodcock. I was surprised, pleasantly, to learn that Chandler won the 120<sup>th</sup> Conservation Award from Maine Audubon. Fifteen individuals and groups came to the podium to support Chandler Woodcock, none in opposition. One of the things that I think is incredibly important for the new Commissioner of Inland Fisheries and Wildlife is their demeanor, their honesty, and their ability to lead people. Chandler Woodcock has all of those qualities. Many times, as we all know, committee meetings can become quite contentious, but there has never been a time that I saw Chandler Woodcock get knocked off the rails. Never did he lose

his temper. Never did he raise his voice. Never did he attack anyone. He just always put forward his principled position on issues. Lastly, the thing that I found out, and I think to be the most important piece of Chandler Woodcock's commitment to the outdoors, is that he always put the resource first and politics second. For someone who has run for Governor and been in the political process, that is a very difficult road to walk but he did it like a pro. I hope today that our vote will be unanimous for one of what I think is the best picks of this administration for any office. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Franklin, Senator Saviello.

Senator SAVIELLO: Thank you Mr. President. I've known Chandler for over 20 years, long before I knew either one of us would be sitting in this seat and I have in fact, as many of you know, followed his footsteps. In that time I've learned that Chandler is a man of integrity, professional, and exudes the word leadership in everything he does. He is a leader. He's an avid outdoorsman. Most importantly, he wears bowties. There is no doubt in my mind his enthusiasm, energy, leadership, and, yes, his bowtie will lead the Inland Fisheries and Wildlife Department into the future. I look forward to working with Chandler Woodcock. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Oxford, Senator Patrick.

Senator PATRICK: Thank you Mr. President. Ladies and gentlemen of the Senate, colleagues, and friends, I, too, stand in favor of the nominee, Chandler Woodcock, I must admit that I was one of the two that didn't make it to the confirmation hearing and I had at least 35 questions to ask the nominee. I know I could have made the hearing at least three hours long. I did serve with Chandler on the Legal and Veterans Committee. He is an honorable man. I do have full confidence in him. I do realize that he and I probably never voted the same on labor issues and stuff like that but that doesn't deter my support for him. I know that in the capacity that he will be in that he will do a wonderful job and that all the questions were answered and vetted in a very professional manner. #### READ and ORDERED PLACED ON FILE.

The President laid before the Senate the following: "Shall the recommendation of the Committee on LABOR, COMMERCE, RESEARCH AND ECONOMIC DEVELOPMENT be overridden?"

THE PRESIDENT: The Chair recognizes the Senator from Knox, Senator Rector.

Senator RECTOR: Thank you Mr. President. Men and women of the Senate, rarely is someone so exceptionally well qualified for a position as Mr. Sighinolfi is for the position of Executive Director of the Workers' Compensation Commission. This is an extremely important position for both employers and employees in Maine because it is critically important that our Workers' Comp program operates as smoothly as possible and that compensation be awarded fairly for all concerned. Literally, Mr. Sighinolfi wrote the book that we use as the guidebook for Workers' Comp here in Maine. He was one of the co-authors and so that, I think, in itself qualifies him for this position. We had a public hearing where people from all walks of business and labor came forward and spoke on his behalf. He has the trust, I think, of those that will be working with him and will be relying on the decision making that will come from the Workers' Comp Commission. It was a unanimous committee report and I think many of the members spoke in favor of this nomination. I think we are fortunate, as a state, to have someone who is willing to take this time and step away from their law practice and instead realize that service to the state of Maine is so important that they would take up this position and lead us in Workers' Comp. I'm very grateful to Mr.

Sighinolfi for doing this and I trust that my colleagues will join me supporting his nomination. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Oxford, Senator Patrick.

Senator PATRICK: Thank you Mr. President. Colleagues in the Senate, I'm standing here probably speaking neither for nor against because I didn't have an opportunity to make the hearing. I do have some reservations and I'm not even going to touch upon the reservations that I have because of the 13 - 0 report. What I want to do is go on record for the members of the Senate and the citizens of the state of Maine and Mr. Sighinolfi and let him know that we had a problem prior to 1993 with Workers' Comp. Although I was not happy with the bill he evidently helped get passed, I am here to say that since the initiation in 1993 that our Workers' Comp System, although I don't agree with a lot of it, is actually a success.

I wanted to go on record to let people know that in the early 1990s the Maine Workers' Comp System was a major problem facing the State of Maine. Costs were spiraling out of control, the highest in the nation. Workplace injuries were above the national average, most of the insurers had left the state, and employers were shutting their doors. Reforms were enacted in 1993. After a slow start, these reforms have placed Maine's Workers' Compensation System among the most successful in the country. Seventeen years later the Workers' Compensation System is strong. The cost of Workers' Compensation insurance has decreased by over 43%. In 1992 there were three Workers' Compensation insurance carriers doing business in Maine, only three. Today the Workers' Compensation insurance market is competitive with over 200 insurers underwriting Workers' Compensation in this state. The self-insured market is stable. with over 40% of the market. MEMIC has been a leader in the field, insuring nearly 65% of Maine employers. Dispute resolution is probably at an all time best level with 76% of its cases being resolved within 90 days and more complex cases within eight months. In the early 1990s it took nearly 24 months for a case to clear dispute resolution. The Office of Monitoring, Audit and Enforcement, the Maine program, has compliance with the act to the 80% to 90% by insurance, self-insured and third party administrators. This program has gained recognition as one of the outstanding programs in the country. The Maine staff ensure that employees are paid timely, paid accurately, and their cases are not unreasonably denied. The staff also makes sure that employers are receiving the best coverage possible by keeping claims administration costs low. Examples are: ongoing adjusting training, workshops, utilization analysis, and compliance penalties are paid by the insurers and not by the employers. The Workers' Compensation Board advocate program represents 40% of the injured workers at the mediation level and 30% at the formal hearing level, with saving to the system in attorney costs of approximately \$25 million per year.

Maine has gone from one of the costliest states in the nation to one that is moving to the level of average cost for both premium and benefits and has positioned itself to continue with this trend. The NCCI has estimated a 4/10 of a point premium increase in 2011. We do have some challenges: implementing the hospital/medical fee schedule; updating the current permanent impairment threshold and introducing legislation to establish a 10 year PI threshold; maintaining excellence in the current delivery of service with 109 staff members with a \$10.4

million budget, which is dedicated funding and not General Funds; addressing employee misclassifications by insuring an equal playing field for all Maine employers; developing one uniform definition of independent contractor for all State agencies, especially the Maine Revenue Service, Maine Department of Labor, and Maine Workers' Comp Board.

What I would like to say to Mr. Sighinolfi is that this is a level that, over the last 17 years, we have raised up and it is my feeling that anything that moves us back where people are going to take longer and longer to get their hearings and cases resolved is not acceptable and I'm hoping that this 13 - 0 decision on his behalf will give him the impetus to make sure we at least maintain what we have and I hope he can actually make it a little bit better. With that, I will be supporting him. Thank you Mr. President.

Men and women of the Senate, I rise to concur with my colleague from Knox on all of his remarks and also just to say that I had the good fortune to know Mr. Sighinolfi for many many years. He has the highest integrity and I know he will rise to the occasion and serve us well in this post. I, too, will be supporting this nomination and voting red. Thank you.

Rule 312. Fiscal Notes.

1. Fiscal note required. Every bill or resolve that affects state revenues, appropriations or allocations or that requires a local unit of government to expand or modify that unit's activities so as to necessitate additional expenditures from local revenues and that has a committee recommendation other than "Leave to Withdraw," "Ought Not to Pass" or "Referral to Another Committee" must include a fiscal note prepared by the Office of Fiscal and Program Review. For a bill or resolve not yet reported out and upon request of a majority of the committee, the Office of Fiscal and Program Review shall, after notice by the committee to the sponsor of the bill or resolve, meet with the committee at a work session to present its analysis and provide copies of the written public materials relied upon by the office to prepare that fiscal note. The committee clerk shall provide the Office of Fiscal and Program Review with a copy of all testimony and other materials received by the committee on a bill or resolve whenever the committee recommendation is other than "Leave to Withdraw," unanimous "Ought Not to Pass" or unanimous "Referral to Another Committee." The fiscal note must accompany the committee report before it is reported out of committee. Any amendment introduced that would affect the fiscal impact of the original bill must also include a fiscal note. The Office of Fiscal and Program Review has the sole responsibility for preparing all fiscal notes.

If a sponsor of a bill disagrees with the fiscal note prepared pursuant to this rule, the Office of Fiscal and Program Review shall indicate that the sponsor disagrees with the fiscal note and shall delineate the reasons for the sponsor's disagreement.

2. Preparation of fiscal notes. If, in its preparation of the fiscal note required under this rule, the Office of Fiscal and Program Review receives fiscal information from a state agency, consultant, lobbyist, lobbying organization or other outside entity, the office shall notify the sponsor of the bill of the receipt of the information and shall provide to the sponsor an opportunity to review the information. The sponsor of a bill may meet with the office and source of the information to review the information; if the sponsor is unable to schedule such a meeting, the office shall provide to the sponsor any notes relating to such a meeting between the office and the source of the information.

- E. Amounts and sources of costs or savings resulting from increased or reduced federal funds expected to result from the bill, including increases or reductions in employment, salaries or tax revenues; and
- F. Any other information relevant to the preparation of the fiscal note.

After meeting with the Office of Fiscal and Program Review, the sponsor has 2 working days to prepare a proposed committee amendment for submission to the joint standing committee to which the bill has been referred, or to provide additional information, including the names of persons with expertise in the subject matter of the bill, to the Office of Fiscal and Program Review to aid the office in its preparation of the fiscal note.

ORDERED, the Senate concurring, that the Joint Select Committee on Health Care Costs is established as follows.

1. Joint Select Committee on Health Care Costs established. The Joint Select Committee on Health Care Costs, referred to in this order as "the committee," is established.

- 2. Membership. Notwithstanding Joint Rule 353, section 5, the committee consists of 17 members, appointed as follows:
- A. Five members of the Senate appointed by the President of the Senate, including members from each of the 2 parties holding the largest number of seats in the Legislature and with preference to members of the Joint Standing Committee on Insurance and Financial Services, Joint Standing Committee on Health and Human Services and Joint Standing Committee on Appropriations and Financial Affairs; and
- B. Twelve members of the House of Representatives appointed by the Speaker of the House, including members from each of the 2 parties holding the largest number of seats in the Legislature and with preference to members of the Joint Standing Committee on Insurance and Financial Services, Joint Standing Committee on Health and Human Services and Joint Standing Committee on Appropriations and Financial Affairs.
- 3. Committee chairs. The first-named Senator is the Senate chair of the committee and the first-named member of the House is the House chair of the committee.
- 4. Appointments; convening of committee. All appointments must be made by June 20, 2011. The appointing authorities shall notify the Executive Director of the Legislative Council once all appointments have been made. When the appointment of all members has been completed, the chairs of the committee shall call and convene the first meeting of the committee, which may not be held before June 20, 2011. If by June 20, 2011 a majority but not all appointments have been made, the chairs may request authority and the Legislative Council may grant authority for the committee to meet and conduct its business.
- 5. Duties. The committee shall review current health care costs in this State, including, but not limited to, the costs for health care delivery and health insurance, and determine the State's opportunities for reducing overall health care costs.
- 6. Consultation with stakeholders. The committee shall consult with stakeholders including the Office of the Governor; the Department of Health and Human Services; the Department of Professional and Financial Regulation, Bureau of Insurance; health insurance companies; hospitals; health care providers; business and labor representatives; and advocates for health care reform.
- 7. Staff assistance. Notwithstanding Joint Rule 353, subsection 6, the Legislative Council shall provide necessary staffing services to the committee.
- 8. Report. No later than December 7, 2011, the committee shall submit a report that includes its findings and recommendations, including suggested legislation, to the Second Regular Session of the 125th Legislature.
