# JOINT RESOLUTION MEMORIALIZING THE UNITED STATES CONGRESS TO URGE THE GOVERNMENT OF CANADA TO END ITS SANCTIONING OF THE ANNUAL SEAL PUP HUNT

WE, your Memorialists, the Members of the One Hundred and Twenty-fifth Legislature of the State of Maine now assembled in the First Regular Session, most respectfully present and petition the United States Congress as follows:

WHEREAS, the State of Maine has strong and valuable ties to Canada, sharing a long, common border with the Provinces of Quebec and New Brunswick, and Maine is the state closest to the Canadian Maritime Provinces; and

WHEREAS, the Canadian commercial seal hunt is the largest annual mass slaughter of marine mammals in the world, and harp seals are the primary target of the hunt, with 98% of all harp seals killed in 2006 being pups under 3 months of age, and hooded seals are also killed; and

WHEREAS, the annual shooting, clubbing and often live skinning of more than 300,000 seal pups in front of their mothers has outraged much of the international community, including the European Union, which has banned all trade in harp and hooded seal products, and has prompted the international effort to boycott Canadian seafood products; and

WHEREAS, the slaughter is done mainly for the luxury fur market and therefore is unnecessary and is demonstrably cruel, as evidenced by wounded seals that are often left to suffer in agony and pups that are often initially only wounded, with an estimated 42% skinned alive while conscious; and

WHEREAS, Maine citizens believe in the humane treatment of animals, and a report by an independent team of veterinarians who studied the commercial seal hunt concluded that government regulations regarding humane killings were being neither respected nor enforced; and

WHEREAS, the Canadian government once banned this practice, but then removed the ban, which has resulted in the brutal deaths of over 1,000,000 seal pups in the last 3 years, and reports have shown that the slaughter of the pups failed to comply with Canada's basic animal welfare standards; now, therefore, be it

RESOLVED: That We, your Memorialists, respectfully urge and request that the United States Congress call on Canada's government to end its sanctioning of the annual baby seal hunt without delay; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the President of the United States Senate, to the Speaker of the United States House of Representatives, to the Canadian Ambassador to the United States and to each Member of the Maine Congressional Delegation.

**THE PRESIDENT**: The Chair recognizes the Senator from Penobscot, Senator Schneider.

Senator SCHNEIDER: Thank you very much Mr. President. I appreciate this moment to speak on this change to this legislation that we had passed in a previous legislature. Most communities are not in a position to afford the employment or services of town planners. As a result they move forward often not really understanding the wide, broad implications of large scale development on their communities. In an effort to provide a funding mechanism so that there would be ample opportunity to study the changes the large scale development would bring we passed the Informed Growth Act. This provides communities, without pitting them against each other, the funding mechanism for the impact study. We wanted to avoid pitting towns against each other and so all of them were brought in together to avoid that. The change on this bill, unfortunately, will undo that good work that we did. It sounds like it won't but what will end up happening is some communities will participate and others will not and this will create a patchwork which will definitely pit communities against each other because some will take advantage of the funding and others may not. I recognize, and some of us understood, that some of the large towns already have the means to develop an impact study and to understand what the implications will be of large scale development on their communities. However many of them don't take advantage of those services and, as a result, we see around Maine a lot of towns, until the large scale development is put in, don't understand that their downtowns are going to become virtual ghost towns. We see that. Our towns are very important to Maine's guality of life. It is why many of us choose to stay and live in Maine. It's because of that very unique quality our downtowns have on our quality of life. Unfortunately, this change will make it so our communities will not have a mechanism because they will feel, I think, that they cannot take advantage of the fee involved that will be collected from large scale developers. Unfortunately, they won't have the necessary information to at least make an informed decision on whether or not this is what they want for their community. I hope people will vote against the pending motion and I encourage you to reject the current motion and hold your vote for the Minority Report. Thank you very much.

On motion by same Senator, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT**: The Chair recognizes the Senator from Oxford, Senator Hastings.

Senator **HASTINGS**: Thank you Mr. President. Ladies and gentlemen of the Senate, this has been a bill that I have had great concern about since it first came before the legislature, I believe,

three sessions ago. First I want to point out that although the title indicates that this involves the repeal of the Informed Growth Act that, in fact, is not what it does. This bill simply says that any community that wishes to avail itself of what it sees to be the benefits of the Informed Growth Act must opt into that, must affirmatively decide that it wishes to be covered by the Informed Growth Act and its provisions. My opposition to the Informed Growth Act, from the beginning, has been based on my belief that the act was brought forward not to help engender development but to prevent development. It was brought forward initially as an attempt to prevent the development of large scale retail in Maine. That is my belief. What the Informed Growth Act does is require any developer of a large retail complex to pay a fee of about \$40,000 to the State Planning Office and then studies are done by a list of providers. Most of these providers coming from out-ofstate. Most of these experts on the list are from different places such as New Jersey, Chicago, and very few are from Maine. They are to do a comprehensive impact study. That sounds fine. An economic impact study. One of my great concerns has been that it's not to engender the growth and make sure that it is done in the right way. The way the study is set up, and the impacts that are to be studied are laid out, it sets up a roadmap to set up a roadblock for large scale development because the study says that if you find more than two of these impacts to be a negative, it doesn't say what it means by negative, that this is a reason to deny the project. One of those impacts will be that it competes against existing retailers. My goodness, that's the American way to start a new business. Obviously it competes against those already in the community. That's how we improve. To say that it is a negative impact because you might compete against somebody who already is selling the same goods in the community is, to me, just proof in and of itself that the purpose of the bill was to prevent large scale development. I don't know how much of it is because of the economy or how much of it is because of the act, but I do know that since the act became law not one of these large scale retail developments has occurred in the state of Maine. When I look at another thing, if this is all about keeping big boxes out of Maine what it really has become is Wal-Mart protection bill. They are already here. All this does is mean that the Targets of the world and the other large competitors aren't going to be able to get into Maine because they are going to come in and they are going to be selling the same goods as Wal-Mart. They are going say they want to put another store in to compete but they are not going to be allowed to. Ladies and gentlemen of the Senate, this bill, nevertheless, allows any community that wishes to go down that road to do so by simply voting to opt into the provisions of the Informed Growth Act. I think it's a fine compromise by the committee and I would hope that you would support the motion before the Senate. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Sagadahoc, Senator Goodall.

Senator GOODALL: Thank you Mr. President. Men and women of the Senate, I rise today in opposition to this motion. I rise to just point out a few specifics and add to this debate. It's important to note that I agree, compromise and working together in drafting proposals, no matter what the bill is, is appropriate most of the time in this distinct Body. That being said, compromise with an amendment to allow communities to opt in will further divide our communities when it comes to economic development and create competition, in essence, or pit one community against another because some communities will adopt ordinances and some may not. As a result not only will the communities not have the tools in their toolbox to know how the project will impact their community there is a greater likelihood that this community will probably receive the development without the proper planning. One thing we should not do is enact policies that pit one community against another. I think that is a very important component of this debate and I would encourage you to reject this motion. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Sullivan.

Senator SULLIVAN: Thank you Mr. President. Men and women of the Senate. I would ask you to support this motion. I sat through the committee hearings this year and we had several choices. I was actually going through my bag here to try to find a note that I was going to read to you. Then I remembered I couldn't use props. What I really wanted to do was show you that I did pay attention. The lady who wrote this sent me a dragonfly birthday card, crossed out birthday, and thanked me for the questions and for protecting this. It would have been somebody that probably would have preferred me to be on the Minority Report. I am not. This is a compromise. Compromise is both sides of the aisle giving up something they want and both sides of the aisle getting something or taking something they really didn't want. The opt in was the middle ground. Yes, it competes. It allows one community to compete against an other if they decide to opt in. The reality, people, whether it is in Veterans and Legal Affairs right now where we're talking about racinos or casinos, whether you are talking about where the next grocery store should go, or whether you are talking about the rate of property taxes in one community versus another, there is competition between communities. That's the name of the game. This says, what I think it should say, if a community wants to take part they may. They may. What is wrong with that? It is a compromise. I'll take the half a loaf of bread. It puts communities back where good government comes as close to the people as it can be. Times have changed. This is compromise. I think we need to look at what has happened. I'm surprised I was not prepared to even debate this morning, quite frankly. I am recalling from memory and when you get to be my age that's not always a good thing to do. I will tell you this was spoken about, talked about, and both sides gave. It is not often very easy for me to argue with the good Chair from Somerset, Senator Thomas, but he gave in a lot. I think it was to keep me quiet but that's okay. Whatever the reason. I gave in a lot. I think we've come out with the best we possibly can do. I think it keeps those communities that want to continue with growth so they certainly can. It allows competition and puts government closer to the people, the way it should be. I'm all for it. I hope you will join me in supporting this motion. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Penobscot, Senator Schneider.

Senator SCHNEIDER: Thank you Mr. President. Men and women of the Senate, the law on the books today does not prevent development in any way. I don't think there is a smoking gun of any sort that says that it's to hold up progress because I'm very much in favor of development as long as people understand what that development means. I don't think that a lot of communities have the funds necessary to really understand what that means. This was in no way, this law from my perspective nor do I think it does, saving to communities that they shouldn't develop. It simply allowed a mechanism to get funds to those communities on a level playing field that would allow them to at least understand potential impacts. Yes, negative impacts because that is really what most communities want to know. What will happen to our community that may really hurt us? Unfortunately, the opt in, as good as it sounds, is a compromise that unravels the legislation. It unravels the law. We were trying to prevent a situation which often happens under, for example, the Tax Increment Financing Law where communities are essentially forced into having TIFs because if they don't then the other community next to them will and they would lose the development. I don't want communities to lose development because they participate in having an impact study done. They may want that development. They may want large scale development. That's just fine. I think what we were trying to do was to say here is a mechanism to provide the community, on a level playing field statewide, the necessary information for them to at least move forward in whichever direction they choose in an intelligent and thoughtful way. By opting in, as wonderful as the compromise sounds, it creates a patchwork of one community who might want to participate but now feels that they can't because if they do they may actually lose the large scale development that they actually want. That was not my intension. That's what will happen here. We can see around the state what has happened to our downtowns. We know it because you only need to visit very close by towns whose downtowns suffer because the large scale development has pulled away a lot of the business to the little merchants down there. That's fine if that is what communities want and they understand what the implications are, whatever those implications are. That's great, At least this was a way to provide that information. I think you all know I'm always willing to compromise. I think this is one bill where compromise is not going to achieve what the law was intended to do, which was to create a level playing field with good information for communities so that they could make informed decisions. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Androscoggin, Senator Craven.

Senator **CRAVEN**: Thank you Mr. President. Men and women of the Senate, I actually rise to explain my vote and my support for this measure. When I served in the other Body I had voted in favor of the original bill and felt strongly that it was a good way to go. I realized that this bill is good for some communities and not good for others. However, I am standing in support of my own community because we do have in-house planners and have prepared space as well, right off Exit 80, for any large company that would like to come and do business in that area. I will be supporting this measure. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Somerset, Senator Thomas.

Senator **THOMAS**: Thank you Mr. President. I think a lot of folks expected more fireworks when the Senator from York, Senator Sullivan, and the Senator from Somerset, Senator Thomas, ended up on the same committee. To some displeasure, it's

been a great pleasure for me to serve with the Senator from York and I appreciate her wisdom. It's very wise not to underestimate the Senator from York, Senator Sullivan. We have a long and proud tradition in Maine of home rule and local control and town meetings. This compromise that we reached on the Informed Growth Act allows that home rule, allows that local control, so that each town can decide for itself if they want to limit or restrict growth. If they need tools in their toolbox those tools are available. I think that is why we passed it. I think it ends up a good bill. I think it ends up better because those who want growth and decide not to get in the way of growth can help facilitate it. Those that think that they need to restrict it and plan more are able to do that. With all of the communities in Maine, if there is one state where one size doesn't fit all it has to be Maine. Thank you.

THE PRESIDENT: The pending question before the Senate is the motion by the Senator from Somerset, Senator Thomas to Accept the Majority Ought to Pass as Amended Report. A Roll Call has been ordered. Is the Senate ready for the question?

In some cases I know that parents would like to have a second opinion. You go to a doctor. You take your appendix out or leave it. That's obviously a lot more involved than this. Thank you, Mr. President.

Senator **ALFOND**: Thank you Mr. President. Ladies and gentlemen of the Senate, I also just want to speak for a second and thank the good Senator from Aroostook for explaining it so well. I'm afraid that by passing this change we will put the parent-hired qualified examiner or evaluator up against the school qualified examiner and this may not be the best way to serve our students, their teachers, or the administrators.
