**JOINT RESOLUTION RECOGNIZING
MAY 17, 2011 AS DIABETIC PERIPHERAL NEUROPATHY
ALERT DAY**

WHEREAS, diabetes is one of the most prevalent and costly chronic diseases in the United States, and it is estimated that 23.6 million Americans, or 7.8% of the population, including approximately 77,000 Maine residents as of 2005, have the disease, a serious illness that has no cure; and

WHEREAS, another 57 million Americans, or one in 5 Americans, have prediabetes, a condition that puts them at greater risk for developing type 2 diabetes, and the prevalence of diabetes in Maine has been steadily rising, with a 50% increase in nongestational diabetes since 1994; and

WHEREAS, Maine has the highest rate of diagnosed nongestational diabetes in New England, and, among 10 other rural states with similar demographics, Maine ranked 2nd only to West Virginia in the prevalence of diagnosed diabetes; and

WHEREAS, diabetes is a leading cause of chronic disease mortality in the United States, and prevention of the disease is achievable only with education and regular medical care, including recommended testing and self-management practices; and

WHEREAS, diabetes can affect anyone, young and old alike, and minority populations have a higher prevalence of diabetes, especially the Hispanic, African-American, Asian and Native American populations, and minority populations in America have an increased risk for developing type 2 diabetes; and

WHEREAS, the American Diabetes Association estimates that about 60% to 70% of people with diabetes have mild to severe forms of nervous system damage due to diabetic peripheral neuropathy, which is a serious condition that damages nerve fibers due to the prolonged exposure to high amounts of glucose in the blood; and

WHEREAS, diabetic peripheral neuropathy sometimes causes intense chronic pain, including aching, tingling, burning and numbness of the feet, although most patients with this neuropathy have no symptoms but lose sensation in the feet and are at increased risk for falls and complications such as foot ulcers; and

WHEREAS, the rate for amputation of limbs in people with diabetes is 10 times higher than for people without diabetes, and in the United States more than 60% of nontraumatic lower limb amputations occur in people with diabetes; and

Joint Resolution

WHEREAS, diabetic peripheral neuropathy accounts for more diabetes-related hospitalizations than any other complication and many hospitalizations and deaths can be prevented by better management of the disease, including annual foot exams that encompass testing and treatment of diabetic foot issues; and

WHEREAS, in 1999, The Neuropathy Association found that 8.6% of all Medicare recipients had peripheral neuropathy as their primary or secondary diagnosis, with peripheral neuropathy treatment accounting for approximately 14 million Medicare claims at an approximate cost of \$3.5 billion dollars; and

WHEREAS, an increase in community awareness of risk factors and symptoms related to diabetes can improve the likelihood that people with diabetes will get the attention they need before suffering devastating irreversible complications; now, therefore, be it

Diabetes can infect anyone, young and old alike. Some ethnic groups are at higher risk for developing the disease than others. Notably, 60% to 70% of the people with diabetes have mild to severe forms of nervous system damage due diabetic peripheral neuropathy, which sometimes causes intense, chronic pain; including aching, burning and numbness of the feet. Indeed, some diabetics require amputation of lower limbs.

What is the prevention? The prevention of the disease is achievable only with education and regular medical care, including recommended testing and self management practices. Better management of the disease is possible when it includes annual foot exams that encompass testing and treatment of diabetic foot issues. We, the members of the 125th Legislature, take this opportunity to indicate our support for public awareness efforts to inform people of the many dangers posed by diabetes

and, in particular, what steps to take to delay or prevent diabetes and diabetic peripheral neuropathy. Thank you.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Cumberland, Senator Dill.

Senator **DILL:** Thank you Mr. President. Ladies and gentlemen of the Senate, this bill has to do with the streamline sales tax agreement, which was a creation of the National Governor's Association and the National Conference of State Legislatures in 1999 to simplify the collection of sales and use tax and make it easier for states to administer the collection of sales tax. This is a business friendly bill. The bill, itself, is simply to study what it would take for Maine to join the 26 other states in the country that have joined this interstate compact. The bill was supported by the Maine Merchants Association and the Maine Municipal Association. There are no opponents. There is no fiscal note. It is a bill that is supported widely by Wal-Mart and other businesses around the country because it simplifies a very complicated thing that businesses have to do, which is to collect sales tax. Most importantly though for Maine is that it levels

the playing field between small businesses and large businesses because, as you know Mr. President as a business owner yourself, you are required under Maine law to collect sales tax and remit it to the State and that has a cost to you and to your business. Out-of-state retailers, such as Amazon, transacts business with Maine residents and does not have to collect the sales tax. Now people who purchase things online are supposed to, in fact, denote that they have purchased things online and remit a sales and use tax to the State of Maine. I think it is indisputable that, unfortunately, people, either because they are unaware of that or are unwilling to conform to that law, don't do it. Therefore, Maine and other states that don't comply with the streamline use and sales tax fail to collect significant sums of taxes that are already owed. This bill would simply present information to the Taxation Committee and the Legislature about what it would take for Maine to join the 26 other states to make Maine more business friendly and to simplify and modernize the tax code. I strongly urge members of the Senate to reject the Majority Ought Not to Pass Report. I would simply note also that at the public hearing we had the benefit of hearing how this would help Maine businesses from Maine Merchants Association. We also had the benefit of a former Republican House Speaker from Iowa, Representative Christopher Rants, come and tell us how good this bill is for business. Initially there was a unanimous Ought to Pass report in the Taxation Committee, which pleased me very much. Circumstances arose. I am not quite sure what motivated a prompt and somewhat surprising reconsideration but there was one some weeks ago when I was involved, as some of you know, in an election in District 7. After the reconsideration, there was a Ought Not to Pass on party lines. I am not quite sure why there was reconsideration in committee. This is simply a bill that would collect information, present information to us, as legislators, to make Maine more business friendly. There is no fiscal note. It's supported by the Maine business community. It levels the playing field and it is a good bill for Maine business. I urge you to reject the Majority Ought Not to Pass Report and vote with me to support Maine business. Thank you.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Cumberland, Senator Woodbury.

Senator **WOODBURY:** Thank you Mr. President. Men and women of the Senate, I too am opposing the pending motion. We have three major taxes in Maine, as you know; income tax, sales tax, and property tax. Nobody likes any of them very much. I think that I would argue that the one they dislike least is the sales tax. One of the great challenges of the sales tax, in the current economy, is that more and more of our purchases are happening initially through mail order and now through internet orders, which don't have you going thru a store where sales tax is naturally collected. The great profound difficulty in trying to collect the sales tax through internet and mail order sales, that are dealing with buyers from all over different states, is that the definitions of what different products vary state by state. The entire goal of the streamline sales tax project is to have common definitions so that you know if you call something groceries, for example, it has that same definition state by state, by state. That is what the streamline sales tax project is about. I consider this largely a conformity bill, trying to conform, or at least how to conform, Maine's definitions to what the national standards of definitions are. All this bill does is ask Maine Revenue Services to look into what our definitions are and to show us what we would need to do

to conform. I want to be very clear, this doesn't lead to taxing anything new. We can still decide that any particular thing is exempt from tax or could be taxed. It just creates an environment where we have the same common definitions. Again, coming back to this bill. The bill is doing nothing but studying how would we change the definitions in Maine if we wanted them to conform to the national standards. I think that is a very sensible thing to do and that is why I am opposing the current motion. Thank you.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Lincoln, Senator Trahan.

Senator **TRAHAN:** Thank you Mr. President. Ladies and gentlemen of the Senate, I do want to address an earlier speakers' confusion as to why the bill might have been reconsidered. Our committee reconsidered at the very end dozens of bills that the votes changed. People, as they learned more about the issue, wanted to change their vote. That came from both parties and it happened a lot at the very end. It was very frustrating. That was just one of the bills that got caught up in it. It happened on both sides and it is just part of the process. As far as this bill and why we need to study it, this has been studied before nationally. If we are going to do this amongst the states it should really be done from the national level down, to create an even playing field for all states, and then work toward common definitions of what should be taxed. I think this is an attempt by some states who want to collect the money earlier then when the feds act to get that revenue. For Maine, it would mean about \$50 million in new revenue, according to the testimony. It is in the billions at the federal level. I think states see it as a new revenue stream. I don't disagree with that. In the future, as technology becomes more and more prevalent, you will see states eventually move to this. I believe it makes more sense to have it happen at the federal level instead of having individual states moving in that direction without any federal guidance. I believe that is the intent of the committee.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Cumberland, Senator Brannigan.

Senator **BRANNIGAN:** Thank you Mr. President. I'd pose a question thru the Chair if I may.

Senator **DILL:** Thank you Mr. President. In answer to the Senators' question, yes.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Lincoln, Senator Trahan.

Senator **TRAHAN**: Thank you Mr. President. Ladies and gentlemen of the Senate, a little different answer to that question. I think that we would have to have the streamlining and all of those definitions laid out before we actually had an idea of what that tax would look like once it's collected. Again, these are just guesses from Maine Revenue Services. I think it is important to note that this is an entire new area of statute that needs to be written. Definitions need to be clarified. It's a lot of work. Really, I think it is odd that each state would want to even work on local compacts until we got guidance from federal level on this issue. I think it's an attempt for individual states to form new compacts to create new revenue streams. To the Senator's point, I do remind him that we do have a free market society where people can travel around and find the best buys on goods. If they are doing that as an enforcement issue now, the Revenue Services from each state want to go out and try and enforce it to a greater extent they can do that. I can tell you right now it is not very politically popular. Imagine if we stopped people on the boarder, I will use this as an example, going into New Hampshire. We know how popular that is. If we tell people they can't shop in another state to save money, it maybe technically against the law, but when you try to track these people down and stop them from trying to find deals, I can tell you, it is not very pleasant. I am not saying I am for doing that. I am just saying it is a real mess. To the good Senator's point about trying to streamline it so that we can eventually get there, that may be what we are going to do in the near future, but I think it is unwise to do it as a state without federal guidance.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Penobscot, Senator Schneider.

Senator **SCHNEIDER**: Thank you very much Mr. President. Men and women of the Senate, I am concerned because this bill, what it seems to do, is trying to level the playing field for business that are here in our state, or at least too look at that. It seems to me very reasonable, since 26 states are already participating in this compact, to proceed and try to level the playing field so our Maine business, the businesses here in our state, are not at a disadvantage to the business online and that are not in Maine. This seems like a very reasonable way to move forward with this and I would really hope that we would use some very commonsense here and try to advantage some of the businesses here in our state. I don't want to incent people to go online to buy their products and items out of state. It weakens our economy here in this state. I am really in favor of moving forward with this because I think that this is an appropriate and business friendly bill. I would hope very much that you might consider joining me and voting against the motion. Thank you.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Cumberland, Senator Dill.

Senator **DILL**: Thank you Mr. President. Men and women of the Senate, I just want to address three points; one is that there is action being taken at the national level in conjunction with the states efforts in the streamline sales and use tax. There is a federal bill, the Main Street Fairness Act. It is currently moving through the congressional process. The problem that needs to be solved has to be solved at both the federal and state level. The feds are doing their part. The Maine Merchants Association is encouraging Senator Snowe and Senator Collins and our

Congress people to support the Main Street Fairness Act. Meanwhile the states are taking action in order to simplify and make it easier for business to comply with the myriad of state tax laws. The second point, I want to address is that yes, this would be a way for us to collect a tax that is already on the books. What we do with that money is up to us. The Republican House Speaker, Representative Rants, who was here speaking with us, used the money in his state for tax relief. If there was \$50 million in revenue we could use it to decrease our businesses' and constituents' tax burden, which I think is a good thing. The last point I want to make is on this free market idea. Free market depends on rules that are consistently applied. Right now in-state businesses, your book store on Main Street, is under the obligation to collect and remit a sales tax. That is something that costs them money and puts them at a competitive disadvantage to Amazon, which sells the books for less because they don't have to pay for the administration of the collection of sales tax. These out-of-state companies also do not contribute to the roads and the infrastructure that their companies use to make money here in the state. That is why it is businesses that are here in Maine that support this bill. It is a business friendly bill and I urge you to object to the pending motion. Thank you.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Sagadahoc, Senator Goodall.

Senator **GOODALL**: Thank you Mr. President. Men and women of the Senate, I rise today to join in the comments that the good Senator from Cumberland, Senator Woodbury, made earlier in regards to what the intent of this bill is. I think we need to bring it back home and also think about what we often deal with, with our constituencies, especially our small business owners, and their concerns about interpretation of laws and sales tax and addition to the legal arguments they often use, or the agreements they use to be persuasive, for why certain appeals should go forward or why certain taxes shouldn't be collected. They often refer to other states. They talk about conformity and the need to bring greater clarification so that it is done the same way when they are multijurisdictional in the businesses in which they operate. This bill is going to provide answers to us to allow us to move forward in a better way that is pro-business and, in addition to that, is going to allow us talk about raising taxes. There is a likelihood that some taxes will either be eliminated or not assessed on a certain type of sales based on conformity with other states. It cuts both ways. Before we take any action in the future we need to get the answers. That is what the intent of this bill is and I would urge you to oppose this motion.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Lincoln, Senator Trahan.

Senator **TRAHAN**: Thank you Mr. President. I was just going to rise to remind people that this does not do anything to add us to the compact. It doesn't do anything to define and actually collect the tax. This is just a study. This work is being done, as the previous speakers have mentioned, at the federal level already. I think we see this duplicative. I don't think there is anybody in this Chamber that is anti-business, as it is being implied. This has nothing to do with that. This is a study. This is an attempt I think, to get ahead of the curve so that if there is anything done at the federal level that we will be in line to begin to collect those taxes. I will remind you there is also this little old thing called the

Constitution and going across state lines and the sovereignty issues, they are very complicated. It is not as easy as just coming up some new definitions, join a new compact, and start collecting taxes. Our committee was very clear that we think this is premature. I will say that the House Chair mentioned that, maybe during the interim when we are doing some recodification of the tax code, we can look at doing things to see if we can't better line up our tax code. We are ready to do that. I don't think we have to have two things going on at the same time. I do think that members in this Chamber were here when we talked about doing that. It is not like we are trying to be anti-business or anti-agreements or anti-compact. We just feel there is a better mechanism to do that with the entire committee during a recodification of our tax code. With that, I hope that we would continue to support the motion. Thank you.

THE PRESIDENT PRO TEM: The pending question before the Senate is the motion by the Senator from Lincoln, Senator Trahan to Accept the Majority Ought Not to Pass Report. A Roll Call has been ordered. Is the Senate ready for the question?
