In Senate Chamber Thursday February 2, 2012

WHEREAS, the Legislature has learned with deep regret of the death of:

The Honorable James C. MacLeod, of Bar Harbor, our colleague and friend, who served in the Maine House of Representatives during the 105th, 106th and 107th legislative sessions. After graduating from Bar Harbor High School, Mr. MacLeod enlisted in the United States Army, serving in the Rhineland-Central Europe-Ardennes area during World War II. Mr. MacLeod and his wife, Jane, owned and operated MacLeod's Variety Store and Cabins and the original Bluenose Inn. He worked as vice president of marketing and public relations at Bar Harbor Bank and Trust, and served on its board of directors for 37 years. Mr. MacLeod also served on countless boards and committees around his community and was an original founder and trustee of College of the Atlantic. He was an active member of the Republican Party. serving as the Republican County Committee Chairman, the Republican Town Committee Chairman and a delegate to several state Republican conventions. He was a member of the Bar Harbor Congregational Church. We acknowledge his dedicated and longtime service to his community and to the State. He will be greatly missed by his family, friends and colleagues;

Senator ROSEN: Thank you Mr. President. I'm very happy to stand and join my colleagues from Hancock County in recognizing Jim MacLeod. I've known Jim a long time. His list of accomplishments here that are listed in the sentiment, I think, express to those folks in the Chamber the breadth and background and commitment to the community that Jim always held. He was dedicated to achieving things, to making sure that solid accomplishments took place. He had a quiet resolve, but was always on course and always steady and put community first. He loved his family very much. I wish to offer my condolences and best wishes to the family. Thank you, Mr. President.

Senator RAYE: Thank you Mr. President. I, too, rise to pay tribute to the memory of the Honorable Jim MacLeod. It is hard for me to imagine Bar Harbor, Maine without Jim MacLeod's presence. He was a genial, outgoing person who seemed to be involved in every facet of the life of that community. I've known him for many years. He was a true gentleman. He was devoted to his family. He was devoted to his community and to the state and his nation. He was a legislator, a businessman, a banker, a husband, and a father. He was predeceased by his wonderful wife, Jane. He was a veteran and served this nation with honor. He would, I am sure, want it noted here today that he was also a very devoted Republican. I rise, along with the Senators from Hancock, to join in paying tribute to the memory of a very good man.

Senator HOBBINS: Thank you Mr. President. Men and women of the Senate, I, too, rise in tribute to Jim MacLeod. This is truly a bi-partisan tribute to Jim MacLeod. I remember one time when I was running for another office, a higher office. He ran into me in Augusta and he said, "I really wish you luck in the election, but not too much luck." He put it all in perspective. Over the years, I can tell you, he was a fine person and he was a real pillar of his community and served the Legislature well. I served with him for two terms, in the 106<sup>th</sup> and the 107<sup>th</sup> Legislatures. I just want the record to show that we remember those who have been good to us and I will remember him.

Senator RAYE: Thank you Mr. President. It is with mixed emotions that I rise to pay tribute to Robert H. "Bob" Foster, who passed away on the 8<sup>th</sup> day of December. Emotions of sadness and a sense of loss at his passing. Emotions of great pride and deep gratitude for the life that he lived among us. A native of Dennysville, Bob Foster was one of the most well-known, admired, and well liked citizens of Washington County. More than 50 years ago, back in 1959, he started his own small business, Foster Fuels, in Machias with one truck and one employee, himself. Over the years he built that tiny, one man operation into one of the most successful businesses in Maine, R.H. Foster Energy, which now has more than 20 convenience stores and gas stations across the state. Bob guided the company as its President and, since his retirement, as Chairman of the Board right up until his death. In his spare time he founded the Maine Wild Blueberry Company. Bob was more than just one of the most astute businessmen in Maine. He was also a person who cared deeply about his neighbors, his community, and his state. He served as a trustee of the University of Maine System. He was a charter member of the Friends of the Jackson Lab. He was the past President of the Machias Rotary Club, a corporator of the Downeast Community Hospital, a member of the Anah Temple Shine, director of the Katahdin Area Council, and devoted to his church, both in Machias and in South Portland. His good works earned him many awards and notable recognition, including Eastern Maine Development Corporation's Vernon P. McFadden Memorial Award, the Rotary's Paul Harris Fellowship, the Boy Scouts of America's Silver Beaver Award, and an Outstanding Service Award by the University of Maine in Machias, just to name a few. Bob also loved his homes in Marshfield and his beautiful, beautiful home at Cathance Lake. I know that the precious and happy memories of him at those special places will be held in the hearts of his family for the rest of their lives, for they were blessed to have a wonderful husband, father, and grandfather. We, Mr. President, were blessed to have a son of Maine who lived his life in such a productive and giving way. We are all better for having had Robert H. Foster live in our midst and today we pause in this Chamber to honor his memory. It should also be noted that Bob faced his very significant health challenges over the years with a courage and dignity that inspired others. He truly was a remarkable man. I'm very pleased that

Bob's devoted wife, Carolyn, is here today along with his beloved children; Robert W. Foster, Daniel Foster, Scott Stacey, Brett Stacey, Beth-Marie Stacey, and their families, along with his close and dear friends, Don and Marilyn Crandlemeier. Bob's daughter, Dorothy Vachon, and her family are unable to be here today, but they are very much here in spirit. May God bless them all and may they all take comfort with the knowledge that their loved one was loved and respected by so many people across this great state. I thank you, Mr. President, and I ask that the memorial sentiment be read.
