- 2. Duties. The committee shall examine the minimum requirements for guardian ad litem certification with the intent of making certification more stringent.
- 3. Staff assistance. The Legislative Council shall provide necessary staffing services to the committee.
- 4. Compensation. Members of the committee are entitled to receive the legislative per diem and reimbursement for necessary expenses related to their attendance at authorized meetings of the committee.
- 5. Report. No later than December 6, 2013, the committee issue a report that includes its findings and recommendations, including any suggested legislation, for the consideration of the Second Regular Session of the 126th Legislature. The Joint Standing Committee on Health and Human Services may introduce a bill during the Second Regular Session of the 126th Legislature to implement recommendations.

Tobias Leboutillier, of Brewer, on his retirement as host of Maine Public Broadcasting Network's show "Down Memory Mr. Leboutillier officially retired from Maine Public Broadcasting Network in 2002 and has hosted the show as a volunteer since that time. He first launched his program in 1979, which featured musical hits from 1940 to 1955. He also hosted 2 other programs that aired music from other eras and eventually merged into "Down Memory Lane." His appreciation for timeless performers such as Bing Crosby, Frank Sinatra, Benny Goodman and Jim Reeves will forever be part of Maine Public Broadcasting Network's radio history.
