Resolve, To Protect Concealed Handgun Permit Information on a Temporary Basis

Was reported by the Committee on **Engrossed Bills** as truly and strictly engrossed.

The SPEAKER: The Chair recognizes the Representative from Newport, Representative Fredette.

Representative **FREDETTE**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. Last week, we became aware of a FOIA request regarding concealed weapons permits and as a result of that event, a series of events occurred whereby leadership in both bodies, in the House and the other body, Democrats and Republicans alike, came together to bring this measure before the House and the other body today with the help of our Chief Executive in the executive branch. Mr. Speaker, I appreciate the hard work of the effort that has been put into this. I ask people to support this measure and I ask for a roll call.

The same Representative **REQUESTED** a roll call on **FINAL PASSAGE**.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Augusta, Representative Wilson.

Representative WILSON: Thank you, Mr. Speaker. Mr Speaker, Ladies and Gentlemen of the House. I would like to just take a moment to speak about the bill that has been put forth, if I could. This is really not a partisan issue. This is guite bipartisan. I just wanted to share a quick story from a woman that sent me an email. Basically, she, about seven years ago, was involved in a domestic violence case, and she ultimately made the decision to leave her husband and she relocated to a different area which, coincidently, happens to be within my district. She wrote to me thanking me for putting forth a separate and unrelated bill to this. Basically, what she cited was that she feared that if this information had been released, if her ex-husband was aware that this information could have been released, he would have known not just where she lives, he would have known that she had a firearm, which she cited would have made it much more dangerous because he would have shown up, potentially at her house, knowing where she lived. But knowing that she had a firearm, he likely would have brought a firearm to protect himself as well. So she felt that her life would have been at risk had he known that this information existed. Without getting into the nuts and bolts, because I know other people want to speak on this LD, I would just like to lastly raise that we choose which information is publically released and what isn't already. Currently, under state statute, we have over 300 exemptions on the books for various different reasons and I would hope to see that this one would pass as well. Thank you.

The SPEAKER: The Chair recognizes the Representative from Skowhegan, Representative McCabe.

Representative McCABE: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House. I rise today in support of the pending measure. I am glad that Democrats and Republicans could come together to provide some breathing room around this highly sensitive issue and provide this temporary shield. I personally feel that this will allow us to thoroughly and carefully evaluate this complex matter. I think this measure deserves all our support. Thank you very much.

By unanimous consent, all matters having been acted upon were **ORDERED SENT FORTHWITH**.

The SPEAKER: The Chair recognizes the Representative from Winterport, Representative Brooks.

Representative BROOKS: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I rise to try to go on record and make the record absolutely straight for some of my comments and some of the motions that I made earlier today. Many years ago, I worked with Russ Wiggins, who was then the editor and owner of the Ellsworth American, a former diplomat, Washington, D.C., and Marshall Stone as they wrote the Right to Know law. I had really not much in a part in it, but I worked with these two geniuses who were putting together a law that has been on the books now for a long time. I think it has protected the public for which it was intended, so don't expect me to stay in my seat if there is ever, ever an opportunity to try to privatize or make confidential things that are in there. What I objected to this morning wasn't so much that. I'll get to that when we bring up the bill on around April 1. What I objected to this morning was the speed with which this was being handled. I objected to it because I wanted not just those people who have called me in the past 72 hours, most of whom were people with gun permits, to have their opportunity to air their feelings, to me, as a legislator, I wanted other people, I wanted the public to come up here. I wanted 151 of us to have the opportunity to debate this. I wanted 35 members of the other body to have the opportunity to debate this.

I see now and I understand why you want to make a moratorium out of this, so that nothing happens between now and April 1. I stand here telling you that's the piece that I still object to. From what I understand, that there are newspapers, true or false, I don't know, that already have this list, threatening to publish it sometime in the very near future. I don't believe that this moratorium that we establish, and I have no doubt that it will be established and will go to the Chief Executive for his signature hopefully today, that will ultimately become law here. But these newspapers will not be grandfathered and if there is a list out there, it will then be published. My only concern is we have rushed through a bill that even as of last night people found constitutional problems with it and found that it also barred police from having access to this. There may be other unintended consequences in this legislation. I wish you well. I will still vote against this, but only because of the moratorium and not because of the bill itself. I think you can count me on April 1 voting for the bill. This one has been rushed way too fast. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Buckfield, Representative Hayes.

Representative **HAYES**: Mr. Speaker, may I pose a question through the Chair?

The SPEAKER: The Representative may pose her question.

Representative **HAYES**: Mr. Speaker, in current statute suggests that this was not an oversight. There is a specific confidentiality provision for all the application information, for applicants, for concealed weapons permits. Then the following paragraph specifically states that the issuing authority shall make a permanent record of each permit to carry concealed firearms in a suitable book or file kept for that purpose, and that the record shall include the information contained in the permit itself and shall be available for public inspection, which suggests that some prior body, in making this decision, made a deliberate outcome to make that information public. My question is, is there anybody who can tell us the legislative intent of that separation so that setting the application information is confidential but the permit information as being public record?

The SPEAKER: The Representative from Buckfield, Representative Hayes, has posed a question through the Chair to anyone who may care to respond. The Chair recognizes the Representative from Freedom, Representative Jones.

Representative JONES: Thank you, Mr. Speaker. Mr Speaker, Ladies and Gentlemen of the House. Let me be perfectly clear about this bill. This is not a Second Amendment bill. This is a First Amendment bill. First, let me tell you this is not an emergency in the context of the Maine State Constitution. This is a political emergency, okay? Those of you that sit on Inland, Fisheries and Wildlife and have received 1,500 to 2,000 emails about rubber worms for bass fishing, that's not a crisis, nor is this, okay? This is not a Second Amendment issue. This is a Freedom of Access Act issue. What we're asking this body to do is to suspend First Amendment rights of transparency in our government to solve a nonexistent constitutional emergency. We're using this as a political football, okay, not as an actual question of safety, wellbeing, or the health of our citizens, okay? Subjects of such great moment, okay, which are restricting the rights of access of our citizens to our governmental records. Subjects of moments such as these should be deliberated carefully, okay, and citizens should be allowed to speak to their legislators and have their voices heard directly on those matters. This process is fundamentally flawed and I would urge you please to reconsider supporting this measure.

The SPEAKER: The Chair recognizes the Representative from Turner, Representative Timberlake.

Representative **TIMBERLAKE**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I stand before you today in support of LD 576. I'm not going to go on with the speech that I have written, but I want to thank Senator Jackson and Representative McCabe for coming forward with the Chief Executive to support this bill in a bipartisan way, and I look forward for us moving forward with the other bills that will come on later on in the process. Thank you.

The SPEAKER: The Chair recognizes the Representative from Chelsea, Representative Sanderson.

Representative SANDERSON: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I believe, as many of you know, very strongly in government transparency and anything that government does should be transparent to the public, however, I also believe very strongly in personal privacy. When we talk about constitutionality of this bill, how constitutional is it for us to have to sign up onto a database in order to carry a concealed weapon, when that right is affirmed to us under the Second Amendment of the U.S. Constitution, as well as in our Maine State Constitution when that says and that right shall never be questioned? We're asking permission to do something that we've been granted to do, so this is an issue of personal privacy. It also is a matter of public safety. If we publish these lists, if these lists are published, are we going to have happen here in the State of Maine what happened down in New York? Are we going to be creating a shopping list for those who would seek to gain possession of firearms through illegal means? You're going to have a name, you're going to have an address, you may have a date of birth on these records. It is a matter of public safety. As the good Representative from Augusta said, what about a woman who moves into a new area with three children seeking a safer place to live from someone who would do her harm, and, all of the sudden, now her name is published on a list with her address and they are able to find her? These are very important issues when it comes to this list. I appreciate the leadership of both bodies who have helped sponsor this and also the amendment on it to keep this open for law enforcement, for law enforcement are the people who should have access to this list. Thank you very much.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Russell.

Representative **RUSSELL**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I would like to point out for the record that we are voting for a bill today that would limit the public's right to know and we are doing so without a public hearing. This is a bad public process, precisely because there has not been a public process. I also wanted an opportunity to allow the public to weigh in on this. Just as Representative Brooks stated, it is this part that I staunchly oppose. I will vote for the 60 days today, but I would like the record to show that this is not a good process. We are much better than this.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Harlow.

Representative HARLOW: Thank you, Mr. Speaker, Without being too redundant, this is a public right to know issue, not a gun issue. We've proven today, or we're getting ready to prove, that we can expedite anything that we want, so if we really wanted this moratorium and we wanted to have the public really be able to weigh in, we could have expedited the public hearing process so that we could have had a public hearing for this moratorium, this week, and had a work session that day and people would have had a chance to voice their opinion at least. We're just rushing through this process. I'm not exactly sure why an extra day would matter. I've just started getting emails this morning about this issue. I have had about one email before this morning. I think that this is also, and I would agree with the good Representative from Chelsea, that this is an important issue that we should be discussing, the gun issue, and so is the moratorium. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Sangerville, Representative Davis.

Representative **DAVIS**: Thank you, Mr. Speaker. I want to thank you and all the leadership for bringing this forward. I appreciate this. With all respect to one of the previous speakers, I had a call at my home the other night from a woman who happens to be in the real estate business, and she was terrified that her name and address as a concealed weapon's owner would be put in the papers, absolutely terrified. She seils real estate. She goes to remote areas all over the state and sometimes, most always, she goes with complete strangers, doesn't know them, and she definitely does not want her name out there as a concealed weapons owner. Thank you.

The SPEAKER: The Chair recognizes the Representative from Farmington, Representative Harvell.

Representative HARVELL: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. It's not very often that we get a chance to correct a wrong in this body so swiftly, and with all due respect to those who think that this needs to take time, we are going to have time down the road. But right now, there are dozens of people that have been involved in domestic violence situations, that probably haven't been sleeping this weekend for fear that they can wake up and find out that their stalker, or if you are a police officer that has concealed weapons that needs to protect, someone that they may have arrested in the past, now we know where they live and their residence. We want gun owners in the state, over and over again, to take a path exactly like this so that the police will know where these guns are and that they will be the most trained citizen out there to use guns and will have gone through the most extensive training, and if we put up roadblocks to this, we aren't likely to get those outcomes in any greater way. Everybody in this room pretty much has a computer on their desk. It isn't just that a newspaper can get this anymore. This thing can go viral in a minute and the

very unintended consequences can be that those whose names don't want to be made known, can they be made known, so let's give the citizens of this state a chance to sleep tonight knowing we did the right thing.

The SPEAKER: The Chair recognizes the Representative from Newfield, Representative Campbell.

Representative **CAMPBELL**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I want to thank leadership on both sides of the aisle for this bill and I would request a roll call vote now on LD 576. I think it's a good bill and I want to thank both sides of the aisle for coming together. Thank you.

The SPEAKER: A roll call is already in order. The Chair recognizes the Representative from Rockland, Representative Dickerson.

Representative **DICKERSON**: Thank you, Mr. Speaker, Mr. Speaker, Ladies and Gentlemen of the House. I just wanted to thank whoever made the amendment. There was language for the record in this original moratorium. A person who has received information that is confidential pursuant to this section may not redistribute or disseminate the information to a person who is not authorized to receive the information. I saw this come across my computer this weekend and had some questions about it and did some work with some other members, and I think some other individuals had some questions about this as well. These were First Amendment auestions concernina dissemination of information in the press and it seemed prudent that rather than wading into a First Amendment debate in this setting, that perhaps this kind of amendment should be suggested. So I thank the individuals who did that. I still have some questions about these sorts of issues concerning this moratorium and I am very concerned about the fact that no public process has been engaged in and we are moving so quickly without time for the public to weigh in. Because we haven't looked at the cascading impact on some of the other rights outside of Second Amendment rights and outside of this issue, I am still very hesitant about what's in front of us, but I do thank the people who put in that amendment.

The SPEAKER: The Chair recognizes the Representative from Lisbon, Representative Crafts.

Representative **CRAFTS**: Thank you, Mr. Speaker. I do want to thank the leadership for bringing this forth and I quite don't understand where some of the body has a problem with this process. I think that we do have a bill in place that's going to debate this and have public hearings, and this is just to give us some time to find out if this is the right thing to do. So again, I hope that this body goes ahead and comes together and passes this. I do thank the other body for sending this down to us and this is the time that we can show the citizens of Maine that we do uphold their rights. Thank you, Mr. Speaker.

The SPEAKER: A roll call has been ordered. The pending question before the House is Final Passage. All those in favor will vote yes, those opposed will vote no.

This being an emergency measure, a two-thirds vote of all the members elected to the House being necessary, a total was taken.
