As members of the Town of Arrowsic Select Board, we are concerned over the direction of the State budget and economic plans as laid out in the recently proposed biennial budget. Like many small towns in Maine, Arrowsic has one primary source of revenue - property taxes - that are assessed without regard to a person's income and therefore unrelated to his or her ability to pay taxes. Property taxes are the only revenue we can raise to provide the basic services - schooling, roads, garbage collection, emergency response - that our citizens need.

The State of Maine, on the other hand, has the power to establish a fairer tax system that takes personal and corporate income into account and that distributes the burden across wealthier and poorer towns. We have a joint responsibility to the citizens of Maine to create a State-Municipal mix of revenues and spending on services that serve our common goals and interests.

For this reason, we urge you to work with the State legislature to craft a biennial budget that fully funds the State's obligations to municipalities in terms of revenue sharing, General Assistance, and the 55% contribution to local schools that was passed by referendum. We ask that you refrain from expanding property tax exemptions, an action which reduces the Town's tax base and which exacerbates inequities in the property tax burden.

In order to do this, we recognize that the State will need to raise revenues. However, the State has the authority and instruments to do this in an equitable fashion that avoids the harsh impact that would otherwise result from shifting the burden so massively to property taxes.

TOWN OF BENTON BOARD OF SELECTMEN RESOLUTION 01-13

A RESOLUTION PROVIDING FOR:

URGING THE MAINE STATE LEGISLATURE TO CRAFT A BIENNIAL STATE BUDGET THAT PREVENTS A SIGNIFICANT INCREASE IN PROPERTY TAXES

BE IT RESOLVED by the Selectmen of the Town of Benton, acting as the municipal officers as follows:

WHEREAS, the Governor's proposed biennial budget includes the suspension of municipal revenue sharing and other revenue sources that would result in an estimated \$200,000.00 or more in lost revenue to the Town of Benton; and

WHEREAS, the proposed budget includes the elimination of the \$10,000 Homestead Exemption for those under 65 years of age; and

WHEREAS, the proposed budget includes changes to the Business Equipment Tax Reimbursement Program and the shifting of some commercial excise taxes from Municipalities to the State; and

WHEREAS, these proposed changes in state policy would shift a significant financial burden onto property taxpayers, which would result in an estimated \$200.00 increase in property taxes for the average Benton household owned by persons under 65 years of age with a property assessed at \$100,000.00, without corresponding cuts that would have a far-reaching and detrimental impact on essential municipal services; and

WHEREAS, the property tax implications referenced above do not include the additional tax levy from the School District as a result of the proposed biennial budget;

NOW, THEREFORE BE IT RESOLVED

THAT the Selectmen of Benton, Maine hereby urge the Maine State Legislature to craft a biennial budget compromise that considers the already high property tax burden, seeks balance, progressivity, and a comprehensive approach with respect to tax policy, and identifies alternative cost savings and tax reforms that would prevent a significant increase in property taxes and protect essential municipal services from detrimental cuts.

The M.S.A.D. #49 Board of School Directors, representing the towns of Albion, Benton, Clinton and Fairfield, has asked that I forward the enclosed resolution to you. The Board adopted this resolution at our meeting on March 7, 2013. We are all

concerned that a permanent shift of responsibility for teacher retirement from the state to local districts will have a detrimental effect. The retirement payments must be paid at the expense of other urgent operating costs, if necessary. The shift of net cost is not merely an accounting exercise but a structural transfer of funding responsibility. Any state subsidy directed at retirement in the current proposal would create the false impression that the state is increasing its percentage of support required by LD #1. Unfortunately, the opposite would be the clear effect.

The Board appreciates the support historically shown by our legislative representatives for education. If you have any questions, please feel free to contact me or the superintendent. Thank you.

A RESOLUTION PROVIDING FOR:

URGING THE MAINE STATE LEGISLATURE TO CRAFT A BIENNIAL STATE BUDGET THAT PREVENTS A SIGNIFICANT INCREASE IN PROPERTY TAXES.

BE IT RESOLVED by the Board of Directors of Maine School Administrative District #49, as follows:

WHEREAS, the Governor's proposed biennial budget includes shifting more than \$28 million in retirement costs onto school districts—a cost shift the state says it will partially subsidize for now, but for which there are no guarantees for the future; and

WHEREAS, under the Maine Constitution the sole responsibility and authority for public education is given to the Maine Legislature; and

WHEREAS, more than 60 years ago, the Maine Legislature established the Maine State Retirement System, mandating that all teachers be included in the retirement system; and

WHEREAS, the teacher retirement system is a defined benefit plan where retirement benefits are determined based on earnings and years of service; and

WHEREAS, the state is proposing shifting \$28 million of the state retirement obligation to local school systems to be funded by property taxes; and

WHEREAS, the relative property wealth of individual school districts varies widely from district to district, which directly affects the amount of money which a local school district can raise for the support of education; and

WHEREAS, the state is proposing funding only 50% and not the 55% as mandated by the school funding formula.

NOW, THEREFORE, BE IT RESOLVED.

THAT the Board of Directors of School Administrative District #49, hereby urges the Maine State Legislature to craft a biennial budget compromise that considers the already high property tax burden, and which does not add to this burden by transferring the Legislature's fiduciary responsibility for teacher retirement to local school districts, and further that the state continue to fully fund teacher retirement now and in the future.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Chelsea, Representative Sanderson.

Representative SANDERSON: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. In 2009, there was a Resolve to further regulate the use of tanning booths by minors here in the State of Maine. Forty-five months later, the rules adopted are just coming out now for adoption. Forty-five months later. These rules are quite restrictive and they are for minors under 14 years of age. They will prohibit the use of tanning devices, and for minors 14 years and older, they are going to require the tanning facility operator to confirm the identification of the minor and the minor's parent and legal guardian because 14 and 15-year-old minors who want to use a legal tanning booth must have a parent onsite with them while they use it. For 16 and 17 year-olds, the parents must physically go into the establishment and sign a permission slip after reading and understanding the required disclosures of the risks surrounding tanning. These new rules also require operator Passage of this legislation denying teenagers with consent by their parents will actually hurt more people than it helps, because what's going to happen is we are going to have, independent studies have shown, that teens will simply tan more aggressively outdoors or will turn to unregulated home tanning beds in the basements of their friends. Here we have the opportunity, with these rules in place now about to be adopted, to have these teens tan, who will do so, with or without our permission, those of us who are sitting in this chamber, but they will do so with a controlled environment with parental consent. Thank you.

The SPEAKER: The Chair recognizes the Representative from Gorham, Representative Sanborn.

Representative SANBORN: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I stand in favor of LD 272, "An Act To Reduce Youth Cancer Risk." The facts are pretty straightforward as it relates to this bill. UV radiation from indoor tanning devices significantly raises the risk of melanoma, the most deadly form of skin cancer, and the rate of melanoma is on the rise. The World Health Organization International Agency for Research on Cancer lists UV radiation from tanning devices as a Class I carcinogen, the highest risk category that can be given for cancer. Melanoma is the second most common form of cancer in adolescence and youth 15 to 24 and the most common for ages 25 to 29. A study of young people calculated that indoor tanning directly caused three out of four melanomas occurring in persons under age 30. Despite the restrictions already in place in Maine, 14.2 percent of females in the ninth grade used indoor tanning in the past 12 months and that rate rises to 38 percent by the twelfth grade. Indoor tanning use by Maine teens exceeds the national average. Public awareness of the risk is suboptimal. This was illustrated to me recently right in this Legislature. A member of our caucus initially said that she would allow her daughter to tan in a tanning booth prior to prom until she became aware by discussing the need for this bill, that even a onetime exposure raises the risk of melanoma in a person under the age of 35 by 75 percent. Parents don't understand that they are putting their children at risk by allowing this form of tanning. Melanoma is a preventable disease to a large extent. If one must tan, there are other safer alternatives. By passing LD 272 to prohibit minors under the age of 18 from using indoor tanning devices, we make people more aware of the risk. We can make a difference in the melanoma rate, and, most importantly, we can save young lives. Thank you and please follow my light.

The SPEAKER: The Chair recognizes the Representative from Hancock, Representative Malaby.

Representative MALABY: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I rise in support of reducing youth cancer, but I am opposed to this bill. This bill, in its essence, highlights the division and thought, if you will, between one side and the other. There are some of us here who feel that personal responsibility is essential to health care and to controlling its costs. There are others who feel that health care is a right and the state should provide it. I am troubled by the fact that we are not allowing the work of the 124th Legislature to be effectuated. They have adopted rules, they are stringent and we are bypassing them. I wonder, too, what is the role of the parents? Lastly, in order to reduce this risk, I wonder when this House will vote to ban the sun.

The SPEAKER: The Chair recognizes the Representative from Farmington, Representative Harvell.

Representative **HARVELL**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. It might well be called "An Act to Neuter Parents." Every dystopia ever written from the beginning of time has had one major theme. That is to assault the family. Why, because it is an organic institution that actually is the greatest threat to the state in the annals of time. Why do we do this? What's the fun in actually giving parents information and allowing them to make the decision when you want to have Munchausen by proxy taking place, where you can keep a population sick and then become their savior? Already when you go to a tanning salon, they must actually read a statement on the potential risk. The parents know it. I say we let them make the decisions. I, for one, know that I don't want to be a parent of 1.3 million people.

The SPEAKER: The Chair recognizes the Representative from Chelsea, Representative Sanderson.

Representative SANDERSON: Thank you very much, Mr. Speaker. I would just like to add a couple of points here, Ladies and Gentlemen of the House. This was distributed to your desk at my request at one point, but I would like to remind you that the question is, is this a public health issue or is it a competitive issue? This is one of the points for you to ponder. Dermatology has lost \$5 billion in phototherapy business as clients are opting for more affordable self-treatment of cosmetic skin diseases and tanning salons. Dermatology uses identical sunbeds in their offices to treat cosmetic skin diseases. Phototherapy sessions cost as much as \$150 a session and are billed to insurance company. If artificial UV devices were dangerous in some report, why would dermatologists continue to use phototherapy sunbeds for the safe treatment - and it is deemed safe treatment - of cosmetic skin conditions. Also, the science doesn't support it. Professional training salons are not the problem. proponents have misrepresented the World Health Organization's data on this topic, which actually points to medical use of sunbeds for the treatment of cosmetic skin diseases and unmonitored home tanning units. That's where they get their percentages from. They don't get it from professional tanning salons which are working under regulations. They are working on a controlled environment. Thank you very much.

The SPEAKER: The Chair recognizes the Representative from Yarmouth, Representative Cooper.

Representative **COOPER**: Thank you, Mr. Speaker. When my daughter was in high school, she was going to the prom and wanted to get a tan and I thought, well, if you do to a tanning

salon, surely it's safer than lying out in the sun because it's a constant stream of regulated radiation waves and so forth. But to make sure, I went to my pediatrician and spoke to her nurse, Annie Bryant, who said, actually it is more dangerous. The reason I bring this story up is that I see this bill as a public health issue that educates both children and their parents. I don't think it is widely known just how dangerous these tanning booths are, and this is a way to get that information across.

The SPEAKER: The Chair recognizes the Representative from North Yarmouth, Representative Graham.

Representative GRAHAM: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I rise in support of this motion. If you look at me, I am a very pale, unless I kind of put the makeup on, Irish skinned lass who, when I was in high school, would go down to Sand Beach in Bar Harbor and lie really flat so I could get a tan. Well, it wasn't a tan. It was a really big burn. I had lots and lots of burns throughout my childhood adolescence because I didn't know it was a bad thing. Neither did my father, who was a surgeon, thought it was a bad thing. So, go forward, hey, I wanted to have a really good tan when I got married, baby. I was living in those tanning beds. Well, I don't have melanoma yet, but I have basal cell carcinoma. When I go to the doctor and I check off whether I have cancer or not, you know what? I do. I've had a least a dozen or more basal cell carcinomas because I burned as a child. If someone had told me that that was unsafe to be in tanning beds or to get sunburns, probably I wouldn't do it. This is a bill that says pay attention to the risks. Have clear informed consent. Because otherwise, the peer pressure that these adolescents have, particularly our young women who want to look bronze for their prom, will continue to do this. So I have cancer and the reason I have cancer is because I sat in the sun a lot. And, by the way, I still do, but I wear sunscreen. So please, I ask that you support the motion on the floor.

The SPEAKER: The Chair recognizes the Representative from Norridgewock, Representative Dorney.

Representative **DORNEY**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I hope that you will support this bill. I have been a family practitioner for 30 years. I have seen people with melanoma. I have seen people with skin cancers. This is a public health issue. We are having increasing numbers of skin cancers in this country. This is one thing that we can do to protect our children. Just like we have laws on how kids this age drive their cars, we have laws on tobacco. We have laws on alcohol use. This is a public health issue that we need to address and I appreciate what the last Legislature did to try to help this problem, but I actually think that we have to have more regulation to help protect the health of our children. I hope that you will support the bill. I have also had skin cancers myself and appreciate what Representative Graham has said.
