Pursuant to Sec. 7 and Sec. 37 of Public Law 2011, c. 682, one member of the newly created Land Use Planning Commission must be nominated by each of the 8 counties with the most acreage in the unorganized or de-organized areas subject to the jurisdiction of the commission.

Piscataquis County contains the second largest acreage in the unorganized and de-organized areas (2,153,099.44 acres) subject to the jurisdiction of the commission, second to Aroostook County (2,554,281.34 acres), thereby making Piscataquis County one of the two counties to be the first to nominate an individual to the new Land Use Planning Commission.

I am pleased to make this report in accordance with the Petroleum Market Share Act (P.M.S.A.), 10 M.R.S.A. §1677. The P.M.S.A. requires the Attorney General to make a report to the Legislature describing the concentration of retail outlets in the State, including a recommendation as to whether additional legislation is needed to further limit or curtail the activity of refiners operating retail outlets.

Enclosed is a report describing concentration of retail outlets in the State. The report, which is based on data collected from wholesalers of both motor fuel oil and home heating oil, includes maps depicting relative concentration in designated markets throughout the State. This report is also available on the Attorney General's website at: http://www.maine.gov/ag/consumer/docs/2010%20PMSA%20Re

port.pdf.
Since no refiners of petroleum products operate retail outlets in

this State, we recommend no legislation to limit or curtail such operations.

## JOINT RESOLUTION RECOGNIZING APRIL 2013 AS AUTISM AWARENESS MONTH

WHEREAS, autism is a spectrum disorder, which means no 2 people with autism are affected the same way, and it is a complex developmental disability that usually appears during the first 3 years of life and results in a neurological disorder that affects the functioning of the brain; and

WHEREAS, autism affects social interaction and communication skills, and an average of 1 in 88 children are diagnosed with this spectrum disorder, and prevalence has increased 78% since the United States Centers for Disease Control and Prevention's first study in 2007; and

WHEREAS, autism knows no racial, ethnic or social boundaries and neither income, lifestyle nor education affects the occurrence, and it is estimated that 1,500,000 people live with autism spectrum disorder in the United States; and

WHEREAS, autism costs the United States \$90,000,000,000 in annual health care costs; 90% of the costs are in adult services. These costs are estimated to increase in 10 years to \$200,000,000,000 to \$400,000,000,000; and

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Autism Society of Maine as a token of our respect and support.

The SPEAKER: The Chair recognizes the Representative from Sanford, Representative Boland.

Representative BOLAND: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. This is a bill that makes up a well-designed Commission on Health Care Cost and Quality that essentially replaces a very similar one that we had before. The only thing about it is that it has eliminated an individual with expertise in the discipline of food science, which was on the previous commission, and that's something that I thought was probably an oversight of the committee but I find it wasn't. I think it really is something that we need to think about because we have a committee, the members are all credible types of members. Hospitals, long-term care, mental health, health care financing, insurance companies, all of that sort of thing, businesses and an individual with expertise on needs of the minorities, all good people to have on it. But in fact really the future of health care is in food science and we have a wonderful department at the University of Maine at Orono on nutrition and food science, and what they do is they work to make foods healthier and they devise what are called functional formulas to help people with particular illnesses, but they do it with nutrients, nutrition. I think of one particular item that is called lunasin. If you went to <u>lunasin.com</u>, you will see that the Federal Government has actually asked for this particular nutrient to be developed into a product for the military to deal with heart disease, and in the studies, they've found that it also supports cancer efforts. So that's just one item, but when we think of things like autism and it's Autism Month and we worry so much about it, I want you to understand that functional formulas like people in food science work on today are turning back autism. Because we really have such a hard time getting away from how all our issues need to be fixed with drugs and other sorts of medical procedures, this asks you to take on someone on this committee who knows how to do it in healthy ways. So as we look at autism, we look at GMO and worry about additives to our foods, we look at pesticides and all of that, think about the value of having someone looking at food science and what it does because this is what it addresses on this committee, because it's very important for the future of our children, for our whole society and really for our budget because we know how high the pharmaceutical costs are today. So I understand there is a lot of resistance to this, but I wanted to share that with you because I've been working on it ever since I've been here and it's probably my last opportunity to send that message to you. So for your health, for the health of your families, I'd like to ask you to

remember that, even though I understand this amendment will be Indefinitely Postponed. Thank you.

WE, your Memorialists, the Members of the One Hundred and Twenty-sixth Legislature of the State of Maine now assembled in the First Regular Session, most respectfully present and petition the United States Congress as follows:

WHEREAS, United States Supreme Court rulings, beginning with Buckley v. Valeo and continuing through Citizens United v. Federal Election Commission and others, disproportionately elevate the role of wealthy special interests in elections and diminish the voices and influence of ordinary Americans; and

WHEREAS, Maine citizens wish to develop effective tools for self-governance, including strong laws governing elections and campaign finance; and

WHEREAS, the current legal landscape severely constrains the range of options available to citizens, frustrating efforts to reduce the influence of moneyed interest in elections and in government; now, therefore, be it

RESOLVED: That We, your Memorialists, hereby declare our support for an amendment to the United States Constitution regarding campaign finance that would reaffirm the power of citizens through their government to regulate the raising and spending of money in elections; and be it further

RESOLVED: That We, your Memorialists, call upon each Member of the Maine Congressional Delegation to actively support and promote in Congress an amendment to the United States Constitution on campaign finance; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the President of the United States Senate, to the Speaker of the United States House of Representatives and to each Member of the Maine Congressional Delegation.

The SPEAKER: The Chair recognizes the Representative from Friendship, Representative Evangelos.

Representative **EVANGELOS**: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House. Voting yes for this Resolution today will put our legislative bodies on record as directing our Federal Congressional Delegation to support a constitutional amendment that would overturn the Supreme Court's 2010 *Citizens United* opinion, which equated campaign spending with free speech. It's time we took action to reverse this onerous decision, which continues to deform our politics by allowing unlimited corporate spending on our elections. This decision marginalizes our democracy and unfairly elevates the role of wealthy special interests in our elections and consequently

diminishes the voices and influence of ordinary Americans. I urge you to vote yes on this measure. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Russell.

Representative RUSSELL: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House. This is about an issue I've been working on for quite some time. Since Citizens United passed in 2010, we have seen a real "wealth" of new money being interjected into the political process. It is sad that we are at a place where the public, the vast majority of people in this country and in this state, believe that there is a reason why pro is in the middle of guid pro guo, and the reason for that is that it takes a professional in order to be able to influence change in this country and I think that's a sad, sad scenario for the future of democracy. Maine has been a real leader in campaign finance reform here in this state and it came and it bubbled up from the people. We have seen some attacks on that through the Supreme Court as well, but I think that overturning Citizens United will have the biggest impact overall in making sure that average everyday citizens, that their voices are heard and not drowned out simply because they do not have the money to be here to stand up for their beliefs, and that when they do come, that bigger money doesn't end up drowning out their voices. Furthermore, we have seen, just here in this state, scenarios where candidates, when their personal contribution to their own campaigns was drowned out by outside influence, that their own message could not get out because so many people were weighing in on a campaign. At that point, what really becomes real and what becomes fiction? There's no way for people to respond and I think it's unfortunate that not only do average everyday citizens feel left out of the political process right now and drowned out by the political process and by the money, but candidates also find themselves in a scenario where they can't get their message out. It's essential that we move forward...

The SPEAKER: Will the Representative please defer? The House is in order. I have had several notes today just saying there is a low rumble. I think there are side conversations, which is not out of character. If you're going to have a longer conversation, please go behind the glass, keep it down, and if it needs to be a louder conversation, go out in the hallway. Thank you. The Representative may proceed.

Representative RUSSELL: I think it's an essential that we move forward in this country with an amendment to the Constitution to make sure that there is a clear distinction between speech and money, if it were not written in the First Amendment that money is equated as speech, but it seems to have become the law of the land by default, and I think Maine has consistently been ahead of the curve on campaign finance. We have led the curve in resolutions here at the municipal level and been a real leader across the country in that regard, and now we have an opportunity today to send a message to the U.S. Congress and the U.S. Senate and to the people of the country that Maine continues to want to be a leader and that it is time that we reform our government in such a way that average everyday people can participate in it and that we can preserve our democracy for generations and generations to come as it was developed and preserved for us. Thank you, Mr. Speaker. I hope you folks will be voting in support of the Resolution.

The SPEAKER: The Chair recognizes the Representative from Lewiston, Representative Libby.

Representative **LIBBY**: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House. A U.S. constitutional amendment is the only way to overcome the U.S. Supreme Court's rulings like *Citizens United*, rulings that have struck down

many of the options we have to push back on the role of wealthy special interests and elections. A constitutional amendment is needed to establish more effective campaign finance reforms for the future and Maine people support this move in large numbers. Our Legislature can and must add its voice to the states, calling for a U.S. constitutional amendment that ends the money arms race in our elections. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Farmington, Representative Harvell.

Representative HARVELL: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I know I'm stunned to learn this morning that money and politics have gone together for a long time. I also listened to a word and it reminds me of some of the research that I've done and that is that we are directing our Congressional Delegation to enact upon this. We are doing no such thing. If you want to direct somebody to do something, go back and read the Legislative Record from the 19th century before the 17th Amendment. Then we actually did use the phrase "directing the Senate to vote such a way," and why did we do that? We did that because when we were directing them, they were hearing for who voted for them. Since I've been here, there has been a series of resolves that have come through this body. One of your favorites is back at the time of the Iraq War. We were directing the State Department to take all measures short of war as if we had access to the CIA, the Pentagon or any other of the mechanisms that would allow us to make that decision, and as if they were not making that decision already themselves. The reality is this Resolve is a feel good thing. Pass it if you want, feel good to put your light up there, but we're directing nobody to do anything and it is little more than most of these. I mean, last year, we had a Resolve here to ask Congress to expedite the tar sands. It just happened to be put in by a guy running for Congress.

The SPEAKER: The Chair recognizes the Representative from Caswell, Representative Ayotte.

Representative **AYOTTE**: Mr. Speaker, may I pose a question through the Chair?

The SPEAKER: The Representative may pose his question.

Representative AYOTTE: I am wondering if unions are considered special interest groups and that would influence the way I would vote because – well, I will allow you to answer the question first. Thank you.

The SPEAKER: The Representative from Caswell, Representative Ayotte, has posed a question through the Chair to anyone who may care to respond. The Chair recognizes the Representative from Portland, Representative Russell.

Representative **RUSSELL**: Thank you, Mr. Speaker. I would be very honored to answer that question from Representative Ayotte. Under the *Citizens United*, whether it is corporations or unions, the flood of money, it doesn't matter. So both are considered appropriate uses of funding. So to answer your question, yes. But under, if we were to change the Constitution, we would be able to put limits on both sides of the equation. I hope that answers it. It's probably not as clear as you'd like, but the answer, I think, is yes.

The SPEAKER: The Chair recognizes the Representative from Caswell, Representative Ayotte.

Representative **AYOTTE**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. In my last election, I spent a total of \$447.50. I ran traditional. The opponent, my opponent, was able to receive money from the unions. I felt a little at a disadvantage, although obviously it didn't hurt too bad, where the union could extract money where Maine is not a right to work state, could extract money involuntarily from union members and then use that money to support your

opponent. Of course, I'm sure there can be arguments for the other side. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Belgrade, Representative Keschl.

Representative **KESCHL**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. WHEREAS, becoming a citizen in the United States means taking a solemn oath to uphold the United States Constitution; and

WHEREAS, citizenship is an important symbol of full membership and participation in society that should be encouraged, not barred; and

WHEREAS, keeping families together not only is the right thing to do, but also is good for the economy because families provide a base of support that increases worker productivity and spurs entrepreneurship; and

WHEREAS, immigration enforcement will be much more efficient and effective once the number of undocumented immigrants is reduced due to immigration reform; and

WHEREAS, the nation's current immigration system is dysfunctional, harms the economy and does not reflect our values as a state and nation; and

WHEREAS, overseeing immigration is a federal responsibility, and a comprehensive approach to reforming the immigration system would strengthen the economy and free aspiring citizens to make an even greater contribution to their communities; and

WHEREAS, the Federal Government's inability to enact immigration reform has created severe economic, cultural and political strains in Maine and in communities across the United States; and

WHEREAS, immigration reform must occur in a comprehensive, thoughtful manner that builds the strength and unity of working people and guarantees the same rights, obligations and basic fairness for all workers, no matter where they come from; and

WHEREAS, comprehensive immigration reform must include a realistic pathway to citizenship for all hardworking and taxpaying aspiring citizens who live in the United States if they meet reasonable requirements; and

WHEREAS, comprehensive immigration reform must provide a mechanism for those citizens who have grown up in this country to become citizens and be able to fully contribute to our joint future; and

WHEREAS, comprehensive immigration reform must update the immigration system so that the future flow of immigrant workers more realistically matches our nation's labor needs and is structured to protect the wages and working conditions of citizen and immigrant workers; and

WHEREAS, any new worker visa program must provide for strict compliance with United States labor standards and wage and hour standards, portability of visas so that workers can change jobs and the ability for workers to petition for permanent residency; and

WHEREAS, comprehensive immigration reform must limit the wait times and rules that keep families separated from their loved ones: and

WHEREAS, comprehensive immigration reform enforcement provisions must restore respect for law by promoting strict

adherence to our nation's values, including due process, civil and human rights, accountability and proportionality; and

WHEREAS, internal and border law enforcement should focus on preventing criminals, drug cartels and other negative and harmful elements from entering the United States or engaging in criminal activities; and

WHEREAS, Maine supports a comprehensive immigration reform bill that keeps families together, upholds national values, promotes economic growth and provides a long-term solution to the immigration system; and

WHEREAS, elected officials must create an immigration process that strengthens our nation's economy and lets aspiring citizens continue their contributions to their communities; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-sixth Legislature now assembled in the First Regular Session, on behalf of the people we represent, support comprehensive immigration reform that addresses earned legalization with a path to citizenship, updated future immigration of families and workers and improved immigration enforcement and border security that is consistent with national values.

In paragraph three, where it talks about we support the value of human dignity of all Maine residents – well, that is true – regardless of immigration status – though I have a problem with – and recognize the importance of immigrants and their many contributions to the social and economic fabric of Maine, I agree with that also. But when we talk about immigration status, it seems to me that we're talking about illegal and legal immigrants, or, in this case, as it's named in here, documented and undocumented immigrants.

In paragraph five, citizenship is an important symbol of full membership and participation in society that should be encouraged, and not barred – and I agree with that. But it's not now barred. However, there is a process in place where you have to come into this country legally and gain your citizenship.

In paragraph seven, where it talks about immigration enforcement will be much more efficient and effective once the number of undocumented immigrants is reduced due to immigration reform. So we're just going to give a free pass to all these people who have come here undocumented and I have a real problem with that. I think, as I talk to my constituents around Eddington and the surrounding areas, I have one person yet to tell me that they think that undocumented immigrants or illegal immigrants ought to be afforded these passes and the things that we're looking at handing out to them. The list goes on and on through here. I just saw this as coming up and I just made a few quick notes. There is a lot more. This is just, I would think that the people of the State of Maine would overwhelmingly be against us passing this Resolution and I thank you, Mr. Speaker, for your time.
