Representative **GRAHAM**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. You may note on this report that I am on the other side, but I have further considered this and I believe we should not tell someone they cannot run for public office. That is what we are doing with this bill. That is a very serious restriction and facts simply don't support the need to do it. It is up to the voters as to whether a person or current office holder should be elected to a new position. There is no evidence that electing a constitutional office holder has ever been an issue. There are safeguards in the Secretary of State's office so that election conflict of interests are completely resolved. This was the case when Secretary of State Charlie Summers was in office. It is the case now and it will be the case moving forward. Trying to remedy a problem that does not exist is not a good idea. I ask that you follow my light and vote the Minority Ought Not to Pass Report.

The **SPEAKER**: The Chair recognizes the Representative from Winterport, Representative Brooks.

Representative **BROOKS**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I hope I'm not too late, Mr. Speaker. I tried to jump quickly. I am opposed to this bill.

The **SPEAKER**: Will the Representative defer? The Clerk will read Committee Amendment "A" and then it will be proper for the Representative to speak to the pending motion.

Committee Amendment "A" (H-166) was **READ** by the Clerk.

The **SPEAKER**: The Chair recognizes the Representative from Winterport, Representative Brooks.

Representative **BROOKS**: Now thank you, Mr. Speaker. Sorry about, I apologize for the untimely move on my part. Mr. Speaker, Ladies and Gentlemen of the House, this, to me, it's another encouragement into establishing service centers. I have been opposed to service centers all along and that is only because I come from rural communities and I see no absolute gain for the Town of Winterport. I only see losses. This is a bill that will make a select few, if you will, richer, and those of us who live in small towns a little bit poorer. I know it doesn't involve an awful lot of money. However, for a long time now, the people in my district and the Maine Municipal Association, of which I am a member of its legislative policy council, has indicated that they do not support this, nor do I support it, and it is again, because it selectively will pay back those communities whose retail sales have gone up. In Winterport, we have a barbershop and we have a pizza house, and I doubt very seriously if our retail sales are going to go up. They may well go down. So I will be voting against this bill when it comes up. Thank you, Mr. Speaker.

The **SPEAKER**: The Chair recognizes the Representative from Wells, Representative Chase.

Representative **CHASE**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I would like to explain what this bill actually does. This bill is offered in lieu of a local option sales tax, as it will provide additional funding to those towns or cities who are finding it more and more difficult to fund the growing expenditures needed to support the services required and a municipality that generates the large state sales tax revenues. It will provide for the additional funding without increase in taxes to taxpayers, yet not create another bureaucratic tax layer. It will give an incentive for towns to encourage business expansions as they will benefit from increased sales tax revenues generated within their own municipalities, and as 95 percent of the referred to expanded taxes will flow to the state, any encouragement for growth by

municipalities will benefit all of us. How it works is that LD 401 sets a base year, with '15-'16 being the first base year, to establish the amount of sales and use tax, not including meals and lodging taxes, that are generated with a municipality and then compares that baseline established amount to the sales tax raised within that community going forward every year. Sales tax amounts generated within a municipality every year going forward above that sales tax baseline that year will be determined by the state, and the municipality will be reimbursed by the state at an amount equal to 5 percent of the expanded taxes only. The established baseline year is reset every four years and the process repeats. If the amount of sales and use tax collected in a fiscal year in a municipality is below what is collected in the established base year, then the municipality receives nothing. The municipality must use the local sales tax increment payments from this process received to reduce the property taxes. What this bill is not is a tax increase and it's not a local option sales tax. What it is, is an encouragement for towns to expand certain businesses by sharing with the state in the gains in revenue and an additional means to reduce property taxes. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Lewiston, Representative Libby.

Representative **LIBBY**: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House. The bill before us is a pretty good concept in my view, however, I do not support the bill as written. This bill does have a fiscal note. It's estimated in fiscal year '16 and '17, a General Fund reduction of \$1.7 million. The idea being that that \$1.7 million is distributed to the service center communities. Just with a quick back of the envelope calculation, if you know that there is about 500 Maine municipalities and let's just say 200 of them are retail centers and we divide that math out, towns would be looking to receive about \$9,000 back to their General Fund to reduce property taxes. It's, I think, a lot of work for very little benefit and, in my view and in the view of the Maine Municipal Association, this bill does not address the elephant in the room, which is municipal revenue sharing, and I came up to Augusta to fight for my community and its share of revenue sharing, and I'm going to keep my eye on the prize. Thank you, Mr. Speaker.

Representative JONES of Freedom **REQUESTED** a roll call on **ADOPTION of Committee Amendment "A" (H-166)**.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

Representative **BEAVERS**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I oppose the Ought Not To Pass Majority Report, although I totally understand the majority voting the way they did. I thank the good Representative from Biddeford, Representative Casavant, for casting the single vote for LD 192, "An Act To Allow Consideration of Fetal Alcohol Spectrum Disorder at Sentencing in a Criminal Case," which gives me the opportunity to talk to you about this bill very briefly. Bette Hoxie, Executive Director of Adoptive and Foster Families of Maine, asked me to submit this bill as many children in the foster care system suffer from this disorder.

The Center for Disease Control and Prevention (CDC) defines Fetal Alcohol Spectrum Disorder (FASD) as "a group of conditions that can occur in a person whose mother drank alcohol during pregnancy." Symptoms of concern to us relative to LD 192 include difficulties with judgment and poor impulse control. Individuals with FASD are at an increased risk of substance abuse and mental health issues, thus often end up in the court system, which may be unfamiliar with this disorder and the fact that mental health treatment may provide better results in helping a person who suffers from this disability and at a lower cost than incarceration.

Last year, Alaska passed SB 151, allowing judges to consider FASD as a factor during sentencing, which I would be happy to share with any of you who might request it along with the U.S. DHHS Center for Substance Abuse Prevention Fact Sheet on Preventing and Addressing Fetal Alcohol Spectrum Disorders (FASD) in Your State.

In conclusion, this bill gives our Maine judges more flexibility in sentencing people affected by FASD. I understand why the majority of the committee felt there was no need to itemize every issue that might carry mitigating circumstances. However, my contention is that Maine judges and lawyers are not aware of this condition, its impacts on persons with FASD, how many incarcerated persons suffer from it or how it might be treated. There is a need for education of judicial personnel, which, of course, there are not enough resources to provide. For these reasons, I oppose the Majority Report. Thank you.

The SPEAKER: The Chair recognizes the Representative from Freedom, Representative Jones.

Representative **JONES**: Thank you, Mr. Speaker. Sorry for the untimely response to the motion. I'd like to explain the contents of this bill. This is a takings bill.

The SPEAKER: Will the Representative defer? We had dispensed with the reading of the Committee Report and now we are looking for a motion from the House.

Representative DILL of Old Town moved that the House **ACCEPT the Majority Ought to Pass as Amended Report**.

The SPEAKER: The Chair recognizes the Representative from Freedom, Representative Jones.

Representative **JONES**: Please forgive my clumsiness with the rules of the House. Representative Timberlake and myself, believe it or not, agree that this is a takings bill and let me just basically brief the House on what the contents of this bill entail and leave it up to my brothers and sisters here to decide which is the right path to take. What this bill allows the state to do is this: Assume, for example, that my neighbor has an infestation of – and we've discussed a variety of invasive species and pests – for example, you know, woolly adelgid or green-eyed ash borer or whatever they are. What this bill allows the state to do is if my neighbor has an infestation on his property of an invasive species that is potentially dangerous, this allows the state to come on to my woodlot and take my trees as a preventive maintenance measure with no compensation. Now some of us here, myself included, have put our retirements in our woodlots, that is my investment, and for the state, as a preemptive measure, to take my property without compensation, members and women, that's a taking and I would just urge you to consider that when you make this vote. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Old Town, Representative Dill.

Representative **DILL**: Thank you, Mr. Speaker. While I don't really disagree with what the good Representative from Freedom mentioned, we did talk almost specifically or quite specific, even though it couldn't be larger than this, to insect paths, both invasive, the Asian longhorned beetle and the emerald ash borer, both of which are majority destructive pests, and the unfortunate thing is that the only way to manage this particular pest at the moment is to certainly go around and remove trees around an infestation. As was pointed out, that is a possible way that this could happen, that if it's found on my property line and I happen

to be right next to the good Representative from Freedom, they could also be taking some of their trees also and there would be no compensation. However, this is one of those types of things that could completely devastate forestry in Maine, both the maple industry and the ash industry, which is crucial to the Native American population. So maybe this isn't the best fix, but it's the fix that we have at the moment. Thank you.

Subsequently, the Majority **Ought to Pass as Amended Report** was **ACCEPTED**.

The Bill was **READ ONCE**. Committee Amendment "A" (H-171) was **READ** by the Clerk and **ADOPTED**.

Under suspension of the rules the Bill was given its **SECOND READING WITHOUT REFERENCE** to the Committee on Bills in the **Second Reading**.

Under further suspension of the rules the Bill was **PASSED TO BE ENGROSSED as Amended by Committee Amendment "A" (H-171)** and sent for concurrence.

The SPEAKER: The Chair recognizes the Representative from Burlington, Representative Turner, who wishes to address the House on the record.

Representative **NELSON**: Thank you, Mr. Speaker. I would make the same comment. On Roll Call No. 95, I did press my button and it recorded me as absent. I pressed my yea button, green button, and I'd like to be so recorded. Thank you.

The SPEAKER: The Chair recognizes the Representative from Falmouth, Representative Nelson, who wishes to address the House on the record.

Representative **NELSON**: Thank you, Mr. Speaker. I believe my light did light up so that's why I didn't stand up, but then when I got the record, it said that I hadn't voted. Thank you, Mr. Speaker.
