At this point, pursuant to House Rule 201, the Speaker addressed the House.

Speaker **EVES**: Pursuant to House Rule 201, it is my pleasure to address the House. I want to say good morning, welcome back, Happy New Year. It is great to see everybody back in the chamber.

As we begin our short Second Session of the 126th Legislature, I would like to take a few moments to reflect on the work we have accomplished together and the work that lies ahead. Last year, we made great strides for the people of Maine. While the headlines often focused on the areas where we disagreed, much of the successful work we did, we did together. Despite predictions of the worst, we passed a bipartisan budget; we passed an omnibus energy law, invested in our workforce, in our economy, in our roads and our bridges, and strengthened our classrooms and labs. In a divided government, this is clearly no easy task. We could not demand all or nothing and get anything done. Collaboration was our best option and we were able to do it because of the relationship and the respect that we have for one another.

It is easy to forget sometimes how much we all have in common. When we leave this building, we go back home to our families, our friends, our neighbors. We hear the struggles that we face and we come back energized to make a difference, and

we share that goal of making a difference. With that shared goal, I would like to especially thank the Representative from Newport for his leadership and commitment to that goal. Like the caucus we represent, we don't always see eye to eye. But our dedication, passion for moving the state forward and respect for one another, we are able to accomplish that goal.

In this chamber, we have had vigorous and informative debates. We have agreed, we have disagreed, and we have agreed again. We have changed each other's minds, voted green after a passionate speech or an argument well made. As the presiding officer of this body, I am extremely proud to lead you, but I am even more proud to serve alongside you. Today, I challenge myself and I challenge all of you in the chamber to maintain decorum and respect for each other as we enter into this short session. When the debate is heated and the rhetoric is running high, I want it to be clear that this place, in this chamber, is no place to make personal attacks or campaign speeches. We will have plenty of time on the outside to do that after we are done. As the presiding officer, I will be listening keenly to that. I know that I gave wide latitude last time, in terms of allowing some of the speeches. I think we are all better off when we are reminded of the work that we do here and that is to move Maine forward, and we leave the campaign to the campaign outside. There is plenty of time to do that after, hopefully, mid-April, and the work we have to do is critical, the time we have to do it is short, so I encourage all of us to get it done together.

The SPEAKER: The Chair recognizes the Representative from Newport, Representative Fredette, who wishes to address the House on the record.

Representative **FREDETTE**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I do believe last session was a productive session and I have enjoyed the opportunity to work with people on both sides of the aisle. I do believe that while we will have obviously very vigorous debate on many hotly contested issues this coming session, I do think that it is incumbent upon us. The people expect us to conduct ourselves in a professional manner. We certainly will look forward to doing that and joining the Speaker in doing that and the campaigns will certainly take care of themselves. I am always reminded by the comments that Speaker Nutting has made in the past that when you travel throughout Maine and you have one of those books of the 151 Representatives in this body, you can go anywhere and you have a friend. If you're in Fort Kent, or Kittery, or Presque Isle, or Wypitlock, you can pick that book up and whether it's a Democrat or a Republican, you can talk to that person and say, "Geez, you know my car is broke down" or "I need this and I need that." That's the way that I look at this body and the people that served in it. While we may disagree on policy, we certainly are family to a certain extent. With that, Mr. Speaker, I would ask, Mr. Speaker, Representative Dave Johnson is under the weather currently, is not feeling well. I would ask that the body keep him in your thoughts and prayers. Mr. Speaker, I would ask when we adjourn today that we adjourn with Representative Dave Johnson in our thoughts and prayers. Thank you, Mr. Speaker.

Pursuant to 5 MRSA, §13070-J, Maine Revenue Services is required to submit a report to the Legislature identifying the revenue foregone as the result of the Jobs and Investment Tax Credit ("JITC"), the Research Expense Tax Credit ("R&D"), the Seed Capital Investment Tax Credit, the Shipbuilding Facility Credit, the Credit for Pollution-Reducing Boilers, and public funds spent on the Business Equipment Tax Reimbursement Program ("BETR"). Attached are four reports that provide you with this information.

The first attachment shows the number of individual and corporate JITC, R&D, and Seed Capital credits for tax year 2011, as well as the value of those credits. Tax year 2011 is the last year for which we have full information on both corporate and individual filers. Statutes governing the release of confidential taxpayer information prevent us from reporting the names of the corporations or individuals that benefited from these tax credits. No taxpayer took advantage of the Credit for Pollution-Reducing Boilers for tax year 2011.

The second attachment explains the Shipbuilding Facility credit. As required by statute, the report provides information on the level of employment, yearly investment and the cumulative amount of investment. Since the inception of the credit, the level of employment has been such that the annual cost to the state treasury has exceeded the base credit amount of \$3 million per year.

The third attachment is a list of BETR recipients. For purposes of this report, businesses that filed for reimbursement during the fiscal year ending June 30, 2013 are listed. Recipients filed between August 1, 2012 and December 31, 2012 for eligible property taxes paid during calendar year 2011. For that period the state reimbursed \$48,847,400 to approximately 1,668 companies.

Public Law 2009, chapter 337 (LD 1468) amended the definition of "economic development incentive" in §13070-J to include not only the incentives listed above, but "federal and state statutorily defined programs that receive state funds, dedicated revenue funds and tax expenditures as defined by §1666 whose purposes are to create, attract or retain business entities related to business development in the State." The additional incentives identified in this new law can be found in the Maine State Tax Expenditure Report 2014 – 2015 prepared for the Joint Standing Committee on Taxation.
