On motion of Representative TREAT of Hallowell, the following Joint Resolution: (H.P. 1322) (Cosponsored by Senator GRATWICK of Penobscot)

**JOINT RESOLUTION RECOGNIZING
MAINE'S CREDIT UNIONS**

WHEREAS, Maine's credit unions are member-owned and member-governed financial cooperatives dedicated and committed to serving the needs of their members and communities. The nonprofit structure of credit unions provides each member with an equal voice and representation in the operations of the credit union. Serving members in all 16 Maine counties and in every community, Maine's credit unions operate with the primary purpose of benefiting the more than 636,000 Maine consumers who use credit unions; and

WHEREAS, the economic benefit that Maine's credit unions provide to Maine consumers is approximately \$38,000,000 annually, as a result of lower and fewer fees on products and services, lower interest rates on loans and higher interest rates on savings; and

WHEREAS, Maine is once again ranked as the nation's 5th strongest credit union state based on the percentage of the population that uses a credit union, a position Maine has held for 11 consecutive years. With more than 636,000 members, credit unions serve nearly one in every 2 Maine residents; and

WHEREAS, the 2,150 full-time and part-time employees of Maine's credit unions and the more than 1,000 unpaid volunteers who serve on credit union boards and committees demonstrate the core credit union values, philosophy and mission of people helping people by contributing to the communities they serve; and

WHEREAS, since 1990 Maine's credit unions and their members have raised \$5,300,000 to help end hunger in Maine, including a record-setting \$513,309 in 2013. One hundred percent of all money that is raised through the Maine Credit Unions' Campaign for Ending Hunger stays in Maine and goes directly to assist thousands of Maine families and individuals who otherwise would go hungry. In addition to contributing thousands of dollars to food pantries in communities across the State, Maine's credit unions also help to provide funds for statewide initiatives to help end hunger, such as being the primary source of funding for the State's only Food Mobile. In partnership with the Good Shepherd Food Bank, the Food Mobile has delivered over 3,800,000 pounds of food to food pantries in every Maine county since it began in 2005, which equals nearly 3,200,000 meals for Mainers in need; and

WHEREAS, the Maine Credit Unions' Campaign for Ending Hunger has also recently announced its multiyear commitment to the Good Shepherd Food Bank's efforts to end childhood hunger in Maine with its support of the Good Shepherd Food Bank's BackPack and School Pantry programs, as well as other childhood hunger initiatives; and

WHEREAS, in 2013 Maine's credit unions contributed more than \$1,000,000 to a variety of causes and to a number of organizations, such as financial literacy programs, the American Red Cross and Special Olympics. In the past 11 years, members of Maine's credit unions contributed more than 293,000 hours, including more than 37,000 hours last year, volunteering for organizations and activities in communities throughout the State, making a significant and positive impact not only on the organizations that received this assistance but also on the people who were served by and benefited from the services and resources provided; and

WHEREAS, since 1921 Maine's credit unions have been enhancing the lives of thousands of Maine people, who have

been helped to financial success and stability. Throughout Maine, credit unions continue to play a vital economic and socially responsible role in the lives of individuals and remain a local, significant and stable presence in the communities they serve; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-sixth Legislature, now assembled in the Second Regular Session, take this opportunity to recognize the Maine Credit Union League and Maine's credit unions for their positive contributions and the significant role they have played in the lives of Maine citizens and their communities for more than 90 years. Their service and dedication to this State are a tribute to those values and principles that we all hold dear; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Maine Credit Union League and its 61 member credit unions.

I just wanted to let you know that today is Credit Union Day and this Resolution honors our Maine credit unions. If you go downstairs, you will be able to see them between 11 and 1, and I just wanted to mention a couple of things that are in this Resolution that I hope you will take the time to read, one of which is that they contribute \$38 million annually to our economy in the form of business with Maine consumers. Secondly, that Maine credit unions employ over 2,000 people and also have 1,000 volunteers because, of course, they are a nonprofit model of business. Thirdly, that the credit unions are a tremendous force in our society for good, in terms of their volunteer efforts, especially around ending hunger. If you read the Resolution, you'll see the many different things that the credit unions and the people who work for the credit unions and volunteer for the credit unions have done to end hunger in Maine. So I hope you'll support me in supporting this Resolution. Thank you.

Representative **PETERSON**: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House. I hope that the extra time to explore this bill a bit further was helpful to people. Before we vote, I'd just like to once again stress the point that I made in my remarks yesterday, and that's that we literally have the power to vote today to send a clear message that challenges our expectations about the experiences of people living with a disability. Make no mistake it about it—that's the clear opportunity in front of us right now.

It's one thing to tell the advocacy and provider communities to go figure it out on their own, and it's quite another for us to make a declaration as a legislative body to formally acknowledge the value of this work. To recognize that we believe that there are solutions to barriers, both architectural and attitudinal, that can be overcome by assembling and coordinating the best thinking available in this area, the experts in the field, and focusing them with a clear directive, with definable parameters and a deadline to produce a measurable outcome.

The bill before us today provides us with a proactive approach for accomplishing this critical work. And if we really want to challenge the definitions and ultimately change the prospects of what is possible for people living with a disability on a widespread systemic basis, the creation of this commission is an aggressive step forward toward reaching that goal that we all share of seeing more healthy engagement at all levels of society from all Maine citizens.

Mr. Speaker, I'd like to thank all of my colleagues across this chamber for their attention and thoughtful consideration of this bill. I have great respect for all of you and I've truly appreciated this discussion. And I'd just like to note in closing, that I believe that it's fair for people to ask more from themselves and to ask more from our fellow citizens. And if you share this belief, I ask that you vote with me in affirming our commitment to redefining the possibilities and changing expectations. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from North Yarmouth, Representative Graham.

Representative **GRAHAM**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I rise in strong support of this bill for the hard work of the good Representative from Rumford, Representative Peterson. It was brought up yesterday that we have far too many boards and far too many commissions. I want to let the body know that my committee, State and Local Government, actually has a law. We have a law. We repeal boards and commissions that aren't effective, that aren't working, and so rest assured that boards and commissions that don't do their work are eliminated. This is not one. This blue ribbon commission will do its work and report by this coming November. But the main reason I rise is because I worked for several years in a neurology practice. I worked with families who have children who have severe neurological disease. One day, I

had a patient and her mom. The little girl had a very severe neurological disease. I looked at the mom and I told her, I said, patted her on the shoulder and said, "I understand." She looked at me with such anger and said, "No, you don't." The lesson I learned that day I will carry forward. What I ask all of you to think about is that lesson. I can't begin to understand what it means to live with a disability. I can't begin to understand what it means to live independently with a disability. The people that will be on this commission get it. They get it, they understand, and I am sure they will bring forward recommendations that will make a difference in their lives and, quite honestly, all of our lives. So, with that, please support this bill. It's very important. Again, I want to thank the good Representative from Rumford for being so strong and standing for this important work. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Farnsworth.

Representative **FARNSWORTH**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I'll make this very quick. Three points. One is that we pay a lot of lip service to total inclusion for people with disabilities and yet not taking the steps in order to make appropriate plans for this seems to me to be a major failure. Secondly, I think we need to take a look at when we talk about this, about saying inclusion means inclusion in terms of housing, transportation and work, and everybody is well aware of the fact that people with disabilities have a much higher unemployment rate than the general population. This is an important issue that needs to be addressed effectively and this would be a vehicle to do that. Thank you very much.
