## JOINT RESOLUTION TO RECOGNIZE THE 145TH ANNIVERSARY OF THE CITY OF AUBURN

WHEREAS, the City of Auburn, on the Androscoggin River in Androscoggin County, was incorporated as a town in 1842 and became a city 26 years later on February 22, 1869; and

WHEREAS, in 1917 the City of Auburn was the first municipality in the State to adopt a council-manager form of government and was the birthplace of the first shoe factory in Maine, an industry vital to the growth of the State, at one point during the peak of the shoemaking industry providing 75% of the world's shoes; and

WHEREAS, Vestigia Nulla Retrorsum, the motto of the city translated from the Latin as "No Steps Backward," exemplifies the resilience of its citizens and businesses, which have overcome and endured harsh challenges over the years, such as the New Auburn Fire, a conflagration that occurred in 1933, in which 249 buildings were destroyed, leaving 2,000 people homeless; and

WHEREAS, the City of Auburn also recovered from the devastating flood of 1936, which left streets submerged and homes and businesses flooded and caused the loss of 2 spans of the South Bridge, which required the building of a new bridge; and

WHEREAS, the City of Auburn was challenged in the 1950s as the shoe industry began a rapid decline, resulting in the city's changing into a vital regional service center, with investments in infrastructure, public and private partnerships and sound economic development opportunities through its multiple modes of transportation and prudent use of economic attractions to the city; and WHEREAS, the City of Auburn was recognized in 1967 as an All-America City and it remains a proud city that has emphasized growth, family values and industry as it has adapted to the many changes through the years; and

WHEREAS, the City of Auburn has been embraced by a community of diverse residents from around the world who are committed to making their community successful; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-sixth Legislature now assembled in the Second Regular Session, on behalf of the people we represent, take this opportunity to acknowledge the City of Auburn's residents and businesses for their commitment and growth and commend them for their active role in improving the quality of life in the city and making the City of Auburn an economically effervescent and welcoming community; and be it further

RESOLVED: That We, the Members of the One Hundred and Twenty-sixth Legislature, celebrate the 145th Anniversary of the City of Auburn and recognize its important role as a vital part of Maine's history and progress; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Auburn City Manager, Auburn City Council and Mayor of the City of Auburn for display and preservation for the residents of the City.

Representative WERTS: Thank you, Mr. Speaker. On February 22 of this year, the City of Auburn had its 145th anniversary. In 1917, Auburn was the first municipality in the state to adopt a council/city manager form of government. It's the birth place of the first shoe factory in Maine. Its motto itself, "No Steps Backward," exemplifies the resilience of citizens, businesses that overcame such things like the New Auburn Fire in 1933 that destroyed 249 buildings, leaving 2,000 people homeless, or the flood of 1936 that submerged homes, businesses and required the building of an entire new bridge. In 1967, Auburn was recognized as an All-American City, and remains a proud city and emphasizes growth, family values and industry. I want to acknowledge the Auburn residents and businesses for their commitment and growth, and commend them for their active role in improving the quality in the city and making it an effervescent and welcoming community on, this, their 145th anniversary. Despite my having been a pesky, competitive and possibly troublesome Blue Devil at times, they were willing to select me as one of their three Representatives to this particular body. Representative TREAT of Hallowell moved that the House **ACCEPT** the Majority **Ought to Pass as Amended** Report.

Representative FREDETTE of Newport **REQUESTED** a roll call on the motion to **ACCEPT** the Majority **Ought to Pass as Amended** Report.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from North Yarmouth, Representative Graham.

Representative **GRAHAM**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. This bill is my bill. This bill addresses a very important issue that we face almost

every day. This bill was brought actually in the last session, after we experienced the tragedies that occurred in Newtown. It made me think about how vulnerable our young adults are to mental This bill addresses the issues that children face, illness. adolescents moving into adulthood. It comes at a time when individuals are at the highest risk for first onset schizophrenia and bipolar disease. It comes at a time when we should not be cutting kids off. We should be paying attention and helping them on their path towards adulthood. Often, individuals fall off a cliff when they graduate from high school and there are no supports, again, at the most vulnerable time for them, particularly if they have mental illness. This bill would allow a bridge, a bridge to adulthood, and it would do that by providing a cost-effective. assertive community treatment plan that is well proven and cost effective. I have three sons, 24, 22 and 15, and I pray that not any of them will ever experience bipolar disease or schizophrenia, but they could, and many of you in this chamber have been touched by brothers, sisters, sons, daughters, even parents, who have struggled with mental illness. This bill will make a huge difference for the people who are affected by mental illness and it will help us all. I thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Windham, Representative Pringle.

Representative PRINGLE: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House. I rise in support of LD 1367. I would like to read you the revised title of this bill which came out of the Committee Amendment "A." It's "An Act To Decrease Costs and Disability Due to Mental Illness in Children, Adolescents and Young Adults." I believe everyone in this chamber is working to reduce the cost of state government. As Willie Sutton said, when asked why he robbed banks, "That's where the money is." Many are aware that, within MaineCare, 5 percent of the members account for more than 50 percent of the costs. A large portion of these high cost members are young people with severe mental illness. The good news is that there are now proven programs to identify young people at risk for developing serious mental illness, and once you identify them, there are effective treatments that can prevent progression of disease, prevent hospitalization and prevent disability. The bad news is that current insurance, both private and public, do not pay for this specific intervention of assertive community treatment and behavioral interventions.

Our committee struggled with a number of mandate bills this year. It's very hard to insist. You'd like to think that all insurance companies would work with their medical directors to be aware of current research and say, "Wow, look at this. We now have treatments that will work. We ought to pay for this treatment because it will save us money down the road." We have an outstanding child psychiatrist here in the state, Dr. Doug Robbins, who is a constituent of Representative Graham's, who has been a mover behind this because he has been a researcher in this area and has seen the outcomes. He and his fellow researchers around the country have said, "You know what? We don't need to do any more research. We just need to get this implemented because it saves lives; it prevents young people from going down the path to serious mental illness." There's a lot of data that shows the cost effectiveness, the cost of this assertive community treatment which is well standardized and measured through Dartmouth University and can be held as a standard by an insurance company as it looks to whether to pay for these treatments. The reduction in psychiatric hospitalizations is significant, so the cost of the treatment by the community team can be between \$2,500 and \$4,000, whereas the cost of a psychiatric hospitalization is \$20,000. If we look at these highcost utilizers, the average cost of care for a member of MaineCare is around \$4,400, but for these high-cost utilizers, it can be as much as \$77,000 to \$80,000 a year. So I strongly encourage us to vote to pass this mandate, which would require both MaineCare and private insurers to pay for this intervention that recognizes the warning signs and intervenes to prevent progression, because I believe it is essential to our getting out of the hole that we're in with both wait times in psychiatric admissions and the incredible expense that we pay as a state for service to patients whom we could prevent from needing this level of care. Thank you.

Representative TREAT of Hallowell moved that the House **ACCEPT** the Majority **Ought to Pass as Amended** Report.

The SPEAKER: The Chair recognizes the Representative from Hallowell, Representative Treat.

Representative TREAT: Thank you, Mr. Speaker. Mr Speaker, Men and Women of the House. Just to explain what this bill is about and what it does, this legislation addresses the situation of the narrow networks where we've had a number of policies offered by one insurance company on the exchange that have excluded quite a large number of our leading hospitals in the State of Maine. Two different bills came to the Insurance and Financial Services Committee, and the report before you is the Majority Ought to Pass Report, which does two major things. One is that it does what we call kind of a black box warning to consumers to let them know that they are considering to purchase a plan that does, in fact, exclude various providers, and that, in fact, they might not even be able to go to those providers and get even partial coverage for their bills. I noticed in our Sunday newspaper, the Kennebec Journal, there were some almost full-page ads by this particular insurer touting their insurance plan. What this first part of the Majority Report would do, would require those marketing materials to actually have information on them informing consumers that the plan being offered did, in fact, exclude a number of providers. The second piece of the bill, and this is what's different from the Majority Ought to Pass and the Minority Ought to Pass, the second piece of the bill would address concerns of those providers that have been excluded, namely a number of large hospitals in the State of Maine, and what it would do is if those hospitals were excluded from an insurance plan and the hospitals went to the insurers and said, "We want to know why and does it have to do with anything that we've done wrong, in terms of our cost effectiveness, in terms of our performance," the insurer would be required to provide a written explanation to that hospital stating whether or not that was the case. We hope that you will accept this Majority Report. I think that it does address both the consumer point of view as well as the hospital point of view in the narrow network situation. Thank you.

Representative FREDETTE of Newport **REQUESTED** a roll call on the motion to **ACCEPT** the Majority **Ought to Pass as Amended** Report.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from York, Representative McGowan.

Representative **McGOWAN**: Thank you, Mr. Speaker. Mr. Speaker, Women and Men of the House. I sponsored this bill because the York Hospital Health Care System was excluded from this health insurance product. They were given no reason for this exclusion. They were told it was not due to cost or quality. I'm sure many of you are aware that we are the only

developed country in the world that allows for-profit health insurance companies. Twenty cents of every dollar spent on health insurance goes to these companies. Hospitals are extremely vulnerable to the profit driven practices of health insurance companies. So there is a need for some simple ground rules. One, to make sure that the consumer is fully informed of their benefits, and two, is that hospitals have the basis for their exclusion. When you vote on this bill, understand your health care provider could be excluded next and you might not be aware of this until you end up in a crisis in a health care provider's facility. I ask for your support. We must keep an appropriate balance between the profit motives of health insurance companies, the viability of our hospitals and the interest of our health care consumers. Thank you, Mr. Speaker.

I had the honor of working with Deedee Schwartz in one role or another for over 20 years, almost all of my career, eventually succeeding her as Executive Director of the Maine Humanities Council. I've never had a greater mentor, or learned more from anyone. As noted by my former colleague, the historian, Charles Calhoun, "Deedee turned a small, modestly funded non-profit into a major cultural force that brought 'the power and pleasure of ideas' to every county and almost every town in Maine. Deedee championed the belief that the health of the humanities in America could not be trusted to government or to academia alone."

She believed that everyone, regardless of background or formal education, can and should benefit from the humanities, whether it's incarcerated kids at the Maine Youth Center reading *The Odyssey*, or library patrons working their way through *Moby Dick*. or teachers learning how to do primary research, or child care providers learning that a children's book can offer something much more profound than a simple text. Under Deedee and to this day, the Council takes on big ideas, but makes them accessible and welcoming. Deedee had two main principles: never be elitist, but never dumb things down. People all across Maine and in the public humanities community nationwide will miss her wisdom, her passion, and her humor. Thank you very much, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Falmouth, Representative Nelson.

Representative NELSON: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I rise also in honcr of Deedee Schwartz. Deedee was a good friend and a fellow Smithy. She was a unique and special person in her own quiet way. She really moved mountains and enriched all of our lives through her commitment to the humanities, her commitment to books, to reading and to what the humanities could tell us about ourselves, about our societies, about our history and about our future. She worked with children, she worked with nonprofits, she worked with private companies, she worked with anybody that she could, and she was very persuasive at involving other people in working with her to promote the humanities, which she felt so strongly about. My husband served with her on the Board of the Maine College of Art and after she retired, she devoted a lot of her time to her own art and she was an accomplished artist. She was a real treasure for the State of Maine. I know how much of a support she was to her husband, Elliott Schwartz, through the years that he was a professor of music and a composer at Bowdoin College, and I know how important she was to the raising of her wonderful children. So, in honor and with respect from all of us, we honor her and thank her for sharing her life with us in Maine. Thank you, Mr. Speaker.
