Dear Honorable Members of the 126th Legislature:

Under the authority vested in me by Article IV, Part Third, Section 2 of the Constitution of the State of Maine, I am hereby vetoing LD 1365, "An Act To Promote New Models of Mobility and Access to Transportation."

This bill is unnecessary and unwieldy. MaineDOT is in the process of writing a new statewide strategic transit plan, which addresses the concerns outlined in this bill. The Department has been successfully spearheading this effort without legislative action for approximately a year now; I trust they will accomplish this without a legislative mandate.

Further, LD 1365 creates an eighteen member advisory group to provide input on transit issues in the State. After reviewing the membership of such group, I feel conflicts of interest may arise and compromise the duties of the advisory group.

For these reasons, I return LD 1365 unsigned and vetoed. I strongly urge the Legislature to sustain it.

Dear Honorable Members of the 126th Legislature:

Under the authority vested in me by Article IV, Part Third, Section 2 of the Constitution of the State of Maine, I am hereby vetoing LD 1597, "An Act to Clarify Provisions of the Medical Marijuana Act."

This bill makes it legal for an elected official to visit a medical marijuana grow site operated by a registered caregiver or dispensary. Such a visit currently is against the law. This bill would apply to all elected officials, even those that would have no legislative authority whatsoever over medical marijuana issues, such as probate judges or town road commissioners. It seems hypocritical for us as elected officials to exempt ourselves from the law, especially when most of those elected would not need specialized knowledge of medical marijuana to perform their job duties

For these reasons, I return LD 1597 unsigned and vetoed. I strongly urge the Legislature to sustain it.

The SPEAKER: The Chair recognizes the Representative from Westbrook, Representative Gattine.

Representative GATTINE: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House. I hope you will join me today in overriding this veto. LD 1597 received a Unanimous Report, Ought to Pass, from the Committee on Health and Human Services and it went under the hammer in this body. We worked very, very hard in the committee to get the support of the entire committee and I'm very grateful for the hard work that my colleagues on the HHS Committee did. Basically, what this bill does that was passed is it allows marijuana dispensaries and caregivers to allow, if they choose, elected officials, local and state, to come in and receive tours and to try to understand better the work that is done in these budding businesses. One thing I've learned in the short period of time that I've been on the HHS Committee is that there are still a lot of misconceptions and myths about how this health care treatment and how these businesses operate. There's only so much you learn sitting in a committee room. While I've been on HHS I've had the opportunity to tour hospitals, I've had the opportunity to tour Riverview, I've had the opportunity to tour the Mental Health Unit down at the Warren Prison, but I am not allowed, under current statute, even at the invitation of a dispensary or a caregiver, to come in and try to understand better about how they operate. I

think that it's important for us to do whatever we can to try to understand these businesses, especially the folks on the HHS Committee who are charged with overseeing these and driving policy around these businesses. I think this legislation makes a lot of sense and I hope it's going to continue to get the strong support from this body. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Chelsea, Representative Sanderson.

Representative **SANDERSON**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I also join in with the good Representative from Westbrook and urge your support for this legislation. When this legislation first came out, there was a lot of controversy over it. But what this bill is actually intended for is to give elected officials, both legislators and those at a municipal level, the opportunity, at the invitation of the owners of these small businesses, the caregivers in our community and the dispensaries, etcetera, to have an opportunity to become educated about the program. I think it's really important for municipal officials which is why we included them in this to understand about all the businesses in their town. At this time, it's illegal for any of us to enter one of these establishments and I think it's really important that we make it easier for us to do so. Thank you very much.

Sometimes, the less complicated the solution, the easier it is to accomplish.

Representative BERRY: Thank you, Mr. Speaker. Speaker, I rise to urge this body to override the veto that we received yesterday. Mr. Speaker, Men and Women of the House. I do so because I feel very strongly about the issue of child abuse and neglect prevention, and because in all that I have learned here as a policymaker and as a teacher for 20 years, preventing child abuse and neglect rises to the very top of the list for me in terms of the things that we can do to move our economy forward, to move our educational system forward, and to help our state to move forward. The timing of this veto was particularly unfortunate and even shocking. It was unfortunate and shocking not only because yesterday was the beginning of Child Abuse and Neglect Prevention Month, not only because it was April Fools vesterday and in some ways the arrival of this veto letter seemed a cruel joke on children who are suffering today from child abuse and neglect, but more importantly because no time is better than the present to take real action, certain action, with the department to address child abuse and neglect. We know from science, recent science, that adverse childhood experiences have a dramatic effect on a child's brain development, health, learning, productivity, and their ability to lead a happy and productive life in the future. So, Mr. Speaker, I hope today that we can join together in overriding this veto and making sure that the good work that is in this bill goes forward.

Representative DeCHANT: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I rise to speak to this Joint Resolution. I am the Executive Director of the Chocolate Church Arts Center in Bath. I have been in this position since July of last year and it has been a great deal of hard work, but it has allowed me a great deal of insight into the creative economy. At the core of the creative economy is arts and education. When I was in school, I had band every day and had access to choir and art class. I played the cymbals in band, so you can imagine how often I had to practice. Now, in my child's school, the art experience is basically regulated to a couple times a week, if that, as well as all the crafts on a cart, so it moves throughout the school rather than to have a soft place to land. Now, I'm a big advocate for STEM which is Science, Technology, Engineering, and Math, but I also submit, without putting Art in there and without creating STEAM, that the STEM will fall short and not be as effective as it can be for our economy and our future. Now not every child is going to be a dancer and artist. I think my child first wanted to be a goat, so I think we're trying to steer him towards something maybe a little bit more

lucrative. But every child does need to learn creative problemsolving that will lead to innovation, that will lead to risk-taking and that will lead to future entrepreneurialism. At the Chocolate Church, this past December, we produced the best Christmas Pageant ever, and this is an example of what arts and education can do. Our performance required no fees to participate, but what we were able to do with a grant from the Davenport Foundation was to bring in legions of students from the area's schools and many of those students, this was their first time being an audience member, so it was their opportunity to experience what it's like to wait in line, what it's like to get a program, what it's like to sit and keep all of your extremities into a chair in the dark and have a performance that's live. That's something that I believe that can never be replicated in somebody's couch or in the living room playing a video game. So we need to incorporate education and the arts into our curriculum, and I admire that all the folks who are taking the lead and who are working in this and holding this vision for the State of Maine, with the Maine Alliance for Arts Education, the Maine Arts Commission, so that we can make sure that we have future artists, future audience members and future creative thinkers. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from South Berwick, Representative Beavers.

Representative **BEAVERS**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I, too, want to honor this special day. Two of my three children are career artists and one is also an arts educator. They both belonged to their arts societies when they were in high school and they currently make a living through art, one here in Maine and one in New Mexico. Thank you.

The SPEAKER: The Chair recognizes the Representative from Brooksville, Representative Chapman.

Representative **CHAPMAN**: Thank you, Mr. Speaker. Mr. Speaker, Friends and Colleagues of the House. Very briefly, in addition to the things that have just been said, I would like to point out that since I've been working a lot in technical education, one of the things that we look at when we're trying to improve education is to look sort of back up the pipeline of how are kids being educated before they get to the spot we're working on. I'm working primarily in the high school to college transition area, but I'd like to point out that arts education in the elementary school is the precursor to technical education later on. Thank you.

An Act To Protect Jobs in the Forest Product Industry

Representative STANLEY: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. As the sponsor of LD 1792, I wish to state for the record the intentions behind LD 1792 and the intention of the committee in unanimously asking you to support the language contained in Committee Amendment "A." Enacting this bill with your strong support will be helpful in creating the framework for an agreement between Great Northern Paper and Brookfield Renewable Energy that hopefully will lead to the restart of the presently closed mill in East Millinocket, the preservation of over 200 direct jobs, hundreds of indirect jobs and a way of life in the Katahdin region. Indeed, the operations of Great Northern Paper are currently idle, due to the very difficult and unstable market conditions, combined with unstable wood and energy pricing. The mill ceased operations on January 23, 2014, and approximately 210 Great Northern Paper employees were laid off on February 6, 2014. Great Northern Paper's management has assembled a restructuring plan which addresses key elements required for the business to be successful, with its primary focus on energy and wood requirements. The intention is to successfully implement all components of this plan and successfully restart the mill.

Committee Amendment "A," which completely replaces the original bill, has the bipartisan and unanimous support of the Energy, Utilities and Technology Committee. The amendment amends the 2001 Private and Special Law that governs the sale of electricity produced by the former Great Northern dams that were originally authorized by a Private and Special Law enacted in 1897. The dams the Legislature has allowed to be constructed in this area of the Penobscot River and the power they have generated for generations have been key to the operation of the Great Northern Paper mills in Millinocket and East Millinocket. The fate of these towns has always been linked to the mills. The towns were built around the mills. Without the hydropower facilities, the mills would not exist. Without the mills, the towns would not be there.

Great Northern Paper Company, LLC, acquired the mills in September 2011 after they were closed by Brookfield. In late January 2014, the East Millinocket mill was shut down. Great Northern Paper began to put together a strong restructuring plan. The restructuring effort, however, has encountered some obstacles specific to its energy requirements and associated agreements. The existing Private and Special Law significantly impedes Great Northern's ability to negotiate with Brookfield Energy in a collaborative manner as it contains certain restrictions that present potential reasons for Brookfield to decline to share excess revenue generated through remarketing of energy during the restructuring and in the future, thereby allowing the excess profits from the sale of energy to facilitate the restart and ongoing operations of the mill.

The Private and Special Law passed in 2002 effectively prevents the owner of the hydro facilities, Brookfield Energy, and Great Northern from sharing any of the excess revenues associated with a closure of the mill in excess of 90 days. That law was put in place to deter subsidizing the long-term shut down of the papermaking operations with revenues generated from the resale of the power onto the grid. That language is now having the perverse effect of effectively preventing Great Northern from gaining the benefit of revenue generated from the sale of power to assist with its efforts to restart and maintain paper production.

I worked with Senator Cleveland, Representative Hobbins and members of the committee to assure that this new language I am urging you to support specifically clarifies that so-called load-shedding arrangements would allow Great Northern Paper to share in the revenue received from the sale of power that would otherwise be going to the mill is expressly allowed. Indeed, passage of this bill will show that it is the Legislature's specific intent to make load-shedding permissible by assuring that the current law would not prohibit short-term load-shedding and would allow load-sharing for a longer term via a one-time exception.

Let me make it perfectly clear that this legislation is permissible. It does not mandate that the owner of the mills and the owner of the hydroelectric facilities are required to do anything. It is my strong belief and the belief of the committee that the parties should come to a mutually agreeable resolution of their differences so that the mill can restart. We heard that the crucial aspect of the mill's restart is to be able to receive revenue from the load shedding, both during the present closure and in the future. The owner of the hydro facilities objected to the original language. While we could have continued down the path of the original bill, it was clear that the owner of the hydro facilities would litigate whatever was enacted, totally delay the process, and prevent the restart of the mill.

With the Committee Amendment, we believe we have removed any rationale for litigating any aspect of this law. While

it is our strong intention that the parties come together and reach a mutually agreeable solution so that the mill can restart, we fully understand that the owners of the hydropower facilities hold the key to the resolution of this matter. We strongly urge the owner of the hydropower facilities to do what is necessary to assist Great Northern Paper to restart the mill under its new restructuring plan and get the workers back to the mill, on the job.

The state's power as trustee of the public's surface water resource gives this Legislature the authority to determine the appropriate use of these waters to assure that they are used for the benefit of the public. This has been clear since the original charter granting Great Northern the privilege to "construct and maintain dams" on the Penobscot River. Since the state originally granted Great Northern the privilege to develop the dams, this Legislature has amended the original charter over a dozen times and has enacted various conditions on how these assets can be used. With this bill, we are removing any statutory impediments that prevent Great Northern Paper from receiving the economic benefit from these dams as originally envisioned. Great Northern's restructuring plan is the only chance of getting the mill back into operation. The unions have been very involved with Great Northern in discussions regarding the restructuring plan and are fully supportive of the company's efforts and of this legislation.

Sharing revenues that are available from load-shedding is a critical piece of Great Northern's restructuring plan to restart and maintain operations. We are hopeful that by removing any impediments in existing law to allow Great Northern to benefit from revenues from the sale of electricity shows our strong support for restarting papermaking operations, supporting the workers, supporting the heritage of the Katahdin region, and we strongly urge the owner of the hydropower facilities to recognize that it is the key to a successful startup and ongoing paper production. Without this legislation, there likely is little hope of restarting the East Millinocket mill. Even with passage of this bill, there is no concrete assurance the mill will restart. As I've noted, we are looking for the owner of the hydro facilities to partner with Great Northern Paper to give the company its workers and the region the opportunity to maintain jobs and its papermaking heritage. I sincerely hope you will follow the bipartisan and unanimous support of the committee and vote to pass LD 1792. Thank you.

This being an emergency measure, a two-thirds vote of all the members elected to the House being necessary, a total was taken.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Russell, who wishes to address the House on the record.

Representative **RUSSELL**: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House. I want to mark this day as the day that democracy may have died. You may disagree with me, but today the Supreme Court came down in *McCutcheon v. Federal Election Commission* and stated, under the court's ruling, donors will have a \$2,600 limit per campaign but that wealthy donors now do not have to worry about a two-year cap of \$123,200, which means that wealthy donors now can invest their resources in any political candidate across the country with no fear of a cap. If you disagree with *Citizens United*, as many of us did on the floor of this body, one should be very concerned about the ruling that came down today. Thank you. Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Newfield, Representative Campbell, who wishes to address the House on the record.

Representative **CAMPBELL**: Mr. Speaker, if I was in my seat, I would have voted, on LD 1637, I would have voted yea and on 1766 I would have voted yea.

The SPEAKER: The Chair recognizes the Representative from Mexico, Representative Briggs, who wishes to address the House on the record.

Representative **BRIGGS**: Thank you, Mr. Speaker. Mr. Speaker, had I been present on Roll Call No. 617, LD 1637, I would have voted yea.

The SPEAKER: The Chair recognizes the Representative from Harrison, Representative Villa, who wishes to address the House on the record.

Representative **VILLA**: Thank you, Mr. Speaker. Had I been present for roll call, I would have voted on LD 1637 yea and LD 1766 yea.
