**IN CITY COUNCIL  
RESOLVE #3-12/13**

RESOLVE, Expressing the Opposition of the City Council of the  
City of South Portland to Proposals to Shift the Burden of Funding  
State Government to the Property Tax and Property Tax Payer.

WHEREAS, the State Administration has submitted a proposed  
budget for the coming biennium that will dramatically shift the  
burden of funding state government to the property tax by  
eliminating or significantly modifying long-standing property tax  
relief programs; and

WHEREAS, the proposal to suspend municipal revenue sharing  
would result in a \$1.8 million revenue loss to the City of South  
Portland, representing 6.4% of the City's general fund operating  
budget and \$0.53 on the property tax rate; and

WHEREAS, the proposal to redirect the excise tax on tractor trailers will reduce the City's revenues by an additional \$424,540 or \$0.13 cents on the tax rate; and

WHEREAS, eliminating the homestead exemption in FY 15 for those under 65 will increase taxes for no longer qualifying residents by \$165 on the net median home value in that year if the City's tax rate remains unchanged, representing a tax increase of over 5.41% for most of those losing the exemption; and

WHEREAS, low and moderate income residents under the age of 65 who now qualify for the state property tax circuit breaker program will no longer qualify for it in the coming budget year; and

WHEREAS, starting in the second year of the biennium, the business equipment tax reimbursement program (BETR), under which businesses are fully reimbursed for property taxes paid on certain business equipment, will be eliminated with most qualifying property transferred to the business equipment tax exemption program (BETE). Under this program, the City will be reimbursed by the State for 60% of the taxes due, reducing City revenues by an estimated \$761,807 in FY 15, or \$.023 cents on the tax rate; and

WHEREAS, the elimination of the business equipment tax reimbursement (BETR) and the modification to the business equipment tax exemption (BETE) will have a significant impact on the City's commercial taxpayers, many of whom make-up the economic engine for the State of Maine, providing jobs and good paying salaries and benefits. The elimination of the BETR program will adversely impact the retail sector, a sector who will not qualify under the BETE program. Additionally, all businesses within the BETR program will experience an 18 month void in State reimbursement until those businesses qualify for BETE program funds; and

WHEREAS, if enacted, these changes will reduce City revenues by at least \$2,034,460 in FY 14 and \$2,796,267 in FY 15, excluding certain impacts on the school budget; and

WHEREAS, to replace these revenues through property taxation, the City's tax rate would have to increase by approximately \$0.60 in FY 14 and an additional \$0.23 in FY 15 before considering any other expenditure increases that may be required; and

WHEREAS, alternatively, reducing expenditures by this amount would require eliminating general fund expenditures and dramatically reducing community services and staffing over and above the reductions that have been implemented since 2007; and

WHEREAS, further staffing and expenditure reductions of this magnitude would undermine the City's ability to provide local public services; and

WHEREAS, even a balance between tax increases and spending cuts would result in much higher property taxes in return for services that would no longer meet resident expectations or needs.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SOUTH PORTLAND, that the City Council hereby expresses its strong opposition to provisions included in the recently proposed state budget that would significantly shift the burden of funding state government to the property tax and property taxpayer. These proposals will dramatically increase property taxes in South Portland, taxes which often are unrelated to the ability of property owners to pay, and will require spending reductions which will call into question our ability to protect the health and welfare of our community and provide our residents with government services.

BE IT FURTHER RESOLVED, that the City Clerk is directed to provide copies of this RESOLVE to the members of the Legislature representing the City of South Portland, members of the Appropriations and Taxation Committees, the Governor, the Speaker of the House, the President of the Senate and the Legislative leadership.

We, the undersigned Officials of the Town of Livermore Falls, on March 11, 2013, the following resolution for our 2013/2014 Budget Year was signed.

WHEREAS, the Governor's unprecedented biennial budget places towns in an untenable fiscal position; and

WHEREAS, the proposal includes the elimination of \$283 million in municipal revenue sharing, falls \$200 million short of funding local schools at the 55% level passed in referendum; would eliminate the Homestead Exemption for anyone under the age of 65; would eliminate the "Circuit Breaker" property tax and rent revenue from towns; and would fail to reimburse towns for the 50% of the costs for the Business Equipment Tax Exemption Program; and

WHEREAS, the Governor's proposal also contains cuts to health and human services, clean election, the wage benefits of public workers, and other initiatives necessary for strong communities and who's under-funding continues to shift costs to towns; be it

RESOLVED, the Officials of the Town of Livermore Falls have called upon the Maine Legislature to reject these proposals, identify less harmful cost savings, and raise revenue in an equitable fashion in order to avoid a regressive tax shift to municipalities.

**JOINT RESOLUTION  
IN HONOR OF ST. PATRICK'S DAY AND IN RECOGNITION  
OF THE IRISH CONTRIBUTION TO MAINE AND TO THE  
UNITED STATES**

WHEREAS, St. Patrick is the patron saint of Ireland, known for bringing Christianity to Ireland and, it is said, for instilling a sense of literacy and learning that allowed Ireland to become the "island of saints and scholars" when the rest of Europe was in the Dark Ages; and

WHEREAS, the feast day of St. Patrick is a national holiday that is given recognition outside its native land, which indicates the Irish influence throughout the world; and

WHEREAS, the modern secular holiday of St. Patrick's Day was first celebrated in America in Boston during colonial days and the first St. Patrick's Day Parade in New York City was in 1766, and now St. Patrick's Day is celebrated all over America with pride; and

WHEREAS, millions of Irish people emigrated from Ireland in the 1800s to escape brutal poverty and starvation due to the Irish potato famine, and most of those people came to America to start new lives and to embrace and contribute to a new land; and

WHEREAS, tens of thousands of Irish immigrants arrived in New England and many came to Maine, and the Irish have been an important part of Maine's culture, history and society ever since; and

WHEREAS, within a few years of their arrival in the United States and in Maine, these Irish immigrants became part of the American cultural landscape while preserving the best of their native culture, and they dedicated themselves to helping build this Nation and State; and

WHEREAS, the Maine Irish Heritage Center, housed in the former St. Dominic's Church in Portland, is dedicated to preserving the history of Irish culture in Maine; and

WHEREAS, four signers of the Declaration of Independence were Irish-born and nine signers were of Irish ancestry and 19 Presidents of the United States have proudly claimed Irish heritage, including George Washington, the father of our country; John Fitzgerald Kennedy; and Ronald Reagan; and

WHEREAS, the 44,000,000 Americans of Irish ancestry, like their forebears, continue to enrich all aspects of life in the United States, in science, education, art, agriculture, business, industry, literature, music, athletics, entertainment and military and government service; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-sixth Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to encourage the celebration of St. Patrick's Day, and, recognizing the valuable contribution to our State and to our Nation of all Irish-American citizens, we urge the citizens of the State to commend and celebrate the integrity and richness of the Irish culture.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Craven.

Senator **Craven:** Thank you Mr. President. Men and women of the Senate, I humbly request that members read the text in the Resolution because it is time that we all respected each other, no matter where we hail from, and that we all enjoy the richness that every single person and every single culture brings to this great country. I know that there is a lot of talk often about the Irish culture being drunkards and being other than what they really are. Sometimes it is hurtful. St. Patrick's Day in Ireland is a holy day. In the United States St. Patrick's Day was an initiative to have people create an event in an attempt to combat the distain and the hate with which the Irish were held. That worked, but sometimes it backfires. I ask you to read the Resolution, so I won't take up your time to do that, so that you can see the contributions that the Irish have made to this state and to this country. Today Senator Cain has graciously agreed to sing

"Danny Boy" and I really want you to listen to the song in a different way. People think this is a love song. This is a song that was written by a father whose son was going off to war. It is heartbreaking. This is an Irish boy who is going off to war. Senator Cain's going to sing it for us. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Cain.

Senator **CAIN:** Thank you Mr. President. A number of years ago, when I was serving in the other Body, the good Senator from Knox, Senator Mazurek, who at the time was a member of the other Body with me, and his wife visiting. She's quite Irish, as I recall. He made a request through the Speaker of the House that I would sing "Danny Boy" on the floor of the House. It has just gone from there. I appreciate the opportunity and the request of Senator Craven to do the same today. I ask, in the same spirit of reflection and celebration of St. Patrick, and offer the song.
