**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BATH
OPPOSING THE GOVERNOR'S PROPOSED BIENNIAL STATE
BUDGET TO THE EXTENT THAT IT SHIFTS THE BURDEN OF
FUNDING STATE GOVERNMENT TO THE MUNICIPAL PROPERTY
TAXPAYER**

WHEREAS, the proposed Budget for the next biennium submitted by the Governor represents a significant reduction in revenues previously available to municipalities and shifts in a dramatic fashion the burden of funding State government to the municipal property taxpayer; and

WHEREAS, the reduction in revenue represents the elimination or significant modification of longstanding and legislatively approved property relief programs including, but not limited to, the following:

- The proposed Biennial Budget eliminates \$283 million dollars in municipal revenue sharing; based on the Manager's estimates, the first City of Bath Budget affected by the reduction, will see a loss of \$789,500 in revenue.
- The Biennial Budget proposes a level of school funding that is \$200 million dollars short of the 55% level passed in State referendum; this would result in an increase in the City of Bath's share of RSU 1 expenses of \$1,680,750 in the first Bath Budget year affected by the proposed Biennial Budget.

- The Biennial Budget proposes to shift \$8 million dollars in commercial excise tax revenue from the municipalities to State government; this would represent a loss to the City of Bath of \$38,735.

- The proposed Biennial Budget cuts State reimbursement for general assistance by \$6.7 million dollars, with a \$10.2 million dollar cap on reimbursement; if the cap is reached, this reduction could have a significant impact on the City of Bath.

- The shift under the proposed Biennial Budget from the Business Tax Reimbursement Program (BETR) to the Business Equipment Tax Exemption Program (BETE) potentially would cost the City of Bath \$25,234 in revenue, depending on adjustments that may have to be made in the City's Tax Increment Financing Program with Bath Iron Works.

- The proposed Biennial Budget also eliminates a significant portion of the Homestead Exemption and the Circuit Breaker Property Tax and Rent Relief Programs thus representing a shift in cost to the local taxpayers for amounts currently reimbursed by the programs; and

WHEREAS, the implementation of the Governor's Budget as proposed and without modification would result in a reduction of revenue to the City of Bath in excess of \$2,500,000 and represents an 11.4% increase in the City's tax rate during the first fiscal year that the Biennial Budget is in place; and

WHEREAS, municipalities have a limited ability to react to and provide for reductions in State revenues, essentially being limited to reductions in services and/or an increase in local property taxes; and

WHEREAS, local Municipal Budgets, including the City of Bath's Budgets, in recent years have been flat primarily due to prior reductions in State funding; and

WHEREAS, no corresponding option for raising additional local revenue has been proposed, to offset these revenue reductions; and

WHEREAS, the State has not shown any willingness to address revenue issues and tax reform; and

WHEREAS, the proposed Biennial Budget seeks to balance the State's Budget on the backs of its municipalities without providing any additional revenue sources and would require significant tax increases, if municipalities are to maintain reasonable service levels.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Bath that the City Council opposes the implementation of the Governor's Biennial Budget and urges the State Legislature to look to a more comprehensive approach with regard to its tax policies and identifying other cost savings not designated as being passed on to the municipalities and meaningful tax reform, in order to avoid significant increases in municipal property taxes and to protect municipal service levels.

RESOLVE, EXPRESSING THE OPPOSITION OF THE BOARD OF SELECTMEN OF THE TOWN OF ALFRED, TO PROPOSALS TO SHIFT THE BURDEN FUNDING STATE GOVERNMENT TO THE PROPERTY TAX AND THE PROPERTY TAX PAYER AND THAT LEGISLATIVE LEADERS AND MEMBERS OUTLINE A PLAN THAT PROVIDES A REASONABLE LEVEL OF PROMISE THAT MAINE STATE GOVERNMENT CAN ADDRESS AND SOLVE FUNDING ISSUES FACING THE STATE.

WHEREAS, the Governor's unprecedented biennial budget proposal places the State's cities and towns in an untenable and uncertain fiscal position during their budget planning; and

WHEREAS, the proposal includes the elimination of \$283 million in municipal revenue sharing; falls \$200 million short of funding local schools at the 55 % voter referendum approved level; would cut the State's reimbursement level to General Assistance by about \$6.7 million; would eliminate the Homestead Exemption for everyone under the age of 65; would eliminate the "circuit breaker" property tax and rent program for anyone under the age of 65; would take \$8 million in truck tractor excise tax revenues from towns; and would create a corporate tax exemption for large amounts of currently taxable property ; and

WHEREAS, the proposal to suspend municipal revenue sharing to Alfred would result in the loss of \$238,521 in revenues, which would increase property taxes by \$238.00 on the average residential property value at \$250,000; and

WHEREAS, the proposal to eliminate the FY 2015 Homestead Exemption for those under 65 will increase taxes for those residents by \$132 if the town's tax rate stays the same; and

WHEREAS, all of the above shifts costs to towns, whose only major means of raising revenue is property taxes, be it

Resolved, The Alfred Board of Selectmen calls upon the Maine State Legislature to reject these proposals and raise revenue in an equitable fashion to avoid this regressive tax shift. Be it further resolved, that the Alfred Board of Selectmen urgently calls upon the Maine State Legislature to immediately define and communicate the draft of a plan, that at the least, outlines the philosophical approach Legislative Leadership and the Members will follow to meet the demonstrated unmet needs of our State with revenues raised by State Government; and that the

Legislative Leaders and Members recognize how vitally important it is that such a draft plan be available within the near term, providing to all Maine citizens a reasonable level of hope that the huge challenges so evident can and will be successfully addressed by our elected State Officials.

WHEREAS, Governor LePage has proposed a biennial budget which would have a significant and negative impact on local municipal services and properly taxes; and

WHEREAS, this biennial budget proposal calls for redirecting that portion of the sales and income tax revenues normally distributed to municipalities under the Revenue Sharing Program toward balancing the State Budget. The proposal to suspend the State Revenue Sharing funds to Waterboro would result in a \$644,982.00 revenue loss to the Town of Waterboro presenting an estimated SO.85 increase on the property tax rate; and

WHEREAS, this biennial budget proposal calls for redirecting commercial vehicle excise tax revenues away from municipalities toward balancing the State Budget. The proposal will result in a reduction of excise tax in the amount of \$10,073.00 revenue loss presenting an estimated \$0.13 increase on the property tax rate; and

WHEREAS, this biennial budget proposal dramatically curtails the Homestead and Circuit Breaker programs designed to reduce local resident property tax burdens for the purpose of balancing the State Budget. The proposal will result in an increase in the property taxes of \$128.00; and

WHEREAS, this biennial budget proposal calls for the elimination of the BETR program that reimburses municipalities for lost personal property taxes for the purpose of balancing the State Budget. The proposal will result in an estimated \$96,740.00 representing an estimated \$0.13 in the tax rate; and

WHEREAS, this biennial budget proposal calls for drastically reducing funding to local schools (again failing to meet the Citizen Referendum mandate of 55% support) for the purpose of balancing the State Budget; and

WHEREAS, if enacted, these changes will reduce Town revenues by at least \$655,055.00; and

WHEREAS, to replace these revenues through property taxation, the Town's tax rate would have to increase by approximately \$1.12; and

BE IT RESOLVED, that the Board of Selectmen of the Town of Waterboro hereby expresses its strong opposition to provisions included in the recently proposed state budget that would significantly shift the burden of funding state government to the property taxes in Waterboro. Taxes that often is unrelated to the ability of property owners to pay. will require spending reductions which will call into question our ability to protect the health and welfare of our community and provide our residents with basic government services.

Call upon the Maine Legislature and Senator John Tuttle and Representative Aaron Libby to reject these proposals and restore revenue sharing to municipalities, retain full funding of General Assistance reimbursements, maintain the Homestead and Circuit Breaker relief programs, restore excise taxes to previous levels, retain the BETR program and support to the schools in order to avoid this regressive tax shift.

Resolve. Express the Opposition of the Selectpeople of the town of Newfield to the Proposals to shift the burden of funding state Government to the property tax and property tax payer

Whereas, the State Administration has submitted a proposed budget for the coming biennium that will dramatically shift the burden of funding state government to the property tax by eliminating or significantly modifying long standing property tax relief programs; and

Whereas, the proposal to suspend municipal revenue sharing would result in a \$79,418.00 revenue loss to the Town of Newfield representing an estimated 4% increase on the property tax rate: and

Whereas the proposal to redirect the excise tax on tractor trailers will reduce the towns revenues by an additional \$7,418.00 or 60 cents on the tax rate; and

Whereas, eliminating the homestead exemption in FY 15 for those under 65 will increase taxes for no longer qualifying residents by \$77.00 (based on a home value of \$100,000.) in that year if the Town's tax rate remain unchanged; this represents a tax increase of over 10% for most of those losing the exemption and

Whereas, low and moderate income residents under the age of 65 who now qualify for the state property tax circuit breaker program will no longer qualify for it in the coming budget year; and

Whereas, starting in the second year of the biennium, the business equipment tax reimbursement program, under which businesses are fully reimbursed for property taxes they pay on certain business equipment, will be eliminated with most qualifying property transferred to the business equipment tax exemption program; under this program, the Town will only be reimbursed by the state for 50% of the taxes due, reducing Town revenues by an estimated \$100 in FY15 or .001 on the tax rate

Whereas, if enacted these changes will reduce Town revenues by at least \$100,000 FY14 excluding certain impacts on the school budget and

Whereas, to replace these revenues through property taxation, the Town's tax rate would have to increase by approximately 5% in FY14 before considering any other expenditure increases that may be required; and

Whereas, alternatively, reducing expenditures by this amount would require eliminating all capital expenditures.

Whereas, staffing and expenditure reduction of this magnitude would undermine our ability to provide basic public services; and

Whereas, even a balance between tax increases and spending cuts would result in much higher property taxes in return for services that would no longer meet resident expectations or need.

Whereas, the RSU #57 School District is also proposed to received reduced funding within the next Biennial State Budget and the impacts listed do not account for the yet determined additional burden; and

Whereas, The Selectpeople for the Town of Newfield finds that municipal and school operations have been significantly reduced, capital are not keeping pace with depreciation and need, staff and service have already been reduced to minimum levels acceptable by residents, collaborative and shared services have been incorporated into current operations. And that is not feasible to further reduce expenditures sufficiently to account for the State's withdrawal of the distributions for broad-based taxation without further increasing the tax burden upon all property tax payers.

Now, therefore, be it resolved by the Selectpeople of the Town of Newfield that the Town Selectpeople express their strong opposition to provisions included in the recently proposed state budget that would significantly shift the burden of funding state government to the property tax and property tax payer. These proposals will dramatically increase property taxes in Newfield. Taxes that often is unrelated to the ability of property owner to pay. And will require spending reductions, which will call into question our ability to protect the health and welfare of our community and provide our residents with basic government services

Be it further resolved that The Secretary to the Selectpeople of the Town of Newfield is directed to provide copies of this resolve to the members of the Legislature representing the Town of Newfield, members of the Appropriations Committee, the Taxation Committee, the Speaker of the House, the President of the Senate and the Legislative

Some people, fearing their own lives, might have tried to pull away and swim to safety, but Parker, utilizing the first aid and rescue techniques he learned as a Boy Scout, quickly acted to gain control of the situation and was able to aid the boy to safety. This in itself was a true statement of courage and bravery. However, in the next few moments, Parker would again find himself called to action. This time a mother at the pool noticed her daughter had gone under water and not resurfaced. Again, ignoring the possible risk to his safety, Parker swam to her rescue and brought her safely to the side of the pool. These incredible and selfless acts earned Parker the rare Heroism Award. Only 3,506 Scouts have earned the award since its establishment in 1923. Parker is currently working on earning towards the rank of Eagle Scout. I wish him the best of luck and ask you to join me in commending him for his remarkable strength of character and bravery.

As you turn the corner to go out Route 9, headed for Canada, that's where the people that came through this location were all headed. It was the place where the slaves stopped on their journey north. They stayed at the Christmas House. There was a shaft, a tunnel, that went to the river. They stayed at the house in the daytime. That night they would go back to the river and continue their journey onto Canada. It is also the home of the statue of then-Colonel Chamberlain. The hill that it sets on replicates the battlefield at Little Round Top in Gettysburg. It looks like a battlefield. There is a slave coming out of the shaft. I had some material distributed to you today. The very last page of all of that shows both now-General Chamberlain and a slave coming up out of the shaft, looking South, leaning North on his journey to freedom. Unfortunately, I think you'll also see that back in 2000 I was involved in putting a bill in. We didn't see fit to allow this to happen. It is something that we ought to be all very very proud of. Lots and lots of people come up 95 and turn off on 395 headed towards Acadia National Park. They have no idea the piece of history that they are going by. It would get many, many, many more visitors if people could see a sign that says, "Freedom Park." It's worth considering. I ask you today to vote against this motion so that we could go on to the Minority Report. Thank you very much for your consideration.

THE PRESIDENT: The Chair recognizes the Senator from Franklin, Senator Saviello.

Senator **SAVIELLO:** Thank you Mr. President. Ladies and gentlemen of the Senate, I rise to support my good friend, Senator Youngblood. I lived in the Bangor area for about 13 years, or more than that if I count my time at the University. I had the unique opportunity to Joy Christmas, who owned the Christmas House and who actually had a rug cleaning business there at one time. She used to tell me the myth, the myth that it

was part of the Underground Railroad. I went into the house one time but never went downstairs. I'm sorry to say that I didn't do that because there are caves or tunnels that have been dug down in the bottom of that house. To read in some of the testimony by a member of the other Body that, in fact, when they finally took down that house, sadly, they found a slave's shirt in one of the corners. We have a piece of history which I think should have a unique stance out on the Interstate that identifies where this park is located. I would urge you to vote no on this so we can actually move the Minority Report. Thank you very much, Mr. President.

Senator **TUTTLE:** Thank you Mr. President. Men and women of the Senate, while I will not be opposing the pending motion, this is my bill and I feel quite strongly about it. This bill's aims are simple. It would add single gender classes to the pathways that may be used to provide learning opportunities for elementary and secondary school students in the state. This issue was first brought to my attention when a school district in my area, a school in Sanford, created a program that included single gender classrooms. A controversy erupted. However, the American Civil Liberties Union threatened to sue the Sanford School Department if they continued the program. Not wanting to go to court and not having the money, the department ended the program. We had testimony at the hearing where a number of students were positively benefited by this program. They continued to believe, however, that there is a strong case for single gender education for some students. I believe that. There are many studies that indicate that some students perform better in single gender environments. Many of us went to Catholic schools and saw that firsthand. I believe that we should be open to allowing school departments in Maine to try out creative approaches to educating our students. At the very least, they should be given flexibility by the State to do so without fear. I know at the public hearing we had many students from Sanford that did attend. They said how the program had affected them positively. I think that the key to education in Maine is to be as flexible as possible and allow our local school districts to do their job. As I said before, I will not be

opposing this bill. It's my understanding that a letter has been sent to the Maine Civil Liberties Union to have them work with the local school districts. It is also my understanding that the City of Presque Isle has had a very successful program in their high school for a number of years and I'm hoping that this can be extended throughout the state. Thank you, Mr. President.

Senator **CRAVEN:** Thank you very much Mr. President. Men and women of the Senate, this bill addresses one business in Oxford County. The business was established while current law was in place. The business is a cigar lounge. Under current law it does not allow food or drink to be consumed on the premises. This bill, the amended bill, would allow alcohol to be consumed on the premises. According to the owner, his preference would be cognac; to have cognac and cigar smoking. While I'm sure that your mouth gets very dry smoking cigars without being able to drink anything, this would create a lot of inequity in businesses such as coffee shops and restaurants and other bars that are established in the community that are not allowed to use tobacco products on their premises. They follow the law and follow the rules. This really erodes our tobacco laws that we have fought so hard for in the state of Maine to keep our kids and our workers healthy and to keep the cost of our health care in check. While I admire anybody that wants to expand their business, I think that expanding businesses that are unhealthy and that are creating inequities for other businesses that are in their community is not good practice. I will ask you to follow my light in the name of equality. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Oxford, Senator Hamper.

Senator **HAMPER:** Thank you Mr. President. Ladies and gentlemen of the Senate, my colleague from Androscoggin, Senator Craven, has done a nice job speaking to the Minority Report. Now I'll address the Majority Report. The Ought Not to Pass Report would leave current statute in place. Current statute and when it applies to tobacco specialty stores. Let me explain what a tobacco specialty store is. It is an establishment that is restricted in size to 2,000 square feet. It is restricted in its sales so that a minimum of 60% of its sales needs to be in tobacco products. You are also permitted, currently in statute, to consume tobacco in a tobacco specialty store. There is one tobacco specialty store licensed in this state. It was grandfathered before the 2007 change in statute that happened here in this Body from one of its members. It's currently located in the town of Portland, where it is permitted to smoke within the premises. A law change in 2007 put in a provision where drinking and eating in a tobacco specialty store would be against the law. L.D. 22, in its original form, was to remove that one sentence from statute. Currently in Maine, if you walk into a tobacco specialty store with a Dunkin Donut coffee in your hand you are a law breaker because there is no drinking permitted in a tobacco specialty store. Under statute, in the definition of food falls chewing gum. It is very specific in statute that chewing gum is listed as a food. If I walk in with a piece of Juicy Fruit in my mouth I'm a law breaker, except for the one establishment in Portland where smoking, drinking, and eating is permitted. By going with the Majority Ought Not to Pass on this item, we keep statute as it is and we continue to make law breakers out of those who walk into a tobacco specialty store chewing gum and drinking a Dunkin Donut coffee. I urge you to vote against the Majority Report and let's consider the Minority Report. Thank you, Mr. President.

I think that it's very prudent to keep our senior citizens healthy and happy and at home in their communities and also have the federal government help us keep seniors in the least restrictive settings as well as having access to their medications without having to worry or without having to go without. When this waiver was put in place it hurt a lot of my constituents that struggle every day to try to pay for their medications. I won't take up a lot of your time talking about this, but I would ask that people follow my light to reinstate the federal Medicare offset program to the levels it was before we cut it back to 100% of poverty. Thank you, Mr. President.

Senator **HAMPER:** Thank you Mr. President. Ladies and gentlemen of the Senate, this would restore it back to 185% of the federal poverty level. Why not 200%? This spends \$3.9 million annually that we simply do not have. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Katz.

Senator **KATZ:** Thank you Mr. President. Men and women of the Senate, two stories today with respect to this Joint Resolution. The first one has been sent to all of you by e-mail from the Senate President and myself and Representative Nelson of the other Body. It's a link to a YouTube video that lasts about three minutes. I hope all of you will take the chance and watch it sometime today. I suggest that it will be the most meaningful three minutes you spend today. The second story, Mr. President, is that of Max Slabotsky. Max was born in Belgium in 1931. His father was a tailor and his mother stayed at home. He had a younger brother, who was also born in the 1930's. Max only had two years of formal schooling in 1939. That year the family left for Toulouse, trying to get to Spain because they thought it would be safer for them there. They never arrived. The borders were closed off and they returned to Brussels. Though Jews were required to wear the Jewish star on their clothes in 1940, the first year of the occupation, things were still relatively quiet and peaceful. In the area there lived a man named Le Gros Jacques, or Fat Jack, a Jewish man who worked with the Gestapo during the war to identify Jewish people in the street and have them arrested. He used to ride around in a big car with a Gestapo agent next to him. He turned his own parents and children in to the Nazis. In 1941, both Max's Uncle Joel and his father were arrested. In 1943, his mother was arrested and taken to Malines. There a former infantry barracks was transformed into a prison. From there some 45,000 Belgian Jews were transported to Auschwitz. Max soon left and lived with a friend of his father's, hidden in an attic for about six weeks. One day, fed up with being locked up, he left the attic and went out in the street. He went to a department store and when he came out he was standing face to face with the car that Fat Jack drove around in. Max was asked if he was a Jew. He said no, but Jack knew otherwise. Fat Jack had worked as a hotel porter and next door to that hotel had been a café where Jews, like Max, gathered to talk. He told Max, "We have ways of finding out the truth." Max was taken into the basement of the Gestapo headquarters on Avenue Louise. From there he was transported to Auschwitz. When Max and the other prisoners arrived, the doors opened and they marched out. Trains came from all over Europe: Poland, France, Holland, Germany, and also from Russia. Max followed the people in front of him. He could see that those who were selected to go left would end up in the gas chambers. Max, who was young and able to work, was told to go right. The Nazis took the prisoner's clothing, gave them uniforms to wear, a military pot to eat out of, and two blankets for warmth. He was tattooed and given a number on his clothes. Max's first job was to separate the clothing items that were confiscated. Occasionally he would find bits of food. After two months he was moved to another camp where he painted huge septic pipes. It was there that Max and the other prisoners learned why they shouldn't try to escape. Six girls were brought out and put in a pit. German Shepherds were then unleashed. The prisoners watched as the girls were ripped to bits and killed. Max was then transferred to another camp that had a big farm and a barn where the prisoners slept on hay. Later, in 1944, he and the other prisoners were locked up in the barn. They heard a language which was not German. One of them opened the door and saw a Russian soldier. That day they

were taken to an American run hospital in Germany. From there, Max returned to Belgium where he found and lived with his Aunt Anna. He also found his brother, who had been hidden by a nun during the war. In 1945, Max was finally reunited with his mother. His mother had been part of the scientific experiments performed by Dr. Mengele and was seriously wounded. In the Holocaust he lost his grandfather, father, aunt, uncle, and cousins. Following the war, Max first went to Paris, where we apprenticed with a tailor. In 1955, he married and moved here to the United States, where he made a career selling men's clothes and creating costumes at Disneyland. Max is employed today. He works at the Men's Warehouse in South Portland as a tailor. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Cain.

Senator **CAIN:** Thank you Mr. President. Men and women of the Senate, it is my pleasure to rise in support of this Joint Resolution and to share a brief story of my own. In 2009 my husband and I took a lengthy trip to the country of Israel. We had a wonderful experience. If you ever have the opportunity to visit that amazing land I recommend that you do. We spent time in the Old City, in Jerusalem, in Tel Aviv, and visited friends. One of the most special days that we spent was an entire day at Yad Vashem. Yad Vashem is Israel's official memorial to the Jewish victims of the Holocaust. It was established 60 years ago, in 1953, by an official act of the Knesset, Israel's government. This physical space is a world center for education and for research. The on-line materials and the in-person materials they have available are used all around the world to help individuals find family members and connect through personal stories, like the ones you've just heard. It is also to help educate future generations, next generations, about the realities and horrors of the Holocaust. It's a long thin museum. As you enter in you ascend as go through it. You step through the different stages of the Holocaust; what led up to the actions, to the concentration camps, to the stories of release from the concentration camps, and to the heroic stories of people who stood up and said this was wrong and who came in to save many others. Also of the courage inside the camps; camps like Terezin which was a camp where they had an artist's colony, where they put on shows, and where music was composed. The museum, Yad Vashem, commemorates all of that. What stays with me the most when I think about that trip is that at the very end of this long thin museum, where you literally feel the pain and the sadness and the sorrow, it opens up to a balcony; a balcony with a vista, that takes your breath away, of the City of Jerusalem and the country of Israel. It is meant to signify that there is something after the Holocaust; that there is a bright future ahead for Israel that people should look out and look forward to, always remembering and carrying with them the realities of the past. There is a section of the museum when you step outside that is the Children's Memorial. It is a very dark room. When you enter in there are thousands of lights that are illuminated to remember the children who were lost in the Holocaust. As you leave, you come upon the Avenue of the Righteous of the Nations. The Righteous of the Nations are those from around the world who were not being targeted in the Holocaust but who stood up and said this was wrong, who reached out and took risks, and who jeopardized the safety of themselves and their families to help others and to help bring those horrors to an end. One of the quotes that remained with me that is near this avenue that

recognizes the individuals and the countries that stepped up says, "Who so ever saves a single life saves an entire universe." Who so ever saves a single life saves an entire universe. What we are doing today by remembering these lives, by never forgetting what happened, and by making sure this remains a current part of who we are and what we remember as a nation, we, by extension, are saving the universe ourselves. Thank you, Mr. President, I appreciate the opportunity to share these words.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Mason.

Senator **MASON:** Thank you Mr. President. Men and women of the Senate, I just wanted to say that I'm very proud to be wearing a suit that was tailored by Max right now. I would imagine there are many people who are wearing a suit today and, if you thought it at the Men's Warehouse in Portland, it was tailored by him. I just wanted to share a quick story. When Senator Katz mentioned that, it brought back the first time that I went to the Men's Warehouse to get my suit tailored and was talking to Max. Anybody who's talked to him knows that he has a really really thick accent. Even after all these years, he still has a really thick accent. He started telling me his story. It was fascinating. He had no idea who I was. He had no idea what his story meant to me. It's just as every bit amazing as Senator Katz said it was. I think it's great that we're going to pass this. I think that it's also wonderful that Max has had his chance to share his story over the past week in the local papers. I just had to stand up and say that because I just think he's a great guy and I think that passing this does honor to him and so many others like him. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Sherman.

Senator **SHERMAN:** Thank you Mr. President. Ladies and gentlemen of the Senate, I don't usually get up on these, but there is a missing piece to this. When I first started running for the House and I was going door to door, knocking on the doors of veterans. I come from the little town of Hodgdon, over 200 folks that were in the service. Very quickly they began to talk about what they had seen in World War II. There were three brothers by the name of Quint, Shirley and Roy. They fought in Europe. They ended up finding some of these concentration camps. It left a mark on them forever. They were 18, 19, and 20 year old boys at the time. As they got older and older, they kind of reminisced in a sense. You saw some of the actions of these soldiers that came back. We always thought they were a little different. Then you'd find out what they saw and the medals that they earned that they never say anything about. I honor those folks who liberated some of these camps. There were three Quint boys involved in the war. They ended up as part of the liberation of the camps. We should remember those folks also because many of them lost their lives doing those very things.
