**RESOLUTION OPPOSING BUDGET PROPOSALS
TO SHIFT BURDEN
OF FUNDING STATE GOVERNMENT TO
THE PROPERTY TAX AND PROPERTY TAX PAYER**

WHEREAS, the Governor has submitted a proposed budget for the coming biennium that will dramatically shift the burden of funding state government to the property tax and property tax payers by eliminating or significantly modifying long-standing property tax relief programs; and

WHEREAS, the Governor's proposed budget would result in the City of Portland losing almost \$11.5 million dollars in funds as a result of proposals related to revenue sharing, teacher retirement, general assistance and the business equipment tax reimbursement (BETR) program; and

WHEREAS, the reductions in funding outlined in the proposed budget would significantly increase property taxes and compromise the City's ability to meet its resident's expectations and needs, as well as offer basic public services; and

WHEREAS, the City has always worked to maintain an effective partnership with state government; and

WHEREAS, this budget proposal significantly alters the City's partnership with the State and undermines the City's economic development and job creation efforts; and

WHEREAS, this budget proposal places a greater burden on Portland taxpayers to provide a quality education;

NOW, THEREFORE, BE IT RESOLVED, that the undersigned members of the Portland City Council strongly oppose the provisions in the Governor's recently proposed budget that would significantly shift the burden of funding state government to the property tax and property taxpayer. These proposals will dramatically increase property taxes in the City of Portland, taxes which often are unrelated to the ability of property owners to pay, and will require spending reductions which will call into question our ability to protect the health, safety and welfare of our community and provide our residents with government services; and

WHEREAS, Governor LePage has proposed a State budget which would have a significant and negative impact on local municipal services and local property taxes; and

WHEREAS, This State budget proposal calls for redirecting a portion of sales and income tax revenues, collected under the Revenue Sharing Program, away from municipalities and redirecting them to the State of Maine to balance the State budget; and

WHEREAS, This State budget proposal also calls for redirecting commercial vehicle excise tax revenues away from municipalities and redirecting them to the State of Maine to balance the State Budget; and

WHEREAS, This State budget proposal dramatically curtails the Homestead and Circuit Breaker programs, both programs designed to keep local residential property taxes low; and

WHEREAS, This State budget proposal call for the elimination of the BETR program that reimburses municipalities for some lost personal property taxes; and

WHEREAS, This State budget proposal shifts a portion of the cost of teacher's retirement fund to municipalities; and

WHEREAS, This proposed State budget is now before the Legislature for consideration;

**RESOLUTION OPPOSING
GOVERNOR'S BIENNIAL BUDGET**

RESOLVE, Expressing the Opposition of the City Council of the City of Westbrook to Proposals to Shift the Burden of Funding State Government to the Property Tax and Property Tax Payer.

WHEREAS, the State Administration has submitted a proposed budget for the coming biennium that will dramatically shift the burden of funding state government to the property tax by eliminating or significantly modifying long-standing property tax relief programs; and

WHEREAS, the proposal to suspend municipal revenue sharing would result in a \$1,455,480 revenue loss to the City of Westbrook; and

WHEREAS, the proposal to redirect the excise tax on tractor trailers will reduce the City's revenues by an additional \$58,000; and

WHEREAS, eliminating the homestead exemption in FY 15 for those under 65 will increase taxes for no longer qualifying residents by \$174 in that year if the City's tax rate remains unchanged; and

WHEREAS, low and moderate income residents under the age of 65 who now qualify for the state property tax circuit breaker program will no longer qualify for it in the coming budget year; and

WHEREAS, starting in the second year of the biennium, the business equipment tax reimbursement program (BETR), under which businesses are fully reimbursed for property taxes paid on certain business equipment, will be eliminated with most qualifying property transferred to the business equipment tax exemption program (BETE). Under this program, the City will be reimbursed by the State for 60% of the taxes due, reducing City revenues by an estimated \$478,500 in FY 15; and

WHEREAS, the elimination of the business equipment tax reimbursement (BETR) and the modification to the business equipment tax exemption (BETE) will have a significant impact on the City's commercial taxpayers, many of whom make-up the economic engine for the State of Maine, providing jobs and good paying salaries and benefits. The elimination of the BETR program will adversely impact the retail sector, a sector who will not qualify under the BETE program. Additionally, all businesses within the BETR program will experience an 18 month void in State reimbursement until those businesses qualify for BETE program funds; and

WHEREAS, if enacted, these changes will reduce City revenues by at least \$1,513,580 in FY 14 and \$1,992,080 in FY 15; and

WHEREAS, to replace these revenues through property taxation, the City's tax rate would have to increase by approximately \$0.62 in FY 14 and an additional \$0.26 in FY 15 before considering any other expenditure increases that may be required; and

WHEREAS, alternatively, reducing expenditures by this amount would require eliminating general fund expenditures and dramatically reducing community services and staffing; and

WHEREAS, further staffing and expenditure reductions of this magnitude would undermine the City's ability to provide local public services; and

WHEREAS, even a balance between tax increases and spending cuts would result in much higher property taxes in return for services that would no longer meet resident expectations or needs;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WESTBROOK, that the City Council hereby expresses its strong opposition to provisions included in the recently proposed state budget that would significantly shift the burden of funding state government to the property tax and

property taxpayer. These proposals will dramatically increase property taxes in Westbrook, taxes which often are unrelated to the ability of property owners to pay, and will require spending reductions which will call into question our ability to protect the health and welfare of our community and provide our residents with government services; and

BE IT FURTHER RESOLVED, that the City Clerk is directed to provide copies of this RESOLVE to the members of the Legislature representing the City of Westbrook, members of the Appropriations and Taxation Committees, the Governor, the Speaker of the House, the President of the Senate and the Legislative leadership.

RE: Impacts to the Town of Bridgton-Loss of Revenues and Required Retirement Payments

President Alford and Speaker Eves:

As the elected officials for the Town of Bridgton and members of the M.S.A.D. #61, we have consistently advanced our citizen's needs and concerns through the local budget process. As a rural western Maine region, we have also endured the inequities that often come from the formulas developed at the state level when it comes to the revenues and requirements imposed. In no one

year in our past have we ever faced the daunting task of meeting our citizen's needs while experiencing the loss of revenues to our community and the unconscionable shifting of the State's share of the Maine Teachers Retirement System to what is now a 100% local cost. When combined, the impacts are forcing us to raise our local tax rate in excess of \$.56 which represents a minimum increase of 4% before we attempt to meet our local operational and maintenance requirements for FY 2014.

The M.S.A.D. #61, by virtue of the State's education formula, already has inequities such as the fact that as a rural area, our pupil transportation costs far exceed those of the urban and metro areas of the state. When this formula is used to determine prior year essential program and services support, once again we came up short and had to make up the difference at the expense of our local tax payers. Added to this insult, the decision to require the State's share of the Teacher Retirement System, our M.S.A.D. had to absorb 100% of this cost or over \$357,000 while we see the urban and metro regions fairing far better with shares below 60%.

We are also facing additional burdens that are still part of the State's budgeting efforts. Our average per student cost is almost \$10,000 and we have at least 9 students who may opt to transfer to a charter school for which we will become 100% responsible. That means close to \$90,000 of local tax dollars will leave this community and M.S.A.D. to be exported to another region leaving fewer dollars for the very academics which are the key to our local economy and an individual's success in their adult life.

All of this is in light of the facts that our region and specifically the Town of Bridgton has one of the highest percentages of students who qualify for Free and Reduced lunches. The inequities are unfathomable!

The efforts to balance the state's fiscal affairs by transferring the tax burden to our community and M.S.A.D. is a slap in the face to our citizens and their future. As we review the Governor's original proposals, the calculations for our community indicate that we come up short; that the model as proposed is a complete tax shift and represents such a narrow perspective that it leaves us with a greater concern for the future. Labeling this as "getting our house in fiscal order" is nothing less than a carefully orchestrated charade at the expense of every local tax payer.

We ask that as the legislative leaders of our great state, you bring both aisles together to cease the efforts of this tax and burden shift and preserve the integrity of the past relationships between the municipalities, education community and the State. As we have heard from many of our citizens, the best way we can describe their feelings is by asking you to "STOP THIS INSANITY."

In the coming weeks we will continue to observe and respond. We hope that you are listening to echoes of these concerns and hearing that this is not an acceptable approach. Please distribute this letter to all of the legislative members of our state government.

RESOLUTION IN OPPOSITION TO LD 300**

BE IT RESOLVED, by the Town Council of the Town of Scarborough, Maine, in Town Council assembled that,

WHEREAS, the property taxpayers of Scarborough are obligated to fund education for their K-12 students under the laws of the State of Maine; and

WHEREAS, more than 65 percent of Scarborough property taxes are spend to support education in the Scarborough School District; and

WHEREAS, one of the largest line item expenses in the school's budget is for the cost of health care insurance for teachers, administrators and support staff; and

WHEREAS, competition most often produces lower prices for goods and services and improves understanding of the value of such goods and services; and

WHEREAS, the 125th Maine Legislature passed LD 1326 An Act To Allow School Administrative Units To Seek Less Expensive Health Insurance Alternatives and the bill was signed into law by the governor to enable the release of health insurance loss data to individual school districts for the purpose of understanding and soliciting competitive proposals for health insurance; and

WHEREAS, LD 1326, having been in effect for less than one year, breaks a decades-long virtual monopoly by the Maine Education Association Benefits Trust over local health insurance costs by concealing the loss data for individual school districts; and

WHEREAS, the United States Federal Court in Maine and the United States Federal Court of Appeals in Boston both have rejected arguments by the Maine Education Association Benefits Trust that attempted to block implementation of this insurance reform; and

WHEREAS, the Legislative Policy Committee of the Maine Municipal Association voted to oppose LD 300;

NOW, THEREFORE, BE IT RESOLVED, by the Town Council of the Town of Scarborough, that the Town Council hereby urges the 126th Legislature to reject LD 300, or any other legislation that restricts access to local loss data and designates the Town Manager to communicate the Town Council's opposition to this bill's sponsors, other legislators, the Joint Standing Committee on Insurance and Financial Services and other municipal officials; and

BE IT FURTHER RESOLVED, that the Town Council encourages the Scarborough Board of Education to adopt a similar resolve showing its opposition to LD 300.

She has been a member of the board of the Maine State Society for the Protection of Animals for 37 years and a member of the Daughters of the American Revolution for 39 years. She has been a member of the South Freeport Congregational Church for almost 60 years and a member of the Freeport Woman's Club for 11 years, serving as its president twice and vice president twice. Nancy is a member of the Freeport Elders Association and is an active member of the Board of Directors of Freeport Community Services. THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Gerzofsky.

Senator **GERZOFKY:** Thank you Mr. President. Ladies and gentlemen of the Senate, in a loud and clear voice, I would like to say that there are people that you encounter in your life that leave a lasting impression. I would like to tell some stories about this one because she was the first female, first woman, in Leadership in this Body on the Democratic side. I worked here at the time. I had been involved with this hero in my life, Senator Nancy Randall Clark. I can remember standing by those doors, as the Sergeant-At-Arms then, and watching her mentor many other young people. The current Sergeant-At-Arms would be one of them, who she brought in here when I think he was 5 or 6 years old and had him doing paging work. She did the same for many people. I love saying that without her I wouldn't be here today. She showed me how much to love this Chamber. When I started working in here the thing I learned is to don't have your Senators liking you too much because they are going to work you more. She had no compulsions. She was a teacher. She had no compulsions to say, "Stan, the Sergeant-At-Arms, do me a favor. Take the dolly and go down to the Education Department," which used to be a big, ugly brick building right outside here that blocked our view of the library and the museum. She would have a car full for me to take and put in her car. She would take it to Freeport. I'll tell you, I used to often think, "Why does she like me so much?" Well, she did and I love her to death because she taught me what being a Senator was like. About being responsible and about good legislation, no matter which part of the aisle it came from. Good legislation is good legislation. She

taught me how to work with others, on both sides of the aisle and on both floors. You've got to remember that we had a Governor, an Independent Governor, named Longley. Our Chief Executive. Some people thought he might have been difficult at times to work with, but you've got to learn how to work with people. She served in here when we first took the Majority here in the Senate. She taught many of us, Senators and staff, what it was like to work on an issue, work it through its end, get something done, and be able to go home with accomplishments, not just rhetoric. This sentiment for her today, she's retiring and I don't know what she's retiring from. She's retired from everything, but she's never been inactive. She is the sparkplug in Freeport. She's a sparkplug throughout the state of Maine. Whenever I go to look for her she's someplace else doing something else. It's good, organizing people. When you see the Red Hats come up here she's going to be one of them. Usually she's driving the bus. I think she'll still be driving the bus when I'm 75. She has just been a hero in this building. Got an awful lot of work done. She mentored a lot of us. Mr. President, your Sergeant-At-Arms, as a young man and as a Representative many years later, she was still mentoring him. Never once telling us what to do. Never once telling us how to vote on something. Always telling us to look and see what it really means and what is really going to have an impact on the people that we not only serve but for the people in the state. I just wanted to get up and say something because she was an awful nice lady. She was an awful productive person. She was a great Senator. She was a great teacher. She's been great at everything she's ever done. Thank you very much for being here Nancy Clark.

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Tuttle.

Senator **TUTTLE:** Thank you Mr. President. Members of the Senate, it is indeed a pleasure for me to stand and recognize a good friend of mine, Nancy Randall Clark. I call her my favorite Senate leader. Twenty-four years ago I was here when she was a leader. I remember my wife changing my daughter's diapers in Nancy's office, the Majority Office. We are here today. As the good Senator from Cumberland, Senator Gerzofsky said, she was a mentor to many of us, myself included. As far as retirement, I know Nancy pretty good. I don't think she'll be retiring. I'm hoping to encourage her someday to run again. Nancy, if you are listening, I hope you hear this today. Congratulations for a job well done.

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Sherman.

Senator **SHERMAN:** Thank you Mr. President. Ladies and gentlemen of the Senate, I can't resist speaking on this topic. At one time I was a member of the Maine Teacher's Association, now the Maine Education Association. I was also the NEA representative for the state of Maine for a number of years. I ran into Nancy in those quarters, so to speak. As already has been said, she is a dynamo. She never gave up on anything. We had a representative assembly then, which is sort of like the size of the House. When she'd get up to speak most people quit making jokes and listened. She ran for national office. I think she would have done a wonderful job there. Most of this has already been said, but she apparently is master of a number of occupations that she was involved with. I wish her well.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Cleveland.

Senator **CLEVELAND:** Thank you Mr. President. Men and women of the Senate, I had the great honor and pleasure when I was a freshman of having Nancy Randall Clark being our Majority Leader. I found her to be a woman of great integrity and honesty. Hard worker and a good mentor. As a freshman, she always had her door open when you felt you needed to talk and get good guidance as a freshman on issues before us. I always found her a woman of great courage, even on the difficult issues when she knew there was great division. She would always stand up for what she thought was right for the people of Maine and had the courage to vote that way, even when it was not always the most popular way to vote on many issues. She taught me that courage. She also taught me the importance of this Chamber, where we debate the issues of the state and where we try to come to some common understanding on what is best for the people of Maine. I would not be the Senator that I am today without her good guidance in those early years. I am so grateful to have had her leadership at the time. In fact, my sons, who were young at the time and would occasionally join me here in the Senate to page, even to this day, even though they are adults, always mention to me how they could go to her desk and she always had little candies in her desk that she would hand out and how pleased they were and how friendly and kind she was to them, even though they were just young children. Nancy is an exceptional woman, a great leader, and has served this state with great honor. I'm so pleased to be able to recognize her birthday today.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Haskell.

Senator **HASKELL:** Thank you very much Mr. President. Colleagues in the Senate, I'm just going to remark briefly about Nancy Randall Clark. I remember two things. I remember she wore sneakers all the time. You could never catch up with her, and believe me, at the speed that she moved, both professionally and personally, she needed those sneakers. It was always fun to see her do that. She picked up every returnable bottle in the building. If you sat one down, look out, because she kept track of them. She made sure that this building was not littered with returnable bottles. They were always in a box by her desk and she always collected them. My favorite memory of Nancy was when I was a freshman. When I came up here as a freshman and saw my name on the board, I was surprised it was the same size as everybody else's because I was only a freshman. I walked down the hall and I saw her. I introduced myself and I said, "How do you do, Senator?" She said, "I know who you are." I've got to tell you that meant a lot to me. She had been paying attention. If you talk about people who are an example and a mentor in your life, you couldn't talk about anybody any better than Nancy Randall Clark. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Sagadahoc, Senator Goodall.

Senator **GOODALL:** Thank you Mr. President. Men and women of the Senate, I rise today to speak in favor of the pending motion. Our downtowns are just key components of our economy, of our way of life, of our tourism, of our communities, and the heart, blood, sweat, and tears of the fabric of all our lives. Frankly, it is where many of us grew up. It's where many of us go to participate in commerce, to buy our goods, and where many of our friends and neighbors work and run their businesses. Often we are advocating strongly for our downtowns through many different programs; tax credits or through bond packages. In addition we have this very important bill in front of us today. This is to fund the Maine Downtown Center. This is an appropriation of \$100,000 to really help our downtowns grow. There is no coincidence that across the state of Maine there are 30

communities that are participating in the Maine Downtown programs. These 30 communities, many of them, are the most vibrant downtowns in our state. Some of them have received awards, locally as well as nationally. The City of Bath, in my district, has been recognized as one of the top five Main Streets all across the country and the first in Maine. What this has done, in terms of through the help of the Maine Downtown Program and through the hard work of the volunteers, is it has really revived the City of Bath. There are many stories such as Bath throughout Maine. So often we are advocating for stronger economic development. We're advocating for pro-job legislation. This is one of those pieces of legislation. We have many pieces of legislation that look at tax credits, tax breaks, and bond packages that help businesses directly. This bill does that as well. It brings together small businesses. It has a direct effect, a positive impact, on small businesses. We have the opportunity today to take a step forward to continue the efforts that have happened across Maine in growing our downtowns. Every dollar that we invest we see a \$25 return. I would argue that this one of the best investments that we make for small businesses and our economy in the state of Maine as it pertains to return on our investment. Lastly, I just want to share that we need to think about our overall economic plan where we are here in the state of Maine. We all state that we are for small business. We do it on the streets. We do it in our electoral campaigns. We do it here in the Chamber. If you sat through a hearing, whether it is in Labor, Commerce, Research and Economic Development Committee or, this year, the Joint Select Committee on Workforce and Maine's Economic Future, you would see small business owners come in front of these committees to advocate for this bill. They are taking time off from their businesses and having their family members run the shop or they may be closing the shop to come up and testify because they know what this bill does. It has a direct positive impact for their business, for their community, for the tourism industry, for their region, and for both the rural and the downtown communities. I would encourage us all to get behind this important piece of legislation because this is pro-jobs, pro-community, and it brings in a greater economic investment from the private sector as well as other grants from the federal government. I would encourage you to support this bill. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Katz.

Senator **KATZ:** Thank you Mr. President. Men and women of the Senate, I must admit that I'm a child of downtown. My Dad had a jewelry store for 50 years in downtown Augusta and the business of which I'm a partner is in downtown Augusta. I'd like to suggest to you all that when you think about it there is no such thing as a great community that doesn't have a great downtown. It's what's unique about our communities. It's what gives our towns and cities a sense of identity. It's the economic engine for the creative economy. As my good friend Sagadahoc just pointed out, you can look around the state at success stories of downtowns coming back from the 19th Century roots. Look at Belfast. Look at Bath. Look at Waterville and others. Hopefully soon Augusta. They all have one thing in common; they have all been participants in the Maine Downtown Program. This \$100,000 is a fair amount of money, but what it really does is help leverage huge other amounts; federal funds, local tax funds, and, most importantly, private investment. I'd suggest that this is a wise,

thoughtful, and targeted investment, Mr. President, that will help make what's special about Maine even more special. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Hancock, Senator Langley.

Senator **LANGLEY:** Thank you Mr. President. Men and women of the Senate, I, too, rise as having served on the Maine's Workforce and Economic Future Committee. I apologize for being a late arrival here in the Chamber this morning. Besides a doctor's appointment, I had to do an interview for the upcoming Ellsworth sescentennial, 250 years of the City of Ellsworth being incorporated. One of the questions I was asked this morning in my interview was, "What's so special about Ellsworth?" The first thing that came to my mind was our downtown. Our city is a city, but feels like a community. That is because of our Main Street. On our Main Street is our community theatre and our mixed use of new residences and businesses. We find that that is the key to our community success, our downtown. Seeing that firsthand, being a downtown merchant myself, my business is just off Main Street, and getting a sense for that every day as people walk their dogs and we have a community that is striving to be a healthier community. That is something worth investing in. Through this program I've seen firsthand what it has done in communities around the state and also with our community. The return on investment is really quite good. It's one of the programs that has a tremendous return on investment. That's why you can count on my support. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Tuttle.

Senator **TUTTLE:** Thank you Mr. President. Members of the Senate, I'll be brief. I've been very active in my community with this program over the years. It's really been a tremendous plus for us. We can all remember urban renewal of the 1960's. I always called it urban removal. We've learned that we have to invest in our downtowns and not just investing on the out skirts. We've seen the same thing happen in Augusta, my community, and other communities around the state. I think as long as we have a good strong downtown that's the best thing for business. Thank you, Mr. President.
