Senator **MILLETT:** Thank you Mr. President. Members of the Senate, today I rise to recognize a man who has faithfully served the community of Scarborough since 1985. Joseph Giacomantonio retired from the Scarborough Police Department this April after spending 28 years on the force. During those years he made many contributions to the community. He and his

partner, Bandit, were certified as a canine team and worked together to find missing people and track down suspects for five years. He organized Scarborough's first OUI roadblock. He conducted a successful bicycle helmet exchange program, where 200 helmets were given out to community members. He secured grant financing to improve staffing at the department. He was awarded commendation for rescuing a local resident during a house fire. He served as the department's military surplus coordinator, which helped the department save precious funds. He started the Police Explorers Program and the Volunteers in Police Services Program. He also dedicated much of his career and time to the children of the community and state. He became the D.A.R.E. Program State Coordinator in 2002. As you know, the D.A.R.E. Program educates our children about the dangers of drug and alcohol use and teaches them ways to stand up to peer pressure and gives them the skills they need to avoid involvement in drugs, gangs, and violence. He also was involved with Camp Postcard, or Police Officers Striving to Create and Reinforce Dreams, which is a free week-long summer camp in Poland, Maine for 5<sup>th</sup> and 6<sup>th</sup> graders. The camp aims to help our youth build healthy relationships, learn life skills, reduce school dropout rates, improve literacy, and brighten the future of each camper. Clearly, he has made significant contributions to his police department, his community, and the state of Maine. Although he is now retired, he has not stopped serving. He will be deployed any day to Bagdad, Iraq, where he will partner with another canine. This time he will be handling a bomb detecting canine at the Embassy. We wish to thank him for his continued sacrifice in order to serve and protect his fellow Americans. We wish Officer Giacomantonio the very best as he embarks on this next journey and pray for his safe return upon its completion. Thank you.

Senator **CRAVEN:** Thank you Mr. President. Men and women of the Senate, I just wanted to say a few words about what this bill does. The purpose of the bill is to restore contracts with the Resource Development Centers that provide professional and development services to licensed and registered childcare providers and referral services to parents in need of childcare. These services were in place and have been funded with federal block grants. They moved into the Department of Health and Human Services and were delivered through the training under the Maine Roads to Quality. Later they were RFP out into the community and are now being delivered through the department at the USM and also some classes available on-line. This bill is a wonderful early childhood education bill that provides services to

families in order to find adequate local care providers, but also provides excellent training for childcare providers. So far the classes have been cut dramatically. The quality of the classes were cut or very specific, some college level classes offered as opposed to practical childcare provision classes being offered through the Resource Centers. I would ask for your support in making sure that our childcare providers and our families have quality services in their lives. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Oxford, Senator Hamper.

Senator **HAMPER:** Thank you Mr. President. Ladies and gentlemen of the Senate, this L.D. 752 is a question between bricks and mortar or the internet. We are providing the same services with no testimony given in the committee as far as reduction in quality, providing the same services through USM for \$127,000 versus \$1.3 million a year. You make the financial choice, ladies and gentlemen of the Senate. Thank you, Mr. President.

Senator **CRAVEN:** Thank you Mr. President. Men and women of the Senate, this is, again, an early childhood support bill. It's more technical than it is anything else. Often, when the department makes a mistake, for example, of checking the eligibility of families who receive vouchers for their childcare, they are immediately cut off and are not given an opportunity to make sure that they can appeal the findings. This bill would require the department to continue paying the subsidy while they were looking to see if the person continues to be eligible, especially if a person is working and they did not have another adult in the house to care for the child while they were working. It has caused people to lose their jobs because they didn't have the childcare subsidy. This is a very very small change. Often the department has to retroactively pay anyways. In order to support people in their work, I would ask you to vote in favor of this change. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Oxford, Senator Hamper.

Senator **HAMPER:** Thank you Mr. President. There seems to be a little bit of duel this morning, Mr. President. Ladies and gentlemen of the Senate, L.D. 828 would remove deadlines that are statutory or in rules with the department at this time. When a family is going to be losing the childcare subsidy the department notifies the family in three different ways and three different deadlines are extended, plus the department has the ability to give a little extra time on top of that. This bill, as it is written, would be the Majority Report and removes all deadlines and makes things quite indefinite. Thank you, Mr. President.

This is legislation, Mr. President, that was addressed in the prior session and I believe that it was clear in the discussion that it's a matter of fairness to come before you today with this report clearly divided because there were some members who felt that we had had adequate opportunity to

address this previously. I ask the members of the Body to follow my light and reject this report. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Oxford, Senator Patrick.

Senator **PATRICK:** Thank you Mr. President. Ladies and gentlemen of the Senate, colleagues and friends, vacation pay, under Maine law, is treated as wages earned. These wages are earned prior to a worker being laid off. Vacation pay is pay that workers earn before getting laid off and people have already earned their vacation pay. It belongs to them. These prior earnings should not delay their jobless benefits. It is arbitrarily unfair and, I think, discriminatory in some respects that laid off workers are treated differently depending on whether they used their vacation or not. Can you imagine two people who work together. One likes to ice fish and he takes three weeks of vacation every winter and uses his vacation then. The other one works every day of the year and saves his vacations and accumulates his vacation time. Let say he's probably accumulated about eight weeks. If both people get laid off, under current law, one worker can collect unemployment one week after his waiting period. The other wouldn't be able to collect his wages until four weeks after his waiting period. In my plant this actually happened to me. My coworker took his vacation. We both are senior employees. He takes his pay January 1<sup>st</sup>, or January 2<sup>nd</sup> actually because it's a holiday January 1<sup>st</sup>, and takes it to have the money to put in a bank and see if he can earn .75% to .5% so when he does go on vacation he'll have that little extra. People like myself like to wait and make sure that I have it if I have an opportunity to spend three or four weeks later on after vacation season is over. If we both get laid off I take a pounding and he's off scot-free. To me, it just doesn't make any sense.

People who get laid off are in a tough spot. Many of them face the very challenging task of surviving on unemployment insurance. The average weekly benefit in Maine is just a little bit more than \$270 a week, before taxes. Laid off workers know this is likely not enough to pay all their bills, just as they know that if they have banked vacation time built up that is not enough to pay the bills for very long. Laid off workers are looking for the security of an unemployment check when they are laid off they can maintain an economic baseline while they get back on their feet. We shouldn't be delaying that unemployment benefit for people. We did take this bill up two years ago. The idea of what they were trying to do before is to make sure that all weeks were covered so that you'd have to lose your whole vacation. I actually earned my vacations for 2013 in 2012. Monies I've already earned. If I get laid off in 2013 I'm going to have to use two of my weeks of vacation to pay off my unemployment so I can extend my unemployment later on down the road. If you are going to get 26 weeks unemployment you are going to get 26 weeks unemployment whether or not you are forced to take your vacation or not. To me, it just doesn't make any sense, Mr. President, that we would penalize one and not the other. I would ask you to support the motion of the Ought to Pass as Amended. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Cushing.

Senator **CUSHING:** Thank you Mr. President. Ladies and gentlemen of the Senate, I rise today in opposition to the Minority Report of a committee action that I believe was a considerable vote in favor of this motion. This leaves Maine as an outlier again. There is a packet on your desk that was provided that may be of interest to the members. Our state is one of only a handful

that still presents the issue to the Legislature for decision. I think in today's society more and more people are expecting transparency in their government. What I am simply asking for in your consideration is to not support the Minority Report and accept a 9-3 Majority Report that would allow this matter to go before the voters so that they could determine if they feel it's time for Maine to join many of our colleagues, 85% of other states, in having public elections for their Constitutional Officers. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Kennebec, Senator Lachowicz.

Senator **LACHOWICZ:** Thank you Mr. President. Men and women of the Senate, I did push for the Minority Report. This is something I changed my mind about primarily because this is a Constitutional Amendment. It's a really big deal. I have to say in all the talking I had with people in my district not once did I hear anyone bring up that this was something that needed to be changed. I heard a lot of other things that people want to change, but that's not what's before me at this moment. I also talked to a man fairly recently who came down here. I had never met him. He was a constituent of mine. He came up to me and he whispered to me, "You talk about a lot of things in here that I don't think we need to be talking about. You make a lot of laws. Maybe we don't need them." I thought maybe he was right. Maybe he was right. This guy who just came down from Clinton one day just to see what it is we do here, just to see what it is I do here, thought that maybe we talk about a lot of stuff that doesn't have a lot of bearing in what his life is like every day. A Constitutional Amendment is a big deal. I keep hearing about people who want them, but this has never been the one that I've heard. I urge you to support the Minority Ought Not to Pass Report. Thank you very much.

**THE PRESIDENT:** The Chair recognizes the Senator from Arrostook, Senator Sherman.

Senator **SHERMAN:** Thank you Mr. President. Ladies and gentlemen of the Senate, I rise in opposition to this motion. I had a bill in that dealt with one-third of this popular election. I had a bill in on the Attorney General. I had folks take a look at why we should do that. My rational before the committee, when my bill went before the committee, was that Attorney General needs to know his or her stuff, so to speak. I've been here with all the elected Attorney Generals. Some, frankly maybe didn't know their stuff. I'm not casting aspersions on any of those folks. The other issue when I put mine in was that we are one of the few states that don't have a Lieutenant Governor. If I had my druthers I'd have a Lieutenant Governor. We have people always in waiting that haven't had any statewide experience. The whole point of putting this bill, and particularly my bill, before the people is that they would have to go out and campaign from one end of the state to the other. We don't have anyone waiting now, running for these offices. We've got the Governorship. I think we need an assistant there or someone who has at least gone statewide. I'm a little surprised that people wouldn't be interested in that, but I understand some of the realities of life around here. Someone asked me whether I had it in for a particular person. The present Attorney General's name came up. I served with her on Judiciary. Great lady. Had nothing to do with her. I know that was kind of a rumor at times. She and I get along. She has a

certain way about her, as we all know, so we get along in her parameters, so to speak. I would ask you to oppose the motion and put this out to the vote of the people so we can be in tune with the other 40 something states that do this statewide.

On motion by Senator **KATZ** of Kennebec, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Collins.

Senator **COLLINS:** Thank you Mr. President. Ladies and gentlemen of the Senate, when this bill came before the State and Local Committee, which I'm a member obviously, it was a very strong vote. I believe the committee vote was 10-2 in favor of this action. It came up during the committee proceedings and public hearing that a lot of folks back home, when the committee members were discussing it, that they were surprised, the folks back home were surprised, to find out that we do, in fact, we as the Maine Legislature, elect the Secretary of State, Attorney General, and State Treasurer. They were surprised at that. As time evolved with my many terms here in the Maine Legislature, I'm still astonished at the number of people who still think that this is wrong and that we should be having these folks elected based upon their job qualifications, their ability to do the job, and not just as a simple political favor. These are very important positions. They should be elected. I would strongly suggest to everybody in this Chamber today to vote against the pending motion. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, Senator Jackson.

Senator **JACKSON:** Thank you Mr. President. Ladies and gentlemen of the Senate, I'll try to be brief. I haven't supported this in the past and I won't be today. We may be an outlier but I actually like the way the state does it. It's been done like that for as long as I know and probably as long as the Constitution of Maine has been drafted. Quite honestly, I don't think that having high priced elections actually always get you the best person either. I think that both sides of the aisle can say that people get vetted. There are numerous candidates that come up for these positions. People do get vetted. Probably it doesn't get done by everyone in the Legislature, but it certainly does get vetted. I think that in my time we've had good candidates that definitely had the background and the knowledge to do the position. I certainly didn't agree with decisions that I think all of them made at some time or another. Unfortunately, not everyone thinks like me. I just don't like the idea that this is going to get to be a high priced election, that the people that have the most amount of money are probably going to be the ones that get out and are seen more than the other ones. I'm for this motion and I will be supporting it. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Cushing.

Senator **CUSHING:** Thank you Mr. President. I appreciate your forbearance in allowing me to rise again to speak on this issue. I think there were some very important points that were raised in the discussion here as to why opposing the current motion before

is valid. This is an opportunity, Mr. President, to ask the people of the state of Maine if they think it is time for us to follow our colleagues in over 85% of the other states in giving the citizens an opportunity to speak on this issue. I think if we were concerned about the issue related to spending on elections, and that was how it was accomplished, we might have a different individual sitting in the second floor chair and we might have had different nominees for the recent elections for the Executive Branch. To my understanding, Mr. President, this issue before us today, the Minority Report, does not truly reflect the good work of the committee and I would respectfully ask the clerk to read the report before you call the roll. Thank you, Mr. President.

At the request of Senator **CUSHING** of Penobscot, Reports **READ.**

**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, Senator Sherman.

Senator **SHERMAN:** Thank you Mr. President. I won't prolong this. Just two comments. The first one is, in reference to my comments. To my good friend from Allagash, who I've learned to have a great respect for, who is leading the Ag Committee now, the two comments are that we're now in a more complicated world. When you talk about going back to the nostalgia times, we're in a more complicated world. Just think of the number of lawsuits that have been involved with the Attorney General involved. That's point number one. It's rather complicated. Number two, if we went back to the past, if I remember it correctly, I was actually doing other work other than here. They didn't used to have a second session in this house. Years ago something called the Executive Council. If you wanted to make adjustments to the budget we could let the Executive Council come back and do that. We wouldn't have to come back here in January. Thank you very much.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Haskell.

Senator **HASKELL:** Thank you very much Mr. President. Colleagues of the Senate, I was a candidate for a Constitutional Office. I don't know how many of the folks here ever were, but I thought I'd give that a shot at one point in time. I was not successful, obviously. I want you to think about what it would have been like for somebody to have been attempting to become one of the Constitutional Officers and exactly what that path is. I did it because I truly thought I would be in a good position to be able to manage that and I thought that it would be a service to my community and to my state. I am concerned here when the good Senator from York mentioned the fact that people were surprised that we were not popularly elected to become a Constitutional Officer. I think the reason that people are surprised by that is we have not had a problem. We have not had a problem with the folks who have been serving in our Constitutional Offices. Did we disagree ever with what any of them did? Perhaps, but it just has not made the news. It has not been an issue around the state about who are our Constitutional Officers. What if I was deciding that I wanted to run for higher office, let's say I had ambitions to sit on a different floor than I am now? I could think of no better way to find out how my polling would be than if I set out to run for Constitutional Office. Whether or not I was qualified might be secondary in my thinking. Perhaps I'd just like to see how I'd poll,

how an election would go. That, frankly, is my concern about electing our Constitutional Officers. I'm going to be supporting this Minority Report. I think, indeed, here what we have is a solution looking for a problem, which we do not have. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Cain.

Senator **CAIN:** Thank you Mr. President. Men and women of the Senate, I rise in support of the Minority Ought Not to Pass because I do agree that this is a solution in search of a problem. I also don't buy into the fact that we need more statewide races to make politics in Maine better. Maine politics are pretty great because you can go from being a millworker to a Congressman. You can go from being a teacher to being the State Treasurer. You can go from being a Mayor to being the Chief Executive. You don't have to run time and time and time and time again at the statewide level in order to make a difference, to take that leap, and to be a leader for the state of Maine. We don't need more statewide elections with lots more campaign finance to improve Maine politics. Right now, because of Maine, because of the way we are, because of communities that we live in, we're elected because we reach out. We're elected because we make a difference, because we are leaders. To add more statewide elections when we're already seeing the statewide elections we have in place grow and multiply and grow and multiply time and time again will only put us closer to states that we mock, who have lots of statewide contested elections that get very nasty. I think right now we don't have a problem. I think the officers we have in place are goods and the ones we've had in the past are good. We don't have a problem that needs fixing. Most of all, I don't want to change the nature of Maine politics. You can go from being, well there are so many of us and we do so many things, a small business owner and you can become the State Auditor. You can become the Attorney General after being a defense attorney or working anywhere in the state of Maine. You have a lot of opportunities in front of you and good people end up in these positions. We don't need to fix this problem that we don't have. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Collins.

Senator **COLLINS:** Thank you Mr. President. Ladies and gentlemen of the Senate, what are we afraid of? Let's put this out to the voters for these three Constitutional Officers. Let the best qualified person win the election with all the confidence of the people of Maine behind their election. We all go through elections here in the Maine Legislature. Usually the best person wins. I think the same should be applied to the Constitutional Officers. Very important positions here in state government. Sometimes I equate state government and the Maine Legislature to my business background. I was a food broker years ago. I always surrounded myself with the best and brightest I could afford. They always made me look good. I think we should do the same thing with our Constitutional Officers. We should be electing the best qualified person, man or woman, to hold those positions, to help us here in the state of Maine, and guide us on the right path. These Constitutional Officers are vitally important to the progress of Maine and the economy of Maine. They could bring to the table a lot more than I think what is present today and what I've witnessed in past sessions. Ladies and gentlemen, I

repeat my first appeal. Vote against the pending motion. Thank you.

**THE PRESIDENT:** The Senator from Aroostook, Senator Sherman, requests unanimous consent of the Senate to address the Senate a third time on this matter. Hearing no objection, the Senator may proceed.

Senator **SHERMAN:** Thank you Mr. President. I am asking for a point of information, if I may. I'm struck by the good Senator from Penobscot with the list of people who run here and there. I could make an inquiry about that, but I won't. Does anyone have a list of Attorney Generals that were Republican when there was a Democrat majority? It would seem to me that when the Democrats get majority or Republicans get majority that becomes a Republican Attorney General. It has never been a cross pollination, so to speak. That's an interesting dilemma that you have to deal with.

**THE PRESIDENT:** The Senator from Aroostook, Senator Sherman poses a question through the Chair to anyone who may wish to answer. The Chair recognizes the Senator from Penobscot, Senator Cain.

Senator **CAIN:** Thank you Mr. President. I believe there is at least one example in recent history where the longest serving Attorney General in the state of Maine, James Tierney, served for approximately a decade and overlapped with Governors of different parties. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Tuttle.

Senator **TUTTLE:** Thank you Mr. President. I think there was also a Secretary of State by the name of Rodney Quinn that was also in that situation.

**THE PRESIDENT:** The pending question before the Senate is the motion by the Senator from Kennebec, Senator Lachowicz to Accept the Minority Ought Not to Pass Report. A Roll Call has been ordered. Is the Senate ready for the question?

Senator **LANGLEY:** Thank you Mr. President. Men and women of the Senate, just a brief introduction to this bill. I would urge you to oppose it. This bill just would include a statement at the polls. It would require, in the already required listing, that it would indicate the percentage of increase or decrease in the school budget over the previous year just as a point of information for voters. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Millett.

Senator **MILLETT:** Thank you Mr. President. Members of the Senate, the Majority Ought Not to Pass is a bipartisan report. The reasons this include testimony from the Maine Town and City Clerk's Association citing concerns with lack of adequate time to print absentee ballots with specific budget information. Under 20A MRSA 1486, 3C, "Absentee ballots must be delivered to the municipal clerk no later than a day after the date of the regional school unit budget meeting." Many local school budget meetings finish late in the evening and printing overnight would be challenging, to say the least. The Maine Municipal Association testified with similar concerns and added that it is their belief that

the printed ballot question should be as content neutral as possible. Thus, if the change between the current year and the prior year budget must be embedded in the budget question, as this bill and the Minority Amendment would require, the information explaining the variance would need to similarly be reported. That could be problematic and cumbersome. A great deal of testimony was provided by supporters, presenting low turn-out figures for local referendums. This bill does nothing to address voter turn-out. The committee also heard testimony about concerns regarding the posting of ballot information in polling locations. The committee asked the Maine Town and City Clerk's Association to survey its members about the posting of printed information at polling places. The results did not reflect any serious systemic problems and the committee felt that the survey process served to remind the state's clerks about the importance of posting materials in accessible and prominent locations. As such, and given the testimony, the bipartisan majority vote was Ought Not to Pass. I urge you to support the Majority Report. Thank you.

Senator **LANGLEY:** Thank you Mr. President. Men and women of the Senate, I rise to oppose the pending motion. We have a Charter Commission in place, tasked to review all of the RFPs for incoming charter schools. They have done a really tremendous job up to this point. They follow a stringent set of guidelines. They have denied more than they have let in. I believe we should let the commission do its work before we try to micromanage the process. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Millett.

Senator **MILLETT:** Thank you Mr. President. Members of the Senate, the 125<sup>th</sup> Legislature wisely introduced charter schools into Maine in a cautious and reasonable fashion by instituting a cap of ten schools in ten years. This allows the Charter Commission to be careful and approve only those applications that reflect a strong curriculum that fits the needs of Maine students. The law, however, while requiring applicants to be nonprofit, allows these applicants to contract with for-profit educational service providers, or ESPs, to run the schools. This is not in the best interest of our children. Nationally the performance of these ESPs has been poor, to say the least. Ohio, Georgia, Florida, Oregon, and California, all states that allow for-profit charter schools have filed lawsuits against these corporations for a wide range of misconduct. Worse yet, they have done a dismal job of educating students. A 2012 National Education Policy Center study found that only 48% of the for-profit charter schools met federal yearly progress standards while 56% of nonprofit charter schools met the benchmarks. John Morley in the *Yale Law Journal* writes that nonprofits minimize the unusually high agency costs that characterize the relationship between charter operators, parents, regulators, and donors, whereas for-profits only survive through economies of scale which we all understand is not suited to deal with the intricacies of student learning.

Make no mistake, for-profit charter schools is a booming business. Hedge fund managers and Wall Street banks have

both discovered "windfall profits" as a result of the 39% new markets tax credit created by the American Recovery and Investment Tax Act of 2009 to fund new charter school construction. According to a report in 2010 a lender who uses it can double its money in seven years. Imagine Schools, one of the nation's charter school management companies, is notable not as much for its academic results as for its real estate plays. After receiving approval to open up schools in a state its real estate company will buy a campus and has the school pay rent. When the school pays rent the real estate company sells the campus to a real estate investment trust, which then leases the campus back to the school. The school eventually sends rent payments to two companies, sometimes as high as 40% of the publically funded budget, which leaves the school struggling to pay for things like textbooks. Meanwhile, the tiered lease system offers a 10% return on investment for owners and investors of the companies. This bill will make sure that decisions made by charter school operators are made in the best interest of the students. This bill eliminates the drive to reduce educational programs to their least common denominator and, thus, achieve economies of scale. This bill will prevent predators from using public funds to profit on real estate tricks in Maine. This bill will assure that the focus is where it should be, on educating our students. I urge you to support the Majority Report.

**THE PRESIDENT:** The Chair recognizes the Senator from Sagadahoc, Senator Goodall.

Senator **GOODALL:** Thank you Mr. President. Men and women of the Senate, I rise today because I just think this is one of those issues that is so important and often one that probably isn't necessarily anticipated by many of our constituents back home. One would just assume that the education of our young, our children, is done in a non-profit public way. Entities that are private, and they should be, are run for the return to the investor, for the shareholder. We have seen great success in our economy in our country ever since the founding due to capitalism. At times the country has been very consistent that there are some things that should stay outside the realm of for-profit entities. In my opinion, and I think many people's opinions, I believe the residents of Maine would say strongly that they believe that we ought to be focusing every dollar, every single dollar, on our children, on their education, and none of those dollars, not one, should be sent to someone in terms of their bottom line for profit. It's a real clear decision. Are we going to be investing every single dollar, every single public dollar, into public education and into children or, no matter how you slice and dice it, some of our public dollars will be sent to the bottom line to returns on shareholders investments? That's what we're voting on, folks. I would encourage you to support the Majority Ought to Pass Report.

**THE PRESIDENT:** The Chair recognizes the Senator from Lincoln, Senator Johnson.

Senator **JOHNSON:** Thank you Mr. President. Ladies and gentlemen of the Senate, to me, and I know to many of my constituents, education is the most important service we provide in the state for the future of the state of Maine and for our children as they become young adults. As far as I'm concerned, the only return on investment we should be getting out of our school system is what they gain in education, what they gain in skills to

be effective adults, to be good citizens, and to move this state forward. By no means should we be allowing someone to profit at the expense of the quality and the capability of the education system that we put public dollars into. The beneficiaries should be our children. Thank you.

Senator **LANGLEY:** Thank you Mr. President. Men and women of the Senate, I rise in opposition to this bill. In essence, it really isn't needed at this time. It seeks to amend legislation that really hasn't been fully implemented yet. Teacher effectiveness rules and legislation potentially creates a conflict with the state getting an ESA waiver. Lastly, the Educator Effectiveness Council will be making recommendations to the Education Committee regarding the teacher programs that are in higher institutions of education. At this time this piece of legislation is just not needed. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Millett.

Senator **MILLETT:** Thank you Mr. President. Ladies and gentlemen of the Senate, the 125<sup>th</sup> Legislature enacted L.D. 1376, An Act to Ensure Effective Teaching and School Leadership, which establishes state guidelines for teacher and principal evaluation. Everyone agrees that more effective teaching and school leadership is in Maine the better learning experience our children will have in school. The law further directs the Commissioner of Education to calculate the amount of funds available to assist districts with developing and implementing the systems. Setting guidelines for evaluations will do little good if districts do not have the resources to implement them or could even do harm if schools must forego investments in books, technology, or teacher development programs in order to implement these guidelines. In understanding this challenge, but also our state's current fiscal status, the bill presently before us, L.D. 1144, An Act to Further Ensure Effective Teaching and School Leadership, simply states that should funds become available grants will be made to each school administrative unit equal to one tenth of one percent of the school administrative unit's total cost of education, thus ensuring consistency across school districts as this initiative is undertaken across Maine. This Body will be receiving a Majority Report from the Education and Cultural Affairs Committee in regards to implementing this initiative.

Finally, the bill requires appropriate qualifications in training protocols to ensure school administrative units employ qualified evaluators to implement performance evaluations and professional growth plans. It is basic common sense to make sure that evaluators have been trained in the particular model that the school administrative unit is employing to ensure meaningful

and accurate assessments of teacher performance and create consistency between evaluators themselves. An evaluation system lacks credibility if the reviewers are utilizing different benchmarks to arrive at different scores. L.D. 1144 seeks to strengthen the legislation passed in the 125<sup>th</sup> and to strengthen Maine's teacher effectiveness and school leadership. I urge you to unanimously support this bill. Thank you.

Senator **JOHNSON:** Thank you Mr. President. Ladies and gentlemen, I rise to reinforce one of the things that the good Senator before me stated about the rating of teachers and the systems whereby that is done. Tony Wagner, in writing about education and what was working and what wasn't in terms of introducing stronger education and more effective systems that would be put into place, ended up including, and I simplify somewhat because it's a whole book, that his major point was that the best way to improve education was to improve the skills of the teaching staff and what was most important in doing that is that you have a consistent and trustworthy evaluative process. You need that inter-rater reliability. You've got to have the faith of the teaching staff, that what they are being told for skills assessment is accurate, is fair, and identifies well what skills most need improving in the school. That's the way that we're going to improve education. Frankly, this is a bill which addresses exactly what we need to do in the state of Maine to improve education. I hope you will support the pending motion.

Senator **PLUMMER:** Thank you Mr. President. Men and women of the Senate, I rise to oppose the Indefinite Postponement of House Amendment "A". House Amendment "A" allows the rightful owners of a firearm that has been used in the commission of certain crimes to exercise their right to ownership of that firearm. I believe I was the sponsor of the bill initially for the State Police. As I looked into it, I discovered that firearms, even very valuable firearms, \$5,000 or \$10,000 firearms, would, in fact, be required to be destroyed under the initial bill. The House Amendment that we're debating would correct that situation and allow the estate, if they want to, to register their claim for that firearm. If, in fact, the firearm was used in a suicide or a murder they could then request that the State Police keep it, they don't want to see it, and it could be destroyed. I believe that people

who own the firearm, or have rightful ownership to that firearm, should, in fact, be able to determine its final outcome. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Gerzofsky.

Senator **GERZOFSKY:** Thank you Mr. President. Ladies and gentlemen of the Senate, we've had this issue in front of the committee several times. The victims have always come in and talked to us. Handguns get destroyed now. Rifles get auctioned off. This bill would correct that. Nobody, and I mean nobody, should keep the weapon that somebody else used to murder somebody. That weapon should be destroyed for the victim's sake, for the families of the victims, and for the people that are so impacted by this atrocious crime. I see no earthly reason why you wouldn't want to do that. Currently, if the gun is stolen from you and used in a crime, you have the opportunity to retrieve your property. If it was your gun, and you was killed or committed suicide, that gun shouldn't go to your estate. That gun should be destroyed. I would hope that people on both sides of the aisle would take the side of victims, the people that are most impacted by this. The people that are going to live with it for the rest of their lives should know that tool that was used to take their family member's life is going to be destroyed. It's not going to be put on a wall. This was the gun that did such a crime. This gun should be destroyed. It was a bad tool. Thank you, Mr. President.

Senator **PATRICK:** Thank you very much Mr. President. Ladies and gentlemen of the Senate, L.D. 1259 is a Resolve and this Resolve provides for the legislative review of portions of Chapter 17, Rules Regarding Proof of Ownership and Recruitment by Employers Employing Foreign Laborers to Operate Logging Equipment. It's a major substantive rule of the Department of Labor. The amendment, which is the Majority Report of the Joint Standing Committee on Labor, Commerce, Research and Economic Development, makes the authorization of the proposed major substantive rule condition on changes made to the rule to clarify that a foreign laborer may use only one type of equipment, for an employer to provide that a foreign laborer may not own any equipment used in the course of the employment directly or indirectly except as to equipment for which there is a prevailing rate established by the United States Department of Labor and to require that a penalty be assessed against the employer of that foreign laborer for a violation of this requirement with the potential prohibition against the employers employing foreign laborers for two years. These changes are intended to improve consistency with federal requirements and to address issues of fraud. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, Senator Jackson.

Senator **JACKSON:** Thank you Mr. President. Ladies and gentlemen of the Senate, I want to rise to put a couple of comments on the record. I passed out a three page document. It's actually a Maine Department of Labor, Bureau of Labor, standard proof of ownership form. It came right out of the

Department of Labor. For this proof of ownership form, it's Jean-Guy Robichaud & Fils Inc. That's a current company that's incorporated in United States, here in Maine. They are asking for the bonded workers to come and run their equipment. If you look on the front of this, Mrs. Robichaud is the President and she is signing the paperwork for this company. On the third page of the document you will see that Jonathan Robichaud, who I am quite sure is Mrs. Robichaud's son, is one of the workers that she's asking to come and run her equipment. What's really striking and unfortunate, and quite possibly fraudulent, about the whole document, is the third worker on there is Jean-Guy Robichaud, who is the owner of Jean-Guy Robichaud & Fils Inc. Mr. Robichaud is incorporated in Maine to bring his equipment into Maine and turning around and hiring himself to run his equipment, which I am sure was not the intent of the H2 Bonded Labor Program. I'm also quite sure that it's not something I certainly want to see, people bringing in their own equipment to do jobs that U.S. contractors are not having the opportunity to do. That's what the amendment does. It makes, I think, consistent with the federal law, that we're asking for workers, not businesses, to come to Maine. I think that all of us here, again being representatives of the people of the state of Maine, want to make sure that Maine businesses are taken care of over Canadian businesses. Thank you very much, ladies and gentlemen of the Senate.

The federal government requires that states must cover all FDA approved prescription drugs of manufacturers that have entered into a rebate agreement with the federal government. States can impose restrictions, including prior authorization, and exclude certain drugs, but no provision allows the states to exclude Suboxone or Methadone or even apply a hard cap. The U.S. District Court for Maine ruled that Maine may not exclude coverage for Methadone in its Medicaid plan. If this bill gets passed we are not in compliance with federal law. Thank you, Mr. President.
