Senator **JOHNSON**: Thank you Mr. President. Ladies and gentlemen of the Senate, I just wanted to explain briefly why this bill is so important and all the work that went into it. As you can see, all but a couple of members of the committee believed that we should do this and do so with the license surcharges that are in the Majority Report. I would point out every single member of the committee believed that we should move forward with this marketing plan. They just didn't all entirely agree on the amounts. I also want to point out that this is in response to the concerns in the industry about the boat price of lobsters, the difficulty that we

have had recently with early shedders, and the impact that's had on the market affecting the price that harvesters get for their hard work. We feel strongly, as a committee, that this is going to help the industry. I know the Administration agrees and this has the wholehearted support of the department as well. For those who may not be entirely convinced still in the industry, this is the right thing to do. I want to point out a couple of things. In meetings the Lobster Advisory Council frequently voiced that the worse thing we could do, given that this may happen again and it looks this year like it will again, is do nothing. This is the most reasonable and measured response that we, the department, and people in the industry could come up with to help with the price of lobsters. at the boats, by driving demand for Maine lobster. Even being convinced that that is the case, we took a conservative approach and this program's licenses surcharges are only authorized through 2018 and that there will be a report with a third party audit at that time of the effectiveness of the program and actions of the Maine lobster marketing collaborative in using those funds to generically market Maine lobster, as has been very successful in other industries such as marketing Maine blueberries. I wholeheartedly support this Majority Report and I hope you do too for the sake of our lobster industry. Thank you.

On motion by Senator **KATZ** of Kennebec, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Plummer.

Senator **PLUMMER**: Thank you Mr. President. Men and women of the Senate, I was a bit surprised when I saw the report on this bill because when we left committee, and I should say that this was a time when I was trying to be very diligent about taking notes and I had recorded the vote, the members who sat through the public hearing and the work session voted 7-1 Ought Not to Pass on this bill. I was surprised that other members had come in later and signed on to the Ought to Pass. There are good reasons not to adopt this bill. This bill puts in statute specific amounts of time that someone who has abused an animal could not own an animal. No one in our committee argued that people who abuse animals should then have a right to own more animals. The point was; is it wise to put into statute the specific amount of time that a person could not own an animal? I have

learned many things from the good Senate Chair of the Criminal Justice Committee, Senator Gerzofsky from Cumberland. I have learned about driving the bus or riding on the bus. Another thing that I've heard many, many, many times, dozens of times, is we should let the judges judge. That's never more true than in this case because every case is an individual case and it varies. There are some times that the judge should say, "You've lost your right. You never should own another animal." We take the ability of the judge to judge away.

The other big problem that many of us had with this is by passing this bill the Criminal Justice Committee is telling the Commissioner of Agriculture, Conservation, and Forestry to take on some more duties; the duties of reviewing each case if somebody appeals that they should not be able to own an animal for five years because they've been cured of their problem and it'll never happen again. It also requires, or authorizes, the Commissioner to come up with a fee structure for those appeals.

In the past there have been bills passed through other committees that have required the Criminal Justice Committee to do things and the Criminal Justice Committee has objected to that. We were successful this year in getting put into rule that if you are going to vote favorably for a bill that affects the criminal justice system that, in fact, it goes on a criminal justice table and we get to review it.

At the point I left, I thought we were pretty much in agreement that we shouldn't be telling another committee or commissioner what to do. I was a bit surprised to see that people came in and signed onto the Minority Report. Animal abuse is a very very serious problem and concern, but putting into statutes specific amounts of time and requiring that another commissioner take on additional duties is not the answer to this problem. We should let the judge decide every individual case because the judge has that authority right now and say, "Okay, I can see that this happened for a certain reason and we'll take your rights away for six months, or six years, or forever." This bill would take the authority of the judges to judge away from them. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Gerzofsky.

Senator GERZOFSKY: Thank you Mr. President. Ladies and gentlemen of the Senate, I have often said let judges judge in committee. I stand by that. After a judge has judged you, convicted you of animal abuse more than once, and the person doesn't seem to get it and we keep on watching them on our TV screens and reading in our newspapers that those same people are convicted of multiple charges on puppy mills and those sort of things, abusing animals, going to court, being convicted and told you can't have animals, and then going out and doing it anyways because now it's only a breach of court or that kind of stuff. I wanted to put some teeth behind the judge's decision. When a judge convicts you multiple times and you still get caught abusing or mistreating animals in some of the most egregious ways, things that turn all our stomachs, people that get so upset that they get in touch with us about it, it's about time we do something to give the judge the tools to be able to stop this from happening.

We've got to remember that we've debated animal cruelty in this Chamber in the past. We talked about animal fighting, which we don't condone and we have serious consequences if you put on dog fighting shows. We had a bill in here, that we had quite a bit of debate, about dog fighting paraphernalia. We have

consistently said that we are the stewards of those four legged little furry friends of ours, Mr. President, that can't defend themselves. When you have people that want to continually go out and break that law, and find no real consequences, I think it's time we put some consequences into the judge's decision. I do want to say let judges judge. I do want the judge to be able to enforce his verdicts. I do want to see that we're going to hold people accountable and nobody that has abused animals multiple times should ever, in my book, have the opportunity or the privilege to have animals. The courts are only going to tell them on a Class B that they don't have an animal for five years, but on a Class C it's going to be 15 years. With both of those convictions the person can go back in front of the court and try to get away. We asked the Commissioner to, on those rare occasions, because we don't have a lot of these, be able to look at those cases and see if there are any extenuating circumstances, see if there's a way to get this person back. Maybe this person just needed a lot of education. I, personally, don't think so because I think after you've been convicted of it a couple of times you know what you're doing wrong.

Yes, let judges judge, but let us give them the teeth, let us give them the tools, to be able to put the teeth into those laws that they are judging. Mr. President, I hope that the Body will remember that the person that abuses animals, it has been proven year after year and time after time and study after study, is going to be abusing people next. They are going to be abusing their kids next. They are going to be abusing their spouses next. This is where it starts and we have to put a stop to it because you can't come to Maine from away and find a nice rural place to go live, Mr. President, and to create these circumstances for helpless defenseless animals. We can't allow that in the state of Maine. Thank you very much, Mr. President and my friends on both sides of the aisle.

Senator TUTTLE: Thank you Mr. President. Members of the Senate, I hope that you would support this legislation. This was a request by the Commission on Governmental Ethics and Election Practices related to provisions that they thought needed substantial change. It imposes a maximum on the amount of Maine Clean Election Act funds candidate may spend after the election on post-election parties, advertising to thank supporters or voters, or thank you notes. Additionally, adopted changes in the Maine Clean Election Act funds could not be used for a thank you gift, something that they know at this time. Candidates may use personal funds for this purpose. This policy has been in effect through the Commission's guidelines but further needed to be amended in this bill. The winner of a primary election may not use Maine Clean Election funds for post-election parties to thank volunteers, but it may use Maine Clean Election funds on postelection advertising to thank voters or supporters. This is something that the Commission thought was necessary based upon information from the previous election. It's a good piece of legislation and I would encourage your support. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from Androscoggin, Senator Mason.

Senator MASON: Thank you Mr. President. Men and women of the Senate, this bill does not go far enough. The bill needs to include post-election parties for both primary and general elections. It does not do that. The Clean Election statute indicates that candidates can spend their own money on post-election parties. We feel that that is incredibly appropriate and that we need to go further with this, but we had other ways to deal with that but that report is not in front of us. I think that when we're accepting Clean Election money we need to make sure that it's being spent on the election, not on a party. Thank you, Mr. President.

Senator **DUTREMBLE**: Thank you Mr. President. I'd just like to read the summary, as we just heard some statements.
