Dear Honorable Members of the 126th Legislature:

Under the authority vested in me by Article IV, Part Third, Section 2 of the Constitution of the State of Maine, I hereby veto LD 386, "An Act To Reduce Tobacco-related Illness and Lower Health Care Costs in MaineCare."

This bill goes beyond the provisions of the federal Affordable Care Act, under which Maine already provides tobacco cessation coverage for MaineCare members, and precludes certain cost sharing, such as co-pay, for pregnant women. This bill would eliminate all forms of cost sharing for all MaineCare members. am supportive of MaineCare members taking steps to stop smoking; however I believe that cost sharing is an essential component of maintaining fiscal responsibility in our welfare programs as well as improving the success rate of welfare programs generally. Without a cost share component, this bill expands welfare unchecked and does nothing to move us in the direction of a sound fiscal house. This bill presents an opportunity to make clear that Maine lawmakers are ready and able to make tough choices on spending and entitlement programs, and I call on the legislature to find the courage to take that step.

For these reasons, I return LD 386 unsigned and vetoed. I strongly urge the Legislature to sustain it.

#### READ.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Woodbury.

Senator **WOODBURY**: Thank you Mr. President. Men and women of the Senate, I'm here to recognize the retirement of Judge David Kennedy from the Maine District Court. I've known and admired Judge Kennedy for close to 20 years and throughout his service as a judge. Frankly, it's impossible for me to imagine someone with a better temperament and compassionate good judgment to do this work, particularly in a family court. One of my regrets over the past few years is that I never visited the court to watch Judge Kennedy in action. I'm sure he was exceptional. I know he was exceptional. David is also known and loved by many in this building from his time as being Revisor of Statutes. I want thank Judge Kennedy for his many contributions to the state of Maine, congratulate him on his retirement, and wish him the very best in the future. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Kennebec, Senator Katz.

Senator KATZ: Thank you Mr. President. Men and women of the Senate, I have an advantage over my good friend, Senator Woodbury, in that I have seen Judge Kennedy in action on many occasions. He has had quite a career, as you can see by looking at the sentiment. He's a graduate of Holy Cross. He went to the best law school in the United States, Boston University School of Law. Apparently he didn't do very well because he went on to get some further training at Harvard Law School. When you look at his legal history; having been in private practice, served as the Director of Pine Tree Legal Assistance, and, as Senator Woodbury pointed out, in this building as Revisor of Statutes. Then he was part of the early wave of case management officers who were a new level of judicial officer to really deal with families in crisis, those going through divorce and other litigation. He did it with great aplomb. Since 2002 he has been a judge on the Maine District Court. I don't know how he found time, but he also was a faculty member at the Law School. As someone who sees thousands of lawyers in Maine, I really have a great admiration for his rich legal career, and particularly his work in the courtroom, where he hasn't always made the right decisions a few times, in my perspective. Other than that, he has shown real compassion, civility, and a big heart. I congratulate Judge Kennedy on his career, on his retirement from the bench, and I know that he'll continue to contribute to the legal system in Maine in other ways in the future. Thank you, Mr. President.

Senator **HASKELL**: Thank you very much Mr. President. I'd like to add my voice to those who have talked about Judge Kennedy.
