## JOINT RESOLUTION RECOGNIZING FEBRUARY AS 2-1-1 MAINE MONTH

WHEREAS, 2-1-1 Maine is a comprehensive statewide directory of over 8,000 health and human services available in the State; and

WHEREAS, in order to promote the 2-1-1 Maine health and human services and emergency preparedness hotline, which helps Maine citizens get access to needed resources, we recognize February 2014 as 2-1-1 Maine Month; and

WHEREAS, 2-1-1 Maine helps to identify existing gaps in health and human services; and

WHEREAS, throughout the State, 2-1-1 Maine provides aroundthe-clock service through efficient and effective responses to questions arising from the growing complexities and needs in health, socioeconomic and human services; and

WHEREAS, 2-1-1 Maine provides emergency operations during times of natural and other disasters, including providing accurate and timely information for preparations and longer-term referrals for follow-up services, and valuable information for community planning and for future matching of resources and unmet needs; and

WHEREAS, over the course of this winter's storms, 2-1-1 Maine assisted the Maine Emergency Management Agency and the United States Small Business Administration with data collection for Preliminary Damage Assessments in 4 counties in Maine in order to request Federal Emergency Management Agency emergency funding; and

WHEREAS, since 2006, 2-1-1 Maine call specialists have assisted with more than 508,000 requests to locate health and human services information; and

WHEREAS, 2-1-1 Maine handles a number of specialized services, including assisting the Maine Center for Disease Control and Prevention with H1N1 influenza calls and the gambling helpline, and is also a resource to find information about such needs as heating assistance and tax preparation; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-sixth Legislature now assembled in the Second Regular Session, on behalf of the people we represent, take this opportunity to recognize February 2014 as 2-1-1 Maine Month.

**THE PRESIDENT**: The Chair recognizes the Senator from Kennebec, Senator Katz.

Senator KATZ: Thank you Mr. President. Men and women of the Senate, are you unsure of how to find services to help a family member or friend or yourself? Are you wondering where you can make a difference by volunteering? Whether you need to find after school care, counseling, elder care, or volunteer opportunities; if you are where do you look? For years now the place to look has been 2-1-1. Over the last years, Mr. President, over half a million Mainers have taken advantage of that, to call 2-1-1 or log onto 2-1-1Maine.org. In recognition of that, Mr. President, the Joint Resolution recognizes February as 2-1-1 Maine Month. This is a service that many folks have availed themselves of. It's a great example of a public/private partnership between the State and the United Ways around our state. We should all be proud of it. I note that this Resolution was

supported by every single member of the Legislature, unlike the one honoring the Red Sox. It's rare that everybody can agree on something and we all agree on the importance of 2-1-1. Thank you, Mr. President.

Senator CLEVELAND: Thank you Mr. President. Men and women of the Senate, I also wanted to recognize this as an important institution. I'm very honored that Androscoggin County United Way was one of the leaders, originally, in establishing this new service, recognizing that there were thousands, and as we can see over half a million served to date, of people who every day are looking for assistance with basic and critical needs in our society. This provides a 24 hour 7 day a week service. Often, if you look at their reports, what you'll see at the top of the reports are people who are looking for the basic necessities of life; the ability to heat themselves, they're looking for food, the ability to pay for utilities, and healthcare services. You have trained professionals available to direct individuals to the resources that will help them get the needs that they have served. They do a fantastic job and I think it's appropriate that we recognize the terrific work that this organization does, Mr. President. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Franklin, Senator Saviello.

Senator SAVIELLO: Thank you Mr. President. Ladies and gentlemen of the Senate, it's my pleasure today to recognize a friend, a protector, and a hero. Ken has been a member of the Franklin County Sheriff's Department for 12 years. During his career he has demonstrated his ability as a team player again and again, first as a Deputy, Patrol Supervisor, and now a Senior Investigator for the Sheriff's Department. This team work approach to law enforcement has garnered great respect and admiration from his peers in the law enforcement community throughout Franklin County and Central Maine. During the course of any week you'll find Ken investigating sex crimes against children, recovering stolen property from burglaries, or setting up buys for drug cases. Ken does it all without complaint. It is especially moving when crime victims voice their appreciation to different organizations like Safe Voices and DHHS for the way Ken handles their individual cases. Ken is a retired member of the Army National Guard and served as a combat flight medic during Operation Desert Storm, Operation Iraqi Freedom, and during Hurricane Katrina. Ken is a devoted father and his wife, Anne, is wonderful because she puts up with him. We joked today that she does get \$5 in the mail from most of us, so she will stay with Ken and keep him under control. He is a true servant to Franklin County. I've known Ken for a number of years that I've served in the Legislature. There is an image I have of Ken. As you see him sitting in the back waiting to be recognized in a minute, he's wearing a suit and tie. I can remember him coming to a fundraiser for Keep Me Warm Dinner Dance. Here he was, dressed as the Mad Hatter with a big old top hat on. It's an image, I'm sorry Ken, that I can't get out of my head. I ask you to join me in congratulating him as the Franklin County Deputy of the Year for 2013.

Senator BURNS: Thank you Mr. President. Ladies and gentlemen of the Senate, I just want to also add my congratulation to Detective Charles for this achievement. I know how important it is to be recognized for the hard work that you do by your peers and by your community. In order to get that recognition I know you really have to put yourself out there, you and your family. I want to congratulate him on this auspicious occasion and thank him for the great work that he's done, along with his peers, and wish him well. Thank you.

An Act To Require Health Insurance Coverage for Hearing Aids for Young Adults

S.P. 213 L.D. 523 (C "A" S-378)

On motion by Senator **KATZ** of Kennebec, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Valentino.

Senator VALENTINO: Thank you very much Mr. President. Men and women of the Senate, this bill that is before you, An Act to Require Health Insurance Coverage for Hearing Aids for Young Adults, is actually a bill that I put in at the request of a constituent. I feel very strongly about the bill. The bill has been changed and I will go through a little bit of the process. It was introduced last year. We had a very lengthy public hearing with very much support on this. The bill was carried over because the Insurance and Financial Affairs Committee wanted the Bureau of Insurance to do a report on this. The report was actually done to the Joint Standing Committee on Insurance and Financial Services to review the evaluation of L.D. 523, An Act to Require Health Insurance Coverage for Hearing Aids for Young Adults. It was a very comprehensive report that was done. In the report there was a suggestion that instead of extending the hearing age for all adults there was actually another suggestion in there to extend it only to those of 26 years of age. This is what the committee actually voted out. I want to call your attention that it was a majority report, 12 - 1. All three Senators voted Ought to Pass as Amended on the report. One of the things is that the study was done. There was no fiscal note on this. It does not have to go to the Appropriations. It does not create a new mandate. We already have that hearing aid coverage, it has to be given on insurances for people up to the age of 18. All we're doing is expanding this to age 26. That's it. No fiscal note. No Appropriations Table. No new mandate. This will only help the most severe cases. One thing that we found about hearing aids is that there is not going to be a rush. If anything, in the report it said very few people are going to come forward. Hearing aids are not fashionable. People are not going to run out, especially young adults, and say, "I want a hearing aid now because my insurance is covering it." I would almost imagine that there are many people in this room, probably including myself, that might benefit from a hearing aid, but we don't want a hearing aid and we don't get the hearing aids. I don't see a rush to this. The

fiscal cost to the insurance companies was almost negligible. What I do want to read to you is a letter. This letter was written by somebody who testified at the hearing. I will read, "I am 13 years old and I live in Orrington. I have a bone conduction hearing loss. I was diagnosed when I was 2 days old but didn't receive equipment until I was 9 months old. Needing hearing aids to me is like needing a wheelchair. If you took a wheelchair from a person, he wouldn't be able to walk. If you took hearing aids away from a deaf person, they wouldn't be able to hear. If you told me to take off my headset, my bone conductor aid, and were to start a conversation with me, you would not make very much progress. Why? Because I'm deaf without my headset and hearing aid. Now you would say, "Emma, go back home and go to school and get a job." How could I, because I would be deaf without this. My hearing is not going to change. I'm not going to wake up some day and it will be different. I will still need my hearing equipment when I am 18 years of age and older. Please consider us kids as succeeding in life and helping us continue on that path. Please pass this act. Thank you. Emma." I want to say we talked a lot. I Chair the Workforce Committee. We want to give young adults an opportunity to succeed in life. This is just extending something from 18 to 26 years to give them that opportunity. We've already done it for their health insurance. They are already allowed to stay on their parent's coverage until the age of 26 years old. This is something, as Emma says, that is as crucial to her as a wheelchair is to others. This is not a new mandate. This does not have a cost. This is the right thing to do for our young adults. I urge you to pass this. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Penobscot, Senator Gratwick.

Senator GRATWICK: Thank you Mr. President. Ladies and gentlemen of the Senate, I, too, wish to speak for this. This came before the IFS Committee. I think you are all aware, and if you can hear me here you should be aware, that hearing loss in our population is a major issue. In Maine, with a population of 1.3 million, anywhere from 60,000 to 180,000 people are judged to have some variety of hearing loss. I have to say, on a personal note, I have no hearing loss whatsoever, except when I talk to my wife. She felt that I needed hearing aids and so I have hearing aids. It becomes something that people don't report. It's there. It's a round-about. I have to say that hearing aids are not bad at all. I would hate to deprive other people of that. With poor hearing, there are many consequences. We can all realize the social isolation, there are economic problems, and educational problems. It's something that we need; good eyes and good hearing are essential for us, I think, in this world. There are 20 states that have similar laws like we're talking about here today. There are actually three states, which are Arkansas, New Hampshire, and Rhode Island, which mandate it for individuals up to age 65. This is not at all rocket science we're talking about. We discussed it in detail in our committee. There was a very good report from the Bureau of Insurance. Of note, there is no fiscal note to this. Thank you, Mr. President.

**THE PRESIDENT**: The pending question before the Senate is Enactment, in concurrence. A Roll Call has been ordered. Is the Senate ready for the question?
