H.P. 1288

**JOINT RESOLUTION RECOGNIZING THE CENTENNIAL  
OF MAINE NURSING**

WHEREAS, Maine nurses provide professional and  
high-quality health care for people in all parts of the State when  
and where it is needed, including in urban, rural, island and  
wilderness settings; and

WHEREAS, Maine nurses provide their services in hospitals,  
in hospice, public health and emergency settings, in homes, in  
educational, governmental, industrial and private facilities, in  
long-term care, mental health, surgical care and obstetrical  
services settings, in physicians' practices and in community  
health centers; and

WHEREAS, quality health care provided by Maine nurses  
has long been supported by the American Nurses Association of  
Maine, or ANA-Maine, which before 2001 was known as the  
Maine State Nurses Association; and

WHEREAS, ANA-Maine has been a constituent of the  
American Nurses Association since 1914, and nursing practice in  
Maine has been registered by the State Board of Nursing since  
1915; and

WHEREAS, it is the mission of the State Board of Nursing to  
protect the public health and welfare in the area of nursing  
practice, and it is the mission of ANA-Maine to work for the  
improvement of health standards and the availability of health  
care services for all Maine people; and

WHEREAS, it is also the mission of ANA-Maine to foster high  
standards for nursing and to promote the professional  
development of nurses; and

WHEREAS, ANA-Maine advocates for nurses and promotes  
the recruitment and retention of nurses in Maine; and

WHEREAS, nursing education has grown and expanded to  
meet the needs of a changing health care system to include  
certified registered nurse anesthetists, certified nurse midwives,  
nurse practitioners and clinical nurse specialists; now, therefore,  
be it

**RESOLVED:** That We, the Members of the One Hundred and  
Twenty-sixth Legislature now assembled in the Second Regular  
Session, on behalf of the people we represent, take this  
opportunity to recognize the 100th Anniversary of nursing practice  
and education in the State of Maine; and be it further

**RESOLVED:** That a suitable copy of this resolution, duly  
authenticated by the Secretary of State, be transmitted to ANA-  
Maine.

**THE PRESIDENT:** The Chair recognizes the Senator from  
Penobscot, Senator Gratwick.

Senator **GRATWICK:** Thank you Mr. President. I wish to speak  
in favor of the Joint Resolution recognizing the centennial of  
Maine nursing. Very briefly, a personal overview of the state of

medicine in Maine at this time. If you have a complex medical problem I think you can often get very, very good care here in Maine. You can go to Maine Medical Center, Eastern Maine Medical Center, or wherever. There are a number of very good places here. Some very complex issues I think you may want to off to the Mass General or the Mayo Clinic because, again, they are a further level of expertise. The one thing that I think that you'd probably see is you would get better actually nursing and real care here in the state of Maine. I've found this to be true over and over again. After the operation is done, after you've had your complex medicine, the quality of the nursing care here in Maine is superior to that that exists elsewhere in the country. I think this is largely due to the extraordinary women, and some men now, who are going into nursing. I'm in full support of this Resolution supporting Maine nursing. I think Maine is very proud of its nurses. Thank you, Mr. President.
