The SPEAKER: The Chair recognizes the Representative from Saco, Representative Hobbins.

Representative **HOBBINS**: Thank you very much Mr. Speaker and Women and Men of the House. It is an honor and a privilege to be the sponsor of this legislative sentiment recognizing Thomas L. Welch of Hancock on the occasion of his retirement as the Chair of the Maine Public Utilities Commission. He has served more than two and a half terms in total spanning nearly sixteen years.

Commissioner Welch was appointed as Chair of the PUC by three governors: Governor McKernan in 1993, and was reappointed by Governor King in 1999, and he was again appointed by Governor LePage in 2011. Chairman Welch is widely respected for his experience, expertise in utility and energy matters including incentive regulation, telecommunications pricing, wholesale and retail energy markets, and regulatory practice and process. He has been the leading player in the roles in regional discussions to increase the flow of natural gas into Maine in an effort to lower energy costs for electricity and natural gas customers, and issues related to deregulation of Maine's telecommunication industry.

He has played a leading role in the design and implementation of the restructuring of Maine electric utilities industry and regional wholesale markets bringing benefits and competition to the consumers of Maine. Under his leadership he has also made Maine become one of the first states in deploying a statewide Next Generation 911 system designed with the way people communicate between using voice, text messaging, video, and pictures.

During the last session of the Legislature, he was the guiding force behind the historic, Omnibus Energy Bill that was a bipartisan project of this Legislature and of the Energy, Utilities, and Technology Committee. Chairman Welch is known widely

for his intellect, his integrity, his judicial temperament, and his willingness and ability to assist policy makers as they make decisions involving very complicated utility regulation issues. As any member of the Energy, Utilities, and Technology Committee will attest and who Chairman Welch appeared before, he provided a tutorial and an instructive approach, especially to new members in the areas of the intricacies of telecommunication, energy issues, water utility regulations, Next 911 system design, and other areas of jurisdiction of the Committee. He has been a source of professional, personal inspiration to the Maine Public Utilities Commission, cultivating a workplace of innovation, teamwork, and excellence.

He has belonged to numerous professional organizations and served as a member of the National Association of Regulatory Utility Commissions, known as NARUC. NARUC's Executive Committee also was fortunate to have him as a member in NARUC's Electricity and Telecommunications Committees and also he served as a member of the New England Conference of Public Utilities Commissioners and served as Chair of that organization. He was also appointed by Governor LePage to serve as a manager of the New England States Committee of Electricity, known as NESCOE, a nonprofit organization representing the collective interests of the six New England states on regional electrical issues. He has served also as the President of the Federal-State Joint Board on Jurisdictional Separations and as a member of the Federal-State Joint Conference on Advanced Telecommunications Services.

Between his Commission appointments, Chairman Welch served and worked for PJM Interconnection, a Philadelphia based Regional Transmission Organization and for five years as an attorney at Pierce Atwood, LLP in Portland. He has also served, as mentioned before, as a professor, adjunct professor, at the University of Maine School of Law. Before moving to Maine, Chairman Welch, in 1993, served as the Chief Deputy Attorney General for Antitrust in the State of Pennsylvania, Commonwealth of Pennsylvania, in the Attorney General's Office, and was in-house counsel for Bell Atlantic, and Assistant Professor at Villanova School of Law. Chairman Welch graduated from Stanford University in 1972 and Harvard School of Law in 1975.

We send our appreciation and gratitude to Chairman Welch for his many years of dedicated public service, and for commitment to the citizens of Maine. We extend our congratulations and best wishes to him on his retirement. Thank you.

The SPEAKER: The Chair recognizes the Representative from Newport, Representative Fredette.

Representative **FREDETTE**: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House, I think it speaks well of Tom Welch that as I came into my second term in the Maine Legislature, I had this thought one day: I'd like to do an energy bill, but I don't know where to start. And so I had known of Tom during the McKernan years as I had worked on Governor McKernan's reelection campaign, and I had heard of him at that point in time and his accolades over the years, and so being an entrepreneuring, young second-termer, I said, "Well, I'll call Tom Welch," and see if he would guide me on some ideas on how to do an energy bill. Much to my surprise he agreed to meet with me.

And even more to my surprise, if any of you ever travel up Interstate 95, and pass the Newport exit, and most people will stop at either Irving and get gas, or either the Dunkin' Donuts. Tom agreed to meet me at the Irving in Newport on one Friday afternoon in the middle of summer. He came in and we sat down and we had a nice conversation, and ultimately Tom turned to me

and said, "You know, you really want to do an energy bill, you really want to get into this?" And I said. "Yes I do."

And from there, quite frankly, started a journey that lasted well over a year. I had the wonderful opportunity to work with my good friend, my respected friend, Representative Hobbins who cosponsored the Omnibus Energy Bill with me and Senator Cleveland, and we worked through the summer and we worked through the year to pass what I think was a bill that is, quite frankly, shaping the conversation in New England right now in terms of what our electrical prices are and what our energy needs are going to be into the next 20 years. Quite frankly, to the point that there is a pending case now before the Public Utilities Commission related to specifically that issue.

And, so I have greatly enjoyed the opportunity to work with Tom. He has a home down on Hancock Point which I understand he is going to be enjoying quite a bit more. I travelled down to Portland a couple weeks ago where he had a, just a fantastic retirement party with many people there singing his accolades on many different levels and I understand that he's going to plan on doing some travelling before he comes back to Maine to enjoy himself. But I could not ask for a better friend, mentor, person, public servant to the people of the State of Maine, and I wish him the very best in his retirement. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Russell.

Representative RUSSELL: Thank you Mr. Speaker, Men and Women of the House. I am really honored to rise and to add my thanks to Tom Welch's work. In addition to having one of the best mustaches in the State House, Tom Welch comes to the table with a very Joe Friday perspective, which sort of matches his really awesome mustache. One of the things that I always appreciated serving on the Energy Committee, was that you get all this information from multiple sides, and the information changes as fast as you could possibly imagine, but the thing with Tom was always that we could count on his information. He was very much the "facts man"; just the facts. He was very, very Joe Friday, and so you built a level of trust with him, and what he came to tell us was really valued on the committee and I think it had a lot to do with why we were able to pass the Omnibus Energy Bill, which some of us secretly called the Ominous Energy Bill, let's be honest. Took a little while to get through.

But, honestly, it's been such a pleasure to serve with Tom, to have someone who, really who's intellect matches his passion. I think the good Representative from Newport talked about how the transformational policy that we passed last term really has set the stage for being able to lower electricity costs across the region. You know, we are not, when it comes to electricity, our own little world, as much as we'd like to be. We are part of the New England Grid, and sometimes that creates real problems when we're trying to negotiate prices down to an affordable level. And what we've done, with Tom's leadership and with the good Representative from Newport and the good Representative from Saco's leadership is that we're able to change that and to be able to start the conversation about moving natural gas up here which would lower electricity prices.

I don't think we've actually seen the magic behind Tom Welch's intellect just yet. I think we're starting to see it when we see the headlines around energy policy, but what's really going to happen is 3-5 years from now when the outcomes come to fruition for the Omnibus Energy Bill, I think people are going to look back at this day, especially those of us that are in the chamber recognizing his accomplishments and realize that everything that he's done to date has been nothing compared to

what is about to happen with the transforming of the energy policy.

Energy policy, as you know, has a lot to do with economic policy. Much of the economic discussion around major corporations in this state, and we're looking at Verso paper for example, stems from the electricity rates, and Tom has done such a good job of staying the course and being able to build bridges between conservatives and progressives like myself who have very different views on how to approach energy policy. He brought us together, he forced us to sit at the table and really, you know, developed trust and a strong relationship with folks that drove the final discussion and the final outcomes and a lot of what happened, happened here in the House.

So, I just want to add my thanks to Tom. He will be greatly missed, not just for his stellar personality which we all love, but more importantly for his intellect, his stay-the-course manner, and his capacity to really build bridges when so many things around him are burning pretty extensively. So, kudos Mr. Welch, you have earned your retirement and I thank you today, but five years from now I think the whole State of Maine is really going to be thanking you for your leadership.

The SPEAKER: The Chair recognizes the Representative from Embden. Representative Dunphy.

Representative **DUNPHY**: Thank you Mr. Speaker. Mr. Speaker, in an environment where people think they have all of the answers to all of the World's problems, I would suggest that Chairman Welch in fact does. He's been an amazing resource and his ability to take hugely complex issues and break them down so that even a legislator can understand them, it's astounding. So, he guided our Committee, he was always available for questions, very, very thoughtful, and I'd just like to wish Chairman Welch fair winds and following seas. Thank you sir

The SPEAKER: The Chair recognizes the Representative from South Berwick, Representative Beavers.

Representative **BEAVERS**: Thank you Mr. Chair. I'm going to chime in as a third term member of the Energy, Utilities, and Technology Committee. I can't tell you how much I appreciate the education that Chairman Welch provided us the last two terms. And he deserves a special medal for putting up with one of my constituents, who he knows who I'm talking about. And, just want to say thank you for all the reasons everyone's already said. Thanks.

The SPEAKER: The Chair recognizes the Representative from Freeport, Representative Gideon.

Representative **GIDEON**: Thank you Mr. Speaker. Mr. Speaker, Women and Men of the House, one of my first memories of PUC Chairman Tom Welch actually precedes my meeting him. As a new member to Energy, Utilities, Technology Committee in the 126th, I spent a lot of time with individuals trying to learn the ropes a little bit and understand some of the acronyms like ISO, RPS, KWH, PUC. And during one of my conversations with someone, the person sitting across the table from me said, talked a little bit about Tom Welch as the Chairman and he said, "Did you know that Governor Angus King, used to call him the Smartest Man in Maine?"

Well, at that moment, I wasn't sure whether to be comforted by that idea, or whether to be even more intimidated, because I was intimidated by the world of Energy, Utilities, and Technology.

Mr. Speaker, I tell you this because I quickly came to learn that Chairman Welch was all about doing his job with excellence, and that a big part of that excellence meant explaining things to legislators and making sure that legislators could speak the complicated world of technology.

It's one thing to understand these incredibly complex issues, it's another thing entirely to explain them. He has been a problem solver who can untangle twisted paths. He has been a leader who can bring regional entities and political personalities to a solution. He has been a public servant who can articulate a vision of how things can function better to a rotating committee of lawmakers who are constantly learning the proverbial ropes.

So, to the smartest man in Maine, we thank you. We bid you farewell on your next journey. May the lights stay on and may the basis differential be ever shrinking.
