the Wells-Ogunquit Community School District Girls Basketball Teams for their service in forming and sustaining the "Shootin' for a Cure" nonprofit. The players focused their efforts on an issue many of them had in common: family members suffering from breast cancer. Their nonprofit began by raising money to donate to York Hospital's Breast Care Center in order to bring an advanced 3-D breast imaging MRI system to the hospital. Players from 5th to 12th grade initially gathered pledges and shot free throws at their inaugural event, but Shootin' for a Cure has become a year-round campaign with several related events. Over 6 years, Shootin' for a Cure has raised over \$175,000 for the Breast Care Center. We extend to Coach Donald Abbott and all the players of the teams our appreciation for their service;

The **SPEAKER**: The Chair recognizes the Representative from Wells, Representative Foley.

Representative **FOLEY**: Mr. Speaker, Ladies and Gentleman of the House, I rise today in honor of a special group of people who have given so much to their community, my community, the Town of Wells.

Six years ago, the girls of Wells High School Basketball Team discovered they had a terrible thing in common. Several of them had relatives who suffered from breast cancer. The team wanted to find a way to support their loved ones, and to begin a fundraising effort for the Breast Cancer Center at York Hospital.

In order to bring an advanced 3-D breast MRI machine to the hospital, the coach, Donald Abbott, supported the girls' effort, and they embarked on a fundraising journey that has inspired and impacted the entire community. Each year the girls from the 5th grade to seniors in high school meet early on a Saturday in January and shoot foul shots. Fifty shots each with pledges from sponsors for each shot made.

In their first year, alone they raised over \$13,000 dollars. Not being satisfied with this effort, however, the girls, their coaches, and the dedicated group of parents reached out into the community and started different fundraising events year-round, involving the Wells Rotary Club golf tournament, raffle and bake sales, and t-shirt sales.

This past January, the girls held their 6th Annual Shootin' for a Cure event and raised an amazing \$35,000 dollars for the women's health and breast care center at York Hospital. Their total six year contribution to the very worthy program has topped \$176,000 dollars. As one of the State Representatives from Wells, a member of the Wells Board of Selectmen, a Wells Rotarian, and a trustee of York Hospital, I stand in awe of these fine ladies, their parents, and their coaching staff. I thank them on behalf of the lives they have touched.

The community of Wells and the great State of Maine salute you for a job well done. I might also add that they were recently honored by the Maine Principals Association for the 2014-2015 Sportsmanship Award for Class B. Congratulations. Thank you Mr. Speaker.

JOINT RESOLUTION RECOGNIZING ACCESS TO JUSTICE DAY PRESENTED BY MAINE'S JUSTICE ACTION GROUP

WHEREAS, 2015 marks the 20th anniversary of Maine's Justice Action Group, a judge-led coalition of leaders from Maine's legal community who are passionate about helping all Maine people have access to civil justice; and

WHEREAS, the coalition members include representatives of the state and federal judiciary, the Legislature, nonprofit civil legal aid providers, the University of Maine School of Law, the Maine Bar Foundation, the Maine State Bar Association, the Maine Trial Lawyers Association, private practice attorneys and others; and

WHEREAS, key initiator Judge Frank Coffin described the Justice Action Group as a catalyst, something introduced in small quantities that produces great change, and the Justice Action Group has been an advocate for equal access to justice since 1995; and

WHEREAS, equal access to justice is a bedrock principle of a free, constitutional society, but no system of laws and constitutional protections can be effective if only those who can afford a private practice attorney have access to justice; and

WHEREAS, providing equal access to justice has tangible, widespread benefits for Maine's families, children, schools, communities, businesses, charities and government; and

WHEREAS, legal issues profoundly affect basic human needs such as shelter, sustenance, safety from violence, health and child protection; and

The SPEAKER: The Chair recognizes the Representative from Saco, Representative Hobbins.

Representative **HOBBINS**: Thank you Mr. Speaker, and Women and Men of this Body. I rise today on behalf of the Joint Standing Committee on Judiciary to, in a form of the Joint Resolution, recognize this important occasion of Access of Justice Day.

Fortunately, for our committee, both of the co-chairs of JAG, the Justice Action Group, came before our committee and provided reflections on the Access to Justice, and the program which is so important to the guarantee of equal justice here in the State of Maine.

Justice John Rich, a magistrate of the federal court, and a supreme court justice who is the chair of this group, Andrew Mead, made a presentation and I'd like to share with you a few remarks paraphrased which I think really said it all. And, he talked in terms to our committee that when we say the Pledge of Allegiance, we close with, "justice for all." Now, this simple phrase articulates the central guiding principle that the Founding Fathers established, in that all true Americans hold dear, everyone is entitled to, equal justice before the law.

That principle, however, dims and sometimes vanishes when individuals are forced by circumstances to navigate the complex legal landscape without legal assistance or insights into the law.

Civil legal service organizations strive to fill that void between the high principles of our democracy and the economic reality that often marginalizes our needless citizens.

Much has been accomplished in the past 20 years, and I commend the work of the JAG group. I was fortunate to serve on this group several years ago for a three year term and I learned a lot, and I appreciate more what justice should be and what justice isn't at the present time. But much more remains to be done.

Maine's legal service providers do extraordinary work with extraordinarily inadequate funding. They struggle to deliver their services while resources and funding are a mere trickle in relation to the scale of the problem. It is the hope of JAG, and I think the hope of all of us, that we as leaders of our state, all of us will understand and support the objectives of civil legal services in the years to come. Our goal, our common goal, must continue to be, informed by the words, "justice for all." Thank you.

JOINT RESOLUTION COMMENDING THE EFFORTS OF THE PARTIES TO ADVANCE CHANGES IN PRIMARY CARE PAYMENT TO PROMOTE BETTER PRIMARY CARE FOR ALL MAINE

WHEREAS, it is recognized that primary care providers in this country serve as a critical component of the health care system and a fundamental element in efforts to promote health care delivery and payment reform; and

WHEREAS, at the same time, there is widespread agreement that payment for primary care services has not kept pace with payment for other specialties, and that current fee-for-service payment systems undervalue the benefits of primary care services; and

WHEREAS, prominent physician organizations, including the American College of Physicians, American Academy of Family Physicians and American Academy of Pediatrics and the Maine affiliates of these national organizations, together with the Maine Medical Association, Maine Osteopathic Association, Maine Primary Care Association, Maine Association of Nurse

Practitioners and Maine Association of Physician Assistants, recognize that patient care can be improved through a patient-centered practice model called the patient-centered medical home, or PCMH, model; and

WHEREAS, the medical home concept has been adopted by key stakeholders in Maine and is grounded in a set of patient-centered, physician-guided principles that promote an ongoing relationship between a patient and a health care provider trained to provide first contact, continuous and comprehensive care and who leads a team of individuals at the practice level who collectively take responsibility for the ongoing care of patients, including care for all stages of life, acute care, chronic care, preventive services and end-of-life care and coordination of care across settings, and promotes enhanced access to care through systems such as open scheduling, expanded hours and new options for communication between patients and their primary health care team; and

WHEREAS, the Maine Quality Forum, Maine Quality Counts, Maine Health Management Coalition and MaineCare convened the multi-payer Maine PCMH Pilot, which was launched in 2009 and expanded in 2012 to include additional practices and to bring in Medicare as a payer through the federal Department of Health and Human Services, Centers for Medicare and Medicaid Services Multi-payer Advanced Primary Care Practice, MAPCP, demonstration, now involving 75 primary care practices and 10 Community Care Teams from across the State; and

WHEREAS, MaineCare has developed its Health Homes initiative, which includes over 200 primary care practices, in alignment with PCMH principles; and

WHEREAS, those 200 primary care practices have now committed to implementing the PCMH model to improve care for their patients; and

WHEREAS, primary care providers involved in these efforts have committed hundreds of hours to implementing the PCMH model with the goals of improving patient experience of care, improving the quality of health care and health for their patients and controlling health care costs; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-seventh Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to recognize the dedication, commitment and efforts of the 200 or more primary care practices involved in the Maine PCMH Pilot, MAPCP demonstration and MaineCare Health Homes initiative and commend these providers for implementing the PCMH model as a means to improve the health care of all Maine citizens; and be it further

RESOLVED: That the State continue its efforts to promote improvements in primary care delivery and payment and commit to identifying additional multi-payer models for primary care payment that move beyond current fee-for-service payment models and expand the PCMH Pilot to better support and provide the necessary resources for all primary care providers in the State to implement the principle of patient-centered, high-value care.

The SPEAKER: The Chair recognizes the Representative from Gorham, Representative Sanborn.

Representative **SANBORN**: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House, this past weekend I had my first real experience with a patient centered medical home.

My 86 year old mother-in-law, who still lives alone at home, fell and fractured her arm. She was seen at a local urgent care center where the diagnosis was made, her arm was splinted, and the physician recommended a call to her primary care physician on Monday, an appointment to have her arm casted by an orthopedic surgeon, and a fall evaluation at the geriatric center.

When I made the Monday morning call, I was delighted to hear the primary care physician's receptionist say, "I will share this information quote, 'with the doctor and his team,' unquote, and they will talk it over and we will get back to you as soon as possible with our recommendations."

This team knows my mother-in-law well, knows that she wants, above all, to remain at home, and started coordinating her care immediately including a home fall evaluation. By noon her arm was secure in a cast, her pain was much decreased, and follow-up was scheduled. I would give this patient-centered medical home a high grade for patient experience and quality of care.

Over 200 primary care practices in Maine have committed to implementing the patient-centered medical home model, improving care for their patients over the past several years. This has been a monumental effort with the goal of improving the patient experience of care, improving the quality of healthcare and health for patients, and controlling healthcare costs. Dr. Erik Steele, an exemplary primary care physician leader, has called the transformation to PCMH's like quote, "changing your pants while running," unquote.

We have a long way to go to reach this triple aim, and to truly achieve payment reform that rewards quality rather than quantity of care, leaving the fee-for-service model behind. I am pleased that on Physician's Day in the Legislature, we can offer this joint Resolution to commend the effort of the Maine Patient Centered Medical Home Pilot, and MaineCare Health Homes initiative to urge the state to continue to invest in these efforts. Thank you.

WHEREAS, in Girl Scouts, girls develop their leadership potential through activities that enable them to discover their values and skills, and the world around them, and to connect with others in a multicultural environment; and

WHEREAS, Girl Scouting, now in its 2nd century of service to girls, is continuing its legacy of creating gender-balanced leadership in the United States and the world by providing girls with the tools to become leaders dedicated to making this country and the world a better place; and

WHEREAS, through Girl Scouting, girls gain courage, confidence and leadership skills that inspire them to make their local communities and the world a better place; and

WHEREAS, Girl Scouts has made girls' financial literacy a high priority in its programs and activities for over 100 years and continues to develop financial empowerment programs for girls in kindergarten to grade 12 to guarantee future generations of independent female leaders; and

WHEREAS, Girl Scouts outdoor experiences are an integral part of the Girl Scout Leadership Experience. Outdoor activities are woven into the core leadership development program in such a way that girls feel comfortable trying new things and testing their limits, and gain confidence and acquire new skills in a safe and supportive all-girl environment; and

WHEREAS, Girl Scouts is committed to ensuring every girl has the opportunity to explore and build an interest in science, technology, engineering and mathematics, helping them to develop critical thinking skills, problem solving skills and collaborative skills, which are vital throughout life; and

WHEREAS, with more than 2.8 million current members nationwide and nearly 60 million alumnae, and with 60% of the women in the United States House of Representatives and 53% of women business owners being former Girl Scouts, Girl Scouts has ample living proof of this amazing movement; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-seventh Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to commend the commitment Girl Scouting has made to support the continued advancement of girls in their roles as leaders here in our State and to send our appreciation by urging the citizens of Maine to recognize March 12th as Girl Scout Day; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Girl Scouts of Maine.
