Expression of Legislative Sentiment Recognizing Sharon Wise, of Winthrop

(HLS 26)

TABLED - January 20, 2015 (Till Later Today) by Representative HICKMAN of Winthrop.

PENDING - **PASSAGE**.

The SPEAKER: The Chair recognizes the Representative from Winthrop, Representative Hickman.

Representative **HICKMAN**: Mr. Speaker, thank you. Women and men of the House, I rise to honor the heroism of Ms. Sharon Wise of Winthrop, who, back in November, was ready to fight to keep a young girl from being abducted, but first, I would like to read briefly from the Posting Guidance for Federal Agencies as presented by the U.S. General Services Administration Missing Child Notice Program.

And I quote: "At the beginning of each month, all notices from the previous month should be removed and replaced with new notices. It is important that new notices are not added to existing notices. Listing more than ten at a time reduces the impact of this program. When selecting a site within your building to display notices, choose wisely. Ensure that notices are posted in public areas and offer maximum exposure to the public. Missing child notices present a powerful and emotional message, therefore, keep all hardcopy displays tasteful and modest in size out of respect for employees who may see the pictures repeatedly."

End quote.

The compassion on display in this guidance underscores an alarming statistic, Mr. Speaker: Every 40 seconds in the United States, a child goes missing or is abducted. Every 40 seconds.

And so, yes, missing child notices present a powerful and emotional message. I'm sure we have all seen them. Children's faces plastered on the walls of the post office or even the grocery store.

Every 40 seconds.

According to the most recent published statistics here in Maine, since 1971, seven children reported missing have not been found. Their families have no closure. There is a grief for them that knows no outlet. Can you imagine the emotional turmoil of a mother who goes every single day to the last place her son was seen hoping to find him right there calling out her name? Can you imagine the desperation of a father, who, every time he hears the wind blow open the gate to the back yard, he runs to a window hoping to see his daughter walking up to the back door. Can you imagine?

Mr. Speaker, Women and Men of the House, later today or tomorrow or the next, I say go hug your children or grandchildren, your young nieces and nephews and godchildren. Embrace them as often as you can. Let them know that they are special

little angels and that you love them from the bottom of your heart. For in the blink of an eye, any one of them could go missing.

Every 40 seconds.

We wouldn't wish that heart-shattering tragedy on ANY parent or grandparent or uncle or aunt. And so when you hold your children close and tell them how special they are, think of those whose vigilance, responsiveness and bravery have kept families whole.

And so, Mr. Speaker, I rise also to say this:

Let us honor Sharon Wise of Winthrop, who, as far as our research could take us, prevented the first abduction of a child by a stranger in the State of Maine.

I'm going to say that one more time:

Because of the vigilance, responsiveness and bravery of Ms. Sharon Wise of Winthrop, the first abduction of a child by a stranger in the State of Maine was stopped, *while it was happening*. The man could have drawn a weapon on her as she pulled the child back from his grip, and even if THAT crossed her mind, she was undeterred and kept a 2-year-old girl from being taken from her grandmother in plain daylight. And she did it all on a bad knee.

Talk about going above and beyond.

"Generations," wrote James Baldwin, "do not cease to be born and we are responsible to them because we are the only witnesses they have."

So today, we thank Ms. Wise for bearing witness. Today, we honor her for her heroism. Today, we are most grateful to Sharon Wise for her brave act of love. Her example is a blessing. Her example is an inspiration.

May we all be so vigilant, so responsive, and so brave. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Kittery, Representative Rykerson.

Representative RYKERSON: Thank you, Mr. Speaker. I rise in opposition to this motion. Women, Men of the House, Mr. Speaker. Remember November 4, 2014? That was the day when voters from all over Maine pulled the curtains at their voting booths and sent us to these desks.

In the months before that day, my neighbors and constituents would stop me in the supermarket or the hardware store and tell me their concerns. One thing I heard was that voters were losing their voice because politics were for sale. PACS, SuperPACS, lobbyists and corporate interests are highjacking our democracy.

The Supreme Court Decision *Citizens United* is emboldens by this highjack. Corporations increasingly have the same rights as people, but there are those who own those corporations who really ARE people, and they deserve to get their voices back.

This bill simply asks that when corporations make contributions to politicians or issues, the shareholders of that corporation approve of these contributions. At least four other states in the country are proposing similar bills. In fact, the majority Supreme Court Decision on *Citizens United*, Justice Kennedy, opened the door to this remedy. He said, "With the advent of the Internet, prompt disclosure of expenditures can provide shareholders and citizens with the information needed to hold corporations and elected officials accountable for their positions and supporters. Shareholders can determine whether their corporation's political speech advances the corporation's interest in making profits." He said, "Shareholders can determine whether their corporation's political speech advances the corporation's interest in making profits."

So this bill in no way restricts or burdens corporations according to the Supreme Court of the land. To all those who were elected November 4, 2014, we have our microphones at our desks so we can be heard. We owe it to those who put us here, to also let their voices be heard. Don't let money silence our democracy. I urge you to vote no. Thank you.

The SPEAKER: The Chair recognizes the Representative from Limington, Representative Kinney.

Representative KINNEY: Mr. Speaker, Ladies and Gentlemen of the House, I rise in support of the pending motion. This bill is an attempt to restrict political speech. Political speech should be afforded the strongest protection under the First Amendment of the Constitution.

This bill, furtherly, only applies to Maine corporations. Corporations incorporated in other states would not be under the jurisdictions or guidelines of this bill. Again, placing further regulations on Maine corporations that does not affect out of state corporations. Thank you very much, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Stuckey.

Representative STUCKEY: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House, the essence of this bill is remarkably simple, and eloquently straightforward. The U.S. Supreme Court's decision in the *Citizens United* campaign financing case basically affirmed that corporations are people and should have the same rights and freedom of speech as any other citizen when it comes to making political campaign contributions.

It was a long time ago, but I'm quite sure, Mr. Speaker, I learned in Algebra 1 that if A equals B then B equals A. Now, if that's correct, I would think that if a corporation equals its shareholders, then in a corporation where the majority of the shareholders are individuals, those people equal the corporation and their rights as shareholders, and their rights to freedom of speech, would necessitate the corporation follow the very basic requirements outlined in this bill before making any political contribution or expenditure. The corporation and its people should speak with one voice. A equals B, B equals A.

And in a corporation where the majority of the shares are held not by people, but by institutional investors, A does not equal B, B does not equal A. The right of freedom of speech should not apply, and no political contribution or expenditures should be allowed. I hope you'll agree, Mr. Speaker, that it's really as simple as that. Thank you.

The SPEAKER: The Chair recognizes the Representative from Brooksville, Representative Chapman.



Representative **CHAPMAN**: Thank you, Mr. Speaker. Friends and colleagues of the House, campaign finance reform is a complex issue. Overturning *Citizens United* is one mechanism for trying to do that. It's a very difficult job to do.

We'll have an opportunity later on to look at that opportunity, but this opportunity before us at the moment chips away at the basic problem and although it only applies to Maine, Maine can be a leader and show the rest of the country how we can move from the situation we're in at the moment to a much better one. So, I urge that we vote down the pending motion. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Newfield, Representative Campbell.

Representative **CAMPBELL**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House, I don't think any company or any stockholders in the State of Maine need for us to stick our nose in their business. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Ellsworth, Representative Luchini.

Representative **LUCHINI**: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House. While I appreciate the intent of my friend, the Representative from Kittery, I urge you to support the majority of 11's Ought Not to Pass motion on this bill. I know while we all have been frustrated by campaign finance issues, I just don't feel that this bill solves all of those problems, and I'll briefly describe some of the reasons the committee felt so.

First, as written, as the Representative from Limington said, this bill faces potential constitutional issues. In particular, by placing restrictions on political speech, which are afforded the strongest protections under the First Amendment. For a state to place such a restriction, it must provide a compelling state interest, must be narrowly tailored, and minimally burdensome. The majority felt that such a threshold was not met by this bill.

Secondly, this bill would apply only to Maine businesses. This would do nothing to prevent the out of state money that comes into our state, but would simply place additional restrictions on corporations based here in Maine, and could put them at a disadvantage if they wanted to donate to a political campaign or a referenda issue.

This bill also doesn't speak to enforcement—which agency would enforce this, how they're going to require businesses to poll their voters. There's also a provision in here that's particularly difficult to enforce, which would require any shareholder who disagrees with the corporation's contribution, they would be able to request a rebate of the percentage of the contribution that was made by their corporation's company. It would be difficult to enforce, difficult in practical speaking, so that's why the majority 11 were against this bill, and I hope that you support the majority Ought Not to Pass report. Thank you, Mr. Speaker.

Representative **FREDETTE** of Newport **REQUESTED** that the Clerk **READ** the Committee Report.

The Clerk **READ** the Committee Report in its entirety.

The **SPEAKER**: The Chair recognizes the Representative from Portland, Representative Russell.

Representative **RUSSELL**: Thank you, Mr. Speaker, Men and Women of the House, I rise in opposition to the pending motion. I have never been someone that has been in a position to care what the committee report was, as many people know. I just care about what the right thing is to do.

I think it's important that we state for the record that a Princeton study just came out the other day, and it says, "Using data drawn from 1,800 different policy initiatives from 1981 to 2002, the two conclude that rich, well-connected individuals on the political scene now steer the direction of the country regardless of, or even against, the will of the majority of voters."

We have come to a place where we are seeing that money is not speech, money is power, and there's a difference between the two.

Also recently, someone came out and wrote an article as a current Congressperson, and they wrote it anonymously. "I am a member of Congress," they write. "I'm not going to tell you from where or from which party, but I serve and I am honored to serve. I serve with good people, and some less good ones, and we try to do our best. It's a frustrating, even delusioning, job. The public pretty much hates us. Congress polls lower than Richard Nixon during Watergate, traffic jams, or the Canadian alt-rock band Nickelback. So the public knows something is wrong, but they don't often know exactly what is wrong and sometimes the things they do that they think will fix Congress like making us come home every weekend, actually break it further."

Here are the things that they want voters to know about what it's like. Congress is not out of touch with people back home. Number 2: Congress listens best to money. Number 2: Congress listens best to money. It is more lucrative to pander to big donors than to regular citizens. Campaigns are so expensive that the average member needs a million dollar war chest every two years and spends 50 percent to 75 percent of their term in office raising money. That means 25 percent to 50 percent is left over to actually do their job.

I think it's a sad statement on our democracy that we are in a position where money is equated to speech, when in fact money has been driving power and it has been consolidating power for decades, and most ensuredly in the last decade. So, yes, the committee report may be not in favor of this bill, but I'm going to stand here because there's a heck of a lot of money on the other side of the aisle that would like to see something like this go down in flames, and quite frankly I think the people of Maine deserve much, much better. I hope you will vote no to the pending motion.

The **SPEAKER**: I will remind all Representatives that we are not to question the motives or intentions of any member of this body or the other, or the Chief Executive.

The Chair reminded Members it is not proper to assign motives to the Chief Executive position.

The **SPEAKER**: The Chair recognizes the Representative from the Houlton Band of Maliseet Indians, Representative Bear.

Representative **BEAR**: Thank you, Mr. Speaker, Ladies and Gentlemen of the House. I rise simply to explain the position that's indicated in today's calendar that I am having voted Out to Pass in committee. I just wanted to let you know that I had attempted to try to arrange for an extension vote and under the rules, it's either you're voting or you're not, and it's one or the other.

So, I was attempting to abstain. I don't believe that the Tribe has a dog in this race, so to speak. And, so just to be clear on what you're reading in the journal. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Newfield, Representative Campbell.

Representative **CAMPBELL**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House, I request a roll call vote, and I say follow my light and let's kill this bill right in its infancy. Thank you.
