**RÉSOLUTION CONJOINTE HONORANT  
LES FRANCO-AMÉRICAINS**

Considérant que, l'état du Maine est nommé après la province du Maine en France et que les villages de Paris et Calais portent les noms de la capitale de France et du port français de Calais, respectivement; et

Considérant que, plus d'un tiers de la population du Maine est de descendance française et canadienne, et les franco-américains du Maine ont contribué beaucoup à la beauté et la qualité de cet état; et

Considérant que, le français est la première langue de millions de citoyens du Maine, et il y a eu une augmentation de l'utilisation de la langue française et une appréciation croissante de l'héritage franco-américain à travers l'état; et

**JOINT RESOLUTION HONORING FRANCO-AMERICAN DAY**

WHEREAS, the State of Maine is named after the Province of Maine in France, and the towns of Paris and Calais owe their names to the capital city of France and the French port city of Calais, respectively; and

WHEREAS, more than 1/3 of the population of Maine is of French and Canadian descent and Franco-Americans in Maine have contributed much to the beauty and quality of this State; and

WHEREAS, French is the primary language of thousands of Maine citizens and there has been a resurgence in the use of the French language and a heightened appreciation of the Franco-American heritage throughout the State; and

WHEREAS, clubs and organizations to promote French culture and language have sprung up throughout the State, including the Francophone Caucus at the Capitol; and

WHEREAS, fluent French-English bilingual people are a cultural and economic resource to the State; and

WHEREAS, cultural tourism can be greatly enhanced by the genuine Franco-American centers throughout the State, and the large Franco-American presence in Maine can further strengthen our relationships with Canada, France and the rest of the francophone world; and

WHEREAS, the first Franco-American Day was celebrated on Wednesday, March 6, 2002 at the State Capitol; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-seventh Legislature now assembled in the First Regular Session, on behalf of the people we represent, proclaim that Wednesday, March 18, 2015 is Franco-American Day, to be celebrated at the State Capitol; and be it further

RESOLVED: That Franco-American Day be celebrated to commemorate the rich history of the French people in the State of Maine and the United States of America.

**READ.**

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Newport, Representative **Fredette**.

Representative **FREDETTE**: Ladies and Gentlemen, just very quickly, Representative **Hobbins** spoke eloquently yesterday of his heritage here in the State of Maine, and his being Irish and the celebration of St. Paddy's day yesterday, a day of which I congratulate the good Representative from Saco.

As I was on the phone last night speaking to Representative **Timberlake**, he shared with me his wife's heritage as also of being of Franco-American heritage. And so, I think as we all look into ourselves and identify who we are as Americans, we all recognize that we all come from many great places.

At some point in time, from throughout this great world, but certainly for myself as I recognize my heritage going back to Quebec and Canada, certainly three or four generations later, very proud to be an American, but also very proud of my Franco-American heritage, and so I welcome the folks here from Canada, from the Console, and ask people to join us in celebrating a very special heritage day here in Maine. Thank you, Mr. President.

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Eagle Lake, Representative **Martin**.

Representative **MARTIN**: Thank you very much, Monsieur **Président**. Men and Women of the House, it really is a pleasure to be part of this today, and it reminded me when we were asked by the press a little while ago what directions did we all come from, those of us of Franco descent. And of course there are people like myself on my father's side who are through France to Quebec City, then on my mother's side it's Nova Scotia to Maine,

and so those two intermingle together and what has made Maine what it is for the Franco community.

And, we are now, throughout the state, and many of you have intermarried with us and now you're part of the Franco community.

Representative **VEROW**: Merci, Monsieur le de Président. Monsieur le Président, Mademoiselles, Messieurs de la Chambre. I'm pleased to present this Resolution in recognition of one of our outstanding citizens from Maine, Joe Cyr.

Joe and I hail from the same neighborhood. I was born in Old Town, and I was raised for a short time in French Island, which was a community, an important part of Old Town. Looking at that community, we had La Bree's Bakery, we had Judge Jean Beaulieu, and we also had the Cyr Bus Line, which was started by Joe's family, his grandfather I believe. And throughout the years Joe and I have had connections, we attended Husson College together, and Joe has done a lot of community service for the whole area of Eastern Maine, and Maine itself. We know that the Cyr Bus Line, his busses can be found anywhere from Washington D.C. and further, as far as transporting the University of Maine teams, and he's gone beyond just school busses to the transportation business.

I'm pleased that Joe is able to be here with his daughter, Becky, and his son, Chris to recognize it. Joe was in Florida when I told him about this. He was very appreciative and very excited, and he caught a plane and came up from playing golf down there in sunny Florida to be with us. So, I think that speaks well to his feelings about the State of Maine.

So Joe, welcome to the House, and we're glad to induct you into our Hall of Fame. Merci beaucoup, Monsieur Président.

**Recognizing:**

Roland Alfred Ouellette, of Chisholm, part of what is now the Town of Jay, on his posthumous induction into the Franco-American Hall of Fame. Mr. Ouellette grew up in Jay and graduated from Jay High School. He enlisted in the United States Army and served in the First Army in the European Theater during World War II. He was wounded in battle and lost the use of his legs. That loss did not stop him from participating in the sports he loved. He began coaching with American Legion baseball. He led programs in the Farmington and the Livermore Falls-Jay areas. Mr. Ouellette was inducted into the Maine Baseball Hall of Fame in 2002. In the 1970s, he began the Area Youth Sports program with a group of friends, which continues to offer many sports opportunities to the children of Jay, Livermore Falls and Livermore, and participated in the Summer Recreation Program in Jay for many years. In addition to his sports activities, he was active in local veterans organizations and the Knights of Columbus. He and his wife Barbara received the Knights of Columbus State Family of the Year Award and the New England Family of the Year Award. They were married in 1951 and were the proud parents of 7 children. Mr. Ouellette was also a recipient of the prestigious Jefferson Award for public service. We acknowledge Mr. Ouellette's service to his community and to the State, and we send to his family our congratulations on the occasion of his induction into the Franco-American Hall of Fame; (HLS 130)

**READ.**

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Jay, Representative Gilbert.

Representative **GILBERT**: Monsieur le Président, Mesdames et Monsieur de la Chambre. Mr. Speaker, Ladies and Gentlemen of the House, May 8, 2015 marks the 70th anniversary of the end of World War II. It is appropriate that we honor the memory of those who served our country in the years 1941 to 1945. It is also fitting that today, Franco American Day at the Legislature, we honor the memory of those Franco Americans who served our country in those war years. Roland Alfred Ouellette was one of them.

Roland was born September 30, 1923 in Chisholm, a village of immigrants and 1st generations Americans in Jay, Maine. He was the first born of eight children of Alfred and Annie Ouellette. As a teen he assisted his dad with the ice business, harvesting ice from the family pond in Jay and delivering ice to homes and businesses in the Jay/Livermore Falls area.

Following graduation from Jay High School in 1941, Roland briefly worked in the local paper mill and then enlisted in the United States Army as soon as he was old enough to do so.

He was assigned to the 95th Mortar Battalion which was part of the First Army, in support of its infantry. On Friday, April 13, 1945, while advancing toward Plettenberg, Germany, his unit was ambushed by a German mortar platoon. During the attack he was hit by shrapnel from mortar fire. The wound to his back severed his spine, paralyzing him from his hips down. Roland was cared for at several field hospitals, finally being treated at the First General Hospital in Paris. When he was stable enough for transfer back to the states, Roland spent two years at the Framingham General Hospital in Massachusetts where he recovered from his wounds and was rehabilitated. Roland spent the rest of his life as a paraplegic.

Following his return to Maine, Roland began to work at Norwalk Shoe in North Jay, then he was then hired as a supervisor at Livemore Shoe where he was employed until health issues related to his injuries caused him to resign.

A few years after returning from the hospital to Jay, Roland met and married Barbara Jalbert, a nurse at Franklin Memorial Hospital. They were the proud parents of seven children. Each one is a graduate of the University of Maine system and each one married, worked and raised their children here in Maine.

Although his health forced an early retirement from full-time employment, Roland was a person who kept busy. He spent countless hours volunteering in many efforts in his community of Jay as well as the surrounding communities, most of those connected with the youth of the area.

Roland loved sports. In high school he excelled in baseball, football and basketball. His favorite was baseball, and he often spoke of his time playing baseball in the military. He had hopes of playing professional baseball upon his discharge from the military, as he had been scouted while playing in the military leagues.

People in the region remember Roland most for his involvement with sports programs for the youth of the area. Roland began his coaching with American Legion Baseball. He led programs in Farmington and the Livemore Falls/Jay area. He also started a little league team in Farmington and in Chisholm and coached the Chisholm Tigers little league team for many years, instilling his love of baseball in hundreds of children in the area.

It was not unusual to see Roland on the mound pitching batting practice from his wheelchair to anyone who showed up or to see him hitting grounders and fly balls to any boy or girl who wanted to practice their fielding skills.

In addition to his coaching, he was the volunteer "groundskeeper" at the area ball fields, making sure the infields were smooth, the grass was mowed, the bases were on, and the ball fields were lined up according to regulation. He taught many young people how a ball field should be groomed since they not only got to play ball but had to help with the maintenance of their fields. The baseball field at Spruce Mountain High School was dedicated to him and named the Roland Ouellette Baseball Field. As a testament to his dedication to the sport of baseball, Roland was inducted to the Maine Baseball Hall of Fame in 2002.

Roland loved sports and he loved kids. He was also involved with local basketball and football programs. In the 1970s he was instrumental in developing the Area Youth Sports program, AYS. This program continues today, offering a multitude of sports opportunities for the children of Jay, Livemore Falls, and Livemore.

Even though most people who knew Roland connected him to athletics in some way, Roland's love for his community, his state, and his country was evident in other sports. He could often be found doing service for one of the local veterans' organizations or for the Knights of Columbus. He spearheaded the Summer Recreation Program in Jay for many years. It was while he was directing the Jay Recreation Program that the tennis courts in Jay were built. He spent many summers working with underprivileged youth of the community, volunteering his time and often his tools as he taught these young people the value of listening to others, following directions, working together, and then developing each of their unique talents.

Roland was also active in the move to provide handicapped accessibility in the state of Maine, serving on a governor's task force along with other disabled Mainers.

Roland Ouellette was a person who gave of his time and energy to make the lives of others better. He taught by example.

He and Barbara received the Knights of Columbus State Family of the Year award and the New England Family of the Year award. Roland was also a Jefferson Award winner.

Roland passed at 80 years old on September 8, 2004, leaving a lasting legacy: to love God, to help others, to do your best, and to work hard at whatever task is before you. I am honored to have known Roland Ouellette.

**Recognizing:**

Maurice Pelletier, of Augusta, on his induction into the Franco-American Hall of Fame. Mr. Pelletier is a veteran of the United States Air Force and worked for 28 years at the Veterans Administration Center at Togus, where he became a Lead Health Benefit Advisor and received numerous awards. After his retirement, he continued to serve veterans, working part-time as a volunteer Driver Coordinator for the Disabled American Veterans until December 2005. Currently, he volunteers at MaineGeneral Medical Center in Augusta. He is a 48-year member of Le Club Calumet and has served as the club's president. He is also a longtime member of the Knights of Columbus. He is a member of St. Michael Catholic Parish and a founder of the Friends for a Heritage Center at Mill Park, a group that contributes to the preservation and advancement of the State's history and culture. We acknowledge Mr. Pelletier's service to his community and to the State, and we send him our congratulations on the occasion of his induction into the Franco-American Hall of Fame;

Maurice Pelletier, known by many in Augusta as "Mo Pelletier," was the 68th President of Le Club Calumet. He currently serves on a committee to preserve the history of French-Canadian men and women who came to Augusta in the late 19th century to work in the Edwards Cotton Mill.

Augusta's Maurice Pelletier is also a patriot. He served his country in the military and continued with a career at Togus V.A. and upon retiring he volunteered by driving the D.A.V. van.

Thank you Maurice "Mo" Pelletier for all you have done, and all you are still doing for our Capitol City, Augusta. Thank you, Mr. President.

**Recognizing:**

Joseph Donald Cyr, of Lille, on his induction into the Franco-American Hall of Fame. A historian by education and work experience, Mr. Cyr has been at the forefront of efforts to preserve and promote Acadian culture. He has taught many college-level courses on Acadian history and folklore and French Canadian folklore. He was cataloguer and restoration specialist

at the Acadian Village in Van Buren and restoration specialist of the Albert House at the Tante Blanche Museum in Madawaska. He worked with the National Park Service in implementing the Maine Acadian Culture Preservation Act. Active in several major projects, he has raised more than \$3,100,000 in grants for the restoration of the former Notre-Dame-du-Mont-Carmel church and rectory in Lille. A collector of Acadian artifacts, he has amassed more than 300 pieces of handmade Acadian furniture and smaller artifacts, the largest such collection in the country. We acknowledge Mr. Cyr's service to his community and to the State, and we send him our congratulations on the occasion of his induction into the Franco-American Hall of Fame;

Representative **MARTIN**: Thank you very much, Mr. Speaker. Mr. Speaker and Members of the House, whenever you turn to Aroostook or you come to Aroostook for the first time, one of the places you need to go is to Lille, a small section of part of the community of Grand Isle.

It's interesting, because you know when people say a person can't do much, a person can't do something, I want you all to think about what Don Cyr has been able to do. And the old Catholic church which was abandoned, decided to take it over, and he has raised over \$3 million dollars in order to refurbish the church.

It is an unbelievable piece of history that we would've lost if it had not been for Don, because no one else wanted to take on the challenge. A few people tried and gave up. And Don came in and said, "I'm going to do it." And we all said, "Okay, we're going to help, but we can't help you very much." And he said, "Don't worry about it. I will do it."

And if you want to see some artifact of Franco Acadian history, go to the church and you will see it there. Because I don't know of any other way, or any other person that would accomplish what he did. And so, I want to say by the way, that we tried to get him to do this before today, but he really said, "Oh no no no no. Let someone else."

Well, this year, between the Representative of Sinclair and myself, we were able to twist his arm sufficiently, and he was willing to accept it, and we're very happy to have him here today to accept the award. Congratulations.

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Portland, Representative Jorgensen.

Representative **JORGENSEN**: Merci, Monsieur le Président. I wanted to add my congratulations and acknowledgment of the many contributions of Don Cyr, whose distinguished work as a teacher, as an historian, as a preservationist has benefitted not just the residents of Lille and the St. John Valley, but the entire state.

Don's work with the University of Maine, his work with the Maine Humanities Council, Maine Preservation, and other organizations has absolutely been pivotal in helping us all understand Maine's Acadian and Franco American heritage.

It's been an honor to know, and have had the privilege of working with Don over the years, and I was thrilled to see his name on the list of today's honorees. And, if you've never visited Notre Dame du Mont Carmel in Lille, it's magnificent cultural center. It's truly magnificent. It's worth every mile of the very long drive required for most of us to get there, so congratulations to Don.

**Recognizing:**

George A. "Pete" Lamontagne, Jr., of Biddeford, on his induction into the Franco-American Hall of Fame. Mr. Lamontagne served in the United States Army and was stationed with the Adjutant General's staff in France. He worked for over 3 decades at the Westpoint textile mill, until the mill's closure in 2009. He was a leader in the UNITE HERE Local 305T, at one time serving as union president. He helped found the Biddeford Mills Museum and personally restored a missing plaque commemorating 200 mill employees who fought in World War II. Mr. Lamontagne served 5 terms on the Biddeford City Council, including one term as Council President. We acknowledge Mr. Lamontagne's service to his community and to the State, and we send him our congratulations on the occasion of his induction into the Franco-American Hall of Fame;

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Biddeford, Representative Fecteau.

Representative **FECTEAU**: Monsieur le Président, Mesdames et Messieurs de la Chambre. Mr. Speaker, Ladies and Gentlemen of the House. Thank you, Mr. Speaker. I rise to recognize George Lamontagne, better known to those of us back home in Biddeford, as "Pete." I first met Pete when I was 16 years old a long, long time ago. I was the Student Representative on the Biddeford School Committee and Pete was serving as the President of the City Council.

And, for my brief time in those years, having known Pete, serving on the School Committee, it was easy to recognize that Pete was always the center of the scale; always willing to be a voice of reason and compromise, and able to bridge two parties on opposing sides together to produce progress for the city.

And, obviously, a number of the things that were said in the sentiment I won't repeat, but I will recognize the work that Pete is currently doing with Biddeford Mills Museum as a founding member. As you probably know Biddeford and its textile mills have undergone a great deal of renovation and a rebirth of sorts with many, many businesses now located in the textile mills.

And, for me, it's personal. My dad and grandparents moved to Maine in 1964, they moved to Biddeford. My dad and my mémé and pépé, and my dad worked in the mills until about the time of the closure as well. And what Pete is doing, and his colleagues on the Biddeford Mills Museum, is important work. They're carving out spaces in those mills so those of us, like myself, who have a deep attachment to the mills through our parents and grandparents are able to recognize the history and the significance of what that means to our city, and why so many

people decide to locate and move to Biddeford over many, many years.

And I think what's most important about what Pete is doing, is he's including youth. There's so many young people that are involved in what's happening at Biddeford Mills Museum, and that's because of Pete and some of his colleagues in recognizing the significance of having those of us who are a little younger, like myself, in on the fold. So, I have to really say that it's a great honor for me to be standing here today and recognizing someone that I admire as truly a leader of our city; someone who has done extraordinary work in his lifetime and has much more left on his plate to continue to inspire and improve our city, and most importantly preserve a history that is deeply important to so many of us. So thank you, and thank you, Pete for being here today.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Saco, Representative Hobbins.

Representative HOBBS: Merci, Monsieur Président, It gives me great pleasure and honor to rise today, as did my colleague, many, many semesters younger than me from the City of Biddeford who represents the City of Biddeford, Representative Fecteau. I have known Pete Lamontagne all of my life.

I am proud to say that my mémé and my uncle worked at the Pepperell Mills and Pete was not only a leader in the City of Biddeford as a City Councilor, as someone, a go-to person, someone who really, his heart and soul was in the historical background of the City of Biddeford; his cultural pride is very evident. And, anyone who has talked to Pete Lamontagne, or dealt with him, in the years of leadership, both at the municipal level, at the state level, as a union leader, but as a friend, knows what a wonderful person he is and what he has done for the culture of Biddeford and for the culture of my home area of York County.

The early Palmes Académiques was instituted on March 17, 1808, and was bestowed only upon teachers and professors. In 1866, the scope of the award was widened to include major contributions to French national education and culture made by anyone, including foreigners.

This is a significant honor for Ms. Belisle-Bonneau, and for all of us in Maine, I would add. We extend our warmest congratulations to her and thank her for the extraordinary work which she continues to do, and which continues to enrich our entire state. Thank you.

WHEREAS, the United States Food and Drug Administration has determined that over-the-counter medicines are safe and effective for the self-care treatment of minor acute and chronic health conditions and symptoms, such as pain, the common cold, allergies and other conditions that affect large segments of the population; and

WHEREAS, over-the-counter medicines are either developed as new nonprescription medicines or switched from existing prescription medicines; and

WHEREAS, over-the-counter medicines are self-care products that consumers purchase in pharmacies, supermarkets, retail stores and online; and

WHEREAS, each dollar spent on over-the-counter medicines saves the United States health care system \$6 to \$7 each year, totaling \$102 billion in annual savings; and

WHEREAS, over-the-counter medicines help to ease the burden on health care practitioners, eliminating unnecessary medical examinations that could be avoided with appropriate self-care; and

WHEREAS, the State benefits when its citizens practice appropriate self-care and do not unnecessarily visit health care practitioners and are empowered by higher self-esteem, improved health and reduced use of health care services; and

WHEREAS, people of the State are encouraged to take advantage of self-care's potential to improve personal and public health, save personal and public treasury and strengthen the sustainability of our health care system; and

WHEREAS, achieving self-care's potential is a shared opportunity for consumers, health care practitioners, policymakers and regulators; now, therefore, be it

RESOLVED: that We, the Members of the One Hundred and Twenty-seventh Legislature, now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to recognize February 2015 as Self-care Month in Maine and that we recognize the importance of improving awareness of self-care and the value it represents to the citizens of this State, and that we support increased consumer empowerment through the development of new over-the-counter medicines and the appropriate switch of certain prescription medicines to over-the-counter medicines, we acknowledge that over-the-counter medicines can greatly improve and reduce costs to the public health system, and we encourage consumers, health care practitioners, policymakers and regulators to communicate the benefits of self-care.

Ladies and Gentlemen of the House, this Joint Resolution that I have presented, yesterday there was distributed to the desk, an orange two-sided copy regarding brain injury in Maine, which was produced by Alpha One. And I hope you had a chance to read that.

But, I do want to speak on this Joint Resolution. Speaking on this Joint, this is a rather personal matter for me. In 1959, I was in an automobile accident and received a serious head injury. That injury was followed by a long period of what I called a period of "arrested development," both physically and mentally.

I was not wearing a seatbelt at the time; these were not standard equipment in the vehicles then. Had I been wearing a seatbelt, I would have been spared the traumatic head injury. Since the majority of head injuries result from automobile accidents, this Joint Resolution is important to call attention to the importance of wearing seatbelts, and I would also add, also wearing helmets and other restraints when you're on a bicycle or snowmobile, other activities.

So, I respectfully, helmets and others say they can prevent head injuries and save lives. I respectfully request unanimous support for this Joint Resolution. Thank you, Mr. Speaker.
