I guess you'd have to be a member of the old Boston Celtics, or New York Yankees to know the answer to that question. Or, maybe we should ask John Martin, who won Speaker of the House for 20 years.

There is one thing that we all know. It doesn't happen by accident, and I believe that the climb to the top is easier than staying on top. But whether you're climbing or trying to stay, it requires a tremendous amount of dedication, a commitment to excellence, a lot of hard work, and a real attention to detail.

He grew up in Bath and was very active in the Boy Scouts, and became an Eagle Scout at the age of 12. He graduated Morse High School, where he went on to the Marine Corp Reserves and was a veteran from '61 to '67. He worked at BIW for 37 years, from the years of 1964 to 2001 as a chief

mechanical engineer and rose to the rank of Vice President of Engineering.

Furthering his education, during those years, Bill studied at the Naval Architecture School at University of California Berkeley, Harvard Business School, and MIT.
