The **SPEAKER**: The Representative from Bangor, Representative Goode, has posed a question through the Chair to anyone who may care to respond. The Chair recognizes the Representative from Waterville, Representative Beck.

Representative **BECK**: Thank you, Mr. Speaker and Ladies and Gentlemen of the House, the title is indeed misleading. What is before you, a pending unanimous report from the Committee on Insurance and Financial Services, is a study order to examine the issue of the effect of student loan debt on the home buying market.

Ask any realtor or lender and they will tell you that there is an emerging generation and emerging problem in Maine, with inability of people of all ages, but especially young families with student loan debt to secure mortgages to buy homes. We all agree that buying homes is good for the economy, good for our communities, and what the sponsor of the bill and all the committee members of IFS decided on was asking those interested parties—realtors, lenders, higher education—to examine this issue and provide useful information for us to take some action in the future.

Again, the title is misleading, I'd urge this entire body to support the unanimous bill on this important issue.

The **SPEAKER**: The Chair recognizes the Representative from Orrington, Representative Campbell.

Representative **CAMPBELL**: Mr. Speaker, may I pose a question through the Chair?

The **SPEAKER**: The Representative may pose his question.

Representative **CAMPBELL**: Yes, if anyone could answer how is this going to affect the debt to equity on behalf of the banks?

The **SPEAKER**: The Representative from Orrington, Representative Campbell, has posed a question through the Chair to anyone who may care to respond. The Chair recognizes the Representative from Waterville, Representative Beck.

Representative **BECK**: Thank you, Mr. Speaker. Again, the title is misleading. What the bill before you does not propose to do, the text of the bill, the text of the unanimous committee report, is not to allow for a combination loan. It is a perennial study bill, but it's worth studying; it's an important issue, important to realtors, important to our lenders, important to the state, and again I urge the body to support this unanimous report.

Representative **BECK**: Thank you, Mr. Speaker and Ladies and Gentlemen of the House, what is before you is a Majority Report of the committee. Eleven members, I'm actually not on this report, but I, given the importance of the issue, I'm moving this report.

This committee amendment creates what's called third party notification in the cancellation of our state employee life insurance plan. The bill was proposed by the Representative from Augusta, Representative Doore, after the story of Jennifer and Scott Neumeyer. Mr. Neumeyer was a longtime employee of the State of Maine, and before his 40th birthday, and a few weeks before Christmas he succumbed to illness. But, just prior to his passing, his life insurance policy with MainePERS had been cancelled for nonpayment of some amount less than 10 dollars, and as a result his widow, Jennifer, would not receive the benefit of his life insurance plan.

So what the committee did was create third party notification, a insured may designate a third party to receive notices. The Neumeyer's argue that notice of cancellation was never received, and they certainly would've made nonpayment given what was going on. And so, this is an important bill and I hope, in this matter, the full House supports the work of the committee on this Majority Ought to Pass as Amended Report.

Representative RUSSELL: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House, yes, I am standing up on another one person report. I have been introducing this bill for years because I believe that our economy needs some big ideas. And this is one of those big ideas that I think will lay down the future so that we can actually stabilize our economy for generations to come.

This is not a silver bullet solution and it is not an overnight solution, but it is a solution that has worked, not just in North Dakota, but in several countries around the world. In 2008, we watched our entire economy collapse due largely to malfeasance on Wall Street. One of the only places, the only state in the country that did not see its economy collapse, did not experience a recession, was North Dakota.

North Dakota is not exactly known as the progressive bastion of society by any stretch of the imagination, quite the contrary; it's one of the most conservative states in the union. But they have what is known as a "public state bank." They've had it since 1918. They introduced that way back when because farmers were losing their farms to foreclosure. Much like we're experiencing across the country today. Their economy stabilized because of a state bank.

There are a lot of folks who will say there's a whole host of reasons, including the fact that they have natural resources as the fundamental reason why they did not experience a recession. However, all the states in the immediate region also had natural resources. Those economies experienced a recession.

There are also several countries that did not experience a recession during 2008 and 2009. They're the BRIC countries—Brazil, Russia, India, and China. The thing about the BRIC

countries is that their entire banking system is public banking. It is no coincidence that of all the economies in the world, the only ones that did not experience a recession, the only economies that remained stable were built on a public banking.

We have an opportunity to start a discussion about how to move that forward, how to bring that success and model it for here in the State of Maine. We spend a lot of time talking about how to create jobs, how to create and stabilize our economy so that we do not go through booms and busts and booms and busts. And yet, every time we have an opportunity to look at big picture issues, we always say we just don't have the time to look at it because we're always rushed by the process here.

A state public bank would provide us an opportunity to leverage our own treasury, our taxpayer dollars, and channel those resources here at home instead of storing them, as we currently do the vast majority, storing them on Wall Street.

This is a Main Street bill at its heart. It is a bill designed to ensure that we have a stable economy, that we can invest in that economy and grow it for future generations. As I said, it is not a silver bullet, it is not a final solution, but I do believe that if we were smart, we would start the road and start down that path to doing this.

Folks have run on this issue in the past, and this issue has created significant support from constituents. I hear from folks on all sides of the political spectrum around this particular public state bank. There's a lot of support for it in the grassroots, but unfortunately, it continues to stall. I'm not going to ask for a roll call, though I'm sure my good friend across the aisle might consider it, but I do think that it's worthy of putting on the record the importance of new ideas and big ideas, and they don't always have to come from the left side of the aisle or the right side of the aisle, and this is a classic example of a conservative policy that is really working for the people of North Dakota, and I think it's something that's worth bringing here so that we can make sure that we never have to go through a recession like we've had in the past ever again. Thank you, Mr. Speaker.

Mr. Speaker, Ladies and Gentlemen of the House, as you can see there's two that opposed, or voted Ought to Pass, I'm one of them, and the reason I did is, I think because in the last few years, we've found that certain areas within the municipality, with regard as to ordinances, do not seem to work.

Some of those, and the reasons behind it is that, we'll take consumer fireworks for instance, and with the animals which is one of the biggest complaints that we've had, is they scare the animals, and especially when, we'll say neighbors, did not advise the individuals that had those animals that they're going to set something off. With that said, I know that local ordinances have been established, however again on smaller communities where they depend on the sheriff or state police to respond, to find that out they will not respond if they do not have a contract with those entities.

And therefore, I felt that having a state law that required individuals that would set off fireworks, consumer fireworks, within a certain distance of farm property, especially where they have horses and animals and stuff like that, would be appropriate. And therefore, if there was a situation that couldn't be worked out and prosecution was the way to go, you'd have a state law that you would follow and be able to prosecute on that basis.

So, on that basis, I think something should be done. I don't believe to leave it to local control because it becomes patch work regulations, and those don't work. And that's my reasoning that I voted in opposition to this bill, Ought Not to Pass, and my thought is Ought to Pass as stated. Thank you.
