Representative MARTIN of Sinclair moved that the House **ACCEPT** the Majority **Ought Not to Pass Report.**

The SPEAKER: The Chair recognizes the Representative from Sinclair, Representative Martin.

Representative **MARTIN:** Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House, LD 1008 is an extension of a piece of legislation that was enacted in 2011 by the 125th Legislature. Back in the 125th Legislature a statute was enacted, ultimately signed by the second floor, that prohibits

any requirement that a bidder enters into or complies with an agreement with labor organizations on any public works project.

This current piece of legislation, LD 1008, would extend this provision of law regarding the award of public works contracts without regard to agreements with labor organizations by 10 years, to October 1, 2025. Fortunately, a couple years ago, this bill had a sunset provision and will expire on October 1st of this year. It's clearly an anti-labor organization bill and, again, I would urge all members of this body to support the Majority Ought Not to Pass Report. Thank you.

Representative FREDETTE of Newport **REQUESTED** a roll call on the motion to **ACCEPT** the Majority **Ought Not to Pass Report.**

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Dedham, Representative Ward.

Representative **WARD:** Thank you, Mr. Speaker, Ladies and Gentlemen of the House, this bill is about fairness, competition, efficiency, and doing what's best for Maine taxpayers and contractors alike. The 125th Legislature approved extending the sunset to 2015. This bill asks us to extend it further to prevent state, county, and local governments from requiring contractors enter into Project Labor Agreements, or PLA's, as a condition for working on Maine publicly funded construction projects.

Extending this sunset will ensure that government dollars, our Maine tax dollars, will continue to be spent in the most efficient manner. We get more bang for the buck. PLA's usually contain provisions so objectionable that most merit shop contractors like my company cannot, or refuse to, bid on PLA projects as it requires them to recognize the signatory union as the sole representatives of all project workers.

The problem is, Mr. Speaker, that 95 percent, 96 percent of all Maine construction workers choose not to join a union. So, it's very unlikely Maine-based companies will have an opportunity to work on projects with a PLA mandate. That's probably why AGC of Maine, that's the Associate General Contractors of Maine, the Associate General Contractors of the United States of America, which is the largest construction trade organization on the face of the Earth, and the Associated Builders and Contractors all favor this extension.

In short, PLA's prevent fair and open competition, will keep 96 percent of Maine construction workers off these Maine taxpayer funded projects, and increase our cost of construction and maintaining our public infrastructure. Excise tax for vehicles is meant to support road maintenance in the towns where vehicles are parked, and that is indeed where these taxes should be paid. Currently corporations and partnerships do this already with no ill effects and have done since the mid 70's, and this bill would just require that public utilities do the same.

There are winners and losers in this, I will grant you that, and coming from a town, myself, with a lot of non-taxed property, every little bit helps, or every little bit hurts. In this case, via an amendment the committee put in, it creates a soft landing for those towns who may lose some revenue by delaying the implementation until January 1st, 2017. It also puts it between two fiscal years, so those costs can be accounted for in that area.

And, again, it's merely an issue of tax fairness. These vehicles are on the roads in these communities, with the wear and tear associated with large commercial vehicles, and it's my view that this should be changed, and that's what this bill does. Thank you very much.
