The SPEAKER: The Chair recognizes the Representative from Saco, Representative Hobbins.

Representative **MARTIN**: Thank you very much, Mr. Speaker. Mr. Speaker and Members of the House, we finally have, I believe, Dana embarrassed. And, he's one of those who really tries to shy away from some of this, and today he can't avoid it.

Dana and I go back a long way, matter of fact we were students together at the University of Maine in Orono. This is not about tow-behind campers; this is about the type of unit that slides into the back of a pickup truck. This registration program for these campers has failed miserably. There are hundreds of these in the state, but yet there are only 94 that are registered. Additionally to that, the majority of law enforcement doesn't even realize these require registration. So therefore, I'm going to vote against this, and I would ask my colleagues to do the same. Thank you.

The SPEAKER: The Chair recognizes the Representative from Arundel, Representative Parry.

Representative **PARRY**: Thank you, Mr. Speaker, Ladies and Gentlemen of the House, as you can see, I was on the Ought Not to Pass side. We went back and forth on this issue and in reflection, I agree with my good colleague from Bowdoinham that this is such a small thing, and I think that we should allow this exemption, so I'll be voting against the pending motion. Thank you.

The SPEAKER: The Chair recognizes the Representative from Weld, Representative Skolfield.

Representative **SKOLFIELD**: Thank you, Mr. Speaker, I should also point out that I co-signed that bill with Senator Davis, and primarily because about 20 years ago I owned one of those little slide-in pickup campers. It was a neat little rig.

And, I did the right thing, I registered it, and I did that for a couple of years, and in talking to some of my law enforcement friends about that, they said, "What's that sticker on the back of your camper?" And I said, "That's an excise tax sticker; I'm registered." They said, "We had no idea you had to do that."

And, I began to question folks in law enforcement about it, and it was completely new to them that we had to do anything of that sort. So, I think the statute of limitations has run out since that, I stopped registering the doggone thing, and no one ever noticed. So, I believe that this is unnecessary government regulation, and because of the almost minimal numbers who actually abide by the law, I think we should eliminate that particular regulation. Thank you.

The SPEAKER: The Chair recognizes the Representative from Gorham, Representative McLean.

Representative **McLEAN**: Thank you, Mr. Speaker, very briefly, this bill would remove the excise tax for slide-in campers. It's already in current law that folks have to do this, and there are people who are not following the law and cities and towns are losing out on excise tax money that would go into roads and

bridges, or other infrastructure projects in their communities. So, this is money that cities and towns are going to lose out on if we remove this excise tax. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Searsport, Representative Gillway.

Representative **GILLWAY**: Thank you, Mr. Speaker, Ladies and Gentlemen of the House, I just rise to explain why I voted against this bill. The bill certainly seems harmless enough, and I am not even sure if any of these campers are registered in my town, but they certainly are for some of us.

The state has slowly been taking away revenue sharing for the past nine years, and in the last session, we lowered the rate for the local road assistance program by a mere one percent. The revenue that we give towns is dying a death of a slow million dollar cuts. I say we stop the bleeding, and that's why I voted against it.

The SPEAKER: The Chair recognizes the Representative from Norridgewock, Representative Farrin.

Representative **FARRIN**: Thank you, Mr. Speaker, Ladies and Gentlemen of the House, I voted on the Minority Report on this for a very simple reason. You know, I came down here with, listened to my constituents and hopefully from a common sense standpoint.

The intent of this bill that Senator Davis put forward was to do away with a restriction that 94 campers are registered in the State of Maine right now. It was not, and we turned that around from a simple five minute discussion as a committee, to not only defeat knocking down this bill, but the sending out letters to law enforcement and the municipal officials to enforce this. And I talked with some of the law enforcement folks afterwards, and said, "So, we're going to add something else to their plate. Maybe we should stop, you know, OUI enforcement on Memorial Day weekend and look for slide-in campers.

And I just, I think at some point, we have to say, "Folks, we got to stop." And what the intent that the sponsors of this bill had was to take authority, or burdens, away from our municipalities and law enforcement officers, not to add more to it, and sometimes, we just got to take a look and say, "What are we doing?" Thank you, Mr. Speaker.

Representative BECK of Waterville moved that the House **ACCEPT** the Minority **Ought Not to Pass** Report.

The SPEAKER: The Chair recognizes the Representative from Newport, Representative Fredette.

Representative **FREDETTE**: Mr. Speaker, may I pose a question through the Chair?

The SPEAKER: The Representative may pose his question.

Representative **FREDETTE**: Thank you, Mr. Speaker. Mr. Speaker, my understanding of the purpose of the bill is is that if a lien gets put on a piece of property, or whatnot, that that lien has to be removed within 60 days once the lien is paid in full. As an attorney, often times when we do title searches in the Registry of Deeds or the Secretary of State website, you go through and in order for someone to sell a car or sell a house or whatnot, you usually have to find clear title.

And so what that often means is, is that if you've taken out a mortgage or you've taken out a loan and somebody's put a lien on something, you technically can't sell that, or you shouldn't sell it without that lien being discharged. And so, to the extent that I understand the purpose of this bill is to say that those creditors that put a lien on something, whether it's a home or a car, or whatever piece of chattel that that lien be removed 60 days after payment in full of the underlying promissory note. And so, I'd just like to know if in fact that is my understanding of what the purpose of the bill is.

The SPEAKER: The Representative from Newport, Representative Fredette, has posed a question through the Chair to anyone who may care to respond. The Chair recognizes the Representative from Waterville, Representative Beck.

Representative **BECK**: Thank you, Mr. Speaker, in regards to the question, the Representative from Newport, his understanding as far as chattels I think is incorrect. The bill exempts secure transactions that are under Title 11. It also exempts municipalities, who are the most common holder of liens. I should note, keeping my comments germane as I can, I believe the genesis of this bill was a tax lien, but the committee then saw fit to exempt municipalities from the requirements of the bill.

The Representative from Newport spoke as an attorney. The House should be aware, this bill provides a new cause of action with attorney's fees, more law suits, more litigation, if this bill was to be accepted. I pay respect for the sponsor, and you know his duty to his constituents. The committee tried to be as accommodating and as courteous as possible as we worked the bill. I don't recall anyone but the sponsor speaking in favor of the bill.

The House should be aware they should take their duty to vote yes or no very seriously. If we reject the pending motion and pass this law, we will upend the Common Property Law in this state, creating new cause of action with attorney's fees, when no one testified on the bill except the sponsor.

The SPEAKER: The Chair recognizes the Representative from Wells, Representative Foley.

Representative **FOLEY**: Thank you, Mr. Speaker, Ladies and Gentlemen of the House, this bill is a fairly simple bill. It was developed to release liens, making sure that people who place liens on properties remove them within 60 days.

We did exempt municipalities from the legal action against them, but not the requirement to notify the owners of the liens that that lien has been released. And we did require that they don't have to do it by registered mail, only by first class mail. It's a very minimal thing for the town to do, but releasing liens is important because, as Representative Fredette said, we find many times that these liens get on credit reports, they stay there,

and they do deter people's credit, and it's incumbent upon anybody putting a lien on a property, even a municipality, that they release it in due time. So I request a roll call on this matter.

The same Representative **REQUESTED** a roll call on the motion to **ACCEPT** the Minority **Ought Not to Pass** Report.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The **SPEAKER**: The Chair recognizes the Representative from Newport, Representative Fredette.

Representative **FREDETTE**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House, I apologize for rising a second time. I would only suggest that this is a consumer protection bill. I mean, this is sort of where you entered into a contract with a creditor and, essentially, we sort of rely upon the good faith of the creditor to, once you pay a note in full, that that lien on the piece of property is going to be discharged.

Now, what this does is provide a little bit of an incentive for those creditors to actually discharge what they in fact should under the terms of the contract. And again, this is a consumer protection piece, as the good Representative from Wells indicated. You know, not only does this impact a piece of property, you may go to sell your home, and when you go to sell your home, you typically have 30 days to do all the title work. You're moving out and what not, and then you get two days before the closing, and this happens quite frequently, the title search shows up a couple of undischarged liens and you need to go track down the lienholders and, "Well, those have been paid in full, but we don't know if the lien has been assigned to somebody else," and whatnot.

And so, this is a real burden on property owners and those people are impacted, not only by that, but as the good Representative from Wells indicated, on your credit reports, and so I think this is a common sense bill and we should only be asking creditors to do what's expected of them and that is to discharge their liens. And Mr. Speaker, I would ask that the Clerk read the Committee Report.

The same Representative **REQUESTED** that the Clerk **READ** the Committee Report.

The Clerk **READ** the Committee Report in its entirety.

The **SPEAKER**: The Chair recognizes the Representative from Skowhegan, Representative McCabe.

Representative **McCABE**: Thank you, Mr. Speaker, a lot of conversation today about property, and I just pose a question through the Chair as debate was ensuing.

The **SPEAKER**: The Representative may pose his question.

Representative **McCABE**: Thank you, Mr. Speaker, I believe that this would exempt municipalities? I just was looking for clarification on that.

The **SPEAKER**: The Representative from Skowhegan, Representative McCabe, has posed a question through the Chair to anyone who may care to respond. The Chair recognizes the Representative from Waterville, Representative Beck.

Representative **BECK**: Thank you, Mr. Speaker, the final committee amendment, which is not before you, but it did exempt municipalities. They probably would've already enjoyed protection under the Maine Tort Claims Act, but it invites an important point that if we reject this motion and upend the Common Property Law and provide for more litigation and more lawsuits, after the bill becomes law, I believe your phone will ring, Members of the House, and it will be from creditors like banks and credit unions, but also associations like road associations or snowmobile clubs, those who bind together and charge assessments to maintain land or roads. And when people don't pay their assessments, they place liens.

The alternative to this motion would mean making those groups vulnerable to lawsuits and attorney's fees. I'm very pleased to hear my good friend, the good Minority Leader, speaking highly of consumer protection laws and committee reports and lawsuits.

The **SPEAKER**: The Chair recognizes the Representative from Yarmouth, Representative Cooper.

Representative **COOPER**: Thank you, Mr. Speaker, Ladies and Gentlemen of the House, I just wanted to explain why I was on the Ought Not to Pass Report, and that is because one of the things that we learned is that there are many kinds of liens and they're subject to different rules. For example, liens filed under the UCC are subject to certain kind of regulations about the duty to lift those liens when they are satisfied, whereas other liens have different legal requirements. And rather than get into the thicket of all those different kinds of rules, we thought it best to leave the state of the law as it is.

The **SPEAKER**: The Chair recognizes the Representative from Wells, Representative Foley.

Representative **FOLEY**: Thank you, Mr. Speaker, I apologize for rising a second time, I just wanted to clarify that the law as we wrote it says, "Remove within 60 days, unless specified by other provisions of law." So, any other provisions of law that have different periods of time to release liens has been recognized in this law and the only part of the bill that we did exempt municipalities is under the Liabilities Section from being sued for their cost of removing the lien because we felt that that was a burden on the taxpayers of the town if they were allowed to be sued. But the towns still have to, the town are still included in having to release the lien and notifying the property owners. Thank you, Mr. Speaker.

The **SPEAKER**: A roll call has been ordered. The pending question before the House is Acceptance of the Minority Ought Not to Pass Report. All those in favor will vote yes, those opposed will vote no.
